## IMPORTANT NOTES & MISCELLANEOUS CHARGES

Funerals are carried out between 9.30am until 3.00pm Monday to Friday  
Funerals out of hours are subject to additional charges and dependant on staff availability  
Memorials moved to accommodate burial are charged at £104, regardless of number

To comply with the Authority's Ecological Programme Metal caskets/Coffins are not permitted  
In Earth graves, they are permitted in Vaults

Funeral Directors may be fined if funerals are late or disrupt other funerals

The Non Resident Interment charge does not apply for the interment of a person in a grave in which he/she owned the burial rights purchased whilst a resident of Brent or the former Boroughs of Wembley or Willesden

Burial of surgical amputations is charge at £115 for Residents and £175 for Non-Residents

Plaques at Carpenders Park are the property of the Grave Owner who must maintain their height and level,  
The Council will undertake the levelling of a plaque for a fee of £35

Memorial Permits expired after 10 years ( subject to those installed after April 2007) and must be renewed

Searches of Burial Registers are charged at £10 per grave or by Hourly rate if complex

Registration of Probate is charged at £25      Transfer of Rights is charged at £25
