1. Apologies for Absence

2. Minutes of Previous Meeting

4. Mayor's Announcements

The Mayor reported that as everyone was aware Councillor Dorman Long had died on 20th July and everyone was saddened by this news. He stated that Councillor Long would be sadly missed. He welcomed members of Councillor Long's family to the meeting, along with Ashworth Elwyn a close friend of the family.

It was also with great sadness that the Mayor announced the death of former Councillor Noel Thompson who passed away on 18th August in St Luke's Hospice.

The Mayor explained that once the formal business of Council had been completed, there would be an opportunity for members to pay their respects to both Dorman Long and Noel Thompson.

The Mayor reported on the "Not Another Drop Peace March" taking place on Saturday 15th September at 11am, starting at Bridge Park and finishing at St Augustine's Church in South Kilburn. In light of recent events, he encouraged Members to attend.

In accordance with the new arrangements agreed for reporting on the progress of those petitions received under standing order 68, the Mayor drew Members' attention to the schedule circulated. At the end of the meeting the Mayor welcomed to the Council Chamber Mr Peter Owiny, the Mayor of Lira in Uganda who was paying a visit to the borough.

7. New Model Code of Conduct

The Government recently published a new Model Code of Conduct for members of local authorities. 8. Report from the Executive

9. Report from Overview and Scrutiny Committee

There was no report from Overview and Scrutiny Committee to this meeting.

10. Tributes

The Council stood for a minute's silence in memory of the late Councillor Dorman Long and in memory of the late former councillor Noel Thompson.

Tributes were paid to Councillor Dorman Long and past councillor Noel Thompson.

Councillor John, Councillor Blackman and Councillor Lorber remembered Councillor Dorman Long and extended condolences to Councillor Long's family on behalf of their Groups. Reference was made to the large number of people that had attended his funeral which was a testament to his standing in the community. Other members expressed their thoughts on the loss of Councillor Long.

His death was felt to be shocking news for the Council. He had been a councillor since 1974 and was Leader of the Council in 1987. He was remembered as a calm but determined man who during his time as a councillor had made a positive difference to the Council. He acted with integrity and honesty. He always had time for his fellow councillors and treated them with respect. He could be seen as a role model for the Afro Caribbean community. The thoughts of members of the Council were with his wife and family who were present at the meeting.

Much mention was made of Councillor Long's time as a councillor during a very difficult period for both the Council and the Labour Group. During this period he took many difficult decisions in a quiet but decisive way thereby laying the foundations for the future of the Council and the Labour Group. At all times he enjoyed the loyalty and great support of his wife and family. He was recognised as the longest

serving Afro Caribbean councillor. That Brent Council was seen to be the only Council to have an ethnic majority workforce serving an ethnic majority population was a legacy of Councillor Long's work on the Council where he championed equal opportunities in the borough, worked for community cohesion and had regard to the interests of the Council's workforce.

Members also paid tribute to former councillor Noel Thompson, remarking on how brave he had been during his time on the Council when he was very ill. As a senior ex civil servant with a distinguished career behind him he had chosen to give his time to the community by becoming a councillor in 1999. Reference was made to his work representing the Kilburn area and as the first chair of the then new Overview Committee. He was an advocate of the new ways of working introduced by the Local Government Act 2000 and set about ensuring the Overview Committee made an effective contribution to the work of the Council.
