Report Title: PUBLIC CONVENIENCE STRATEGY

1.0 Summary

1.1 This report examines current provision of public conveniences (PCs) in Brent, located on the public highway, Parks Tubes and Train stations and in Council Buildings (for example One Stop Shops and Libraries). The report suggests ways to improve existing facilities and steps to be taken to formulate an overall strategy for future provision in the borough. The report also considers provision of toilets in Wembley Stadium and surrounding area.

2.0 Recommendations

- 2.1 The Executive approves the strategy framework for the provision of public conveniences in the borough as set out in paragraph 5.2 below, to go out for consultation with key stakeholders and residents.
- 2.2 The Executive instructs Officers to explore the possibility of installing a Universal Superloo (USL) in Neasden shopping centre, and to consider installing another USL in Harlesden within the Town Centre, in a continuing effort to ensure that there are adequate toilet facilities in all the town centres in the borough (as referred to in 6.2 below).
- 2.3 Alternative use to be made of the redundant toilet buildings on the Harrow Road NW10 and Victoria Road NW6 as set out in paragraph 7.1 and 7.2 below.

3.0 Detail

3.1 The Council currently provides public toilets across the Borough on the public highway, in Parks and in certain Council Buildings (for example One Stop Shops and Libraries). All public highway-based PCs are accessible by disabled users. Although there is no statutory obligation on Local Authority to provide public toilets, the formulation of a strategy for PCs in Brent would provide direction on how the Council intends to maintain and improve existing provisions.

4.0 Background

- 4.1 The old purpose-built brick public conveniences were expensive to clean and service and were also in a poor state structurally. Some of these have been replaced since 2000. The contract with JC Decaux to provide new fully Automatic Public Conveniences including regular cleaning and servicing, in exchange for advertising concessions has resulted in 6 such automatic facilities being installed and these are located as shown in appendix A. The maximum potential under this Contract is for 10 'Universal Superloos', but it has not been possible so far to increase from the existing 6 sites due to lack of suitable locations that are acceptable in planning terms. There is no immediate prospect of the JC Decaux contract providing further toilet facilities.
- 4.2 In addition to the 6 JC Decaux toilets, another 3 automatic toilets (Superloos) have been installed in St Johns Road and Douglas Avenue in Wembley, and in Tavistock Road Harlesden. These toilets are maintained by Brent and is inspected and cleaned twice daily

5.0 Proposed Strategy

- 5.1 The need for public conveniences is mainly in public areas that are frequented by residents and visitors. These areas include town centres, large shopping parades, parks, cemeteries, council buildings, sport centres, tube and train stations. It is proposed that all new toilets are linked to service provision and include disabled facilities, also where possible provide baby changing areas, and should be accessible for over 12 hour periods.
- 5.2 Officers therefore suggest a strategy framework that will develop our approach for public toilets over the medium term as follows:
 - a. To use British Toilet Association (BTA) charter to develop a policy that sets consistent standards for the quality of all facilities in the borough.
 - b. Ensure all Town Centres have adequate public toilet provisions accessible to all members of the community
 - c. Officers would investigate the possibility of installing PC's in secondary shopping parades, accessible to all members of the community
 - d. Work in partnership with local businesses, Town Centre Managers and other stakeholders to supply access to further conveniences to minimise costs, where this helps us achieve other aims within this framework;
 - e. Ensure adequate provision of PCs around the Wembley event area, utilising s106 monies where appropriate;
 - f. Adequate directions to the toilets for both foot and car users, as appropriate
 - g. Proper signage, both outside and inside the toilets, including name of location, facilities available, person/authority responsible and how to contact if required. Where appropriate, community languages will be used.

- h. Hot and cold running water to wash basins in all facilities provided, with adequate provision for soap
- i. Adequate provision for hand drying
- j. Lockable toilet tissue dispensers, preferably with spare rolls/tissue
- k. Sanitary towel disposal units inside all ladies cubicles
- I. Properly designed and equipped access toilets, to include adequate disposal facilities
- m. Dedicated and properly equipped baby change facilities in both male female toilets or as a unisex facility
- n. Effective cleaning regime and management, to ensure proper standards of cleanliness at all times.
- o. Where possible PCs should be located close to CCTV cameras which may help members of the public to feel more secure when approaching the building and also reduce the incidence of anti-social behaviour.
- 5.3 Officers would be carrying out consultation on the strategic proposals set out in this document, especially those immediately above. Following an agreed timescale for consultation (in table immediately below) a further report will come back to Members for approval.

6.0 Public Conveniences in Brent

- 6.1 The need for public conveniences is mainly in public areas frequented by residents and visitors. These areas include:
 - Town centres Appendix A1
 - Secondary shopping parades Appendix A2
 - Parks Appendix A3
 - Cemeteries Appendix A4
 - One Stop Shops Appendix A5
 - Library Appendix A6
 - Sports/Lei sure Centres Appendix A7
 - Tube Station Appendix A8

A list of current publicly-accessible conveniences on the public highway is shown in Appendix A.

Town Centres

- 6.2 Town centres are those that are listed in the Council's Unitary Development Plan and shown in Appendix A1. The town centres would benefit from adequate PC provision that could mean two PCs each, preferably located where there is a suitable site that benefits from necessary services and at opposite ends of the town centre where appropriate. Some town centres like Kilburn also benefits from PCs provided by neighbouring boroughs, or are quite contained and may need less.
- 6.3 This arrangement will not be suitable for Wembley Town Centre where there is a recognised requirement for a greater amount due to the number of visitors attending events at the Stadium and the Arena. Further information on Wembley appears below.

Secondary Shopping Parades

- 6.4 Some shopping parades have grown in size and would benefit from one PC. We suggest developing criteria for siting PCs on secondary shopping parades. As examples of criteria, we can consider:
 - distance from existing public convenience;
 - number of shops in parade; and
 - customer traffic density.

Officers have identified possible locations in secondary shopping parades suitable for the installation of PCs based on the above criteria. However precise locations within these parades have not yet been identified. See Appendix 2 below.

7.0 Redundant Toilets

- 7.1 There are two redundant toilets located on the Harrow Road NW10 and Victoria Road NW6. These buildings would make excellent satellite depots for street cleansing storage purposes.
- 7.2 Conversion would continue the improvements we have already made with respect to street cleaning. The new Government Best Value Performance Indicator "BV199" requires a much more thorough approach to cleansing and management of the Streetscene. Achieving a high level of performance under BV199 is one of the Council's PSA targets, and can earn us a Performance Reward Grant. To address the problem an agreed programme of intensive cleaning will take place in each Ward four times a year. Intensive cleaning relies to some extent on mechanical sweeping and these machines need to be stored in a safe place. These redundant toilets are an ideal place to store these machines. Examples of such toilets are:
 - The redundant toilet in Victoria Road NW6 which has a new superloo directly in front of it.

• The redundant toilet on the Harrow Road has been closed for years, Officer has not received any requests from residents for this toilet to be reopened and the area is not heavily pedestrianised.

8.0 Public Toilet Usage

- 8.1 The British Toilet Association (BTA)'s best practice guidance recommends that there should be a minimum of 1 toilet for every 10,000 persons. The guidance does not mention whether the Public toilet needs to be located on the public highway or in Council Buildings. What is of more importance to the BTA is accessibility and creating a safe environment that is comfortable for the users.
- 8.2 In Brent the total population is around 267,766 people (mid-year estimate 2005), thus requiring a minimum of 26 toilets. The tables in Appendices listed below show that there are over 70 toilets located on the public highway, Council Buildings, Parks, and Tube and Train Stations that members of the public can use, this amount far exceeds the minimum requirements stipulated by the British Toilet Association (BTA) of 1 toilet per 10000 persons.
- 8.3 Changing demographics and human activity in Brent and provision of toilets in private businesses (i.e. hotels and shopping precincts) will affect the demand for public conveniences. The opening of Wembley Stadium and other developments taking place within the Wembley area may necessitate the Council playing a facilitation role. This would involve Council Officers working with local businesses to determine how privately owned toilets can be made accessible to public use.

9.0 Toilet Provision for Wembley Stadium –. (See Appendix C)

- 9.1 In Wembley there is work underway to identify sites for additional event day toilets in relation to the new Wembley Stadium. These toilets would be funded through monies allocated as part of the s106 agreement.
- 9.2 The new stadium includes over 2,300 toilets with 43 accessible externally without the need to give up a ticket.
- 9.3 Wembley Park Station and Wembley Central Station improvements (planned for stadium opening) include some toilet provision. The St Mowin redevelopment proposals also include some toilets below Wembley Square. Toilets have been sought at Wembley Stadium Station but these will only be available after a later stage of the hub project is completed and a ticket office is provided.
- 9.4 In Olympic Way the existing toilet block is now owned by Quintain. Quintain are required to pay £100,000 (or provide toilets up to that level of expenditure) under the section 106 Agreement in respect of their development next to the stadium.

10.0 Financial Implications

- 10.1 Any further provision of Universal Superloos within the existing JC Decaux contract will not have cost implications for Brent. However, as discussed at 4.1 further provision is dependent on suitable advertising sites being found, and for those sites then gaining planning consent.
- 10.2 Outside of the JC Decaux contract, the initial installation costs for new Universal Superloos are around £15k each.
- 10.3 The proposal to increase the number of public conveniences in Town Centres to two per Centre would necessitate an additional six Universal Superloos, and thus the capital costs to Brent (outside of the JC Decaux contract) would be in the order of £90k, with ongoing revenue costs of between £90k and £150k per annum.
- 10.4 If this Strategy for Town Centre provision is agreed, Officers will use existing provision (either through the JC Decaux contract, or existing revenue budget) to provide a further two facilities. However, any provision above this will require additional funds.

11.0 Legal Implications

- 11.1 Under section 87 of the Public Health Act 1936, a local authority may provide public conveniences, but is not under a statutory duty to do so.
- 11.2 Should the Council decide to procure additional public conveniences and servicing and maintenance of them (including the procurement of public conveniences pursuant to the Quintain s106 agreement if undertaken by the Council) then the procurement will need to be undertaken in compliance with the requirements of the Council's Standing Orders and the EU Public Procurement Regulations.

12.0 Diversity Implications

- 12.1 The proposals in this report have been discussed with members of the StreetCare Equalities Group and they have outlined below the following Equality issues:
 - a. That all PC sites should have:
 - a. adequate provision for men and women;
 - b. unisex facilities for use by mentality and/or physically disabled people with carers of the opposite sex;
 - c. unisex area with nappy-changing facilities; and
 - d. equipment made on a scale suitable for use by young children.
 - b. That all cubicles for women should contain paper bags for soiled sanitary towels and a disposal bin in which to place them. The bins for soiled sanitary towels must be careful monitored to ensure they are serviced or emptied with sufficient regularity;

- c. Instructions for toilets are currently in English, French and German. Instructions should more carefully follow the needs of the Borough's citizens as well as larger tourist groups;
- d. Insufficient information available on street signage and other Council offices regarding location of toilets;
- e. Some residents feel that the toilets (especially the old style) are unsafe. A typical comment on this theme includes: "they are magnet for anti-social behaviour (drug use, vandalism, sexual activity)";
- f. Some degree of mistrust regarding the new toilets (i.e. will they get locked in or will the doors automatically open whilst still inside);
- g. The general perception that public toilets are unhygienic (from all section of the community); and
- h. Lack of baby changing facilities. These were installed initially but were heavily vandalised and later removed.

13.0 Staffing/Accommodation Implications (if appropriate)

13.1 Costs for any additional staffing have been included in the revenue running costs.

14.0 Environmental Implications

14.1 The improved provision of PCs should help reduce health risks and environmental pollution caused by members of the public urinating in the streets or alleyways.
