Healthcare for London – Joint London-Wide Overview and Scrutiny Committee

The Committee is presented with a report outlining the proposed consultation process by NHS London on the findings of the recent 'Healthcare for London: A Framework for Action' report. Details are also provided on the formal consultation request for the establishment of a London-wide Joint Health Overview and Scrutiny Committee (JHOSC), and the Council's planned involvement in this body. The Brent tPCT Director of Strategic Commissioning and Chief Executive will both provide an update for members on this item, focusing on the tPCT approach and the role of the London Commissioning Group (LGC).

A tPCT Board Paper outlining the tPCT perspective on the establishment of a JHOSC (Appendix A) and a letter outlining the preliminary view of the London Scrutiny Officer Network (Appendix B) are included for information.

Establishing the LINks (Local Involvement Networks) – Progress Report

This report provides members with an update on progress to establish a LINk (Local Involvement Network) in Brent. In his capacity as the Council's nominated LINks officer, the Head of Consultation will update members on recent national guidance and local preparatory work underway to create a LINk in the borough. Members are asked to agree the report recommendations, including the nomination of a member to sit on the Brent LINks stakeholder group.

10. Visits and Consultation Plan

As part of the Healthcare Commission Annual Health Check process, the Committee is required to provide a formal response to the 'self declarations' produced by local health trusts. At a previous meeting, it was agreed that visits to local healthcare facilities would be helpful in assisting the Committee's evidence gathering work, and members will be presented with suggested venues.
