5. Local Involvement Network Annual Report p.9

The Brent Local Involvement Network (LINk) has produced its first annual report, which it is required to present to the local overview and scrutiny committee or, in Brent's case, the Health Select Committee. The LINk annual report has to be produced by the 30th June of each year. As members will know, during the year the LINk has worked to get itself established. The Council appointed a host organisation, Hestia Housing and Support, who have been in place since December 2008 and a management committee was elected in May 2009, made up of individuals and representatives of voluntary and community organisations from the borough. Members of the management committee should be attending the Health Select Committee to introduce the annual report. By considering the LINk annual report, the Health Select Committee will learn more about the work of the LINk and they can consider ways to improve working relationships.
