REPORT TITLE : PROPOSED EXTENSION OF CONTROLLED PARKING ZONE GC

1.0 SUMMARY

1.1 This report updates members on informal consultations on the proposed extension of the Zone GC (Chapter Road area, Willesden) Controlled Parking Zone (CPZ).

2.0 RECOMMENDATIONS

- 2.1 That Committee considers the results of the informal consultations on the proposed extension of Zone GC to be presented at Committee, and that where support is identified the streets be approved for inclusion in the extension of Zone GC CPZ subject to statutory consultation.
- 2.2 The Committee authorises the Director of Transportation to consider any objections or comments on the scheme and reject those he considers irrelevant or frivolous and if there are no other objections to implement the scheme, otherwise to report the objections back to Committee.

3.0 FINANCIAL IMPLICATIONS

3.1 The implementation costs associated with the extension of Zone GC will be met from the Transportation Service Unit's revenue budget for the 2004/05 financial year, subject to availability.

4.0 STAFFING IMPLICATIONS

4.1 The Transportation Service Unit will undertake the statutory consultation and implementation of the Zone KL CPZ.

5.0 ENVIRONMENTAL IMPLICATIONS

5.1 The implementation of CPZ schemes is in line with Government guidelines and policies relating to integrated transport policy and road traffic restraint. The CPZ will enhance the local environment by removing commuter parking and the wider environment by discouraging certain car journeys.

6.0 LEGAL IMPLICATIONS

- 6.1 The "pay and display" and permit parking methods of parking control and parking prohibitions (waiting and loading restrictions) associated with implementing the CPZ detailed will require the making of a traffic regulation order under the Road Traffic Regulation Act 1984. The procedures to be adopted for making the actual orders are set out in the associated Statutory Traffic Regulations.
- 6.2 If the Committee agree to include additional streets to the GC zone then the procedures require a period of statutory consultation, which means the authority, must properly consider any comments and objections to the schemes. If it fails to do this the implementation of the scheme would be unlawful and it would be impossible to enforce. If the process is not carried out properly the decision could be challenged by way of judicial review with the same result.

7.0 DETAIL

- 7.1 Informal consultations in Zone GC (Chapter Road area, Willesden) were originally carried out by consultants on behalf of Brent Council in June/July 2002. The consultation identified an inclusive area of support Zone GC, as shown on the map at Appendix A. The results of the consultation were reported to the September 2002 Highways Committee and the Zone was approved for implementation subject to satisfactory statutory consultation. The outcome of this consultation is reported separately in this agenda under the 'CPZ Progress Report'.
- 7.2 In the previous consultation in June/July 2002 the responses from Ackland Road, Balmoral Road and Linacre Road also indicated support for CPZ measures but these streets did not define an inclusive area which could either be considered for inclusion in Zone GC, or as a separate Zone. The Transportation Sub Committee therefore agreed not to proceed with CPZ measures for these streets. However, the September 2002 Transportation Sub Committee instructed officers to re-consult in the 'excluded' streets identified in the first consultation and this was undertaken in November 2002. The results of this second consultation did not identify any further support from streets in the vicinity of Ackland Road, Balmoral Road and Linacre Road at that time.
- 7.3 A petition was recently received from residents of Ackland Road, Balmoral Road and Linacre Road and was reported to the July 2003 Highways Committee. Members instructed officers to re-consult in these streets again, including all the currently excluded streets from the original GC consultation area (map at Appendix A). The consultations were underway at the time of writing this report and the results will be reported at Committee with officers' recommended course of action. A copy of the re-consultation is attached at Appendix A.

Dollis Hill Station Area Proposed Controlled Parking Zone (CPZ) Extension – Zone GC

You may recall that in November 2002 Brent Council's Transportation Service Unit consulted you on proposals for a scheme of parking control, for your street as part of the Dollis Hill area Controlled Parking Zone (CPZ). The consultation was carried out over a wide area of Dollis Hill, as shown on the map overleaf. The response to the consultation identified an area of support which the Council is preparing to implement by the end of this year or early next year. The area will be referred to as Zone GC.

Since giving you the results of the last consultation, which included a plan showing the approved area in January 2003 the Transportation Service Unit has received a number of complaints and a petition from residents outside the approved area of the CPZ Zone GC. The Petitioners explained that the exclusion of their roads from the scheme would lead to displacement parking within the area and have requested that the Zone GC be extended into their streets.

The complaints and petition were considered by the Council's Highways Committee and it was agreed that a re-consultation be carried out in the streets within the area shown overleaf.

I am therefore writing to seek your view on whether the CPZ should be extended to your road and would be grateful if you would kindly complete and return the attached questionnaire to me by Friday 14th November 2003. Please note that your street will only be included in the CPZ if the majority of those who return their questionnaire are in favour of the proposals.

A brief reminder of how CPZs operate generally is provided below:

- All the kerbside space will be controlled. Yellow lines will be introduced to control road junctions (double yellows) and vehicular accesses (single yellows).
- Parking will be either for permit holder or in 'pay & display' bays. Residents
 will need to purchase permits if they, or their visitors, wish to park in the
 designated bays during the scheme's operational hours.
- The cost of permits is £50 a year for the 1st permit, £75 for the 2nd car and, £100 for the 3rd. Each household will be restricted to a maximum of 3 permits.
- Visitors' Permits (vouchers) have to be purchased in advance and will be available in books of 10 at a cost of £5 per book (50 pence per voucher). Each voucher permits parking for a whole day. Alternatively, those residents who receive regular visitors, such as on a daily basis, may wish to purchase an Annual Visitor Permit at a cost of £75.

- Business Permits will cost £300 a year or, in the case of a liveried vehicle, £180 a year. A maximum of 3 permits will be made available for each business.
- 'Pay & Display' parking will be between 1 to 4 hours maximum stay, and the
 cost of parking in these bays will be from 20 pence for 20 minutes, to £3.20
 for up to 4 hours.
- The CPZ is intended to give the permit holders priority use of the parking spaces during the scheme operational times, but does not necessarily guarantee a parking space. Experience with CPZ's introduced elsewhere in the Kilburn and Willesden area has shown that residents are generally able to park close to their homes, even where there is a high density of residents.
- Zone GC permit holders will be entitled to park in any street within the zone, but not in any other zone. Similarly, permit holders from other zones will not be entitled to park in Zone GC. The zoning helps to manage the local demand for parking, especially in the roads close to shopping areas; a larger zone may encourage permit holders to drive and park within the zone in bays near shops or rail stations, thereby inconveniencing residents close to these amenities.

Earlier consultation with residents of Zone GC showed there was majority support for the operational hours of 8.30am to 6.30pm, Monday to Friday, and the scheme will therefore operate accordingly.


