5. **Petitions**

(a) Donnington Road – Against proposed re-routing of Number 6 bus via Donnington Road, Harlesden Road and Pound Lane

Summary	This petition from residents of Donnington Road, states that: "We, the undersigned, object to the re-routing of the Number 6 bus from its current route via Staverton Road to the proposed new route via Donnington Road, Harlesden Road and Pound Lane. This proposed change will create more congestion around Donnington Primary School."

	Reject the conduct of any more "Council" informal "consultations" that have the purpose of introducing any such CPZ scheme as referenced above.
	3) We also authorise Mr Robert Dunwell (chairman of the QARA Group of Associations) to represent us as our spokesman and overall co-ordinator for this petition and related matters. We also require that Brent Council, it's Highways Committee, Brent Councillors and Departments deal with Mr Dunwell in this capacity."
