	(v) That it be Committee noted that Paddock Road would be included in the next independent annual condition survey which would be the basis used to prioritise footways throughout the borough for inclusion in our annual renewal programme, thus enabling the Council to target those in most need;		
	(vi) That it be noted that until such time as it was prioritised for inclusion in the annual scheme of footway renewals, repairs would continue to be carried out in accordance with the councils intervention levels to ensure that the footway was free from major trip hazards and fit for purpose, thereby satisfying the		

	council's legal responsibility;
(\	<i>v</i> ii) That the Director of Transportation be authorised to proceed with any necessary statutory consultation, to consider any objections or representations and either to refer objections back to this committee where he thought appropriate or to implement the order if there were no objections, or if he considered the objections or representations were groundless or insignificant.

6. **Progress report on Controlled Parking Zones (CPZs)**

Summary	This report informed the Committee on the progress of the Controlled Parking Zones (CPZs) implementation programme in Brent, since it was last reported in July 2008 and addressed the following petitions. Petition received from residents of Windmore Close, Wembley HA0 requesting controlled parking zone for their Close. Petition received from residents of Dorchester Way, Kenton requesting short hours of no waiting restriction on their street.

Decisions Taken	 (i) That the outcome of the informal consultation with residents of Staverton Road be noted and the inclusion of Staverton Road in zone KS be approved subject to statutory consultation; (ii) That the outcome of the informal consultation with residents of the GA extension (Anson Road part, Gardiner Avenue, Tracey Avenue and Henson Avenue) be noted and agreed that CPZ proposal for their area be withdrawn; (iii) That the outcome of the zone HW CPZ review consultation be noted and approval be given to the following; (a) Operational times of the zone be 8.00am-6.30pm, Monday to Friday subject to statutory consultation (b) Officers investigate the feasibility of introducing additional parking places and that the CPZ be amended accordingly, if appropriate; (iv) That consideration of NT CPZ be deferred until the 		

	road by road analysis of the consultation is presented to this Committee at its next meeting in January 2009;
(v)	That the implications of free parking report as detailed in items 3.9 to 3.10 be noted and agreed that officers take forward a scheme to replace the existing free parking in Bridge Road and Preston Road with shared bays;
(vi)	That the Director of Transportation be authorised to consider objections and representations during the statutory consultation mentioned within the detail section of the report and implement the schemes but that the Director of Transportation report back to members, if there were substantial objections or concerns raised
(vii)	That the petition from Dorchester Way, Kenton be noted and officers be instructed to investigate and discuss the matters with the petitioner, Ward Councillors and relevant residents associations;
(viii)	That the petition from Windmore Close be noted and be instructed to consult with the residents of Windmore Close as part of the 09/10 CPZ programme.
