### Comprehensive Performance Assessment (CPA) Refreshed Score for 2007

### A comparison of Brent's performance 2006 - 2007

Each year the council reports against a set of national measures called best value performance indicators. Once this information has been audited, it is available for all councils to use to enable them to analyse how well they are performing compared to other councils. The Audit Commission have recently released the data for 2006/07. While this information is nearly a year old now, it is still a very useful gauge of how well the council is performing. This information is also widely used by government agencies and inspection bodies to judge how well the council is performing.

This report assesses whether Brent is performing within the top, middles or lower quartile for each indicator and whether performance has improved or declined since the previous year.
