**Report Title:** Waste Contract Performance

This report provides an update on the performance of the Council's Waste Services Contract with Veolia, specifically with respect to street cleansing, recycling, missed collections and complaints.

It provides an end of year assessment of performance in 2007/08 and describes the current position in 2008/09.

## **Street Cleansing**

Indicator: BV199 / NI195

Headline.

The upgraded cleansing specification delivered a step change in cleansing performance in Year 1 of the new contract.

#### **Headline.**

Last year saw a small overall improvement in recycling performance. An increase in dry tonnage was countered by a reduced composting tonnage as a result of contaminated loads. The annual target of 25% was missed.

#### Recycling Target 27%

Performance to end of June was a combined dry recycling and composting rate of 26.2% - a 2 percentage point improvement on same period the previous year. Contamination of organic loads seems to be much reduced with very few rejections so far. Dry recycling tonnage is starting to increase as awareness of compulsory recycling in August spreads.

#### **Compulsory recycling:**


Early results include:

A significant rush for new boxes – currently over 200 requests per day compared to 50 per week prior to publicity. A possible 30% increase in daily tonnage from first areas to receive information. This needs to be confirmed and established over a longer period.

#### **Missed Collections**

#### 2007/08

The new contract delivered improved performance against the previous year but the annual targets for grey bin, green bin and green bin were still missed. The annual averages were hampered by peaks at periods of significant service change. The annual average number of total missed collections per 100,000 was 95 against a target of 45.




#### 2008/09

There has been improvement so far this year with the average for all collection systems being less than 80 missed bins per 100,000 collections – however this remains 40 short of target.

## **Complaints**

A comparison of formal complaints against the relevant service areas for last year against the previous year is set out below. Refuse and recycling complaints slightly increased. This can be attributed to peaks at time times of significant service change. Street cleansing complaints reduced.
