VIW was spoken to and was unable to provide details of his attacker. He could recall that this was not a robbery however could not provide any relevant information to identify his attackers. No CCTV was recorded of the incident as all cameras were facing the wrong way. Without any further evidence to identify the suspects such as IC code, age etc, there is little significance in submitting clothing as any identification that may result would not point to involvement in the offence.

This report will be closed due to insufficient evidence. This may be reviewed if further evidence comes to light.

side of the road and stated that he was going to go home. Ambulance was redirected to the victim's given address. The victim was not suffering any dizziness and was only suffering from minor pain where his head had been cut. 
