
On the basis of the applicant's agreement to the following conditions NCT withdraw the objection.

- 3. Regulated entertainment will cease at 02:30hrs.



A Temporary Event Notice has been given under section 100 Licensing Act 2003 by

Mr Inderjeet Barmi for regulated entertainment, sales of alcohol and late night refreshment for a New Year party on 1st January 2018 from 2000 to 1st January 2019 0500 hours.

Police are formally making representations to the notice under section 104 Licensing Act 2003. The Police representation is primarily concerned with the prevention crime and disorder, prevention of public nuisance and Public Safety licensing objectives.

I made initial representations on 5th December 2018 and requested more information about the event. The applicant replied to this request on 14th December 2018. In the meantime I have investigated the operation and discovered Masti customers are generating alcohol fueled crime and disorder during the early hours of the morning when emergency service resources are stretched.

The premise holds a licence which allow it to be open from 1000 hours until 0430 hours daily with licensable activities ceasing 30 minutes prior, with the exception of Sunday which is until midnight.

This is sufficient timings for New Year Eve celebrations.

Drunkenness is an issue with this venue which has led to violence and disorder.

There have been numerous crimes linked to the venue in the last 12 months, as detailed below

11/12/17 Common Assault Suspects pushed victim's turban off his head, the victims, husband and wife were in the club dancing when two suspects started dancing with the wife, her husband did not like this and intervened this turned into an argument and male victims turban was knocked off, police attended and spoke to the victims who were both very intoxicated and it was not possible for officers to take a full account from them.

07/01/2018 04:00am it's alleged that suspect grabbed the victim around the neck causing reddening after altercation on the dance floor.

14/01/2018 at 0215 ABH report that a door supervisor assaulted a female customer by pushing her to the ground

4/2/2018 at 0429 hours. Police were called to reports of a female being strangled and ran to the toilets crying. This female was heavily intoxicated and had a dispute with drunk partner, she left the premises and made her way to Harrow Police Station to report.

2/4/2018 at 0400hrs Female alleged she was assaulted by another female. CCTV was provided however the exact location of the assault could not be identified as the victim had consumed a large amount of alcohol.

8/4/2018 at 0154hours a fight broke out after a female alleged she had been touched in a sexual nature on the dance floor by a drunken male. A fight then ensued between friends of the male and female.

13/4/2018 at exact time unknown whilst is Masti female was assaulted by the mother of another female who had been harassing her.

6/5/2018 at 0308 hours Large fight outside the venue involving customers leaving. Two people were arrested and during interview suspect claimed to have consumed amongst other alcoholic drinks '10 shots of Jamiesons Whiskey'.

5/8/2018 at 0238 hours male customers leaving Masti began fighting. Spotted on LBB CCTV cameras. Victim with injuries walked to Wembley Police station to report. He was drunk.

12/8/2018 at 0225 hours Customers leaving Masti began fighting, using weapons (bars and belts) spotted by LBB CCTV

25/11/2018 at 0246 hours victim assaulted on the dance floor received gash to face, heavily under the influence of alcohol.


Police fear that if this notice is granted with excessive hours, there is a very real possibility of crime, disorder, drunkenness and nuisance to residents with up to 300 people attending the event.

It is apparent from the above crime reports that there is an issue with violence and drunkenness and allowing the venue to extend its hours will only increase the risk of more disorder. Police intend to speak to the premises licence holder and resolve the problems through interaction in the new year.

Police say that given the risks to the licensing objective with this notice in terms of excessive hours, crime/disorder and drunkenness associated to this venue police would respectfully ask that this notice is refused.



(a) No supply of alcohol may be made at a time when no designated premises supervisor has been specified in the licence or at a time when the designated premises supervisor does not hold a personal licence or his or her licence has been suspended.

Annexe 1 - Mandatory Conditions

- (b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (c) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (d) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children:-

- (i) games or other activities which require or encourage, or are designed to require or encourage, individuals to:
- drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- drink as much alcohol as possible (whether within a time limit or otherwise);
- (ii) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted

fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

- (iii) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less; (iv) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on:
- the outcome of a race, competition or other event or process, or
- the likelihood of anything occurring or not occurring;
- (v) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- (e) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- (f) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- (g) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

- (h) The responsible person shall ensure that-
- (i) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
- beer or cider: half pint;
- gin, rum, vodka or whisky: 25ml or 35ml; and
- still wine in a glass: 125ml; and
- (ii) customers are made aware of the availability of these measures.
- (i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Annexe 2 - Conditions Consistent With the Operating Schedule

- 1 CCTV shall be installed and maintained in a working condition.
- 2 All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.
- 3 A notice shall be displayed at the entrance to the premises advising that CCTV is in operation.
- 4 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 5 The total number of people permitted on the premises including staff and performers shall not exceed 300.
- 6 No children shall be permitted on the premises after 19:00 hours.
- 7 Door supervisors at a rate of 1 to every 100 customers up to a maximum 3 shall be employed from 20:00 hours on any day when the premises are open for the sale of alcohol past midnight.
- 8 The use of the outside tables fronting on to the main road shall cease at 23:00 hours. The area shall be appropriately delineated and effective control shall be maintained to prevent open glass containers being taken from that external area.
- 9 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 10 Noise or vibration shall not emanate from the premises so as to cause a nuisance to near by property.
- 11 A "Challenge 21" policy shall be adopted and adhered to.
- 12 On major event days at Wembley Stadium the following shall apply:
- (12a) Customers shall not be allowed to congregate outside the front of the pub.
- (12b) No glass bottles shall be handed over the bar but decanted into toughened glass or plastic vessels.
- (12c) Door supervisors shall be employed.
- (12d) Toughened glass or plastic shall be used throughout.
- 13 Free and unimpeded access shall be allowed to Police Officers undertaking an inspection in relation to drugs. Any such visit is usually done on prior notification.
- 14 The licensee shall maintain a record of all authorisations by a Personal Licence holder of staff that do not hold personal licences but are engaged in the sale of alcohol. The record shall be made available to the Police and Licensing Authority upon request.
