

### Questions received from the public:

Please find below our question(s) for the JHOSC. We are focusing on Palliative Care issues and the Pembridge iin-patient beds.

We note with concern the continuing closure of in-patient beds at Pembridge Palliative Care Hospice in Ladbroke Grove. We note also that published summaries of engagement meetings that have already taken place completely ignore what have been clearly articulated and widespread demands from most of the public attending these meetings to reopen the in-patient beds which clearly meet local palliative care needs.

Will the CCGs now ensure that the public voice is properly and honestly recorded in reporting on all subsequent engagement meetings?

Why is it that the only in-patient beds in this part of NW London are NHS beds?

Why are the only in-patient beds to be closed in the poorest parts of the boroughs affected? Surely this can only exacerbate inequalities in provision?

Why have demographic, social and, indeed, transport issues been ignored or boxticked in the review that has taken place? Local knowledge seems to have been entirely ignored.

Is this a prelude to rolling out a similar programme across NW London?

#### **Responses from NWL Collaboration of CCGs:**

Dear colleagues,

Our response to the points raised are as follows:

Firstly, it is important to note that a decision has not yet been made about the future of the services at the Pembridge Palliative Care Centre. We will be engaging with patients and stakeholders fully in the coming months before any decision is agreed. The CCGs are indeed working to make sure that local knowledge is given full consideration and our engagement process will give everyone affected the opportunity to make their voices heard. To date we have involved local people in the Independent review, published in June 2019, public workshops, the Palliative care Patient and Public working group and on-going communications with residents and local stakeholders.

With regard to Merril's view about our written summary, we do take on board this feedback and will consider it when summarising future meetings. However, the workshops that took place were designed to seek people's views on the totality of a specialist palliative care service and to help commissioners determine what should be included within a future model for palliative care. The group discussions that took place were designed with this aim in mind and the report that then followed captured

these conversations. The community concern regarding the on-going suspension of the Pembridge in-patient unit was fully heard and recognised and we are working to resolve this situation as soon as possible in the context of the wider review taking place across the four boroughs.

At the beginning of February 2020 we will be continuing our engagement on this matter, publishing potential solutions which seek fundamentally, to ensure our services reach a greater number of residents in these areas and address the current challenges services face in terms of access, service provision and staff shortages in this specialism.

As part of this work, we will, of course be carrying out an Equalities Impact Assessment. It is understandable that our residents would want to make sure we have given careful consideration to any impact on equalities, and this will be picked up within that piece of work. It is arguable that the proposed changes, if taken forward, would actually have a positive impact on inequalities in provision by investing in home care services and community care.

Any similar work we do take forward in future would incorporate the learnings from this piece of work.

We look forward to continued engagement on this matter.
