## Foreword

Brent Council is committed to the development and encouragement of a broad range of cultural activities that help to bring communities together and showcase the borough at its very best.

Four priorities for an inclusive events programme 2012-2015

## Vision

Brent Council, its partners and communities will together deliver an annual programme of innovative and exciting cultural events that bring communities together to celebrate Brent's cultural diversity and enrich the lives of local people.

## Background

Brent Council is committed to encouraging the development of cultural activities within the borough. Over many years the council has delivered a broad arts and festivals programme catering for a range of different communities.

The Arts and Festivals programme delivered by the council up until 2010/2011 had endured over several decades and was no longer reflective of all of the many diverse communities the council now serves. This coupled with the new financial constraints facing the council prompted a re-think on how cultural activities should be provided in the borough.

The council has less money to deliver all of its services and this inevitably means there needs to be a reduction in the money directly spent by the council on Arts and Festivals.

The council launched a consultation with local people about its provision of Arts and Festivals activities on 7 March 2011. Feedback indicated that people felt that what the council provided should be more equitable. There was also a desire to have fewer specific faith-based events and more wholly inclusive activities.

The feedback from this consultation was considered along with other consultation and evaluation to help shape this document.

Over the last ten years many of Brent's local community groups have developed and staged their own events across the borough, some independently but many with advice and support from the council. Given this community desire to celebrate specific events in the faith or cultural calendar, and the current financial climate, the council is now shifting its emphasis to focus on directly delivering a small programme of core events that are wholly inclusive. It will also work in partnership with local groups to help them develop a richly diverse calendar of events that are community-led.

## Introduction

A future provision of an inclusive events programme will be developed to reflect and support the key principles of Brent's Cultural, Sport and Learning Forum.

The Cultural Forum adopted eight key principles to guide its work based on these eight principles:

- Enhancing cultural vibrancy - Brent's infrastructure
- Supporting the cultural economy - arts, culture and creative industries
- Raising the profile of culture - promotion
- Encouraging young people to take part - participation and engagement
- Developing public space - design and animation
- Making the most of London 2012 and other major events - place making
- Increasing participation - access
- Promoting health and well-being - use of parks and open spaces


## To develop and support a range of cultural opportunities that are engaging, accessible and enriching for all local communities.

## Events vision and principles

Brent Council recognises that access to cultural activities contributes to a safe, health and cohesive community. The council aims to work in partnership to develop and support a range of cultural opportunities that are engaging, accessible and enriching for all local communities.

## Events principles

## 1. An all encompassing approach

Promoting festivals and events which are inclusive of all Brent's communities. Festivals and events are a great driver for promoting a sense of belonging and unity in local communities. The new condensed event programme aims to produce cultural events that are inclusive to all its diverse residents.

## 2 .Promoting best practice.

To ensure that Brent delivers safe events officers will work with and assist external event organisers. There will be on line guidance which is accessible to both council event organisers and community event organisers, which will provide clear, up-to-date guidance on all the necessary steps for organising an outdoor event.

## Events goals

1. Celebrate Brent and engage its residents through diverse events
2. Widen audiences and participation in events;
3. Celebrate the borough's cultural heritage
4. Support a vibrant mix of quality, well managed events that reflect the diverse cultures and interests of Brent's residents.
5. Focus on fewer quality events delivered in house
6. Develop 2 major events to focus on different parts of borough
7. Seek and support events that contribute towards the vitality of Brent
8. Facilitate neighborhood events and the animation of local open spaces
9. Empower local neighborhood groups to organise their own events


## Festivals and Events Visions

## 3. Events that act as a community showcase.

Promoting events that create vibrant public spaces which attract visitors to the borough. Events create opportunities that showcase areas that are not typically tourist
 attractions, thus attracting visitors to the borough. Participation in events can broaden horizons, realise aspirations, improve education attainment and contribute to health through feelings of selfworth and well-being.

## 4. Promoting a business development approach.

Securing additional funding and sponsorship. With a new programme there is an opportunity to create a business plan for festivals and events with the aim to increase earnings from sponsorship to support limited budgets.

## Festivals and Events Goals

1. Improve and extend the use of Council media and other communication and tourist channels, including digital, to promote Borough events and venues.
2. Facilitate and promote neighbourhood events and the animation of local open spaces;
3. Ensure the sustainable use of parks, open spaces and indoor venues for events;
4. The Council will work with Friends Groups and other local stakeholders to stage events in the borough;
5. Advise and work with arts and community groups to ensure longer lasting benefits from events;
6. Provide enjoyment, learning and value for local residents and visitors through events.
7. Improve coordination of the council's event assets: venues, parks, public spaces, roundabouts, advertising;
8. Ensure the sustainable use of Brent's parks, open spaces and indoor venues for events;
9. Promote the use of Borough venues for events to maximize income potential;
10. Work with funding agencies and businesses to maximize support for events across the borough;
11. Work collaboratively with cultural organisations, venues, hotels and attractions to offer a Brent package to attract more visitors to the borough;
12. Review events funding processes to ensure they provide maximum opportunity and incentive to attract new funding support and appropriate levels of recognition for Council's contribution.

## Cultural activities will be part of the fabric of everyday life....

## Monitoring and Review

This document has been produced by the Brent Council to ensure an inclusive events programme is planned and developed in an agreed and co-ordinated way within Brent. It recognises the range of organisations and agencies involved in delivering a wide cultural offer in Brent, the role they will play in delivering this strategy and the benefits of working together to do this. It has highlighted the contribution that Arts and Festivals can play in Brent in terms of improving health, creating safe places, tackling worklessness and increasing community cohesion.

Brent Council will oversee the delivery of the actions and will review, comparing achievements against the key actions, taking account of changing circumstances and new opportunities, thereby allowing all partners to forward plan and identify resources with which to deliver key actions.

Improvement in participation rates as measured through the national indicators will allow us to determine whether the vision is being met. A comprehensive review will take place in 2014 to allow sufficient time for a subsequent strategy to be produced.

APPENDIX 1: POLICY CONTEXT FOR THE CULTURAL STRATEGY

## Local

Brent' new Corporate Strategy One Borough, One Community, One Council sets out an ambitious vision for Brent:'

- Creating a sustainable built environment that drives economic regeneration and reduces poverty, inequality and exclusion
- Providing excellent public services which enable people to achieve their full potential, promote community cohesion, and improve our quality of life
- Improving services for residents by working with our partners to deliver local priorities more effectively and achieve greater value for money from public resources.

Brent Culture, Sport and Learning Forum, comprising partners from local businesses and arts as well as sports and learning providers, produced a five year over-arching Cultural Strategy which was adopted by the Council in 2010. It offers eight key principles:

- Enhancing cultural vibrancy - Brent's infrastructure
- Increasing participation - access
- Raising the profile of culture - promotion
- Encouraging young people to take part - participation and engagement
- Developing public space - design and animation
- Making the most of London 2012 and other major events - place making
- Supporting the cultural economy - arts, culture and creative industries

The Local Development Framework focus will be on five key growth areas: Wembley, Alperton, South Kilburn, Church End, Burnt Oak and Colindale. It will see growth of 45000 new homes. A cornerstone of the Strategy is the creation of a new Civic Centre within the Wembley Regeneration area. The Council will be demonstrating its commitment thereby to both offer accessible community services and "much needed space for arts and cultural events".

## Regional

The Mayor of London's strategy Cultural Metropolis sets out the Mayor's commitment to support the cultural and creative business sectors and highlights their role in regeneration and employment. The strategy links the physical environment to the cultural offer through good urban design, to 'revitalised' public space through high-quality public art and announces a strong intention to "widen access to the arts from London's outer boroughs". In terms of London 2012 the Greater London Authority (GLA) is supportive of plans to develop festivals, productions and exhibitions that will form the city's celebrations of the Olympics. While the resources available to the Mayor are limited the GLA has a key role on the direction of the arts in London through the influence that can be exerted on Arts Council England, London. The GLA may also be in a position to benefit from a shift in Government thinking around the function and purposes of the London Development Agency which could impact on the development and support for the creative industries in London. The Events Strategy contributes to the priorities of:

- Maintain London's position as a world centre cultural excellence
- Support grassroots culture
- Create a lively public realm
- Increase access and participation

By using the Borough's cultural institutions when programming content for events, empowering neighbourhoods to run their own events and become involved in their local open spaces, grassroots culture can be supported and access and participation increased.

The London 2012 Olympic and Paralympic Games is a huge sporting and cultural event. The four year Cultural Olympiad programme was launched in 2008 to celebrate the Games coming to London. The programme includes the opening and closing ceremonies, major cultural projects and Inspire Mark projects. Inspire Mark projects are UK wide, community projects and events that have been inspired by the Games. Each year in the run up to the Games, Open Weekend will take place.

Regionally the Events Strategy contributes to and supports the work of the West London 2012 Partnership, WLA and the Western Wedge.

## National

The Department for Culture, Media and Sport (DCMS) has a Structural Reform Plan in line with Coalition Government agendas. Top priorities include the delivery of a safe and successful Olympic Games, support for the Big Society and reform of the National Lottery with 40 per cent of funding to be directed to the voluntary and community sector. It is currently undertaking a review of its network of public bodies to be delivered in the autumn with a view "to improving accountability, transparency and value for money".

Arts Council England (ACE) In 'Great Art for Everyone' ACE set out its view for the impact of the arts as: 'building people's capacity for understanding the world around them, enriching people's experience of life and offering an important emotional connection, creating links between different communities'.
As part of the Government's Comprehensive Spending Review, ACE's budget will be cut by 29.6 per cent. The arts landscape can be reshaped in line with the new strategic framework, and in full dialogue with arts organisations, artists and funding partners. Brent currently plays host to 5 RFOs.

The new National Performance Framework sets out the 198 national performance indicators for local government. Of the 198 indicators, the following relate to Arts and Festivals:

NI10: Visits to museums and galleries
NI 11: Engagement in the arts
NI 6: Participation in regular volunteering
NI 110: Young people's participation in positive activities
NI 199: Children and young people's satisfaction with parks and play areas.

## Consultation on Brent's Arts \& Festival Strategy

## Executive Summary

This consultation ran between 7 March and 26 April 2011. The consultation took the form of a questionnaire in both on-line and paper formats.

Number of responses. There were one hundred and ninety four (194), responses to the online questionnaire and eight (8) paper responses. Responses to both questionnaire formats have been amalgamated for the purposes of analysis. In addition a number of emails and letters were received. The Council has also received two petitions:

1. To retain funding support the St Patrick's day parade
2. To retain funding to support the Navratri Festival .

## Top line analysis

## Arts questions

The consultation document set out the council's proposed four priority areas of work - which would be used to inform a programme of support to future arts events in the borough. The priority areas were:

- Supporting the regeneration and infrastructure investments underway;
- Promoting the cultural economy;
- Commissioning and promoting art;
- Promoting arts and festivals linked to the 2012 Olympic and Paralympic Games.

Are they the right priorities? Participants were asked whether or not they agreed these were the correct priorities? The answers to this question were fairly evenly split with $54 \%$ agreeing they were and $46 \%$ saying they were not. When asked if the priorities were equally important a majority of respondents, (71\%) said the proposed priorities were NOT of equal importance. Only $29 \%$ agreed the four priority areas were of equal importance.

Rating the priorities! When given the opportunity to rate the proposed four priority areas of work in order of importance, ( $1=$ most important / 4 = least important), the responses were as follows:

| Importance | Priority area |
| :--- | :--- |
| Ist | Promoting the cultural economy |
| 2nd | Supporting the regeneration and infrastructure investments underway |
| 3rd | Commissioning and promoting art |
| 4th | Promoting arts and festivals linked to the 2012 Olympic and Paralympic Games |

Other suggestions! Participants were also asked if they could suggest other areas of work not covered in the proposed priority areas. 93 respondents answered this question. The comments have been themed and are attached.

Arts activities that promote the cultural economy, particularly with reference to Brent's cultural diversity, feature significantly in the responses to this question. Black art, history, young people, schools and the disabled are groups specifically mentioned as priorities for arts development. Activities that support the regeneration and infrastructure investments etc., also attract some additional support. Willesden Green Library Centre, the Stables Art Gallery and 'job creation' are specifically mentioned in relation to this priority. Promoting arts and festivals linked to the Olympic and Paralympic games was rated $4^{\text {th }}$. There are few comments on this proposal - one commentator questions the relevance to Brent while another is not clear that the Olympics will have a lasting legacy in order for this to be a priority. A few respondents have taken the opportunity to register their support for continued funding to festival events - notably the Navratri Festival.

## Festivals questions

The consultation document set out the council's proposed four priority areas of work. The priority areas of work would be the guiding principles which be used to inform a programme of support to future festival events in the borough. The priority areas were:

- An all encompassing approach that promotes festivals and events which are inclusive of all Brent's communities;
- Promoting events that act as a community showcase creating vibrant public spaces which attract visitors to the borough;
- Promoting a business development approach to festivals and events which secure additional funding and sponsorship;
- Promote best practice jointly between council officers and external event organisers to ensure we deliver safe and well organised events.

Are they the right priorities? Participants were asked whether or not they agreed these were the correct priorities? The answers to this question were fairly evenly split with $53 \%$ agreeing they were and $47 \%$ saying they were not. When asked if the priorities were equally important a majority of respondents, (70\%) said the proposed priorities were NOT of equal importance. Only 30\% agreed the four priority areas were of equal importance.

Rating the priorities! When given the opportunity to rate the proposed four priority areas of work in order of importance, ( $1=$ most important / 4 = least important), the responses were as follows:

Other suggestions! Participants were also asked if they could suggest other areas of work not covered in the proposed priority areas. 85 respondents answered this question. The comments have been themed and are attached.

An all encompassing approach that promotes festivals and events which are inclusive of all Brent's communities feature significantly in the responses to this question. Other communities identified include, young people, disadvantaged and at-risk groups youth and homeless. Promoting 'community spirit' and community cohesion are also mentioned. Promoting 'best practice' and promoting a 'business development' approach both attract support in this section. As with the similar question on arts, some respondents have taken the opportunity to register their support for continued funding to festival events. Navratri attracts the most support and to a lesser extent support is registered for 'Respect', Diwali, Christmas, St Patrick's Day. Eid, Chanukah and Holocaust Memorial Day.

Anything additional! The final question asked participants if there was anything additional to add to proposals for supporting arts and festivals in the borough. 109 respondents answered this question. Comments have been themed and edited - a full list is attached.

The largest single number of respondents to this question have chosen to register their support for continued funding of the Navratri Festival. Comments in some cases have been reproduced verbatim in different individual consultation responses. One comment was repeated on 10 occasions. Support for continued funding of the St Patrick's Day parade is also registered as is support for Christian festivals and 'Respect'. A number of commentators support the notion of arts and festivals on a more community (than religious) basis. Young people and the importance of the Olympics are mentioned. Considerable support is expressed for support to and development of local art and artists. Sponsorship and partnership arrangements to maintain funding receive some support. Closer involvement with local people and the voluntary sector is also recommended. There are some commentators who are promoting more equal distribution in the funding regime - citing examples of current unfairness or bias. There are two comments recommending no funding in favour of community self support.

## INTRODUCTION

Brent Council Libraries Arts and Heritage team are carrying out a review of their Festival strategy and want to ensure that the opinions of stakeholders are reflected and considered in that review.

The consultation that has informed this report was intended as a short targeted piece of research designed to inform an internal report to the Council's Executive. At a later date a full public consultation will be carried out.

The consultation targeted 45 key stakeholders of Brent's Festival Programme, as identified by Brent LAH. The consultation took the form of a questionnaire that was devised by Vashti Waite of Brent, with input from fellow Council officers, her Manager and the consultant Annie Grundy.

Turn-around time on the consultation was tight, so the key stakeholders were offered the choice of completing either digitally and emailing back to Annie Grundy, by telephone interview either with Annie Grundy or her colleague Sarah Morton, or by completing and returning by post.

The process of carrying out the consultation raised some difficulties with a few of the questions - these are set out in the 'reception' part of the RESPONSES to questions within each of the sections.

## POSITIVE

Brent 's festival programme reflects a sensitivity to the diverse nature of Brent's citizens,
As compared to the other councils, I feel the Brent Council does a great job
As a relative newcomer to Brent, I am quite impressed by the breath of festivals offered, spanning so many different communities - and most importantly the care with which each festival aims to focus upon as many audiences as possible (something for everyone).

Brent is progressive and programme reflects wide group of people. They also have family events. Excellent programme.

Overall an effort has been made to try to have diverse programmes. Various faith events is a good thing.

In the past youth and festivals were almost mutually exclusive.
Vashti's involvement has been great - have started to join up and feed in to programme.
Brent has a population change over of around $30 \%$ a year so it will always be a challenge to hold secular events for each specific communities. Integrated events like Respect allow for changes in the community. Diwali is a very successful event, with the most attendees and has a history of 14 years support from the community.

## AREAS PEOPLE FEEL NEED TO BE IMPROVED

Generally it's hard that it's all so split up. If break down festivals into religions and ethnicity, someone is going to feel left out. Not particularly a supporter of having a St George's Day - but then why have a St Patrick's Day? If do break down into ethnicity then why not an English day - but not just morris dancing and folk music! Events that celebrate living in Brent are better - that focus on the area or themes that all ethnicities and religions can relate to.
Can be hard to involve everyone if, as Queen's Park event is, you are over-subscribed. EG: used to put a lot of effort into bringing in henna hand painters. Indian food stalls etc have eased off on this since have reached maximum capacity on stalls, attendance etc. NB: involving community takes a lot of work - encouraging, informing, hand-holding through process of being part of a festival. But is ultimately worthwhile.

Need to look at growing the programme of Arts
Lack of publicity for overall programme and some of the events.
Don't know how the success of events is measured - needs to be looked at.
There is nothing specific for the Afro-Caribbean community
Appears to be bias towards some events more than others. Communities don't carry same weight: eg: more towards muslim and Indian events than African / Christian. This alienates some people.

Difficult to know who is responsible for each of the different festivals - what is Council and what is not, and if Council which department organises it.

Involve young people in planning an event.
Would like broader participation to be supported through more outreach activities in
schools to prepare for event e.g. music, arts, dance, poetry workshops
Bring different groups together to plan the same event
I feel that Brent have tried very hard to make the festivals accessible and inclusive with the intention of celebrating the diversity of Brent. But I just feel they have lost their way with it. We have discussed this at BMFF and are not clear of the aims of the Festivals of the strategy behind it.
BMFF are liaising with Nick Lane, LBBrent as we wish to be involved in developing the strategy that is needed by the people of Brent, reflecting the diverse communities, in particular the faith communities and working towards Community Cohesion.

Please ensure that ALL festivals are multicultural. I am concerned that religious groups should not be funded out of the public purse

I think the scale of inclusively and accessibility changes with each culturally specific event. The different cultures currently represented and celebrated through the current festivals programme are majority Faith based and secular events.
It has been highlighted by members of the Brent's community that faith based events often means members who do not belong to these specifically targeted groups do not feel represented whether it be through age, faith, culture ect. Another concern that has been highlighted by members of Brent's community is that the faiths based events receive larger amount of resources/support from Brent council and some are not even represented i.e. St Patricks Day is St Georges day is not or Jamaica day is not supported by Brent council. Diwali is a large scale event that is highly assessable to members of Brent's Hindu and non Hindu Community, Brent Christmas Senior citizens Christmas Lunch involving volunteers and performances from young people accessible to only Brent's Senior citizens from the Christian and Catholic community.

Consider working more closely with local community organisations and regional agencies to deliver events

To be inclusive and accessible it is essential that events are popular at the grass root level like local schools and community associations in the area., however I feel that the initiatives at the grass root level could be improved. We also need to explore ways that we could increase the attraction for people from other ethnic backgrounds and faiths to ensure they are willing to join in, better still contribute as well.

## FESTIVAL SPECIFIC COMMENTS

Instead of getting agencies to organise why not let community organise it. Lots of things lacking of the cultural aspect that is important to people who get angry. Doesn't feel all festivals are in the hands of people who know / understand the cultures. Community could organise for free. Gist of programme is $30-40 \%$ authentic only - rest superficial diwali. Hindu community receiving more and more complaints - hindu festival needs to be organised by hindu community under instruction and supervision of Brent.

Festivals are the only opportunity to get everyone together. Diwali is a hindu event but everyone takes part - though would be good to encourage more of the hindu organisations to take part so would be more popular (eg more people attending)
Better to focus on cultural festivals than religious festivals. Festivals with a religious origin often have a cultural nature.

Respect Festival is a highly assessable inclusive event which represents the thriving and diverse community within Brent through a variety of exciting art forms. It involves a range of departments across the council to maximise resources which is something that Brent Christmas, BHMday could benefit i.e. Collaboration between Town Centre mangers, diversity team, Arts \& Festivals team LAH.

We tried to be involved in the RESPECT Festival last year but the Company managing the event did not get back to us to confirm arrangements etc until it was too late. They were also very distant. Some of our members attended the Respect festival anyway to hopefully prepare for 2008 involvement and were very unclear what the point of the festival was. People seemed to be having fun, which is good and needed. We had thought/hoped that BMFF being involved in such an Event would be a fun way of helping with Community Cohesion, but this was not apparent to those who attended.

In particular being involved with the advisory group associated with Holocaust Memorial Day I am aware how the events department has developed plans for HMD that gives me confidence that the work will be carried forward in the future.

RE CONNECTING BRENT RESIDENTS TO THE COUNCIL
To qualify responses - connects to Council - to an extent but depends on the festival/event and what Council involvement is. EG: difficult to get Council departments to Queens as it is on a Sunday and the park is run by corporation of London not Brent

Re connecting residents to Council - people don't know what is Council led and what is not. In many ways the festivals program is the way of council engaging with residents on their terms rather than other way round. Main point of contact for council and residents is about finances in some shape or another - festivals take this away from the equation and allow a better, more holistic relationship to be developed

It demonstrates support from the local authority and that it values its diverse population.
RE IMPROVING COHESION
A number of people wanted to give emphasis to the benefit of improving cohesion and the fact that the programme celebrates diversity and brings people together. Some people 'double-ticked' cohesion as a benefit.

Cohesion is the most important thing - a community that celebrates together can live together in harmony.

The most important benefits of a festival programme are improving cohesion through understanding and creating a sense of local ownership. Parades / carnivals are good for this -need to feel they have something to parade and be proud of.

Improves cohesion - depends whether event is monocultural or multicultural - mixed events do have this benefit.

## RE LOCAL OWNERSHIP

Festivals should involve LOCALS. Local ownership is possible through festivals but not achieved at present.
Helps people find place in locality, makes a locality distinctive. Festivals offer a shared collective experience of a positive event.

Understanding and respect between faiths
Could provide opportunities for local people to learn new skills eg: organisational - start as volunteers. Encourage. Support.
Brings higher quality events to community
Makes the members of the different communities feel part of a bigger community
Provides healthy day out in the open air
Builds on Arts activity and supporting creativity throughout the borough and raising awareness or current issues/social issues/factors through the an variety of arts forms.

Reception: This question caused some confusion for quite a few people, who found it hard to put ways of getting involved in order of importance. Many, instead gave a tick or 1 to all those they felt were important and no mark to those that they felt were not important at all.

The results (See Appendix 2, Question 3) do however show quite clearly that the vast majority ( $60 \%$ ) felt the two most important ways of involving residents are through community outreach projects and active involvement through performing, holding a stall etc.

The next most important ( $42 \%$ thought it of importance) was for residents to have an advisory role, although conversely a relatively large number of people - (21\%) gave this little or no importance or did not mark at all indicating they do not think it is a good idea.
$33 \%$ of people felt that voluntary and paid work were of importance although again conversely $36 \%$ of people gave paid work little or no importance and $30 \%$ gave volunteering little or no importance.

## ADDITIONAL / QUALIFYING COMMENTS

## RE ACTIVE INVOLVEMENT

Re stalls and providers - keep business local using local companies for entertainment, costume hire, musicians etc wherever possible.

## RE ADVISORY / PROGRAMMING ROLE

Advisory and steering groups are good but can be a nightmare - possibly consult with and take advice from communities but not decision making - as too many different ideas.
Decision makers must be impartial and that must be seen - possibly based on evaluation.

## RE COMMUNITY OUTREACH PROJECTS

Community outreach very, very important but must be out of school hours as children and young people need more activities to do - children tend to have a set regime when younger, that fades. NEED TO CATCH KIDS at 7 years old - 10 and give them activities to do that will engage and divert them and make them feel valued and teach them about
working in harmony with others. Need to 'reward' participants - pay people, give them new skills, make them take responsibility AND feel part of festival/s.

I think resident buy in is integral to success. The outreach projects esp related to faith based events where some people might know very little about a particular faith's celebration is a non threatening and fun way of teaching people about that celebration and that faith thus allowing for more social understanding and cohesion.

## RE PAID WORK

Paying hard to reach young people who can feel part of the festival and learn a skill e.g. setting up stalls/stages; roping off areas; stewarding

## RE VOLUNTARY WORK

Gave a 5 to voluntary work and mentoring as not sure what means
Yes good to get people involved in voluntary work at festivals but at some festivals this is difficult as many people want to go to the festival as audience etc.

## GENERAL COMMENTS ON RESIDENT INVOLVEMENT AND ADDITIONAL IDEAS

Involve as organisers, but also as supporters of the events.
Involve companies / businesses in publicity - give a higher profile to the events - current publicity not representative of all the communities or diverse events

Festivals are the only real way to bring people together. Need to involve more organisations so more people come.

Brent is not good at engaging local groups and getting them involved eg: the voluntary organisations. Should be more networking opportunities with BRAVA (though their list of orgs in their directory appears to be very ethnic/health based - not many of the vol orgs that are sports or arts based.
Festivals can greatly help local vol orgs to recruit - especially sport and arts vol orgs.
Should involve residents and local people in all ways possible.
Festivals help local economy and are also social. Would be good to have community workers on patrol (throughout year) who know how to inform people about events and how to get involved.

Individual: Through Brent Magazine inviting ordinary residents to participate in organising, or to join in various activities or competitions held at the festivals (e.g. winning road - most people from that road register at the special tent, then some benefit for that street e.g. tree/flowers/wheelie bins/free entry to something/councillor visits on Sat am, for local people to express concerns????
Associations: Through residents' associations being given tables free (renting tables is expensive when they have little funds) and all together so they meet up. Having a focus for the residents' associations e.g. local issues, green, supporting social networking in their areas.

Creating 'Get involved' awareness campaign via libraries, local schools and brent magazine and local church, mosque, synagogue, temple etc

## QUESTION 4

Have you attended events outside of Brent that you particularly enjoyed? If so which event and what made it successful?

Harrow County Show \& Green Festival in Regents Park - large, lots to do, quirky, involves arts, good acts and entertainment. Themed around something that relates to all so can attract a diverse attendance and participation.

Thames Festival, Greenwich and Docklands, Notting Hill Carnival - all have good quality programmes that are free and accessible.

Summer Mela in Ealing brings people together - culture event open to all.
Leicester Diwali - partnerships between businesses, Council and voluntary groups
Notting Hill Carnival and Reading Festival - lots of people with specific themes, good performances and good organisation

## Notting Hilll Carnival.

Brent group major role - top in carnival often wins prizes - not known / valued by Brent.
Nice (the place) in France - 13 parades, lots of international groups. Capitalises on touristic attraction of festivals. Their festival of 13 parades contains different sorts - some very gentle and target families and some paid - others free and a bit more full-on where everyone can attend. Very well publicised, creates a big income for the town. Each parade isn't overly long - 2 hours.

Harrow - is on a smaller but more multicultural scale. It's run by an organisation and could see the authenticity of the programme. To organise ones own 'thing' is not a duty or work as its organised from the heart.

Lewisham People's Day - scope enormous. Was there in 2005 just after the bombings in London - amazing event as so inclusive - eg gay and lesbian event sponsored by the police, kids and teenagers participating in all as so cool - half village fete feel but also cool. Felt like everyone could go - good atmosphere, safe for toddlers amongst all else happening. Beautiful flags and environment.

Bedford River Festival - engulfs the town, involves everyone. Big engagement from schools and groups such as rotary club. River good setting with carnival boats etc.

02 Hyde Park - quality of music and food and stalls and fair trade

## 1. What is the service/policy/procedure/project etc to be assessed?

Future funding of an events programme - Reduction of the festivals budget resulting in a reduced delivery of festivals activity.
2. Briefly describe the aim of the service/policy etc? What needs or duties is it designed to meet? How does it differ from any existing services/ policies etc in this area
i. There is a clear commitment from Brent Council to the development of an improved arts and culture offer in Brent and a strategic context for change outlined in the Borough Plan 2010-2014, Brent Cultural Strategy 2010-2015 and the One Council agenda. A clear strategy for future funding of an inclusive events/activities provision in Brent is overdue and there is an increasingly urgent need for clarity and direction for a number of reasons:

- Public sector spending cuts and the need to make savings
- Imbalance of resource invested in festivals as the programme has developed in an 'ad hoc' way over time.
- Need for clear outcomes from grant funded organisations.
- Fragmented approach to delivery of events across the council.
- The opening of the Civic Centre in 2013 with the potential to provide significant cultural opportunities.
ii. Under sections 144 and 145 of the Local Government Act 1972 the Local Authority has a power to provide (or arrange for the provision of) entertainment, the development and improvement of the knowledge, understanding and practice of the arts, and otherwise attract visitors to the area for recreation etc.
iii. This equality impact assessment will look at the future funding of an events programme.
iv. Previously Brent's festivals function delivered the following:

v. Festivals and events are one mechanism we use to advance equality of opportunity for a number of different groups with protected characterispageh $\ddagger \mathbb{Z} 4$ ay a part in enabling those groups to celebrate particular festivals/events which are important o their particular race, religious group, gender, sexual orientation etc. They also play a role in promoting understanding between different groups and fostering

good relationships between different groups.
vi. The Festivals team (two members of staff) were moved from Environment and Neighbourhood Services to Customer and Community Engagement in November 2010. This provided for an opportunity to identify savings within the provision of events and activities and to review the existing programme of events and activities.
vii. As a result it was recommended to Executive in January 2011 that consultation take place on reducing the funding for festivals and the reduction in the number of festivals and events delivered.
viii. Two options were proposed to Executive in January 2011 to agree consultation on with Option 1 being the preferred option. These were:

- Option 1 - All festivals are stopped apart from a Brent Festival (incorporating Respect and Countryside Day), Diwali, Holocaust Memorial Day and Bonfire Night. The cost of Diwali is reduced by $£ 25,000$ to $£ 72,000$ and the Navatri grant of $£ 67,000$ is stopped.
- Option 2 - All festivals are ceased and the Festival team is disbanded (staff savings of $£ 82,000$ ), total saving of $£ 508,000$ (less redundancy costs in the first year).
ix. Option 1 would result in ceasing the following festivals/events:
- Chanukah
- St Patrick's Day Parade
- Eid
- Christmas
- St George's Day
- LGBT Month
- International Women's Day
- Navratri grant
- Festive lights (tree dressing).
x. Option 2 would result in ceasing the above nine festivals/events plus the following:
- Countryside Day
- Respect
- Fireworks Night
- Diwali
- Holocaust Memorial Day.
- It would also result in the redundancy of two members of staff.
xi. Executive agreed the recommendation to go out and consult on these two options and that consultation took place from 7 March to 26 April 2011.
xii. The results of the consultation, plus previous consultation which had taken place (public consultation in 2008 for stakeholders to comment on the festivals programme, a mapping exercise of current provision in 2009, consultation on the Cultural Strategy in 2010 and London borough events comparison) informed the recommendations in the report this EIA relates to - the future funding of an events programme.
xiii. The future funding of an events programme report for Executive on 18 July 2011 recommends that from 1 April 2012 the council cease delivery of cultural and faith-related events/activities and delivers an inclusive programme of activities that will engage across all communities.
xiv. The council would retain delivery of fireworks night and Holocaust Memorial Day and look to develop a programme of activities under the title of Brent Celebrates.
xv. In the current year - 2011/2012 - there is insufficient time to deliver large scale events, namely Respect, Countryside Day and Diwali. With the recruitment of specialist staff on hold until the outcome of the Executive decision on future funding of an events programme the planning activity necessary to ensure the safe delivery of these events has not taken place.
xvi. There is an opportunity to deliver a reduced programme of events in the current financial year but these would have to be delivered within the identified reduced budget. This programme could include:
- Fireworks Night
- Chanukah
- Festive lights (tree dressing)
- Christmas
- Holocaust Memorial Day

- St Patrick's Day
- St George's Day
- International Women's Day
- LGBT month
- Eid
xvii. While a Diwali parade as previously provided cannot be delivered it is proposed that a combined Festival of Light and Fireworks Night be delivered which would be open to all to attend.
xviii. The Navratri grant could be accommodated in the current financial year but would have to be considered in light of the reduced budget identified.
xix. It is not the intention of the council to cease all future provision of a festivals/events programme. But rather to deliver a programme that would be more inclusive whilst continuing to allow for the discretionary power under the Local Government Act 1972, sections 144 and 145 in which it is stated that the Local Authority has a power to provide (or arrange for the provision of) entertainment, the development and improvement of the knowledge, understanding and practice of the arts, and otherwise attract visitors to the area for recreation etc.

3. Are the aims consistent with the council's Comprehensive Equality Policy?

The policy is consistent with the council's Comprehensive Equality Policy.
The proposal to develop an inclusive events/activities provision that will be open to all in the community will include encouraging all those with protected characteristics to become involved. The programme will be developed with input from residents and service users to ensure that in delivering the programme we aim to improve social cohesion, community relations and to foster good relations between those who share a relevant protected characteristic and those who do not share it.
4. Is there any evidence to suggest that this could affect some groups of people? Is there an adverse impact around race/gender/disability/faith/sexual orientation/health etc? What are the reasons for this adverse impact?
a. The equality assessment is being undertaken to determine the impact of ceasing funding to the majority of the current historic provision, excepting fireworks night and Holocaust Memorial Day.
b. The key stakeholders directly affected by the proposals are:

- Festival/events attendees and potentially non-attendees (who might have attended in the future)
- Staff
c. However, a separate Staff Impact Needs Requirement Assessment has been carried out as part of the council's 'Managing for Change' process.
d. Therefore the main group affected will be festival/events attendees and potentially non-attendees.
e. Respect/Countryside Day - these are grouped together as the two events historically delivered that are inclusive of all the protected characteristics. They are both council organised, funded and delivered. They are open to all to attend and offer a variety of activity/entertainment including fun fairs, falconry displays, live music, drama, art activities, food and much more. It is proposed to deliver a Brent Celebrates event or programme of events which will bring together these two events in the future. The impact on the suggested changes on attendees will be minimal, as a substitute event will be provided. It is also noted that similar events take place within the borough delivered by local communities, notably Gladstonbury and the Queen's Park Festival. Also the Nottinghill Carnival is also held locally.
f. Chanukah - a festival in which the council provides space for a Menorah and promotional material for other activity taking place in the borough provided by local communities. This is a festival which is well observed within the Jewish community at very local and often family levels. It will be recognised in the calendar of events in the new Civic Centre. The impact on attendees will be minimal as the festival will continue to be celebrated in places of worship and the home.
g. St Patrick's Day Parade - an event delivered by the council working with a steering group from the community. It is a parade through Willesden where historiqall ${ }^{2} \mathrm{~g}^{3} \mathrm{e}^{\text {sinfigant }}$ Irish community live. It includes a stage with live music and floats. There is already interest from within the community to deliver this event themselves with tne council proviaing support in iaentirying sponsorsnıp opportunities ana proviaing aavice ana guiaance on tne

safe delivery of a large scale event. The impact on attendees will ultimately be minimal as this event is celebrated in pubs, clubs and venues across the borough and London and also with the Mayor of London's St Patrick's Day Parade.
h. Eid - Historically the council provided this festival but have in the past two years worked with a community group to enable them to deliver from within the community with advice and guidance from the council but at no financial cost. This has resulted in limited impact on the attendees and an improved delivery of the event. It is anticipated that the community organisers will continue to deliver this event annually. The event is celebrated in homes, places of worship and other venues across the borough.
i. Christmas - the council has advised and supported organisers of the various events which make up the Christmas programme to the extent where this festival is delivered from within the community with council support only in its promotion. The impact of the council ceasing support will be minimal on the delivery as advice and support could be provided to identify alternative sponsorship for promotion. The festival is also celebrated widely in homes, places of worship and other venues across the borough and London.
j. St George's Day - activities supporting this event are supplied through the library service. Historically it has not been well supported achieving less than 200 attendees. It is unlikely that the community will stage this event themselves as it does not attract the attention and support that similarly culturally themed days do, such as St Patrick's Day. With the attendance figures low the impact on attendees is likely to be limited.
k. LGBT Month - this event has not been held for at least the past two years with no request to continue it from the community. Events are staged in the wider community, for instance Gay Pride Parade in London, which do attract significant attendance.
I. International Women's Day - this event has not been held for two years with no request for it to continue. There are opportunities to attend London-wide or nation-wide events associated with the date. It is anticipated there will be limited impact on attendees if the council cease to provide.
m. Navratri grant - the grant provides funds to pay for locations for various events organised by the community and the Hindu Council. Currently there is no monitoring of how the funds are used so it is difficult to identify the impact of ceasing the grant. No other grant is paid to faith-related groups for the provision on events/festivals. Advice and support would be available from the council to help identify sponsorship to help with covering the cost. With planning the impact on attendees would be minimal as Navratri celebrations are likely to continue to be delivered from various venues and places of worship in the borough.
n. Festive lights (tree dressing) - this has developed in an ad hoc fashion with no clear priorities for where lights should be placed. It is anticipated that the new Civic Centre would include festive lights at a location at the heart of the borough. The impact on the eight characteristics would be limited if the funding ceased as festive lights are provided in homes, places of worship, places of entertainment and retail outlets.
o. Diwali - the Diwali Parade is a major event which attracts approximately 75,000 . It involves the community and schools in outreach arts work to develop the floats and culminates in a firework display at a local park. There is a large Diwali event at the Neasden Temple which will continue with or without the council run parade and it is suggested that by keeping the Fireworks Night a combined Festival of Light and Fireworks display could be provided by the council. Attendees are likely to be disappointed if the event is cancelled, however Diwali will continue to be celebrated in homes, places of worship and other venues in the borough. In the present financial climate, the Council can no longer sustain the cost of providing this festival.
p. This year Diwali and fireworks night are on the same date, 5 November, and it presents the council with an opportunity to combine these two events. Therefore ensuring that fireworks are delivered in an organised and safe display whilst enabling people to celebrate Diwali.
q. It is proposed to maintain Holocaust Memorial Day as it is an international remembrance occasion which if not delivered by the council would not be delivered in Brent in another day. It is an international remembrance occasions recognising all forms of genocide.
5. Please describe the evidence you have used to make your judgement. What existing data for example (qualitative or quantitive) have you used to form your judgement? Please supply us with the evidence you used to make you judgement separately (by race, gender and disability etc).

Measured against the festival activity in many other boroughs Brent's programme is considerable. (appendix 2) However the current level of festivals activity is increqgind on budget and the changing demographic profile of the borough. A number of current festivals celebrate cultural

distinctiveness or difference but by changing the future provision we would work towards a more transparent delivery of events meeting the aim of the Cultural Strategy of 'an accessible and vibrant local culture and shared community activities'. Historic spending commitments and the lack of transparency of some decision-making about grants may lead to claims of unfairness or lack of access of resources for newer communities. The current offer fails to meet the needs of the wider community or to address its complexity. There is also often no clear benefits or value for money for the Council.

Consultation was carried out on option 1 and 2 from 7 March to 26 April 2011, and the full results of that consultation are attached as appendix 1a and 1 b .

The consultation document set out the council's proposed eight priority areas of work, four for Arts and four for Festivals, and asked: if they were the right priorities; were they of equal importance; and to rate them in preference of importance. It also asked if there were other areas of work not covered in the identified priorities and there was a final open question asking if there was anything to add.

Attached is a range of monitoring activity related to the current festivals programme (appendix 3). It will be noted that it is not comprehensive and has not been carried out in a consistent method. It also does not monitor all of the protected characteristics, being largely restricted to age, gender, ethnicity and disability.
6. Are there any unmet needs/requirements that can be identified that affect specific groups? (Please refer to provisions of the Disability Discrimination Act and the regulations on sexual orientation and faith, Age regulations/legislation if applicable)

The review of funding will result in the way we engage with communities will be different. However may result in some unmet needs particularly in those areas where there may not be opportunities to celebrate in the wider community, for instance the lesbian, gay, bisexual and transgender communities. However the aim of the review is to identify ways of making the programme more accessible and diverse, enabling greater participation from the community and an increase in community led ideas and views on programme content.

There will be opportunities to support groups representing the protected characteristics with advice, support and training to enable them to deliver their own targeted activities/events.
7. Have you consulted externally as part of your assessment? Who have you consulted with? What methods did you use? What have you done with the results i.e. how do you intend to use the information gathered as part of the consultation?
A public consultation took place from 7 March to 26 April 2011. It was undertaken through direct postal consultation with known stakeholders (approximately 2,000) involved in the delivery of Arts and Festivals activity in the borough and an online wider public consultation.
There were 202 respondents - 194 online and 8 paper - plus nine emails, one letter and feedback from the
Environment and Neighbourhoods policy team. There were also two petitions which were:

- Save St Patrick's Day - approximately 300 signatures
- Continue funding the Navratri Festival - 281 signatures
- Save Navratri petition - We oppose Brent Council cutting funding for the Navratri celebrations and call for it to be restored - approximately 5,000 signatures.

The consultation was publicised through local media, the council's website and The Brent Magazine delivered to all households.

The consultation asked if the priority areas of work were right and were of equal importance. There were four priority areas for both arts and festivals.

The response to the question 'Are they the right priorities?' were fairly evenly split:

- $53 \%$ agreed, $47 \%$ disagreed.

The response to the question 'Are they equally important?' were quite clear that the majority said they were not of equal importance:

- $70 \%$ disagreed, $30 \%$ agreed.

The open responses identified the following:

- There was no appetite for ceasing all festipagactiyity8
- Keeping clearly faith focused events may leado claims of unfairness or lack of access to resources for newer communities.

- No real opposition to ceasing faith focused events and concentrating on an event/festival that celebrated Brent's communities.
- A wish to be encouraged to deliver activities/events with the support and advice of the council.
- A wish to see a Brent Celebrates event that didn't distinguish between faiths or cultures.
- A recognition and acceptance that there is a need to save money but not to stop activity altogether.

The consultation top line results and themes are attached as appendix 1.
The results of this consultation have informed the final options in the report to go to Executive on 18 July.
8. Have you published the results of the consultation, if so where?

The results of the consultation are available on the council's website and will be published with the report that goes to Executive in June 2011.
9. Is there a public concern (in the media etc) that this function or policy is being operated in a discriminatory manner?

There has been some local media coverage on the proposed deletion of the Navratri grant, but it was not the angle of the consultation report that the policy was being operated in a discriminatory manner. The consultation does show concern over the cutting of the grant and keeping Diwali but equally respondents expressed the desire to not have faith focussed events but rather an encompassing programme of activity across all Brent residents.
10. If in your judgement, the proposed service/policy etc does have an adverse impact, can that impact be justified? You need to think about whether the proposed service/policy etc will have a positive or negative effect on the promotion of equality of opportunity, if it will help eliminate discrimination in any way, or encourage or hinder community relations.

The proposal to deliver a reduced programme may on the surface appear to impact in a negative way and effect the promotion of equal opportunity. But the proposal is to develop an inclusive events/activities provision that will be open to all in the community will include encouraging all those with protected characteristics to become involved. The programme will be developed with input from residents and service users to ensure that in delivering the programme we aim to improve social cohesion, community relations and to foster good relations between those who share a relevant protected characteristic and those who do not share it.

However, in a number of cases these activities are delivered by other organisations or the communities they represent. Where they are not delivered in other ways the aim of the review is to identify ways of making the programme more accessible and diverse, enabling greater participation from the community and an increase in community led ideas and views on programme content.

There will be opportunities to support groups representing the protected characteristics with advice, support and training to enable them to deliver their own targeted activities/events.

There are a number of local independent community festivals, notably Gladstonbury and the Queens Park Festival which are popular, well run and inclusive of all communities. Also locally is the Camden Council funded Kilburn Festivals and two major London festivals, the Notting Hill Carnival and the Mela (in Ealing).

The proposed reduced programme would allow for the development of a more inclusive festival programme, which would move from faith or cultural focus to community focused delivery. This could aid to break down discrimination and positively encourage good community relations.
11. If the impact cannot be justified, how do you intend to deal with it?

The EIA shows that adverse impacts are mitigated by proposed actions, in particular through the development of a new programme of festivals that brings together the communities in Brent in a more inclusive way, and by offering support, advice and training to allow communities to develop their own celebrations in a safe and controlled way.

The current economic situation and its impact on local government necessitate a review of all services at local, regional and national level. Brent's Festivals delivery is overdue a review and while savings have to be made there are opportunities to deliver activities which more closely meet the needs of all residents. The aim of this proposal is both to secure savings and to deliver a better focused, more transparent and better supported events programme.

The delivery of the reduced programme will be through an inclusive events programme strategy to be developed for 2012-2014. It will be monitored through performance monitoring of outcomes attached to specific and individual festivals activities. The strategy will be reviewed on an annual basis with a comprehensive review planned for 2014 to allow for sufficient time for a subsequent strategy to be produced.
15. What are your recommendations based on the conclusions and comments of this assessment?

It is recommended to reduce the programme of festival activity to allow for savings to be made and new programme to be developed which better meets the needs of Brent's residents.

## Appendix 8

## The Equality Act 2010 - The Public Sector Equality Duty

Section 149 in Chapter 1 of Part XI EA 2010 is the new public sector equality duty. It came into force on 5 April 2011. It replaces the existing public sector equality duties in sections 71 Race Relations Act 1976 (introduced on 2 April 2001), 76A Sex Discrimination Act 1975 (introduced on 4 December 2006) and 49A Disability Discrimination Act 1995 (introduced on 2 April 2007). Broadly speaking, it extends the scope of the duty to all 'protected characteristics' (as defined in section 4 of the Act) except marriage and civil partnership. Section 149 provides as follows:

## 149 Public sector equality duty

1. A public authority must, in the exercise of its functions, have due regard to the need to:
a. eliminate discrimination, harassment, victimisation and any other conduct that is prohibited by or under this Act;
b. advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it;
c. foster good relations between persons who share a relevant protected characteristic and persons who do not share it.
2. A person who is not a public authority but who exercises public functions must, in the exercise of those functions, have due regard to the matters mentioned in subsection (1).
3. Having due regard to the need to advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to:
a. remove or minimise disadvantages suffered by persons who share a relevant protected characteristic that are connected to that characteristic;
b. take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of persons who do not share it;
c. encourage persons who share a relevant protected characteristic to participate in public life or in any other activity in which participation by such persons is disproportionately low.
4. The steps involved in meeting the needs of disabled persons that are different from the needs of persons who are not disabled include, in particular, steps to take account of disabled persons' disabilities.
5. Having due regard to the need to foster good relations between persons who share a relevant protected characteristic and persons who do not share it involves having due regard, in particular, to the need to:
a. tackle prejudice, and
b. promote understanding.
6. Compliance with the duties in this section may involve treating some persons more favourably than others; but that is not to be taken as permitting conduct that would otherwise be prohibited by or under this Act.
7. The relevant protected characteristics are:
a. age
b. disability
c. gender reassignment
d. pregnancy and maternity
e. race
f. religion or belief
g. sex
h. sexual orientation.
