My name is Noel Anthony Samaroo and I currently operate as an independent Licensing Consultant and Trainer trading as National Training and Development Consultants Ltd ("NTAD"). This Statement is prepared for the purposes of a Premises Licence Review Hearing relating to JAMIES News & Convenience Store, 200 A Lyon Park Avenue, HAO 4HG.

I have considered all the paperwork served in relation to these review proceedings.

I would like to make it clear at the outset that I have been involved in advising the Premises Licence Holder and in preparations for this review hearing in my capacity as a licensing consultant. My reputation is based on integrity and I have been scrupulous in not compromising my independence when writing this Report which is designed to assist the Licensing Sub Committee in promoting the licensing objectives in an appropriate and proportionate manner. My fees for preparing this report are not contingent on its contents or conclusions and clients may use or reject the Statement at their discretion. The contents of this Statement are true, fair and accurate and reflect my honest and professional opinion on the matters I have observed.

### **Experience**

Prior to taking up the role with **NTAD** I completed 20 years as a licensee and Designated Premises Supervisor (DPS) within a variety of London Boroughs. In 2009 due to ill health I made a conscious decision to change my lifestyle from constant night work and put my wealth of experience to good use. I achieved my **PTTLS qualification** along with **APLH level 2 and NAPLH level 3** and began to train candidates for their APLH 2 qualification in preparation for their Personal Alcohol Licence.

During this period I became increasingly aware that many, otherwise responsible, Premises Licence Holders were non-compliant with all the conditions of their premises licences usually because of ignorance of the law under the Licensing Act 2003 and were thus putting their premises licence in jeopardy. I therefore also began to consult with my clients on a variety of issues surrounding compliance under the Licensing Act 2003, Food Safety Act, and the Health and Safety Act. In recent years I have continued my professional development in regard to licensing by taking and passing the National Licensees Certificate and National Door Supervisors course. This enabled me both to successfully apply for a Personal Licence and to become approved by the Security Industry Authority (SIA) as a front line operative. In September 2011 I successfully applied to become a nominated tutor with EDI enabling me to carry out training in the Award for Responsible Alcohol Retailing and the Award for Personal Licence Holders Level 2 and the Level 3 Award for Designated Premises Supervisors.

Since January 2012 I have worked in a consultancy role with licensed premises producing strategies aimed at reducing crime and disorder and public nuisance issues in and around venues. This experience has enabled me to give sound advice in regard to licence compliance and licensing in general. I have considerable respect for the responsible authorities and seek to work in partnership with them whenever possible.

### **REVIEW HEARING 27 January 2016**

The Review application has been brought by way of an application for a review of the Premises Licence due to breaches of the Licence, by Mr PRAJABATI Navin, DPS of JAMIES NEWS & CONVENIENCE STORE, 200 A Lyon Park Avenue, HAO 4HG.

The Trigger for this Review being brought is based that on the 23<sup>rd</sup> October 2015 a Premises licence check was carried out by officers from Brent Licencing Police.

Brent Licencing Police Team visited the premises on a routine visit where it is alleged that breaches of the premises licence were found.

- a) Males standing outside the off licence Premises consuming alcohol.
- b) DPS failing to promote the licencing objectives.

In addition there were found to be some plastic cups outside the premises and some plastic cups in a sleeve behind the counter.

Acting as a consultant in the best interest of my client, I have taken the proactive approach to all the conditions brought forward by Brent licencing Police Team to promote the licencing objectives. Having taken into account PC AULAK Manjit's statement, and the intel gathered by the police, it has come very apparent that the area around, 200 A Lyon Park Avenue, HAO 4HG, suffers from a street drinking and anti-social Behaviour problem. Those previous incident and accounts of events except from the Statement of PC AULAK are non-relative to JAMIES NEWS & CONVENIENCE STORE as they occurred further away from 200 A Lyon Park Avenue , HAO 4HG. I would like to draw the attention of the committee that within a mile radius, 2 off licences with full off licence conditions, an on licence and a public house are present.

On Wednesday 13<sup>th</sup> of January, I Met PC SULLIVAN, to discuss the proposed conditions and in consultation with my client, I would like to draw the committee's attention on the following condition:

### No High strength beers, lagers and ciders above 6.0% ABV shall be stocked.

This condition in particular will reduce my client's variety of choice available at the premises, thus drastically affecting his ability to compete against the other off licences present within a walking distance in the area. Bearing in mind that JAMIES NEWS & CONVENIENCE STORE has been present in the area since 1969, and would for some be classified as a landmark, we therefor would like the committee to consider having an exception to this condition by allowing 3 specialist brands:

" DESPERADOS, FOREIGHN GUINNESS, DRAGON STOUT." It is to be noted that the police have stated that they have no objection to that proposed condition

Please find below the proposed conditions as per the review for a premises licence.

### PROPOSED CONDITIONS TO THE PREMISES LICENCE HOLDER

- CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised officers from Brent Council.
- A CCTV camera shall be installed to cover the entrance of the premises.
- A sign stating "No proof of age –No sale" shall be displayed at the point for sale.
- A "Challenge 25" policy shall be adopted and adhered to.
- A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for the inspection.
- No High strength beers, lagers and ciders above 6.0% ABV shall be stocked with the exception of 3
   named specialist beers "DESPERADOS, FOREIGHN GUINNESS, DRAGON STOUT."
- An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
  - (a) all crimes reported to the venue
  - (b)all ejections of patrons
  - (c)any complaints receives
  - (d)any incidents of disorder
  - (e)all seizures of drugs or offensive weapons
  - (f)any faults in the CCTV
  - (g)any refusal of the sale of alcohol
  - (h)any visit by a relevant authority or emergency service
- A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

- A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.
- No single cans or bottles of beer or cider shall be sold.
- No miniature bottles of spirits to be sold.
- A clear and unobstructed view to the premises must be maintained at all times.

### Conclusion

I would also like to take this opportunity to confirm to the committee that all of the alleged breaches raised In the Review Application have now been rectified along with Full APLH Level 2 Training has been delivered. An extra member of staff will be assisting with operating procedures during peak hours.

The premises licence Holder/DPS have taken steps to correct the deficiencies with regard to Compliance issues and have taken a positive step in proposing and agreeing the Proposed Conditions within the operating schedule. A considerable amount of improvement has been made to the premises; a new CCTV camera system has been installed to Home Office Guidance standards covering the entrance of the premises.

Right outside JAMIES NEWS &CONVENIENCE STORE in front of the bay window, was an open patio area that was being used as a meeting point for individuals in relation to street drinking. I can now confirm that a fence has been placed preventing this from occurring, please see Picture exhibit provided. The signage stating "No Proof of Age –No sale " a "Challenge 25" and "No street Drinkers" has been made more visible along with a CCTV system in operation. All these improvements involved a financial cost to my client, but goes to show his willingness to improve his services.

Through my frequent visit to the area, I came across a local Police Community Support Officer based next door to 200 A Lyon Park Avenue, HAO 4HG, who has confirmed that since the improvement has been made to the front of the premises, it is longer being used for people to meet and drink.

From my observations, contact with the client, the retraining of the staff and the new operating Schedule, I have not observed any further issues that would lead me to believe that this premises offers any risk to the general public or to undermine any of the Licensing Objectives. Given the nature of the business it is clear that any further financial conditions imposed would be financially unsustainable.

It is my opinion that the premises can operate within the parameters of the Brent Concil's Licensing Policy. It is therefore that I respectfully request that the Licencing Sub Committee show leniency and proportionality in their decision.



### STATEMENT OF AHMED AZIZ

I, AHMED Aziz of 107 Kingley Road, South Harrow, HA2 8LF, make this statement in support to resist the application to review the premises licence for the premises at 200A Lyon Park Avenue, HA0 4HG

I have held the lease of the property at 200A Lyon Park Avenue, HA0 4HG, for several years and has known this shop to be existing since 1969. I have, am and always will be committed to working hard, fully observing my legal obligations in growing my business.

I acknowledge the fact that on the 23<sup>rd</sup> October 2015, Officers attended 200A Lyon Park Avenue, HA0 4HG, where they found Mr PRAJABATI who sublet the premises and is also the DPS not conforming to the Licensing objectives.

I have taken into consideration PC SULLIVAN's accounts of events and all the intelligence gathered and have had a meeting with Mr PRAJABATI in regards to the various flaws in operating procedures.

Based on the conditions put forward by the Police and in pursuance of best practice, I have made some considerable and costly changes to the premises with the help of a licensing consultant appointed to enhance our operation and to ensure that are no future licensing breaches.

As per Police recommendation we have agreed to and adopted the following, paying attention to condition 6 where I feel it will be detrimental to the business and would like the Committee to consider our proposed condition.

1 CCTV has been installed to home office guidance standards and maintained in good working condition and recordings will be kept for 31 days and will be made available to police and authorised officers from Brent Council.

2 CCTV Camera has been installed to cover the entrance of the premises.

3 A sign stating "No proof of age-No sale" is displayed at the point of sale and made more visible.

Following a meeting with my consultant, we have come to the conclusion that as per condition number 6:

No high strength beers, lagers and ciders above 6.0 % ABV will be stocked with exception of specialist brands "DESPERADOS, FOREIGHN GUINNESS& DRAGON STOUT" We would like the members of the committee to consider the exception of the 3 specialist beers mentioned as they give us from a business point of view some bargaining power over the competitors nearby. We believe if no such option was available, it would restrict our

choice of product supplied to our customers. In the light of the events, I agreed with the police that a change of DPS is necessary as Mr PRAJABATI, has failed in his duty of promoting the licencing objectives.

Please note, members of the committee that the improvement made to the premises came with financial ties. Having taken into consideration about concerns that the front of the premises became a meeting point for locals, I have taken the proactive step to put up a barrier thus preventing any conglomeration in front of the shop window.

I would therefore ask the Members of the committee to consider my goodwill into promoting the Licencing objectives and preventing any further breaches prior to any decision being implemented.

Jamie's News & convenience Store currently has a Premise Licence to sell alcohol between the hours of 08.00 and 23.00 hours Monday to Saturday and 10.00 and 22.30 hours on Sunday.

The Licence allows for alcohol to be consumed off the premises, and should not be sold in open containers.

The Premises Licence holder (PLH) is Mr Aziz Ahmed, and Mrs Bhadravati Ahmed, and the Designated Premises supervisor (DPS) is Mr Navin Prajapati

Jamies News and convenience Store are failing to promote one of the licensing objectives namely the prevention of public nuisance.

Police have no faith in the ability of the management to operate the premises responsibly and therefore wish to bring the matter before the sub-committee for consideration.

On Friday 23rd October 2015, officers from Brent Licensing Police Team conducted a licensing visit at Jamies News & Convenience Store, 200a Lyon Park Avenue HA0 4HG.

As officers approached the venue they saw four Asian males standing directly outside the shop, all were drinking cans of beer and they had white plastic cups on the window ledge, there were several empty beer cans on the floor next to where the males were standing.

The males were talking loudly and laughing, and one of the males in particular appeared to be drunk.

Officers went into the shop and introduced themselves to a male who gave his name as Mr Navin Prajapati, he informed officers that he was the Premises Licence Holder (PLH) and also the Designated Premises Supervisor (DPS) he became very nervous when realising that we were police officers and quickly went outside to speak with the males, officers followed him outside only to see the males running off down the road, officers also saw several empty miniature bottles where the males had previously been standing.

On re-entering the shop officers noticed a tube of white plastic cups behind the counter, similar to the ones that the males were drinking from outside, Officers asked Mr Prajapati why he had half a tube of white plastic cups behind the counter, to which he admitted selling to street drinkers for ten pence each, it was explained to him that this was unacceptable, and was to stop immediately, he was asked about the males that had been drinking outside and eventually admitted that they were regulars that bought alcohol from his shop and stood outside drinking, again it was explained to him that this needed to stop.

Mr Prajapati speaks very limited English and called his wife to come to the shop, shortly after Mrs Nehal arrived and I asked her if she was aware that the shop sold plastic cups for ten pence, she confirmed that she was aware and that they would stop selling them.

During the visit there was a large amount of people coming into the shop, many of them buying alcohol most seemed to be buying single cans of beer, some appeared to be what I would describe as street drinkers none of them were challenged, there was also people that in my opinion appeared young that should have been asked for identification under the 'Challenge 25 policy' again no one was asked to verify their age, Mr Navin Prajapati seemed more interested in just serving one customer after another as quickly as he could to avoid a queue and possibly losing money by people not wanting to wait to be served, than running the shop in line with the licensing objectives.

Before leaving I arranged a meeting with Mr Navin Prajapati to be held at the Civic Centre to talk through the issues I had found, this meeting was arranged for 29/10/2015.

Mr Navin Prajapati attended the meeting on the 29/10/2015 at the Civic Centre and I discussed the issues that I had found on the 23/10/2015, Mr Prajapati stated that he sold to the local street drinkers as all the other shops did and that if he didn't the other shops would, it became very clear that Mr Prajapati did not understand what was being said during the meeting due to his lack of English, and the meeting was adjourned until a later date so that he could bring someone along with him to interpret what was being said.

A few days later I received a call from a licensing consultant by the name of Mr Noel Samaroo who stated that he was now acting for the premises and suggested that the shop put in a variation with conditions that would be suitable to police.

I then contacted Mr Aziz Ahmed to make him aware of the issues with his shop, I spoke to him on the phone and he denied having any involvement with the shop, stating that he had leased the shop to Mr Navin Prajapati, and had no involvement with the day to day running of the shop, he stated that the Premises Licence was in Mr Navin Prajapati name, I informed him that the Licence was still in his name, he was very confused by this saying that it had been transferred into Mr Navin Prajapati name some time ago.

I asked him if he could attend the next meeting which he declined to do.

I then received a second call from Mr Noel Samaroo who informed me that he had met with his clients and that they felt that the conditions that the police would be asking for would be detrimental to the business, in particular they felt it was unfair for the police to propose that they should stop selling single cans of beer, as other shops are allowed to sell single cans and they would lose customers to them, they also felt that the condition of No high strength beers, lagers, and ciders above 6.0% ABV shall be stocked was unfair as other shops were allowed to sell high strength beers and again people would go elsewhere to buy, and due to this they had now decided that they would not be putting in a variation.

A statement from the dedicated Ward Officer (DWO) has been obtained, this outlines the problems that the area suffers from street drinkers that are linked to this premises.

Below is information taken from one of the police intel systems of drunken behaviour around the location of the shop over the last few months it highlights the street drinking culture in this residential area which also has a primary school very nearby.

### QKRT00450868

On Saturday 15/08/2015 PC 743QK attended to the rear of 152A of HEATHER PARK DRIVE HA0 at around 0800hrs where police have received complaints of ASB related to drink.

was identified and given a PND ticket. He was consuming alcohol in a controlled drinking zone in a public place contrary to a requirement not to do so.

### QKRT00451604

On Thursday 10/09/2015 PC 743QK whilst on cycle reassurance patrol received a call at 1730hrs relating to the rear of HEATHER PARK DRIVE HA0 which is a hotspot area for drink related anti social behaviour.

On this occasion PC 743QK attended the scene and identified two people who were drinking.

The officer seized their open cans and was met by anger and finger pointing but the MALE calmed down immediately after the officer warned him. There were no passing members of the public although the route is used all the time to access different roads.

On this occasion they were suitably advised and warned regarding brent borough being a controlled drinking zone.

### QKRT00450870

On Saturday 15/08/2015 at around 0745hrs PC 743QK was on a reassurance patrol in HEATHER PARK DRIVE HA0 where officer came across the following male who had six pack beer cans in a black bag and was seen in a area where police have had large number of complaints related to ASB involving alcohol.

He was standing possibly getting ready to consume alcohol.

Details ##### ###### dob ##/##/1975 of ### TRAVELLER LANE

On this occasion no further action was taken.

He is known for numerous theft related offences.

### Police would ask for the following conditions to be added to the Licence

To reduce the risk to the licensing objectives and to assist the DPS in upholding these objectives, in particular to prevent public nuisance, within such a densely populated residential area, police request the following conditions be put on the licence.

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.

Good quality CCTV is essential as a deterrent for the prevention of crime and the detection of offenders. It allows for both covert and overt monitoring of the premises. With proper signage, this reassures both staff and clientele, that this is a safe environment where illegal activities are not tolerated.

2. A CCTV camera shall be installed to cover the entrance of the premises

This will give a clear facial view of every person entering the store

3. A sign stating "No proof of age – No sale" shall be displayed at the point of sale.

This will assist staff in asking for Identification and show that a policy is in place

4. A "Challenge 25" policy shall be adopted and adhered to.

This will ensure all staff ask for Identification

5. A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for inspection.

This will be used when a person is refused a sale of alcohol and be made available to Police, and Council licensing officers

6. No high strength beers, lagers, and ciders above 6.0% ABV shall be stocked.

The London Borough of Brent is a controlled drinking zone, this was implemented to curb the problem of street drinking connected to alcohol related crime and disorder and public nuisance. This problem exists in Alperton. In recent years there has been an increase in the number of European beers that are above 5.5% ABV that are mainly consumed by Street drinkers.

- 7. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received
  - (d) any incidents of disorder

- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

This will allow the police and local Authority to view any incidents that have occurred in the shop and assist in helping the DPS in manage the premises better.

8. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

A notice displaying the opening hours, the type of licensing activity and licence conditions should be clearly displayed and visible to anyone outside the premises. This may be incorporated in the summary of the licence, which must be displayed, or the form of a separate item. likewise the name of the Designated Premises Supervisor (D.P.S.) if required should be similarly displayed. This will allow the Police and other responsible authorities to readily identify the licence details. Clearly displayed opening hours will also reduce any confusion for customers prior to entering the premises and possible conflict when the premises close/stop selling alcohol.

9. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

The sale of alcohol to drunken people and children is a major cause of concern to police and highlighted in the Governments Alcohol Harm Reduction Strategy. Off Licences are particularly open to these sales receiving little supervision or visits from the responsible authorities. Those who sell alcohol should be fully aware of the legislation and issues around alcohol and should be fully trained to a national standard. This condition is proposed by police as good practise.

### 10. No single cans or bottles of beer or cider shall be sold

It is apparent that the sale of single cans, and bottles of Beer, and Cider is mainly being consumed by street drinkers that are congregating around the shop or nearby, causing uneasy to local residents that have to put up with their Anti-Social antics and make residing in the area unbearable, as stated in Officer Aulaks statement this shop is near to a school and street drinkers are seen regularly urinating in public.

### 11. No miniature bottles of spirits to be sold

As with the sale of single cans of Beer and Cider street drinkers buy miniature bottles of alcohol to supplement their beer intake allowing them to become drunk quicker and cause misery to the lives of local residents, who regularly complain to the local officer. Jamie's has been allowing street drinkers to buy miniatures and selling them plastic cups to allow them to drink in the street, this is a total disregard for the licensing objectives and shows that the shop are more interested in profit and show no consideration for local residents, or schools.

12. A clear and unobstructed view into the premises must be maintained at all times

Having a clear and unobstructed view into the premises allows for any crime taking place inside the premise to be witnessed by passers-by who can alert police.

Police would also be asking for a change of DPS as it is apparent that Mr Navin Prajapati is failing in this role. It is my opinin that it would be detrimental to the licensing objectives if Mr Prajapati is allowed to continue running this operation in such a way.

#### This list is not exhaustive.

Police feel these requests are in keeping with the license holder's human rights and promote the running of his business and livelihood. These conditions are wholly reasonable, proportionate and appropriate measures to be put in place to promote the licensing objectives.

Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.


### Summary

The above highlights a clear mismanagement of the premises, and the lack of responsibility taken by the DPS to run his business within the licensing objectives.

The above evidence shows the lack of control, along with noise nuisance, and Anti-Social Behaviour caused to local residents, the DPS has failed to show any regard towards local residents.

It is my opinin that it would be detrimental to the licensing objectives if the current DPS is allowed to continue running this premisesy.

To further reduce the risk to the licensing objectives and to assist the new DPS in upholding these objectives, in particular to prevent public nuisance within such a densely populated residential area, police request that all of the conditions asked for be placed on the licence..



### **Conditions Proposed by Premises Licence holder**

### No High strength beers, lagers and ciders above 6.0% ABV shall be stocked.

I would like the committee to consider having an exception to this condition by allowing 3 specialist brands:

" **DESPERADOS, FOREIGHN GUINNESS,DRAGON STOUT**." It is to be noted that the police have stated that they have no objection to that proposed condition.

#### **DPS**

The DPS is fully aware of his responsibilities under the LA 2003. The DPS has been made fully aware of the risk assessments towards licensing objectives. This has given her a greater understanding of the licensing objectives and the necessary risk assessments to ensure that at no time is the licence in jeopardy.

#### **CCTV**

The Premises License Holder has installed CCTV that follows Home Office guidelines for camera systems .Inside and at the entrance of the premises the system records for 31 days and all recordings will be made available to the police upon request. At least one member of staff will be fully trained on the full workings of the system. Signage is in place to inform members of the public that a CCTV system is in operation.

There will always be a Personal Licence holder on the premises throughout the time that licensable activity is taking place to authorise any sales or alcohol.

#### **PUBLICISE OPEN AND CLOSING TIMES**

All details of the premises opening and closing times will be clearly displayed on the premises and any website for the information of customers.
