I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Gambling Act 2005 licensing objectives for the reasons indicated below.

Licensing Constable PC157QK

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Gambling Act 2005.

The application has been made to vary the premises licence in accordance with schedule 2 regulation 7 of the Gambling Act 2005.

This application is to vary the trading hours to 0700 - 0000 hours daily.

The Police representations are concerned with all three gambling objectives.

Since the introduction of the Gambling Act on 1st September 2007 there has been a dramatic rise in the number of betting shops coming to police notice. It

is true that the betting shops in the vicinity of Wembley Central give cause for concern to police in relation to crime and anti social behaviour. It is an obvious assumption that as the other betting premises close at 10pm that custom will move to Coral being the betting premises remaining open.

I wrote to Kevin Williams at Coral on 16th April 2013 and as yet have not received any communication.

The notice of application that is submitted to Police under section 160 of the Gambling Act 2005 requires very little detail.

In order to decide whether the proposed application would uphold the Gambling Objectives could you please indicate the reasons why Coral Racing intend to extend the shop operating hours from 0700 - 0000 hours daily?

Would you supply statistics to indicate the primary gambling activity at this shop for the last year and the predicted primary gambling activity if you were to open until midnight?

May I have evidence of how the operating procedures at this shop will differ to incorporate issues around the night time economy, alcohol consumption and associated problems, in order to uphold the Gambling objectives?

Finally there are no plans of the venue supplied with the application, could these be supplied.

I reserve the right to produce any further evidence which may amplify the grounds for representations

On 15/03/2013 at 1955 hours officers were called to assist CORAL **shop** staff in **HIGH ROAD WEMBLEY** with removing a male from the premises

The male was in a state of intoxication and there was a strong smell of alcohol detectable on his breath

He was speaking loudly inside the CORAL **betting shop** arguing with the staff causing nuisance He had been asked several times by the staff to leave the premises but he would not listen Instead he kept arguing and demanding to be given a reason as to why they wanted him to leave

When approached by officers he started to be rowdy and aggressive

He was not compliant and eventually he was escorted from the premises

He was asked not to come back on that day He then walked away and was seen outside another CORAL **shop** in HIGH ROAD

On Tuesday 17/05/2011, Ms XX, the assistant manager of X Bookmakers, **HIGH ROAD**, **WEMBLEY**, provided an impact statement re ASB of a group of 5 - 15 youths within and around the **shop** since February 2011 when she arrived at the premises.

She described behaviour of youths of black, Afghani, Iraqi, Iranian and Somali description including throwing pens in the **shop** at the ceiling and each other, inking out the lens on the entry door security camera, passing what are believed to be drugs to each other and selling them directly outside in the street, setting off the fire door alarm at the rear of the premises by trying to force entry and exit, threatening the last 2 assistant managers forcing them to leave their employment, hiding between the window and the false wall at the front of the store, intimidating genuine customers using the machines in the bookies by crowding around them, telling them what number to **bet** on the roulette and then expecting a cut of the winnings if the customer receives any winnings. This has led to one act of violence against a male customer who remonstrated with them and went outside to complain and was assaulted outside.

The asst manager deals with them robustly by removing them from the **shop** when they are causing any kind of ASB and can usually manage this without calling police. She states that there has been a dramatic improvement during the last 4 weeks with some youths not coming into the **shop** and those that do behaving much better. She believes that is due to her robust approach and frequent visits by SNT.

It may also be due to the removal of X and X who have been remanded and are known to be pivotal to the group of youths causing ASB.

She stated the youth who causes the **shop** most problems is X , who she stated seemed to be a part of every group who went to the **shop** and is banned from the premises as he threatened a previous employee thus his ban is company wide and permanent. He sometime enters the **shop** and it causes her difficulties trying to remove him. She is willing to provide further statements if required to assist in obtaining an ASB against him. He is XX who is permanently in the HIGH ROAD during the evenings.

The youths tend to be around the **shop** between 1700 - 2200 daily. She states thay often have what she believes is cannabis. She has requested one to leave with a lit spliff of cannabis and states that others smoke cannabis behind the back of the **shop** fronts.





An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a premises licence under section 17 of the Act.

The Police representations are primarily concerned with crime and disorder.

Police require the following points to be included in the operating schedule or added as conditions on the premises licence.

Personal Licence Holder

The sale of alcohol to drunken people and children is a major cause of concern to police and highlighted in the Governments Alcohol Harm Reduction Strategy. Off Licences are particularly open to these sales receiving little supervision or visits from the responsible authorities. Those who sell alcohol should be fully aware of the legislation and issues around alcohol and should be fully trained to a national standard.

Members of staff who have formally been given authority should be fluent in English in order to properly conduct the sale of alcohol and more importantly to refuse the sale if so required.

Closed Circuit Television (CCTV)

Good quality CCTV is essential as a deterrent for the prevention of crime and the detection of offenders. It allows for both covert and overt monitoring of the premises. With proper signage, this reassures both staff and clientele, that this is a safe environment where illegal activities are not tolerated.

Closed circuit television cameras and recorders of an agreed image standard will be installed at locations on the premises and in accordance with advice from the Police.

All cameras and recording equipment will be installed and maintained in accordance with Home Office Guidance and the manufacturers instructions and will be fully operational when the premises are open to the public.

Notices shall be displayed at the entrance to the premises, and in prominent positions throughout the premises, advising that CCTV is in operation.

Operating Hours to be displayed on Premises

A notice displaying the opening hours, the type of licensing activity and licence conditions should be clearly displayed and visible to anyone outside the premises. This may be incorporated in the summary of the licence, which must be displayed, or take the form of a separate item.

Likewise the name of the Designated Premises Supervisor (D.P.S.) if required should be similarly displayed.

This will allow the Police and other responsible authorities to readily identify the licence details. Clearly displayed opening hours will also reduce any confusion for customers prior to entering the premises and possible conflict when the premises close/stop selling alcohol.

A Summary of the Premises Licence will be displayed at each public entrance to the premises.

High Strength alcoholic drinks

Street drinkers and drunkenness is a major cause for concern in Brent. It is proven that high strength but cheap lagers, beers and cider contribute to the problem. If the premise does not stock these cheap high strength drinks (above 5.5% ABV) then the problem will be lessened or displaced. All Off Licenses in the area will be required to stop stocking these High strength drinks as they vary or come to review.

<u>Security Measures</u>
The following measures are proven to improve the security of your shop premises.

The floor area in front of the counter must be kept clear of any objects that could be used as a step to attack staff. Behind the counter the floor area should be raised 15 centimetres.

The premises must be protected by a monitored Intruder Alarm system including a panic button immediately accessible near the till.

The till/s should be secured from being lifted or moved. There shall be a door where access to the till area begins.

The window of the premises shall be kept clear of signage and advertising.

Spirits, Champagne and other similar valued goods should be displayed behind the counter. All alcohol within the shop should be displayed within the direct sight of the till operator and not obscured by other shelving etc.

Clear visible access in to the premises from the street

A clear visible and unobstructed internal view of the premises will be afforded at all times. This will discourage individuals using the premises for criminal activity.

The conditions that Police require to be added to the Premises Licence are listed below:

A sign stating "No proof of age – No sale" shall be displayed at the point of sale.

A "Challenge 25" policy shall be adopted and adhered to.

A clear and unobstructed view into the premises shall be maintained at all times.

A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

A suitable intruder alarm complete with panic button shall be fitted and maintained.

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council

A CCTV camera shall be installed to cover the entrance of the premises.

No high strength beers, lagers, and ciders above 5.5% ABV shall be stocked.

An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

The following crime prevention measures be implemented:

A time delay safe with deposit slot and anti fishing mechanisms must be used at the counter till area


Regular robbery awareness and cash minimisation training given to all staff

A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by customers or staff.

The premises license for Westcoast Restaurant and Bar has been reviewed previously and at the hearing on 26th November 2009 the licensing Sub Committee removed regulated entertainment-recorded music from the licence. Therefore the venue is licensed to supply alcohol to be consumed ON the premises from 9am to 11pm and close to the public at 11.30pm daily. The designated premises supervisor is Leticia Kusah.

Since May 2010 the venue has come to Police notice for the following breaches of licensing legislation and criminal offences that have been committed at the premises:

displaying their security industry badges and gave their names as Nadine Watson and Paul Kidd. They informed me they were working at the club until 5AM and were employed by the owner of the venue Leticia Kusah. She is not authorised to do this as she does not hold a non-front line security badge. Both Leticia and her mother came to speak with me. They said they were financially struggling and needed to pay the bills and to give her a chance. I explained a temporary event notice had not been received for this party and that to continue licensable activities without an authority was committing an offence under the Licensing Act 2003. I then left the premises and contacted Brent CCTV and requested they monitor activities at the venue. On 11th May 2010 I attended Brent CCTV Control room and viewed footage from outside Westcoast on 9th May 2010 and saw the customers were still leaving at 0300 hours.

On Saturday 25th February 2012 I was on duty in full uniform in company with Council Licensing enforcement officer Susana Figueiredo and Clive Vincent, Fire Safety Officer for the London Fire Brigade. At 2230 hours we attended Westcoast, to conduct a joint partnership licensed premises visit. As we walked towards the main entrance on the ground floor I noticed the footpath outside was guite busy with people chatting. As we entered the premise we were immediately surrounded by black adult females sucking their teeth and asking what we wanted and what power we had to be on the premises. Their manner was very intimidating. There was loud dance music playing through speakers. I squeezed towards the bar and noticed Ms Fatima Cotay standing there. She is the mother of the designated premises supervisor. The DPS was not present but had left her son, Ben Kusah, to manage the venue. She recognised me and I introduced her to my colleagues and explained that we would be conducting a licensing inspection. As word spread that a Police Officer was at the venue the ground floor filled with persons coming up the stairs from the mezzanine and basement levels. I noticed that the majority of 'party-goers' were juveniles. Ms Cotay explained that the premises had been privately booked for a teenage birthday party. I asked how many persons were on the premises, but she had no idea. Alcohol was being sold. Ms Cotay was providing food on the mezzanine level and soft drinks for the children. There were no door supervisors.

During the inspection of the three floors it became very obvious that the premises were well over the capacity of 90. I counted 60 children in the basement alone, the basement capacity is 40 only. There were approximately 40 persons on the ground floor and 20 in the mezzanine.

In the basement there were no lights illuminated, just a small selection of coloured lights near the DJ's equipment. In the basement I examined the rear fire exit with the fire officer and discovered it had no signage, there was no emergency lighting and the door was locked. If an emergency had occurred in the premises the only means of escape was back up two narrow flights of stairs to the main ground

floor entrance door. Ben Kusah went to find the key to unlock the door and we discovered upon opening the door the external escape means were blocked by rubbish and a steel drum BBQ. The basement smoke detector head had been removed but the fault was not showing on the alarm panel which indicates the fire detection system was not functioning. I noticed the basement toilets smelt of cigarette smoke and cannabis, there was cigarette butts in the toilet. The cannabis smell was stronger in the kitchen area where I found two older youths extinguishing a cigarette. As I went through the kitchen I noticed a moped parked, leaning towards the food preparation surface. There were several beer bottles on the floor. The fire officer asked Ben Kusah for the fire risk assessment, he was unable to provide one and from his response was unaware what it was. He also asked to see the emergency evacuation plan and staff training records, but none were produced. The young persons in the basement were unsupervised in a totally unsafe environment. The premises were packed so tight with teenagers it would have been impossible to supervise the premises efficiently and prevent any children under 18 years of age consuming alcohol. During our basement inspection the DJ had turned the music off and put the lights on, this was making the adults on the mezzanine and ground floor levels more angry, shouting at us, that we were spoiling the party. At no point did Ms Cotay or Ben Kusah try to calm the patrons down. Their lacklustre response gave the impression we were ruining the night. They did not appear to appreciate the severity of situation. Making a dynamic risk assessment for my colleague's safety, I quickly advised Ms Cotay and Ben Kusah that the party must finish, that the premises were not licensed for music and dancing, that the premises license conditions had been breached and it was unsafe.

On 14th March 2012 I had a conversation with the DPS in regard to the visit on 25th February. She was advised to make necessary fire safety improvements and operate the premises in accordance with the premises licence. I requested a copy of the CCTV footage from 2230 - midnight on 25th February. Leticia agreed to get that to me. I have never received the footage contravening condition 2 of the premises licence.

On 13th August 2012 the DPS submitted a temporary event notice for Notting Hill Carnival weekend. Brent Police Licensing made representations to the notice and at a Licensing Hearing the subcommittee issued a counter notice. After the hearing the DPS told me should could not continue opening the premises at a loss and whilst out completing late night licensing patrols I have not seen the premises open to the public.

Since the Notting Hill Carnival weekend Brent Police, in response to allegations of drug dealing at Westcoast executed a search warrant. On 30th August 2012 Ben Kusah was arrested for possession of controlled drugs with intent to supply. A large amount of cannabis resin was found at Westcoast. (Cris 1922740 refers and can be provided)

In October 2012 Ben Kusah was arrested at Westcoast again, on this occasion he attempted to resist arrest and assaulted a Police officer.

On 7th December 2012 at 1520 hours Police executed another search warrant obtained from the Magistrates under the misuse of drugs act for Westcoast and the residential premises above. On this occasion both the DPS's Son Ben Kusah, (his girl friend Naomi West) and her mother Lynda Kusah were all in Westcoast. No drugs were found in the venue. Police Officers had to force entry to the residential premises above Westcoast as the Kusah's could not find the chubb key. A bag containing herbal cannabis was found in the flat. West was arrested for possession with intent to supply cannabis. When Ben Kusah was searched a Chubb key was found upon his person. This key was for the door to the residential flats above. (Cris 1931585 refers and can be provided)

Since October 2012 I have not seen the premises open and I have not had any contact from the DPS. The evidence above, highlights that this premise is being run unprofessionally and as such is detrimental to the licensing objectives. Intelligence indicates the premises had become a known venue for the sale of illegal drugs resulting in the Magistrates issuing the search warrants. The premises Licence holder and DPS Leticia Kusah still has ownership of the venue and during a recent licensing operation (7th December 12) members of the family were still residing above the venue and socialising in it. It is possible that they will attempt to open the premises, with such disregard for the law and enforcement, police have no option but to seek the revocation of the premises licence.
