1. **Mayor's introduction**

The Mayor referred to conduct at the previous meeting of Council and reminded all Members to abide by the Members' Code of Conduct when addressing each other. She reported that Councillor Davidson had submitted a letter of apology to herself and the Leader of the Council for any offence caused by what he had said at the meeting. This had been accepted. However, other Members' behaviour had fallen short of the expected standard and she asked that this improve.

2. **Procedural motion**

Councillor Warren moved a procedural motion to amend the seating plan and requested a recorded vote. The motion was put to the vote and declared LOST.

 - (b) the Leader of the Brent Conservatives be permitted to speak for up to 15 minutes,
 - (c) the Deputy Leader of the Council be permitted to speak for up to 10 minutes,
 - (d) the Chair of the Scrutiny Committee be permitted to speak for up to 10 minutes,

- (e) a general debate to follow during which the usual rules for debate will apply as set out in Standing Orders 46 and 47 save as set out in this procedural motion,
- (f) the Leader of the Council be permitted to speak for up to 5 minutes to submit his closing remarks;
- (ii) that voting on each Group's budget proposals shall be taken en bloc.

4. Minutes of the previous meeting

RESOLVED:-

that the minutes of the previous meeting held on 18 January 2016 be approved as an accurate record of the meeting subject to minute 1 showing a recorded vote (amendment incorporated).

5. **Declarations of personal and prejudicial interests**

None declared.

6. Mayor's announcements (including any petitions received)

The Mayor was delighted to report that she had received her MBE on 4 February at Buckingham Palace from Prince Charles.

The Mayor reminded Members that the Council was celebrating Lesbian, Gay, Bisexual and Transgender History Month with an event open to employees, elected members and residents on 23 February, in the Civic Centre from 12noon to 2pm. The Mayor added that LGBT History Month had been celebrated since 2005 and the theme of the event this year was 'Embracing LGBT Lives in Brent'.

The Mayor announced that the Council was celebrating International Women's Day on 8 March from 10am - 2pm in the Civic Centre. She stated that International Women's Day was a global day celebrating the social, economic, cultural and political achievements of women. The day also marked a call to action for accelerating gender parity.

The Mayor announced that Mr Colin Hegarty, a maths teacher at Preston Manor School in Wembley, had been included in the top ten shortlist for the Varkey Foundation Global Teacher Prize 2016. Colin had created his own online videos to teach his pupils and on behalf of the Council she wished him well.

The Mayor reminded Members that Her Majesty the Queen would celebrate her 90th birthday on 21 April. She paid tribute to her significant service to the country. Events across the country – including in Brent – were planned, and she encouraged everyone to get involved to mark this historic milestone.

The Mayor announced that she had recently welcomed students from the Lycée International de Londres who were doing a project on Brent and its services and from the School Council of the Avigdor Hiirsch Torah Temimah Primary School. She reported that both groups had very much enjoyed learning about democracy and the work of the Council. The Mayor reported that the previous week Mayors from across London and councillors had visited the Swaminarayan Mandir which she had hosted in aid of her charity appeal

The Mayor announced two dates for Members to note. On 5 April she was hosting a Theatre Evening at the Tricycle Theatre and on 13 May was her End of Year Celebration at the Civic Centre. Full details would follow.

The Mayor took the opportunity to thank everyone who had supported her Mayoral year so far, including those who were taking part in a quiz night the next day. The Mayor was pleased to report that to date she had raised over \pounds 6,000 for the Brent Young Carers.

The Mayor reported on Maisie Summerton who had recently celebrated her 100th birthday in Carrick House Nursing Home.

In accordance with Standing Orders a list of current petitions showing progress on dealing with them had been circulated around the chamber.

8. Budget 2016-17 and Council Tax

The Council had before it a report on the 2016/17 revenue and capital budgets and proposing an increase in the Council Tax to be levied.

The Leader of the Council, Councillor Butt, addressed the meeting in support of the proposed budget. He referred to the cuts imposed by Government on local government, stating that the effect of this would be to reduce the Council's budget by half during the period 2010-2018. He stated however that action was being taken to protect the services that local residents cared about. Nevertheless there was a need for honesty in recognizing the scale of cuts faced by the Council and that current levels of services could not be maintained and Council Tax levels not increased. He presented an optimistic view of the future based on everyone in the borough working together to make Brent a better place. Councillor Butt referred to Brent as a growing borough which in turn put pressure on local services, particularly from increasing numbers of young people and elderly people. He outlined how the Council had responded to the Government cuts by adopting values that ensured value for money, protecting vulnerable people and providing for the young. So far it

had been possible to hold down Council Tax levels but he explained this was no longer possible if the priorities of residents were to be protected. Councillor Butt outlined the proposals contained in the budget for growth and development. He encouraged everyone to download the Cleaner Brent App to help the Council keep the streets free from rubbish. He expressed confidence that the people of Brent would help the Council get through this difficult time and commended the budget proposals to the meeting.

Councillor Kansagra responded by saying that at every budget meeting the blame was laid on the Government but it was forgotten that the past Labour government had left the economy in a very weak position. He outlined what he regarded as improvements since achieved by the present government such as increased employment levels, cuts in taxes and increases in the state pension. He agreed with the proposal to increase the Council Tax by 2% to help fund Adult Social Care but did not agree with the proposal to further increase the Council Tax by 1.99%. He submitted amendments to the budget designed to delete the proposal for the green bin collection charge and introduce free parking for half hour where appropriate in Brent's secondary shopping parades.

Councillor Warren presented his alternative budget headlined by a 2.5% cut in the level of Council Tax. He criticized what he regarded as the high level of reserves held by the Council and indicated areas where the Council had not spent the money it had available to it which he felt was unacceptable. He stated that residents did not need to be consulted on improving services and that the money spent on this would be better spent on dealing with potholes in the borough. Councillor Warren's proposals sought to make savings on some central items and increase funding for Adult Social Care, fly tipping enforcement, CCTV and removing the green bin charge. He commended his alternative budget to the meeting.

Councillor Pavey, Lead Member for Resources and Deputy Leader, thanked those local people that had taken part in the consultation on the budget. He thanked Scrutiny members for their work on considering the budget proposals and the contributions made by individual councillors. Councillor Pavey addressed the proposals submitted by Councillor Kansagra and asked how they would be paid for. Commenting on the proposals put forward by Councilor Warren he stated that these lacked proper scrutiny. He stated that the level of reserves held by the Council had been carefully examined. Consultation with residents had shown support for a Council Tax increase. The proposed budget preserved services for children and older people and helped people get into work.

Councillor Kelcher, Chair of Scrutiny Committee, referred to the work of scrutiny members on CCTV, tackling illegal dumping and the budget. He stated that a lesson learnt was that scrutiny of the budget needed to start earlier in the year. A view of scrutiny members was that in future years a clearer vision was needed to support the budget discussions. He referred to areas of the budget which had been influenced by the work of scrutiny.

A general debate followed with councillors commenting on the proposed budget and the amendments put forward. Reference was made to the impact the banking scandals had had on the economy. It was submitted that the budget proposals contained in the report sought to protect the most vulnerable. It was felt that the money generated by a 2% rise in Council Tax was not sufficient to meet the increasing need for Adult Social Care. A point was made that government cuts should be recognised for what they were. Criticism was made of the government's Universal Credit system. A point was made that the budget sought to achieve equality and fairness. Members supported the allocation of additional resources to various areas that supported the needs of local residents. The view was expressed that it was the responsibility of the Council to present a balanced budget and this had been done under difficult circumstances. People who lived and worked in the borough were asked to make best use of the dwindling resources available.

A view was submitted that the alternative budget proposals put forward by Councillor Warren were to be applauded. Reference was made to the additional money allocated to local councils by the government for repairs to potholes and that well run efficient councils would be able to make good use of this. A view was submitted that the government was addressing the level of debt just as householders were encouraged to do.

The Leader thanked everyone for their contribution and suggested that the opposition parties did not understand the impact the cuts in government grant were having.

Review and Determination of Representation of Political Groups on Committees

1.0 Summary

1.1 This report fulfils the Council's duty to review and determine the representation of different political groups on certain committees at its annual meeting or as soon as practicable thereafter. Subsequently, the Council has a duty to make appointments to those committees giving effect to the wishes of the political group allocated the seats.

2.0 Recommendations

- 2.1 That Full Council:

 - (iii) make appointments to those committees giving effect to the wishes of the political group allocated the seats;
 - (iv) note that the political balance on sub-committees will be reviewed at the first meeting of the General Purposes Committee; and
 - (v) review which opposition group is designated the Principal Opposition Group for the purposes of the Members' Allowance Scheme.

3.0 Detail

3.1 The Council is required to **review** the representation of different political groups on certain committees at, or as soon as practicable after, its annual meeting. As soon as practicable after the review, the Council has a duty to

determine the allocation to the different political groups all the seats on the relevant committees. The allocation is determined by applying the "political balance rules" prescribed by the Local Government and Housing Act 1989 and supplemented by the Local Government (Committees and Political Groups) Regulations 1990. These rules are set out in Appendix 1 to this report and are designed to ensure that the political composition of the Council's decision making and deliberative committees, as far as possible, replicates the political composition of Full Council. Subsequently, the Council has a duty to make **appointments** to those committees giving effect to the wishes of the political group allocated the seats.

- 3.2 The Committees that the political balance rules apply to have similar duties in relation to any sub-committees they may have.
- 3.3 The current membership of the Council is 63 persons and there are three different political groups: 56 Labour Group councillors (i.e. 88.88%); 3 Conservative Group councillors (4.76%) and 3 Brent Conservative Group councillors (4.76%). According to the political balance rules a political group for this purpose is a group of two or more members. The sole Liberal Democrat councillor is not therefore part of a group.
- 3.4 The table below sets out the 6 ordinary committees of the Council which the political balance rules apply to; the size of each committee (excluding any non-voting co-opted committee members in accordance with the political balance rules); the total number of seats required to be allocated; the number of seats each political group is strictly entitled to based on the number of group members and any adjustments required by the political balance rules.
- 3.5 For example, there are a total of 36 ordinary committee seats. As the 56 members of the Labour Group constitute 88.88% of the total membership of the Council, the proportion of seats the group is strictly entitled to is 32. However, as the political balance rules do not allow all the seats on a committee to be allocated to the same political group, at least 6 seats have to be allocated to the other political groups. Resulting in a final allocation of 30 seats to the Labour Group.
- 3.6 Conversely, as both opposition groups have 3 members each (i.e. 4.76% of the total membership of the Council), each group is strictly entitled to an allocation of 2 seats. However, as the Labour Group can only be allocated 30 and not 32 seats, the two remaining seats also have to be allocated to the other political groups. In the past this has been done on an equal basis. It is, however, for Full Council to determine the allocation of seats on committee and members are requested to make such a determination.

3.7 The only other committees which the political balance rules apply to are the Scrutiny Committees. As members will recall, the new two scrutiny committee structure agreed by Full Council at its last meeting will be implemented on 19 May 2016. The table below confirms the size and make-up of the Committees (i.e. a total of 8 councillors on each Scrutiny Committee notwithstanding the requirement to appoint 4 education co-opted members with voting rights on

the Community and Well-being Scrutiny Committee) and it is for Members to determine the allocation of the two remaining seats to the opposition groups.

- 3.8 Subsequent to allocating seats, the Council has a duty to make appointments to the specified committees giving effect to the wishes of the political group allocated the seats.
- 3.9 The political balance rules do not apply to the Health and Well-being Board but it has been previously agreed that this Board comprise 4 Cabinet Members and one opposition Member. Members are asked to make the appointments to the Health and Well-being Board too.
- 3.10 Nor do the political balance rules formally apply to the Alcohol and Entertainment Licensing Committee but are applied as a matter of policy (not law). The proportionate entitlement to the available seats is set out below and Members are asked to make the appointments.

Appendix 1

The political balance rules prescribed by the Local Government and Housing Act 1989 ('the Act') and the Local Government (Committees and Political Groups) Regulations 1990 ('the 1990 Regulations')

- 1. The rules are that seats on relevant committees must be allocated to different political groups so far as reasonably practicable in accordance with the following four principles:
- (a) that not all the seats on the body are allocated to the same political group;
- (b) that the majority of the seats on the body is allocated to a particular political group if the number of persons belonging to that group is a majority of the Council's membership;
- (c) subject to paragraphs (a) and (b) above, that each political group is allocated the same proportion of the <u>total seats</u> across all the <u>ordinary</u> <u>committees</u> of the Council as the proportion of the members of the Council that belong to that group; and
- (d) subject to paragraphs (a) to (c) above, that each political group is allocated the same proportion of the seats on each relevant <u>body</u> as the proportion of the members of the Council that belong to that group.
- 2. Principle (c) refers to "ordinary committees" which under the Act means those appointed under section 102(1) of the Local Government Act 1972, namely General Purposes Committee, Audit Committee, Standards Committee, Corporate Parenting Committee, Planning Committee and the Equalities Committee.
- 3. Principle (d) applies to a "body" to which the Council makes appointments. The Act provides that the bodies to which this principle applies include ordinary committees (as defined above) and ordinary sub committees, advisory committees and sub-committees, and joint committees where at least 3 seats are allocated. By virtue of the Local Government Act 2000, principles (a), (b) and (d) also apply to the Scrutiny Committee.
- 4. Accordingly under principle (c) above, the General Purposes Committee, Audit Committee, Standards Committee, Corporate Parenting Committee, Planning Committee and the Equalities Committee first have to be taken together to determine the *number* of seats that should be allocated to each group. Then, in accordance with paragraph (d) above, the number of seats each political group is entitled to has to be allocated proportionately to individual committees so far as possible.

5. The political balance principles do not apply to the London Councils' Joint Committees or the Joint Health Overview and Scrutiny Committee because only one seat on each Committee is allocated by the Council. This page is intentionally left blank

Municipal Calendar of Meetings 2016/17

1. Summary

1.1 This report presents a calendar of meetings for the 2016/17 Municipal Year (Appendix 1).

2. Recommendations

- 2.1 That Members agree, in principle, the dates for Full Council and other meetings to take place during the municipal year 2016/2017, as attached in Appendix 1.
- 2.2 That Members agree that the Head of Executive and Member Services be authorised to make any alterations deemed necessary to the Municipal Calendar during the course of the municipal year having consulted the Leader of the Council; the Leader of the Principal Opposition Group and the Chair of the affected meeting.

3. Detail

- 3.1 Members are asked to agree the dates in the calendar of meetings for the 2016/17 municipal year, on which the council, and its committee/sub-committee meetings, meetings of the Cabinet and other bodies should be held.
- 3.2 In general, meetings of Full Council and the Cabinet take place on Mondays whilst most other meetings take place on Tuesdays and Wednesdays. With the exception of the Fostering Panel, Fridays are avoided entirely and Thursdays where possible.
- 3.3 As a basis for putting together the calendar, an attempt has been made to avoid clashes of appointments for Members on the basis of memberships

of committees in 2015/6. However, where memberships change it may be necessary to review the frequency of any clashes.

- 3.4 Religious holidays have been included on the calendar and meetings have not been arranged on evenings where it has been deemed inappropriate to hold meetings because of the importance associated with any particular religious holiday.
- 3.5 For information purposes, the calendar will also list some events organised by other bodies such as the Brent Housing Partnership Board.
- 3.6 The dates of the meetings proposed for Full Council are as follows:

(18 May 2016 – Annual Council)
11 July 2016
13 September 2016
21 November 2016
23 January 2017
27 February 2017 (Council Tax and Budget Setting)
17 May 2017 (Annual meeting of Council and Mayor Making)

- 3.7 Following the successful daytime Cabinet meetings, it is proposed to hold a number of Cabinet meetings at 2pm (dates tbc). It is intended that these meetings will take place across the Borough. Evening meetings of the Cabinet will take place in the Civic Centre.
- 3.8 In February 2016, Full Council approved the adoption of a new model for the Council's statutory scrutiny function and associated activities. From May 2016, the council will move to a model of two scrutiny committees. Across the new structure there will be a total of 12 scrutiny meetings held during the municipal year, six per committee.
- 3.9 Tentative provision has been made for Member Learning and Development sessions throughout the municipal year.
- 3.10 Meetings of the Welsh Harp Joint Consultative Committee have been agreed by Barnet Council.
- 3.11 The Trading Standards Joint Advisory Board meetings have been agreed with three meetings scheduled for the year.
- 3.12 The dates of the five Brent Connects Forums are included. Each Forum will meet four times during the year.
