## Please state the ground(s) for review (please read guidance note 1)

The premises licence for this venue has been in existence since it's conversion with the introduction of the current licensing Act in November 2005. The current premises licence holder Timothy Sheahan is also the designated premises supervisor, he has held this position since December 2013. However Mr Sheahan has been managing the venue since Autumn 2012. The permitted licensable activity is supply of alcohol only from 1000 to 2300 hours Monday to Saturday and 1200 to 2230 hours on Sundays. There are no conditions attached to this premises licence.

Unfortunately Mr Sheahan fails to operate this premise within the terms of the licence. He regularly authorises unlicensable activity contrary to Section 136 Licensing Act 2003, usually allowing music and entertainment or supply of alcohol. Even when Mr Sheahan has submitted a temporary event notice he has allowed licensable activity to continue after its conclusion. The venue permits the sale of alcohol to a person who is drunk contrary to Section 141 Licensing Act 2003. The operation of the venue sanctions breaches of the Heath Act 2006 by allowing the smoking of cigarettes in an enclosed commercial premises.

These offences have either been witnessed by Police or Police have received complaints from local residents.

Mr Sheahan has received a formal warning letter from Police, in addition when further offences were committed the management were called in to the Civic Centre of a meeting with Brent Police Licensing and an Action plan compiled. He has been spoken to over the telephone on many occasion and advised how to improve and strengthen his role and responsibilities. Regrettably Mr Sheahan's disregard to the licensing legislation has continued. The licensing objections are going to be jeopardized more if he is allowed to continue operating the venue in this way.

Police request that a 'time the premises closes to the public' be added to the licence and that be 30minutes after the sale of alcohol stops (2330 hours Monday to Saturday and 2300 hours on Sundays). This allows a drinking up time for his customers.

Police request Mr Sheahan be removed as the designated premises supervisor, the evidence outlines that he ignores the importance of licensing legislation and is unable or unwilling to operate the premises within the authority given.

To assist a new DPS control the venue more successfully, Police consider the following conditions to be added to the premises licence

Door supervisors Mandatory Condition

Door supervisors to be employed on the premises from 2000hrs on Friday, Saturday and Sundays they shall control entrance to the premises and to control order within the premises.

Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.

A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.

A CCTV camera shall be installed to cover the entrance and exit of the premises.

A "Challenge 21" policy shall be adopted and adhered to.

A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for inspection.

An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

No entry or re-entry shall be permitted after 2230 hours.

Regular documented staff training on licensing legislation and operating procedures to be given. This training shall be signed and dated and a copy of these training records available for inspection by Police and local authority enforcement officers.

Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

No drinks shall be served other than in plastic or toughened glasses.

Customers carrying open or sealed bottles or glasses shall not be admitted to the premises.

# Police also request Music to become licensable, that the effect of the de-regulation be removed from this premises licence by the committee.

This list is not exhaustive and relies upon up to date plans of the premise.

Police feel that these are wholly reasonable, proportionate and appropriate measure to be put in place to promote the licensing objectives. Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.

Greenes bar

Please provide as much information as possible to support the application (please read guidance note 2)

4th October 2013 2350hrs. PC's McDonald and Lewis-Evans visited Greenes Bar. Tim Sheahan was managing the bar, the designated premises supervisor (DPS) was not there. Mr Sheahan informed Police he was applying to become the DPS. There was a handful of customers and evidence that smoking was being permitted within the premises. There was a strong smell and haze of cigarette smoke and an ashtray on the bar containing cigarette butts. Mr Sheahan was advised of the Health Act legislation.

10th January 2014 0120 hrs PC's McDonald and Lewis-Evans visited Greenes Bar. The front external shutters were closed and the entrance door was locked. Officers knocked on the door and it was opened, before officers could identify themselves the unknown male who opened it said 'if you want a drink you had better hurry and come in before you are seen'. As officers entered the Bar they saw approximately seven customers drinking beer from pint glasses. Some customers were smoking cigarettes. There were three members of a band packing away their musical equipment. There was a white male behind the bar, Officers identified themselves and at this point the staff member began telling customers the premises were closed. Mr Sheahan was in bed, the member of staff went to wake him. Mr Sheahan was aware his licence was until 2300 hours. Officers advised him to operate the premises within the authority or apply to vary the premises licence or submit Temporary Event Notices. A warning letter was posted to Mr Sheahan (See Attached)

## 9th March 2014 0415hrs

## CRIS 1905687/14 CAD1856/09MAR14

Female member of the public phoned 999 that a group of men had come out of Greenes Bar and were fighting in the street. Upon Police arrival one Irish male was taken to hospital with a head injury. The remainder of the Irish males claimed he had fallen over. All the males were heavily intoxicated. The front door of Greenes Bar had been locked and Police could not get a reply from their knocking.

There was a TEN in place for the night of 8th to 9th March however the event was to finish at 0200 hours. (See attached)

#### 21st March 2014

Complaint received from local resident and witness to the above incident. Complaints refer to noise music, and drunkenness at Greenes Bar. Complainant spoken to by licensing Officers (see attached)

#### 5th April 2014

CAD 1113/05APR 0212 hours 362 High Road, NW10.

Complaints from local resident A local resident reported a noise nuisance from the pub and he could hear glasses being broken. He confirmed that the pub was spilling out and the people were being very rowdy and very drunk. He stated there were approx 20 males and females gathered outside all very drunk. (see attached)

#### 6th April 2014 0600hrs

#### Cris 1908116/14 CAD 2378

Police were called to a male who had been assault by other males. Witness saw the victim leave Greenes and walk along Neasden lane to the Cab office at 447 Neasden Lane . After a short time he came running back towards Greenes and was being chased by three other white males who attached him. Victim was taken to hospital. He was heavily intoxicated. He refused to make a statement to Police. Officers visited Greenes and spoke to the female member of staff named Lee. She could not operate the CCTV. Mr Sheahan provided CCTV footage but it

was an incorrect format.

15th April 2015-04-10 Nick Mortimer Brent Police Licensing made representations to a TEN submitted for 4th and 5th May 2014.(See attached)

19th April 2014

CRIS 1909279/14 CAD 1849/18APR14 time of origin 0703hrs

Cab driver phoned Police after collecting three males from Alperton area.

They requested to be taken to Greenes Bar Neasden Lane North and on arrival asked to be taken round the back of the pub as the door would be open.

They were already drunk and presumably wanted to go drinking in the bar. They seemed to know that the back door would be open.

Suspect asked driver to get out and knock on the door for them. He refused and then there was an argument which culminated in a scuffle where the driver was punched and kicked by suspect.

Investigating Officer PC Cox spoke to staff at Greenes Bar on 9th May 2014 and he viewed the CCTV system. For the month of April there is footage available from 22nd onwards but no recorded footage available from 01 - 21st, therefore there is no footage available from the 18th It is not known whether this was because of a faulty system or whether it is merely that footage is only kept for a short period of time.

I outlined the fact that the national standard for CCTV footage being obtained is 31 days and that this falls below that. They are aware and will be ordering an engineer to solve this issue. There is insufficient evidence from this investigation to be able to identify the suspect of this assault.

## CRIS 1909586/14 CAD 5648/21APR14

Victim and friend met up and decided to go for a drink at GREENES in NEASDEN. They arrived at approx 2220 hours and Victim states that between this time and approx 0010 hours they had 3 drinks and were in a jovial mood. Victim states that he was stood near the pool table in the corner of the pub when he noticed Suspect walk past him towards a pool cue that was stood up in the corner behind Victim. Victim suspected that he was getting it to play pool when Suspect picked it up in the middle and using the butt end of the cue hit Victim at eye level across the face.

VIW states that this point he had not had any conversation with SUS at all and his nose exploded. He had blood pouring down his face and before he could react he had the two bouncers had grabbed him and was marching him towards the door. Closely followed by the Owner of GREENES. Victim was taken back to his H/A by a taxi where when he entered the premises he collapsed. He was then taken by friend to CMH where it was diagnosed he had concussion.

Investigating officer spoken to the assistant manager Lee at Greenes 19/5/14. She was aware of the incident. She will speak to the manager when he returns to get the cctv burned. She has informed me that the cctv inside the pub has been temperamental recently so it may not have recorded.

Investigating Officer spoke with Lee from Greenes on 31/5/14 She states they had lost my number. She has passed my details on to the manager to call me when he is free. Lee has told me that they did look through the footage to see if the incident had recorded but it does not appear to have recorded. The problem being that they had more cameras installed and the hardrive capacity remained the same so not all of the cameras footage has been retained. They are looking into getting a larger hardrive. I await confirmation of this from the manager The manager of Greenes, Tim has called the investigating officer 5th June 14. He has explained that the CCTV is no longer available as the system was upgraded when 4 new cameras were added and this has affected the memory.

Meeting held with Tim Sheehan, Ray Hagan and Brent Police Licensing at Brent Civic Centre. Meeting to discuss recent assaults and late night opening without authority. Brent Police licensing have made representations to recent temporary event notices made by Mr Sheahan due to crime and disorder at the location. The licensing sub committee heard the evidence on 25th April and refused the TEN;s. It was agreed the following actions to be implemented by Mr Sheahan at the venue: CCTV recording for 31day, door supervisors, and a 'members only' entry policy in the interim. Mr Sheahan would like to meet after a few months to discuss the venue extend the licensable activity times permanently.

## 8th Feb 2015

## CAD 1684/08FEB15 0400 hrs.

Caller is complaining about noise at Greenes PH, Neasden Lane North. Caller states she called Brent Council noise team but they finished at 0200 hrs. She believes the pub knows this and they turn the music up louder.

## 8th Feb 2015 0415 hours

PC McDonald was driving past Greenes Bar off duty and saw the front entrance door open. Attention was drawn to the location by the verbal noise emanating from inside the premises; it looked very busy with customers. There was no Temporary Event Notice in place for this date, the premises should have been closed.

## 8th Feb 2015

CAD refers 2469 0800hrs

## CAD refers 2478

Emergency calls made to Police from members of public concerned for the welfare of a drunken distressed female in the North Circular Road near the junction of Neasden lane North. Statements received from a Police traffic officer and local Brent Police Officer who attended this call and assisted the drunken female who alleged to have left Greenes Bar between 0630 - 0700hrs on 8th Feb.(Statements attached)

## 21st February 2015

Letter sent to Mr Sheahan requesting CCTV footage from 0200 to 0600 hours on 8th February 2014. Request also sent via Email to Mr Sheahan

27th February 2015 Email to Mr Sheahan requesting the CCTV footage as the above request.

## 20th March 2015 2300hrs

Premises visited by PC McDonald and PC Whitcomb, Mr Sheahan was expecting the visit and arranged for the above CCTV footage to be downloaded and available for collection. There were approximately 30 customers, all but one was male. A high proportion appeared to have Irish accents and was in workman's clothes. One male wearing a high visibility jacket and trousers was drunk and due to his unsteadiness officers had problems walking around him in the small bar area. Officers spoke to the lone male member of staff, Frank, who provided a memory stick left by Mr Sheahan containing the CCTV footage from 8/2/15. As the officers left the bar, the drunk male in the high visibility jacket also walked out into the street. This male staggered to the nearby lamp post and urinated in full view of the public. At this point Frank also came out of the pub and called to the Officers that Mr Sheahan was coming downstairs to speak to them. Frank also saw the drunk male urinating, he spoke to him, the male staggered around on the pavement for a short while before unlocking a door adjacent to the lamp post and entered the premises. When Mr Sheahan appeared on the pavement the officers explained what they had witnessed pointing out the urine now in full flow down the street. Mr Sheahan could not understand and explained the male actually lives in the premises next to the lamp post. Officers told Mr Sheahan it was probably as he had been allowed to get drunk in his pub. Officers spoke briefly about the incident on 8th February and he openly said he had

permitted licensable activities outside his authorised hours. Mr Sheahan is convinced he runs a 'tight ship' in a tough area. His members' only rule is keeping the Eastern European gangs and travellers' out of the premises and such deserves a late licence.

## 24th March 2015

PC McDonald attempted to view the CCTV footage provided by Mr Sheahan of the events on 8th February. Unfortunately the memory stick contained two files that were empty. PC McDonald telephoned Mr Sheahan and left a voice mail and explained the problem. PC McDonald has taken the memory stick to the specialist CCTV unit at Wembley Police Station and they confirmed the files are empty. There is no reason to pursue this matter as there are no conditions attached to this premise licence requesting CCTV.

14th April 2015 More advertisements on social media highlighting late licence and music and entertainment at the venue.

19th April 2015 Cad 1537 at 0332 hours. Complaints from local resident to noise and music at Greenes Bar.

## Please state the ground(s) for review (please read guidance note 1)

The premises licence for this venue has been in existence since it's conversion with the introduction of the current licensing Act in November 2005. The current premises licence holder Timothy Sheahan is also the designated premises supervisor, he has held this position since December 2013. However Mr Sheahan has been managing the venue since Autumn 2012. The permitted licensable activity is supply of alcohol only from 1000 to 2300 hours Monday to Saturday and 1200 to 2230 hours on Sundays. There are no conditions attached to this premises licence.

Unfortunately Mr Sheahan fails to operate this premise within the terms of the licence. He regularly authorises unlicensable activity contrary to Section 136 Licensing Act 2003, usually allowing music and entertainment or supply of alcohol. Even when Mr Sheahan has submitted a temporary event notice he has allowed licensable activity to continue after its conclusion. The venue permits the sale of alcohol to a person who is drunk contrary to Section 141 Licensing Act 2003. The operation of the venue sanctions breaches of the Heath Act 2006 by allowing the smoking of cigarettes in an enclosed commercial premises.

These offences have either been witnessed by Police or Police have received complaints from local residents.

Mr Sheahan has received a formal warning letter from Police, in addition when further offences were committed the management were called in to the Civic Centre of a meeting with Brent Police Licensing and an Action plan compiled. He has been spoken to over the telephone on many occasion and advised how to improve and strengthen his role and responsibilities. Regrettably Mr Sheahan's disregard to the licensing legislation has continued. The licensing objections are going to be jeopardized more if he is allowed to continue operating the venue in this way.

Police request that a 'time the premises closes to the public' be added to the licence and that be 30minutes after the sale of alcohol stops (2330 hours Monday to Saturday and 2300 hours on Sundays). This allows a drinking up time for his customers.

Police request Mr Sheahan be removed as the designated premises supervisor, the evidence outlines that he ignores the importance of licensing legislation and is unable or unwilling to operate the premises within the authority given.

To assist a new DPS control the venue more successfully, Police consider the following conditions to be added to the premises licence

Door supervisors Mandatory Condition

Door supervisors to be employed on the premises from 2000hrs on Friday, Saturday and Sundays they shall control entrance to the premises and to control order within the premises.

Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.

A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.

A CCTV camera shall be installed to cover the entrance and exit of the premises.

A "Challenge 21" policy shall be adopted and adhered to.

A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for inspection.

An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

No entry or re-entry shall be permitted after 2230 hours.

Regular documented staff training on licensing legislation and operating procedures to be given. This training shall be signed and dated and a copy of these training records available for inspection by Police and local authority enforcement officers.

Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

No drinks shall be served other than in plastic or toughened glasses.

Customers carrying open or sealed bottles or glasses shall not be admitted to the premises.

# Police also request Music to become licensable, that the effect of the de-regulation be removed from this premises licence by the committee.

Police feel that these are wholly reasonable, proportionate and appropriate measure to be put in place to promote the licensing objectives. 4th October 2013 2350hrs. PC's McDonald and Lewis-Evans visited Greenes Bar. Tim Sheahan was managing the bar, the designated premises supervisor (DPS) was not there. Mr Sheahan informed Police he was applying to become the DPS. There was a handful of customers and evidence that smoking was being permitted within the premises. There was a strong smell and haze of cigarette smoke and an ashtray on the bar containing cigarette butts. Mr Sheahan was advised of the Health Act legislation.

10th January 2014 0120 hrs PC's McDonald and Lewis-Evans visited Greenes Bar. The front external shutters were closed and the entrance door was locked. Officers knocked on the door and it was opened, before officers could identify themselves the unknown male who opened it said 'if you want a drink you had better hurry and come in before you are seen'. As officers entered the Bar they saw approximately seven customers drinking beer from pint glasses. Some customers were smoking cigarettes. There were three members of a band packing away their musical equipment. There was a white male behind the bar, Officers identified themselves and at this point the staff member began telling customers the premises were closed. Mr Sheahan was in bed, the member of staff went to wake him. Mr Sheahan was aware his licence was until 2300 hours. Officers advised him to operate the premises within the authority or apply to vary the premises licence or submit Temporary Event Notices. A warning letter was posted to Mr Sheahan (See Attached)

## 9th March 2014 0415hrs

## CRIS 1905687/14 CAD1856/09MAR14

Female member of the public phoned 999 that a group of men had come out of Greenes Bar and were fighting in the street. Upon Police arrival one Irish male was taken to hospital with a head injury. The remainder of the Irish males claimed he had fallen over. All the males were heavily intoxicated. The front door of Greenes Bar had been locked and Police could not get a reply from their knocking.

There was a TEN in place for the night of 8th to 9th March however the event was to finish at 0200 hours. (See attached)

#### 21st March 2014

Complaint received from local resident and witness to the above incident. Complaints refer to noise music, and drunkenness at Greenes Bar. Complainant spoken to by licensing Officers (see attached)

#### 5th April 2014

CAD 1113/05APR 0212 hours 362 High Road, NW10.

Complaints from local resident A local resident reported a noise nuisance from the pub and he could hear glasses being broken. He confirmed that the pub was spilling out and the people were being very rowdy and very drunk. He stated there were approx 20 males and females gathered outside all very drunk. (see attached)

#### 6th April 2014 0600hrs

#### Cris 1908116/14 CAD 2378

Police were called to a male who had been assault by other males. Witness saw the victim leave Greenes and walk along Neasden lane to the Cab office at 447 Neasden Lane . After a short time he came running back towards Greenes and was being chased by three other white males who attached him. Victim was taken to hospital. He was heavily intoxicated. He refused to make a statement to Police. Officers visited Greenes and spoke to the female member of staff named Lee. She could not operate the CCTV. Mr Sheahan provided CCTV footage but it

was an incorrect format.

15th April 2015-04-10 Nick Mortimer Brent Police Licensing made representations to a TEN submitted for 4th and 5th May 2014.(See attached)

19th April 2014

CRIS 1909279/14 CAD 1849/18APR14 time of origin 0703hrs

Cab driver phoned Police after collecting three males from Alperton area.

They requested to be taken to Greenes Bar Neasden Lane North and on arrival asked to be taken round the back of the pub as the door would be open.

They were already drunk and presumably wanted to go drinking in the bar. They seemed to know that the back door would be open.

Suspect asked driver to get out and knock on the door for them. He refused and then there was an argument which culminated in a scuffle where the driver was punched and kicked by suspect.

Investigating Officer PC Cox spoke to staff at Greenes Bar on 9th May 2014 and he viewed the CCTV system. For the month of April there is footage available from 22nd onwards but no recorded footage available from 01 - 21st, therefore there is no footage available from the 18th It is not known whether this was because of a faulty system or whether it is merely that footage is only kept for a short period of time.

I outlined the fact that the national standard for CCTV footage being obtained is 31 days and that this falls below that. They are aware and will be ordering an engineer to solve this issue. There is insufficient evidence from this investigation to be able to identify the suspect of this assault.

## CRIS 1909586/14 CAD 5648/21APR14

Victim and friend met up and decided to go for a drink at GREENES in NEASDEN. They arrived at approx 2220 hours and Victim states that between this time and approx 0010 hours they had 3 drinks and were in a jovial mood. Victim states that he was stood near the pool table in the corner of the pub when he noticed Suspect walk past him towards a pool cue that was stood up in the corner behind Victim. Victim suspected that he was getting it to play pool when Suspect picked it up in the middle and using the butt end of the cue hit Victim at eye level across the face.

VIW states that this point he had not had any conversation with SUS at all and his nose exploded. He had blood pouring down his face and before he could react he had the two bouncers had grabbed him and was marching him towards the door. Closely followed by the Owner of GREENES. Victim was taken back to his H/A by a taxi where when he entered the premises he collapsed. He was then taken by friend to CMH where it was diagnosed he had concussion.

Investigating officer spoken to the assistant manager Lee at Greenes 19/5/14. She was aware of the incident. She will speak to the manager when he returns to get the cctv burned. She has informed me that the cctv inside the pub has been temperamental recently so it may not have recorded.

Investigating Officer spoke with Lee from Greenes on 31/5/14 She states they had lost my number. She has passed my details on to the manager to call me when he is free. Lee has told me that they did look through the footage to see if the incident had recorded but it does not appear to have recorded. The problem being that they had more cameras installed and the hardrive capacity remained the same so not all of the cameras footage has been retained. They are looking into getting a larger hardrive. I await confirmation of this from the manager The manager of Greenes, Tim has called the investigating officer 5th June 14. He has explained that the CCTV is no longer available as the system was upgraded when 4 new cameras were added and this has affected the memory.

Meeting held with Tim Sheehan, Ray Hagan and Brent Police Licensing at Brent Civic Centre. Meeting to discuss recent assaults and late night opening without authority. Brent Police licensing have made representations to recent temporary event notices made by Mr Sheahan due to crime and disorder at the location. The licensing sub committee heard the evidence on 25th April and refused the TEN;s. It was agreed the following actions to be implemented by Mr Sheahan at the venue: CCTV recording for 31day, door supervisors, and a 'members only' entry policy in the interim. Mr Sheahan would like to meet after a few months to discuss the venue extend the licensable activity times permanently.

## 8th Feb 2015

Caller is complaining about noise at Greenes PH, Neasden Lane North. Caller states she called Brent Council noise team but they finished at 0200 hrs. She believes the pub knows this and they turn the music up louder.

## 8th Feb 2015 0415 hours

PC McDonald was driving past Greenes Bar off duty and saw the front entrance door open. Attention was drawn to the location by the verbal noise emanating from inside the premises; it looked very busy with customers. There was no Temporary Event Notice in place for this date, the premises should have been closed.

## 8th Feb 2015

CAD refers 2469 0800hrs

## CAD refers 2478

Emergency calls made to Police from members of public concerned for the welfare of a drunken distressed female in the North Circular Road near the junction of Neasden lane North. Statements received from a Police traffic officer and local Brent Police Officer who attended this call and assisted the drunken female who alleged to have left Greenes Bar between 0630 - 0700hrs on 8th Feb.(Statements attached)

#### 21st February 2015

Letter sent to Mr Sheahan requesting CCTV footage from 0200 to 0600 hours on 8th February 2014. Request also sent via Email to Mr Sheahan

27th February 2015 Email to Mr Sheahan requesting the CCTV footage as the above request.

## 20th March 2015 2300hrs

Premises visited by PC McDonald and PC Whitcomb, Mr Sheahan was expecting the visit and arranged for the above CCTV footage to be downloaded and available for collection. There were approximately 30 customers, all but one was male. A high proportion appeared to have Irish accents and was in workman's clothes. One male wearing a high visibility jacket and trousers was drunk and due to his unsteadiness officers had problems walking around him in the small bar area. Officers spoke to the lone male member of staff, Frank, who provided a memory stick left by Mr Sheahan containing the CCTV footage from 8/2/15. As the officers left the bar, the drunk male in the high visibility jacket also walked out into the street. This male staggered to the nearby lamp post and urinated in full view of the public. At this point Frank also came out of the pub and called to the Officers that Mr Sheahan was coming downstairs to speak to them. Frank also saw the drunk male urinating, he spoke to him, the male staggered around on the pavement for a short while before unlocking a door adjacent to the lamp post and entered the premises. When Mr Sheahan appeared on the pavement the officers explained what they had witnessed pointing out the urine now in full flow down the street. Mr Sheahan could not understand and explained the male actually lives in the premises next to the lamp post. Officers told Mr Sheahan it was probably as he had been allowed to get drunk in his pub. Officers spoke briefly about the incident on 8th February and he openly said he had

permitted licensable activities outside his authorised hours. Mr Sheahan is convinced he runs a 'tight ship' in a tough area. His members' only rule is keeping the Eastern European gangs and travellers' out of the premises and such deserves a late licence.

## 24th March 2015

PC McDonald attempted to view the CCTV footage provided by Mr Sheahan of the events on 8th February. Unfortunately the memory stick contained two files that were empty. PC McDonald telephoned Mr Sheahan and left a voice mail and explained the problem. PC McDonald has taken the memory stick to the specialist CCTV unit at Wembley Police Station and they confirmed the files are empty. There is no reason to pursue this matter as there are no conditions attached to this premise licence requesting CCTV.

14th April 2015 More advertisements on social media highlighting late licence and music and entertainment at the venue.

19th April 2015 Cad 1537 at 0332 hours. Complaints from local resident to noise and music at Greenes Bar.

I am writing this letter in regard to Greenes Bar, 362-364 Neasden Lane North, NW10 0BT which is authorised under the Licensing Act 2003 to supply alcohol for consumption off the premises from 1000 hours to 2300 hours Monday to Saturday and from 1200 hours to 2230hours on Sundays.

On Saturday 11th January 2014 at 0120 hours the bar had the shutters down and the doors were locked, when we knocked at the door it was opened and before we identified ourselves we were told if we wanted a drink to hurry up and come in so we weren't seen, there were approximately 7 customers in the bar some of which were smoking. Three band members clearing away equipment. Only when we identified who we were did staff start tell customers that the bar was closed. You also currently do not have the provision for regulated entertainment on your licence. This is an offence under section 136 of the Licensing Act 2003 namely unauthorised licensable activity.

I am aware that the premises licence was not displayed in the bar. If you do not have a copy of the premises licence, I suggest you contact the council as soon as possible as it is an offence not to have it displayed in the bar.

This letter comes as warning that any other breaches of licensing legislation will be brought to the attention of the Licensing Authority Committee by the way of a premises licence review. If you have any questions in relation to this letter please do not hesitate to contact me.

# Police Objection to the Temporary Event Notice for Greene's Bar, 362 Neasden Lane North, NW10 on 2nd to 4th May 2014.

I certify that I have considered the notice shown above and **I wish to make representations** that the use of the premises for the temporary event would undermine the crime prevention initiative, for the reasons indicated below.

Officer: Nicholas Mortimer

An authorised officer of the Metropolitan Police, in whose area the premises are situated, for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

A Temporary Event Notice has been given under section 100 Licensing Act 2003 by Mr Timothy Sheahan, received in this office on Tuesday 15th April 2014. Police are formally objecting to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the crime and disorder and public safety objectives:

The notice is to allow for the use of the premises on 2nd and 3rd May from 2300 to 0200 and 4th May from 2230 to 0100, the licensable activity is for the sale of alcohol. The nature of the event is described as a 60th birthday party.

This premise has had several TEN's this year, not all without incident however there have been two complaints from the public about noise and music going on as late as 5am. In addition there have been three allegations of assault, CRIS's 190493/14 at 1930 when no TEN was in place and the applicant himself was assaulted, 1905687/14 at 0415 when there had been a TEN until 0200 and 1908116/14 when there was no TEN. In the latter two cases the victims and suspects appear to be travellers and the assaults are never substantiated. The most recent case is the most disturbing where a male was hospitalised after being struck repeatedly with a brick. This allegedly occurred at 0600 on the 6th April 2014 after the victim and suspects had been drinking in the premise. There was no TEN in force on that occasion and a request for CCTV has been made, to date this has not been received.



I have spoken to the applicant and voiced my concerns over the recent issues but despite now having door supervisors little seems to have improved.

It is my opinion that should this TEN go ahead that the licensing objectives would be breached and further complaints about anti social behaviour and crime and disorder will take place.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a premises licence under section 17 of the act.

The Police representations are primarily concerned with crime and disorder.

# Police require the following points should be included in the operating schedule or added as conditions on the premises licence.

#### Smoking area

There needs to be contained smoking area next to the entrance of the premises. This should not impede the public highway or cause obstruction to neighbouring premises.

#### Personal Licence Holder

The sale of alcohol to drunken people and children is a major cause of concern to police and highlighted in the Governments Alcohol Harm Reduction Strategy. Off Licences are

particularly open to these sales receiving little supervision or visits from the responsible authorities. Those who sell alcohol should be fully aware of the legislation and issues around alcohol and should be fully trained to a national standard.

Members of staff who have formally been given authority should be fluent in English in order to properly conduct the sale of alcohol and more importantly to refuse the sale if so required.

#### Door Supervisors

At least 1 supervisor to every 50 customers.

They will ensure compliance with licensing and security guidance.

A register /log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing authority on request.

Door Supervisors shall wear clothing that can be clearly and easily identified on CCTV.

Ensure that there are a sufficient number and gender mix of door supervisors to monitor and control the numbers and behaviour of persons present.

The premises will be operated in accordance with advice from the Metropolitan Police Service, which will include search procedures, the confiscation, storage and ultimate disposal of suspected illegal drugs and weapons.

#### **Open Containers & Areas for Consumption of Alcohol**

Customers will not be permitted to take open containers outside the premises, as defined in the plan submitted with the operating schedule and approved by Responsible Authorities.

The consumption of alcohol will be restricted to those parts of the premises identified on the plan submitted with the operating schedule and approved by the licensing authority.

#### **Closed Circuit Television (CCTV)**

Good quality CCTV is essential as a deterrent for the prevention of crime and the detection of offenders. It allows for both covert and overt monitoring of the premises. With proper signage, this reassures both staff and clientele, that this is a safe environment where illegal activities are not tolerated.

All cameras and recording equipment will be installed and maintained in accordance with Home Office Guidance and the manufacturers instructions and will be fully operational when the premises are open to the public.

Notices shall be displayed at the entrance to the premises, and in prominent positions throughout the premises, advising that CCTV is in operation.

#### **Capacity Limit for Premises**

Proper control of the numbers of people in the premises is essential to prevent overcrowding and the risk of disorder. It is impossible to conduct any meaningful risk assessment, without knowing the maximum number of people that may be safely accommodated at any one time. There must also be adequate facilities to monitor and control the number of people present The capacity limit will be set by Officers from the Local Authority.

#### **Operating Hours to be displayed on Premises**

A notice displaying the opening hours, the type of licensing activity and licence conditions should be clearly displayed and visible to anyone <u>outside</u> the premises. This may be incorporated in the summary of the licence, which must be displayed, or take the form of a separate item.

Likewise the name of the Designated Premises Supervisor (D.P.S.) if required should be similarly displayed.

This will allow the Police and other responsible authorities to readily identify the licence details. Clearly displayed opening hours will also reduce any confusion for customers prior to entering the premises and possible conflict when the premises close/stop selling alcohol.

A Summary of the Premises Licence will be displayed at each public entrance to the premises.

#### **Drunkeness**

Substantial food and non-intoxicating beverages (including free drinking water) shall be available during the whole of licensed hours in all parts of the premises where intoxicants are provided

The premises to adopt and advertise a scheme requiring all patrons under 21 years of age to produce identification with the accepted forms of identification namely a passport or photo driving licence.

#### No Entry or Re-Entry

This will help to reduce disorder and nuisance from people migrating to the premises from establishments that have already closed or are about to.

#### <u>Drugs</u>

The DPS should ensure a written drugs and weapons policy for the premises has been completed and is adhered to. Please see the Metropolitan Police *Safe and Sound* booklet for further advise (available on the Web).

# The conditions that Police require to be added to the Premises Licence are listed below:

#### CCTV

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

A CCTV camera shall be installed to cover the entrance of the premises, top of the stairs on to the first floor, search area, night club dance floor and points of supply of alcohol.

#### **Door Supervisors**

Mandatory Condition

Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.

Door supervisors of a sufficient number and gender mix, shall be employed from one hour prior to the commencement on any day when the premises are open past midnight for licensable activity.

A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

#### **Bottles and Glasses**

Customers shall not be permitted to take open vessels outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

The consumption of alcohol will be restricted to those parts of the premises identified on the plan submitted with the operating schedule and approved by the licensing authority.

#### **Capacity Limits**

The total number of people permitted on the premises including staff and performers shall not exceed (to be set by public safety team)

#### Proof of Age

A sign stating "No proof of age - No sale" shall be displayed at the point of sale.

A "Challenge 21" policy shall be adopted and adhered to, photographic proof of age required.

No person under the age of 18 years shall be permitted on the premises after 2200 hours unless it is for an event specifically arranged for young people and prior notice has been given to Police and Licensing Authority.

#### **Drugs and Weapons**

A comprehensive record of all seized drugs and weapons shall be kept and made available to police and licensing officers for 12 months from the date of seizure.

Notices clearly explaining the licensee's drugs and weapons policy shall be displayed at the entrance and at suitable places throughout the premises.

Toilets shall be checked at regular intervals for the use of drugs and other illegal activities.

Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.

#### General

An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

No alcohol shall be available for any customer when the premises are open for primarily for use by persons under the age of 18.

A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

No entry or re-entry shall be permitted after 0200 hours.

All persons entering or re-entering, including staff and performers, shall be required to pass through a search and wand search on days when there is a public or private event.

Where Police or licensing Officers require admittance to the premises in an emergency or part of an impromptu visit they shall not be impeded by requiring to sign in or be searched.

After 2300 hours smoking areas shall be limited to 20 persons and each area shall be suitably supervised.

The Licensee shall undertake a risk assessment agreed by the Police and Licensing Authority of any significant promotion or event, using the Metropolitan Police Service Promotion/Event Risk Assessment Form (Form 696) or an equivalent and provide a copy to the Metropolitan Police and Brent Council's Licensing Unit not less than 14 days before the event is due to take place.

Where an event has taken place the licensee shall complete a Debrief Risk Assessment Form (Form 696A) and submit this to the Metropolitan Police and Brent Council's Licensing Unit within 3 days of the conclusion of the event.

No noise or vibration shall be detectable at any neighbouring noise sensitive premises.

The level of music shall be arranged so as not to cause a nuisance to local residents.

All speakers shall be mounted on anti-vibration mountings to prevent transmission of sound energy to adjoining properties.

All doors and windows shall remain closed during any licensable activity and where a door is used for patrons to enter or leave the premises the door shall be lobbied and fitted with a self-closing device.

Notices requesting customers to leave quietly shall be displayed at each exit.

Nudity, striptease and other entertainment of an adult nature shall not be permitted on the premises.

## **Annexe 1 - Mandatory Conditions**

(a) No supply of alcohol may be made at a time when no designated premises supervisor has been specified in the licence or at a time when the designated premises supervisor does not hold a personal licence or his or her licence has been suspended.

(b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

(c) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(d) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children:-

(i) games or other activities which require or encourage, or are designed to require or encourage, individuals to:

- drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- drink as much alcohol as possible (whether within a time limit or otherwise);

(ii) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

(iii) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of <u>24 hours or less</u>;

(iv) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-

- the outcome of a race, competition or other event or process, or
- the likelihood of anything occurring or not occurring;

(v) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

(e) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

(f) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

(g) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

(h) The responsible person shall ensure that-

(i) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

- beer or cider: half pint;
- gin, rum, vodka or whisky: 25ml or 35ml; and
- still wine in a glass: 125ml; and

(ii) customers are made aware of the availability of these measures.

(i) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

## Annexe 2 - Conditions Consistent With the Operating Schedule

- 1 CCTV shall be installed at locations agreed with the police and maintained in a working condition.
- 2 CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 3 If the CCTV becomes inoperative, or is not installed to the satisfaction of the Police and Licensing Authority, they shall be contacted at the earliest opportunity by email or telephone to enable agreement to be reached as to what licensable activities can take place.
- 4 Notices shall be displayed at the entrance and in prominent positions throughout the premises advising that CCTV is in operation.

Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.

- 5 Door supervisors of a sufficient number and gender mix, shall be employed from 21:00hrs hours on any day when the premises are open for the sale of alcohol past midnight.
- 6 There shall be a minimum of 2 door supervisors on any day when the premises are open for the sale of alcohol past midnight to control the entrance to the premises and to control order within the premises.
- 7 There shall be at least one door supervisor for every 50 customers or part thereof.
- 8 Door supervisors as part of their duties shall ensure that customers when queuing for entry, or leaving, do so in a manner that does not cause a nuisance.
- 9 All persons entering, or re-entering, including staff and performers, shall be required to pass through a search and wand search on days when there is a public or private event.
- 10 No entry or re-entry shall be permitted after 02:00 hours.
- 11 After 23:00 hours outside smoking areas shall be limited to 20 persons and each area shall be suitably supervised.
- 12 A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

- 13 A hand held and/or "head cam" camera system should be operated at the premises in accordance with the Police Clubs and Vice Unit's "Recommendations for the Use of Hand Held Cameras within Licensed Premises" document.
- 14 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.
- 15 A daily record sheet shall be kept and maintained to ensure that all fire exits are accessible and free from obstruction during trading hours before any public use. All fire exits must be free from locks, barrel bolts, fastenings other than push bars or pads.
- 16 Door supervisors as part of their duties shall ensure that customers when queuing for entry, or leaving, do so in a manner that does not cause a nuisance.
- 17 The licensee shall keep an incident book which shall be made available to the Police and Licensing Authority.
- 18 Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 19 There shall be a minimum of 2 door supervisors on any day when the premises are open for the sale of alcohol past midnight to control the entrance to the premises and to control order within the premises.
- 20 There shall be at least one door supervisor for every 50 customers or part thereof.
- 21 A copy of the premises licence summary including the hours which licensable activities are permitted shall be clearly displayed and visible from on a notice board to be affixed to the ground floor left hand wall located immediately to the left of the entrance area.
- 22 The total number of people permitted on the premises including staff and performers shall not exceed 200.
- 23 Where Police or Licensing officers require admittance to the premises in an emergency or as part of an impromptu visit they shall not be impeded by requiring to be signed in or searched.
- 24 Substantial food and non-intoxicating beverages including a free supply of drinking water shall be made available to customers during the whole of the licensed hours in all parts of the premises where intoxicants are provided.
- 25 Toilets shall be checked at regular intervals for the use of drugs and other illegal activities.
- 26 There shall be a minimum of one hour between the termination of general activities and the commencement of a "Club Dance" and this sterile period shall be used to ensure the premises searched.

27 Photographic proof of age shall be required from all persons appearing to be under the age of 21.

The Licensee shall undertake a risk assessment agreed by the Police and Licensing Authority of any significant promotion or event, using the Metropolitan Police Service Promotion/Event Risk Assessment Form (Form 696) or an equivalent and provide a copy to the Metropolitan Police and Brent Council's Licensing Unit not less than 14 days before the event is due to take place.

- 28 Where an event has taken place the licensee shall complete a Debrief Risk Assessment Form (Form 696A) and submit this to the Metropolitan Police and Brent Council's Licensing Unit within 3 days of the conclusion of the event.
- 29 When prior notice has been given the licensee shall allow free and unimpeded access to police officers with drug sampling equipment and/or "sniffer" dogs, to test customers prior to entry, for drug use and possession.
- 30 The premises may be subject to surveys from the Metropolitan Police Clubs and Vice Unit re the suitability of club events, and matters arising from the surveys shall be incorporated into the operating schedule as agreed.
- 31 All doors and windows shall remain closed during any licensable activity and where a door is used for patrons to enter or leave the premises the door shall be fitted with a self-closing device.
- 32 All speakers shall be mounted on anti-vibration mountings to prevent transmission of sound energy to adjoining properties.
- 33 No noise or vibration shall be detectable at any neighbouring noise sensitive premises.
- 34 All entertainments shall use the in-house amplification system and a noise limiter set at a level agreed by Brent Council's Licensing Unit shall be used at all times.
- 35 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 36 Notices clearly explaining the licensee's drugs and weapons policy shall be displayed at the entrance and at suitable places throughout the premises.
- 37 Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.
- 38 The licensee or his/her deputy shall be a member of, and actively participate in the local pubwatch scheme.
- 39 Arrangements shall be made with a local licensed taxi/minicab company to ensure sufficient transport is available to take patrons home after a late night event.
- 40 Notices advertising the number of a local licensed taxi service shall be displayed in a prominent position in the premises.



The public safety team wishes to put in a representation for this review following my visit to the premises and propose the following conditions to be considered for inclusion on the licence at committee stage.

- 1) The maximum number of persons permitted on the premises shall not exceed 60 not including staff.
- 2) The inward opening front entrance/exit door to the bar area shall be fixed back in the open position when the public are on the premises
- 2) Any locks or latches on exit doors, shutter or gates shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.
- 3) Appropriate emergency exit signage shall be installed within both bar and pool room areas and on exit doors to ensure any person on the premises is aware of emergency exit routes.
- 4) The exit door from the pool room area shall only be used as a fire/emergency exit if an appropriate push bar door is installed or the door is locked in the open position at all times whilst public are on the premises
