Please state the ground(s) for review (please read guidance note 1)

The premises licence for this venue has been in existence since it's conversion with the introduction of the current licensing Act in November 2005. The current premises licence holder Timothy Sheahan is also the designated premises supervisor, he has held this position since December 2013. However Mr Sheahan has been managing the venue since Autumn 2012. The permitted licensable activity is supply of alcohol only from 1000 to 2300 hours Monday to Saturday and 1200 to 2230 hours on Sundays. There are no conditions attached to this premises licence.

Unfortunately Mr Sheahan fails to operate this premise within the terms of the licence. He regularly authorises unlicensable activity contrary to Section 136 Licensing Act 2003, usually allowing music and entertainment or supply of alcohol. Even when Mr Sheahan has submitted a temporary event notice he has allowed licensable activity to continue after its conclusion. The venue permits the sale of alcohol to a person who is drunk contrary to Section 141 Licensing Act 2003. The operation of the venue sanctions breaches of the Heath Act 2006 by allowing the smoking of cigarettes in an enclosed commercial premises.

These offences have either been witnessed by Police or Police have received complaints from local residents.

Mr Sheahan has received a formal warning letter from Police, in addition when further offences were committed the management were called in to the Civic Centre of a meeting with Brent Police Licensing and an Action plan compiled. He has been spoken to over the telephone on many occasion and advised how to improve and strengthen his role and responsibilities. Regrettably Mr Sheahan's disregard to the licensing legislation has continued. The licensing objections are going to be jeopardized more if he is allowed to continue operating the venue in this way.

Police request that a 'time the premises closes to the public' be added to the licence and that be 30minutes after the sale of alcohol stops (2330 hours Monday to Saturday and 2300 hours on Sundays). This allows a drinking up time for his customers.

Police request Mr Sheahan be removed as the designated premises supervisor, the evidence outlines that he ignores the importance of licensing legislation and is unable or unwilling to operate the premises within the authority given.

To assist a new DPS control the venue more successfully, Police consider the following conditions to be added to the premises licence

Door supervisors Mandatory Condition

Door supervisors to be employed on the premises from 2000hrs on Friday, Saturday and Sundays they shall control entrance to the premises and to control order within the premises.

Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.

A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.

A CCTV camera shall be installed to cover the entrance and exit of the premises.

A "Challenge 21" policy shall be adopted and adhered to.

A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for inspection.

An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

No entry or re-entry shall be permitted after 2230 hours.

Regular documented staff training on licensing legislation and operating procedures to be given. This training shall be signed and dated and a copy of these training records available for inspection by Police and local authority enforcement officers.

Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.


No drinks shall be served other than in plastic or toughened glasses.

Customers carrying open or sealed bottles or glasses shall not be admitted to the premises.

Police also request Music to become licensable, that the effect of the de-regulation be removed from this premises licence by the committee.

This list is not exhaustive and relies upon up to date plans of the premise.

Police feel that these are wholly reasonable, proportionate and appropriate measure to be put in place to promote the licensing objectives. Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.

4th October 2013 2350hrs. PC's McDonald and Lewis-Evans visited Greenes Bar. Tim Sheahan was managing the bar, the designated premises supervisor (DPS) was not there. Mr Sheahan informed Police he was applying to become the DPS. There was a handful of customers and evidence that smoking was being permitted within the premises. There was a strong smell and haze of cigarette smoke and an ashtray on the bar containing cigarette butts. Mr Sheahan was advised of the Health Act legislation.

10th January 2014 0120 hrs PC's McDonald and Lewis-Evans visited Greenes Bar. The front external shutters were closed and the entrance door was locked. Officers knocked on the door and it was opened, before officers could identify themselves the unknown male who opened it said 'if you want a drink you had better hurry and come in before you are seen'. As officers entered the Bar they saw approximately seven customers drinking beer from pint glasses. Some customers were smoking cigarettes. There were three members of a band packing away their musical equipment. There was a white male behind the bar, Officers identified themselves and at this point the staff member began telling customers the premises were closed. Mr Sheahan was in bed, the member of staff went to wake him. Mr Sheahan was aware his licence was until 2300 hours. Officers advised him to operate the premises within the authority or apply to vary the premises licence or submit Temporary Event Notices. A warning letter was posted to Mr Sheahan (See Attached)

9th March 2014 0415hrs

CRIS 1905687/14 CAD1856/09MAR14

Female member of the public phoned 999 that a group of men had come out of Greenes Bar and were fighting in the street. Upon Police arrival one Irish male was taken to hospital with a head injury. The remainder of the Irish males claimed he had fallen over. All the males were heavily intoxicated. The front door of Greenes Bar had been locked and Police could not get a reply from their knocking.

There was a TEN in place for the night of 8th to 9th March however the event was to finish at 0200 hours. (See attached)

21st March 2014

Complaint received from local resident and witness to the above incident. Complaints refer to noise music, and drunkenness at Greenes Bar. Complainant spoken to by licensing Officers (see attached)

5th April 2014

CAD 1113/05APR 0212 hours 362 High Road, NW10.

Complaints from local resident A local resident reported a noise nuisance from the pub and he could hear glasses being broken. He confirmed that the pub was spilling out and the people were being very rowdy and very drunk. He stated there were approx 20 males and females gathered outside all very drunk. (see attached)

6th April 2014 0600hrs

Cris 1908116/14 CAD 2378

Police were called to a male who had been assault by other males. Witness saw the victim leave Greenes and walk along Neasden lane to the Cab office at 447 Neasden Lane. After a short time he came running back towards Greenes and was being chased by three other white males who attached him. Victim was taken to hospital. He was heavily intoxicated. He refused to make a statement to Police. Officers visited Greenes and spoke to the female member of staff named Lee. She could not operate the CCTV. Mr Sheahan provided CCTV footage but it

was an incorrect format.

15th April 2015-04-10 Nick Mortimer Brent Police Licensing made representations to a TEN submitted for 4th and 5th May 2014.(See attached)

19th April 2014

CRIS 1909279/14 CAD 1849/18APR14 time of origin 0703hrs

Cab driver phoned Police after collecting three males from Alperton area.

They requested to be taken to Greenes Bar Neasden Lane North and on arrival asked to be taken round the back of the pub as the door would be open.

They were already drunk and presumably wanted to go drinking in the bar. They seemed to know that the back door would be open.

Suspect asked driver to get out and knock on the door for them. He refused and then there was an argument which culminated in a scuffle where the driver was punched and kicked by suspect.

Investigating Officer PC Cox spoke to staff at Greenes Bar on 9th May 2014 and he viewed the CCTV system. For the month of April there is footage available from 22nd onwards but no recorded footage available from 01 - 21st, therefore there is no footage available from the 18th It is not known whether this was because of a faulty system or whether it is merely that footage is only kept for a short period of time.

I outlined the fact that the national standard for CCTV footage being obtained is 31 days and that this falls below that. They are aware and will be ordering an engineer to solve this issue. There is insufficient evidence from this investigation to be able to identify the suspect of this assault.

CRIS 1909586/14 CAD 5648/21APR14

Victim and friend met up and decided to go for a drink at GREENES in NEASDEN. They arrived at approx 2220 hours and Victim states that between this time and approx 0010 hours they had 3 drinks and were in a jovial mood. Victim states that he was stood near the pool table in the corner of the pub when he noticed Suspect walk past him towards a pool cue that was stood up in the corner behind Victim. Victim suspected that he was getting it to play pool when Suspect picked it up in the middle and using the butt end of the cue hit Victim at eye level across the face.

VIW states that this point he had not had any conversation with SUS at all and his nose exploded. He had blood pouring down his face and before he could react he had the two bouncers had grabbed him and was marching him towards the door. Closely followed by the Owner of GREENES. Victim was taken back to his H/A by a taxi where when he entered the premises he collapsed. He was then taken by friend to CMH where it was diagnosed he had concussion

Investigating officer spoken to the assistant manager Lee at Greenes 19/5/14. She was aware of the incident. She will speak to the manager when he returns to get the cctv burned. She has informed me that the cctv inside the pub has been temperamental recently so it may not have recorded.

Investigating Officer spoke with Lee from Greenes on 31/5/14 She states they had lost my number. She has passed my details on to the manager to call me when he is free. Lee has told me that they did look through the footage to see if the incident had recorded but it does not appear to have recorded. The problem being that they had more cameras installed and the hardrive capacity remained the same so not all of the cameras footage has been retained. They are looking into getting a larger hardrive. I await confirmation of this from the manager The manager of Greenes, Tim has called the investigating officer 5th June 14. He has explained that the CCTV is no longer available as the system was upgraded when 4 new cameras were added and this has affected the memory.

22nd July 2014

Meeting held with Tim Sheehan, Ray Hagan and Brent Police Licensing at Brent Civic Centre. Meeting to discuss recent assaults and late night opening without authority. Brent Police licensing have made representations to recent temporary event notices made by Mr Sheahan due to crime and disorder at the location. The licensing sub committee heard the evidence on 25th April and refused the TEN;s. It was agreed the following actions to be implemented by Mr Sheahan at the venue: CCTV recording for 31day, door supervisors, and a 'members only' entry policy in the interim. Mr Sheahan would like to meet after a few months to discuss the venue extend the licensable activity times permanently.

8th Feb 2015

CAD 1684/08FEB15 0400 hrs.

Caller is complaining about noise at Greenes PH, Neasden Lane North. Caller states she called Brent Council noise team but they finished at 0200 hrs. She believes the pub knows this and they turn the music up louder.

8th Feb 2015 0415 hours

PC McDonald was driving past Greenes Bar off duty and saw the front entrance door open. Attention was drawn to the location by the verbal noise emanating from inside the premises; it looked very busy with customers. There was no Temporary Event Notice in place for this date, the premises should have been closed.

8th Feb 2015

CAD refers 2469 0800hrs

CAD refers 2478

Emergency calls made to Police from members of public concerned for the welfare of a drunken distressed female in the North Circular Road near the junction of Neasden lane North. Statements received from a Police traffic officer and local Brent Police Officer who attended this call and assisted the drunken female who alleged to have left Greenes Bar between 0630 - 0700hrs on 8th Feb.(Statements attached)

21st February 2015

Letter sent to Mr Sheahan requesting CCTV footage from 0200 to 0600 hours on 8th February 2014. Request also sent via Email to Mr Sheahan


27th February 2015

Email to Mr Sheahan requesting the CCTV footage as the above request.

20th March 2015 2300hrs

Premises visited by PC McDonald and PC Whitcomb, Mr Sheahan was expecting the visit and arranged for the above CCTV footage to be downloaded and available for collection. There were approximately 30 customers, all but one was male. A high proportion appeared to have Irish accents and was in workman's clothes. One male wearing a high visibility jacket and trousers was drunk and due to his unsteadiness officers had problems walking around him in the small bar area. Officers spoke to the lone male member of staff, Frank, who provided a memory stick left by Mr Sheahan containing the CCTV footage from 8/2/15. As the officers left the bar, the drunk male in the high visibility jacket also walked out into the street. This male staggered to the nearby lamp post and urinated in full view of the public. At this point Frank also came out of the pub and called to the Officers that Mr Sheahan was coming downstairs to speak to them. Frank also saw the drunk male urinating, he spoke to him, the male staggered around on the pavement for a short while before unlocking a door adjacent to the lamp post and entered the premises. When Mr Sheahan appeared on the pavement the officers explained what they had witnessed pointing out the urine now in full flow down the street. Mr Sheahan could not understand and explained the male actually lives in the premises next to the lamp post. Officers told Mr Sheahan it was probably as he had been allowed to get drunk in his pub. Officers spoke briefly about the incident on 8th February and he openly said he had

permitted licensable activities outside his authorised hours. Mr Sheahan is convinced he runs a 'tight ship' in a tough area. His members' only rule is keeping the Eastern European gangs and travellers' out of the premises and such deserves a late licence. 24th March 2015 PC McDonald attempted to view the CCTV footage provided by Mr Sheahan of the events on 8th February. Unfortunately the memory stick contained two files that were empty. PC McDonald telephoned Mr Sheahan and left a voice mail and explained the problem. PC McDonald has taken the memory stick to the specialist CCTV unit at Wembley Police Station and they confirmed the files are empty. There is no reason to pursue this matter as there are no conditions attached to this premise licence requesting CCTV. 14th April 2015 More advertisements on social media highlighting late licence and music and entertainment at the venue. 19th April 2015 Cad 1537 at 0332 hours. Complaints from local resident to noise and music at Greenes Bar.

PRIMARY INVESTIGATION DETAILS: 1 Immediate action

- 1. CAD1856/09MAR14 refers. Crew of QK81E attended. PC Choudry 494QK. PC Rogers 828QK also attended the scene.
- 2. Police were called by a female who stated that she could see a fight taking place outside the Greene's Bar on Neasden Lane.. Upon police arrival there were a number of Irish males stood around. VIW1 was bleeding heavily from above the left eye. Police spoke to the males one scene and asked what had happened. All the males stated that VIW1 had fallen over and banged his head on the ground.

VIW1 was asked the same question and he stated that he had fallen. VIW1 was heavily intoxicated. VIW1 was treated by officers on scene whilst awaiting LAS arrival. Initially PC 494QK was alone at the scene and VIW1's behaviour changed from calm to aggressive. More units were requested to the scene to assist with VIW1's first aid and also to help keep him calm. VIW1 seemed to become agiitated anytime he saw the other Irish males.

Whilst VIW1 was being treated the other males all walked off and refused to speak to police any further. VIW1 was asked if any one them were involved in the injuries he had sustained to which he replied "no".

One male remained on sceme. This male was a friend of VIW1. Whilst waiting for LAS VIW1 appeared to drift in and out of conciousness. VIW1 would then get up suddenly and shout "I'm gonna kill him". VIW1 was asked who he was referring to but would not disclose any details of the person. VIW1 did not even provide a first name.

VIW1 was asked what had happened and confirmed that he had been kicked and punched.

I am writing this letter in regard to Greenes Bar, 362-364 Neasden Lane North, NW10 0BT which is authorised under the Licensing Act 2003 to supply alcohol for consumption off the premises from 1000 hours to 2300 hours Monday to Saturday and from 1200 hours to 2230hours on Sundays.

On Saturday 11th January 2014 at 0120 hours the bar had the shutters down and the doors were locked, when we knocked at the door it was opened and before we identified ourselves we were told if we wanted a drink to hurry up and come in so we weren't seen, there were approximately 7 customers in the bar some of which were smoking. Three band members clearing away equipment. Only when we identified who we were did staff start tell customers that the bar was closed. You also currently do not have the provision for regulated entertainment on your licence. This is an offence under section 136 of the Licensing Act 2003 namely unauthorised licensable activity.

I am aware that the premises licence was not displayed in the bar. If you do not have a copy of the premises licence, I suggest you contact the council as soon as possible as it is an offence not to have it displayed in the bar.

This letter comes as warning that any other breaches of licensing legislation will be brought to the attention of the Licensing Authority Committee by the way of a premises licence review.

Police Objection to the Temporary Event Notice for Greene's Bar, 362 Neasden Lane North, NW10 on 2nd to 4th May 2014.

I certify that I have considered the notice shown above and I wish to make representations that the use of the premises for the temporary event would undermine the crime prevention initiative, for the reasons indicated below.

Officer: Nicholas Mortimer

An authorised officer of the Metropolitan Police, in whose area the premises are situated, for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

A Temporary Event Notice has been given under section 100 Licensing Act 2003 by Mr Timothy Sheahan, received in this office on Tuesday 15th April 2014. Police are formally objecting to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the crime and disorder and public safety objectives:

The notice is to allow for the use of the premises on 2nd and 3rd May from 2300 to 0200 and 4th May from 2230 to 0100, the licensable activity is for the sale of alcohol. The nature of the event is described as a 60th birthday party.

This premise has had several TEN's this year, not all without incident however there have been two complaints from the public about noise and music going on as late as 5am. In addition there have been three allegations of assault, CRIS's 190493/14 at 1930 when no TEN was in place and the applicant himself was assaulted, 1905687/14 at 0415 when there had been a TEN until 0200 and 1908116/14 when there was no TEN. In the latter two cases the victims and suspects appear to be travellers and the assaults are never substantiated. The most recent case is the most disturbing where a male was hospitalised after being struck repeatedly with a brick. This allegedly occurred at 0600 on the 6th April 2014 after the victim and suspects had been drinking in the premise. There was no TEN in force on that occasion and a request for CCTV has been made, to date this has not been received.

I have spoken to the applicant and voiced my concerns over the recent issues but despite now having door supervisors little seems to have improved.

It is my opinion that should this TEN go ahead that the licensing objectives would be breached and further complaints about anti social behaviour and crime and disorder will take place.

The public safety team wishes to put in a representation for this review following my visit to the premises and propose the following conditions to be considered for inclusion on the licence at committee stage.

- 1) The maximum number of persons permitted on the premises shall not exceed 60 not including staff.
- 2) The inward opening front entrance/exit door to the bar area shall be fixed back in the open position when the public are on the premises
- 2) Any locks or latches on exit doors, shutter or gates shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.
- 3) Appropriate emergency exit signage shall be installed within both bar and pool room areas and on exit doors to ensure any person on the premises is aware of emergency exit routes.



I am writing this letter in response to my visit to **Jeen Cash & Carry** on Sunday 22nd March 2015, when the venue was open to the public and alcohol was being sold. I attended to carry out a licensing visit.

During my visit I inspected your alcohol stock, which was for sale on the shop floor. I found Oranjeboom Premium (8.5% ABV), Perla (6.0% ABV), Zubr (6.0% ABV), Tatra Mocne (7.0% ABV), Scrumpy Jack (6.0% ABV) and Okocim (7.0% ABV). **This breaches condition seven (7) of your premises licence.** 'No high strength beers, lagers and ciders above 5.5% ABV shall be stocked.

I must point out that the above breach amounst to an **offence** under **s.136 Licensing Act 2003**, namely carrying on unauthorised licensable activity. Upon conviction, this offence is punishable by up to six (6) months imprisonment and/or a fine of £20,000 or both.

However, I have taken into account that your staff were quick to rectify this issue and removed all products which breached your authority. As such, and on this occasion, please accept this letter as a formal 'warning'.

On TUESDAY 12th May 2015, I was on duty in plain clothes with PC 368QK Sullivan.						
PC Sullivan and I are both police officers working within Brent borough police licensing unit. At around						
12:45pm we attended JEEN CASH & CARRY, 306 HARROW ROAD, WEMBLEY, HA9 6LL, in						
order to carry out a licensing inspection. The premise is licensed for the sale of alcohol by retail twenty						
four hours a day, seven days a week. Upon arrival, the shop was open and alcohol on sale. I noticed two						
Asian males stood behind the shop counter. Both appeared to be very nervous as PC Sullivan and I						
identified ourselves as police officers, by producing our warrant cards. I explained that we were at the						
shop to carrying out a licensing inspection. The first male, who I would describe as the younger of the						
two, spoke very limited English. He gave me his details as Mr. Asadullah SABIR dob 01/01/1984 of 8c						
WILL CRESCENT, WEMBLEY, HA9. I suspect that these details are false, as there is no Will crescen						
in Wembley. The second male behind the counter could speak no English at all. However he kept saying						
to me, 'Helper, helper'. I took this to mean that he was not a member of staff and just helping out. He						
did not give me his personal details. Neither of these men was able to produce a personal licence to me.						
This breaches condition eight (8) of the premises licence, which states that a personal licence holder						
must be present on the premises at all times throughout the sale of alcohol. A few minutes later, a						
female who I know as the shop's DPS arrived. Her name is Ms. Renuka THUSHYANTHAN. I

the licence was different to his current home address. I pointed this out to him. With regard to his two members of staff, he confirmed that neither currently holds a personal licences. Mr KANNAN explained that Mr. SABIR was on a two day trial and that the older male was not a member of staff at all. He was unable to produce any paperwork with these two members of staff details written on. In fact, he claimed not to know the name of the younger male at all! I asked to see his statement of authority. He was unable to produce one, which breaches mandatory condition lettered (b) which states that every supply of alcohol must be either made or authorised by a holder of a personal licence. PC SULLIVAN and I inspected their alcohol stock and this was satisfactory. I then asked Ms. THUSHYANTHAN to show me that her CCTV system operates correctly. The CCTV was displaying on an LCD screen by the main entrance. However, due to a defective mouse and no other way to operate the hard drive, she was unable play back any CCTV footage at all. This breaches condition one (1) and two (2) of their premises licence, which states that the CCTV system must be in a working condition and should be made available to police on request. On further inspection I noticed that there was no sign reading, 'No proof of age - No sale' on display at the point of sale. This breaches condition number five (5) of their premises licence which stipulates that such a sign must be displayed. This concluded our visit, which I documented and then left the shop. P. Wyton R. The premises licence holder is Mr Kannan Thangarasa. The designated premises supervisor is a relative Mrs Renuka Thushyanthan. She is also the designated premises supervisor of another premise situated in the vicinity of this shop. Mrs Renuka Thushyanthan and her husband Mr Thushyantham Alakaratnam have been involved in the operation of this shop since 2008.

Jeen Cash & carry is failing to promote three of the licensing objectives, namely the prevention of crime and disorder, public safety and the prevention of public nuisance.

Police have no faith in the ability or willingness of the management to operate the premises responsibly, they ignore Police advise/guidance and therefore wish to bring the matter before the sub-committee for consideration. Police are primarily concerned with insufficient supervision, disregard of licensing

legislation and sales of prohibited items. The operation of this premises 24 hours daily is adding to the unacceptable number of street drinkers in the vicinity at all hours of the day and night. Police have witnessed much of this and in addition have received complaints from other authorities. Police seek the removal of the DPS who struggles to supervise this 24 hour venue sufficiently whilst supervising another premise and managing a young family. A reduction in authorised hours; sale of alcohol permitted from 0800 hours to 0200 hours daily. Police would request additional conditions be attached to the premises licence in relation to major football event days at Wembley Stadium:

- No sales of beer or cider in glass containers to be undertaken during this period, remove glass bottles except wines and spirits from display.
- No more than four cans of beer or cider to be sold to an individual
- All persons buying alcohol, at any time, to be advised of the Street Drinking ban
- Stop selling alcohol 1 hour before the designated kick off time. Sales of alcohol can resume at the kick off time.

At this time Mr Thushyantham Alakaratnam was the DPS for the shop and had held that position since April 2008. He was informed of the requirement for match days at Wembley Stadium, in particular I fully explained to him and despite poor English he fully understood the requirement to: Not to serve class bottles of beer and cider only cans or plastic.

No more than four cans of beer or cider to be sold to an individual

All persons buying alcohol at any time to be advised of the street drinking ban.

To stop the sale of alcohol 1 hour before the scheduled kick off.

He was supplied with the latest stadium event list and a letter outlining the above.

Mr Thushyantham Alakaratnam agreed to all the voluntary conditions on major football events.

He was then asked what happened in Harrow, he became a bit uneasy and said that he had a very bad experience in Harrow and was let down by his staff. I told him that I did not want a repeat of that, PS Adolphus also informed him that Police had received information of him selling alcohol to children after school time. He totally denied this. He was informed that his premises would be under scrutiny in the near future, and to make sure he was complying with the conditions of his licence and the legislation. He confirmed that he was fully training his staff and that his CCTV at the premises was working correctly and retained images for at least 31 days, he stated that he would not be making any further mistakes as his livelihood and that of his 3 children depended on it.

25th September 2010

At 0020 hours PC McDonald visited the premises with PS Adolphus. The DPS at that time, Mr Piraba IYATHURAI was not present. Mr Thangarasa Kannan, dob 01-09-82 of 92 Walton Ave, Sth Harrow, HA2 8QX was managing the shop (current premises licence holder).

12th December 2014

2200 hours PC McDonald visited the shop, the DPS Mrs Renuka Thushyanthan was not present. One staff member Kumar Andrenou had very broken English stated she was relative of owner but limited grasp of questions regarding who the DPS was. This breaches condition 8 of the premises licence:

A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol. Members of staff who have formally been given authority should be fluent in English in order to properly conduct the sale of alcohol and more importantly to refuse the sale if so required.

There were bottles of Warki beer with an ABV of 6.5% and also foreign Guinness with an ABV of 7.5% on display in beer fridge. This breaches condition 7 of the premises licence:

No high strength beers, lagers or ciders above 5.5% ABV shall be stocked.

13th December 2014

A warning letter delivered to the DPS with regard to the breaches identified on 12th December 2014.

22nd March 2015

PC McDonald and PC Whitcomb visited the premises at 1700 hours during a major football game at Wembley Stadium. The DPS was not present however her husband Mr Thushyantham Alakaratnam was managing the shop. He indicated that there is a silent partner involved in the shop at the present time, negotiating if the shop is a viable investment. Police identified at least five different brands of beer above 5.5% ABV. This breaches condition 7 of the premises licence:

No high strength beers, lagers or ciders above 5.5% ABV shall be stocked.

This was pointed out to Mr Thushyantham Alakaratnam and told to remove them from display immediately. He claimed they must have come in the cash and carry deliver by mistake. This is a very poor excuse. See photos attached.

All stock of glass bottled beers and ciders were also on display. This was breaching the voluntary agreement and jeopardizes the three highlighted licensing objectives.

26th March 2015

Formal Warning letter delivered to the DPS with regard to the breaches identified on 22nd March 2015.

19th April 2015

PC McDonald visited the shop at approximately 1200 hours during sell out football event, FA semi final finals. There was a large amount of football fans on the pavement in the vicinity drinking beer from glass bottles and a minor disturbance. Glass beer bottles is an unusual sight on football events due to the voluntary agreement. Jeen Cash & carry were once again displaying and selling glass bottles of beers and cider. This was very disappointing; however more worrying was the lack of English speaking, trained, knowledgeable staff. The DPS

was not present, neither was their a personal licence holder. This breaches condition 8 of the premises licence:

A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol. Members of staff who have formally been given authority should be fluent in English in order to properly conduct the sale of alcohol and more importantly to refuse the sale if so required

The two Asian male members of staff could not speak English, a customer was translating on their behalf. One of these males appeared to be disabled. These staff members should have been suitably supervised especially on that day with the added risk of football fans. There was no way these males could have challenged or prevented sales of alcohol. It became apparent the DPS was working at her other shop at 297 Harrow Road. I visited this shop to discover more football fans outside drinking beer from glass bottles, and crates full of glass bottled beer on display. I explained the two staff members in jeen cash & carry needed supervision urgently. Visits were made at the two other off licences in the vicinity and neither had glass bottles of beer or cider on display.

22nd April 2015

Formal warning letter written to the DPS with regard the events on 19th April 2015.

23rd April 2015

PC Lewis-Evans delivered the above letter by hand to the shop. The DPS was not present. PC Lewis-Evans spoke to her husband. PC Lewis-Evans saw three High Strength beers displayed for sale on the shelves, namely Zubra 6% ABV, Old Empire IPA Ale 5.7% ABV, and Desporados 5.9% ABV. This is breaching condition 7 of the premises licence:

No high strength beers, lagers or ciders above 5.5% ABV shall be stocked.

Meeting held at Brent Civic Centre with Licensing Police, Mrs Renuka Thushyanthan and Mr. Kannan Thangarasa. Police expressed their frustrations that over a four week period 3 visits were made to the shop and breaches where identified on all occasions. That the operators of the shop just appear to be ignoring warnings and advice and that the only way for them to realise the severity of their operation and the harmful impact it his having on the surrounding neighbourhood is to bring it to the attention of the sub-committee.

12th May 2015


PC Whitcomb visited the premises at 1245 hours. The DPS was not present, neither was their a personal licence holder. This breaches condition 8 of the premises licence:

A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol. Members of staff who have formally been given authority should be fluent in English in order to properly conduct the sale of alcohol and more importantly to refuse the sale if so required. There were two Asian males in the shop one claimed to be a helper and not a member of staff. The one that was staff spoke very limited English and was very nervous. Officers asked to view the CCTV cameras. Officers discovered it was not working in accordance with the authority of the premises licence. This breaches:

Condition 1 CCTV shall be installed and maintained in a working condition.

Condition 2 All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.2 of the premises licence

There was no sign at the point of sale regarding proof of age, this breaches condition 5 A sign stating "No proof of age - No sale" shall be displayed at the point of sale.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

An officer of the Metropolitan Police Service, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to vary the premises licence under section 34 of the act.

The Police representations are primarily concerned with crime and disorder and public nuisance.

Arada Mini Market is located wholly within a residential area, off a main road (Shirland Road). The premise is completely surrounded by residential properties. Flats are above and below the premise. Malvern Mews runs to the rear, which is a quiet cul-de-sac. Opposite the premise are various high rise blocks of flats situated on the South Kilburn estate, which overlook the premise and other small businesses including a late night shisha café and the Chippenham Hotel pub. The applicant intends to serve his alcohol through a 'night hatch'. It is in my opinion that queues of customers will congregate outside late at night causing public nuisance. Customers will have to queue outside residents' front doors, due to the close proximity some properties are to this premise, especially flats above and with the basement of this premise. Disorder is highly likely if sales are refused late at night, especially to customers who are already intoxicated. This scenario is highly likely, as the nearby Chippenham Hotel pub closes at 10.3 Pagen 109 unday and 11pm Monday-Saturday.

There is also a public seating area opposite the shop. Having visited this area both day and night, it is already very well used. I suspect that this area will also be used by the applicants' customers to loiter and consume alcohol, again causing residents nuisance with an increased chance of crime and disorder in the area.

This is an area which already suffers from ASB and street drinking. During my visit to the area, empty alcoholic tin cans were strewn on the floor, around seating areas and in alleyways. I believe that that should this application be granted, we would see an increase in street drinking within the immediate vicinity of this premise.

Further, I have consulted with the local safer neighbourhood police officer, PC Ged Hasse. He has advised me that he has a problem with ASB and drug dealing in this area. Those waiting to collect drugs, loiter on Malven Road consuming alcohol. I anticipate that the approval of this application will intensify this already ongoing issue.

On 10th June 2015, I visited the premises as part of this consultation process. I met with the applicant and current DPS, Mr. Hamid Raza. I carried out a licensing inspection and found the following breaches of his current premises licence; 1. High strength on display - Six (6) in total; Leffe (6.6% ABV), Guinness Foreign Stout (7.5% ABV), Guinness Foreign Extra (7.5% ABV), Brothers Festival cider (7.0% ANV), Zywieck (5.6% ABV) and Brothers Festival Pear Cider (7.0% ABV). 2. Mr. Raza was unable to operate his CCTV system. 3. Mr. Raza was unable to tell me what age verification policy that he has adopted. These breaches amount to an offence under s.134 Licensing Act 2003 namely, carrying out unauthorised licensable activity. At the time of writing this letter, police are still considering what action to take against the licence holder. These breaches completely contradict his operating schedule, which in itself, lacks any real detail about how he intends to uphold the licensing objectives. Despite possessing a personal licence, Mr. Raza appears to lack knowledge of basic licensing legislation. For example, when asked, he was unable to name any of the licensing objectives.

I have also received information from Brent council's licensing inspector, Ms. Susana Figueirdo, that she visited the premises on Friday 19th June 2015 at 11.55pm. The shop was open and alcohol was on display for sale. This is contrary to the current premises licence which shows that the supply of alcohol must stop at 11.00pm and the closed by 11.00pm also.

Although the Licensing Act 2003 allows for all types of licensable activity up to 24hours, this is not an application which supports an extension of hours, the license holder has proven he is unable to promote the licensing objectives, observe his existing premises license conditions and neither is the Arada Mini Market ideally located for such a request. Police would respectfully ask that this application be <u>refused</u>.

However, if the committee are mindful to approve this application, police request that:

The following conditions be **removed**:

- 1. CCTV shall be installed and maintained in a working condition. Outdated condition. To be replaced by an updated CCTV condition.
- 2. All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

 Outdated condition. To be replaced Page up to the CCTV condition.

3. A Challenge 21 policy shall be adopted and adhered to.

Outdated condition. To be replaced by an updated Challenge 25 condition.

The following conditions to be **added**:

- 1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council. CCTV is to display correct time and date stamp.
- 2. A CCTV camera shall be installed to cover the entrance of the premises.
- 3. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulders image of every person entering or leaving the premises.
- 4. A 'Challenge 25 policy' shall be adopted and adhered to at all times.
- 5. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 6. Customers/members of the public shall not be permitted to congregate or loiter in the forecourt of the premises.
- 7. After 2100 hours a minimum of two (2) members of staff must be on duty and at least one (1) of these two (2) members of staff must be the holder of a personal licence and be fluent in English.
- 8. The following crime prevention measures shall be implemented:
 - A time delay safe with deposit slot and anti fishing mechanisms must be used at the counter till area.
 - Regular robbery awareness and cash minimisation training shall be given to all staff.
- 9. An incident log shall be kept at the premises, and made available for Inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

All crimes reported to the venue

All ejections of patrons

Any complaints received

Any faults in the CCTV system

Any refusal of the sale of alcohol

Any visit by a relevant authority or emergency service.

- 10. A clear and unobstructed view into the premises shall be maintained at all times.
- 11. Notices requesting customers to leave quietly shall be displayed at each exit. Page 111

- 12. The licensee shall ensure all public areas within three (3) metres of the premises are cleared of litter arising from the premises daily.
- 13. All deliveries shall take place during the normal working day (i.e. 09:0 to 18:00 daily).

All other existing conditions to remain the same.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Licensing Objectives for the reasons indicated below.

Officer: Susana Figueiredo – Licensing Inspector

An officer of the Licensing Authority, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to vary the premises licence under section 34 of the Act.

The Licensing Authority may make representations concerning any of the four licensing objectives below;

- the prevention of crime and disorder;
- · public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

Looking at the premises as a whole I feel that this application to extend the operating hours should be REFUSED.

Observations

A visit took place on Saturday 13th June 2015 (Friday night) at 00.40hrs as a result of the application to vary the licence of the above premise. The applicant Hamid Raza was not present at the premise at the time of my visit. There was one male working behind the counter





known to me as Ahmed Naseef who has been employed at the business for three to four months.

When I asked Mr Naseef what were the closing times of the shop he replied by saying it was 02.00hrs on a weekend and 23.00-00.00hrs during the week and then stated that alcohol is not sold after 23.00hrs. Along one side of the premise there was alcohol being displayed for sale, including shelves and a fridge. There was an A4 size paper stuck in the middle of the alcohol which said 'No Alcohol' (see Appendix 1). Mr Naseef stated that the CCTV was recording but was unsure for how many days it records in total. I was unable to verify whether the CCTV was recording as Mr Naseef was unable to show me.

For the short time that I was in the premise, there was a high number of people that attempted to enter the premise, one of which went to the fridge to take a beer and when Mr Naseef told him that the alcohol was not for sale the male became annoyed and seemed to ignore Mr Naseef, reaching into his pocket to pay for the beer. It was only because his friend came in and heard the conversation that he managed to get his friend out of the premise. I'm not sure how Mr Naseef would have dealt with this had the customers friend not been present.

Whilst I was at the premise, I told Mr Naseef that I was going to check the plans of the premise that had been sent to Brent Council as part of the application to vary in order to ensure they matched the building. Mr Naseef appeared became very suddenly nervous and stuttered when he spoke. My colleague Alpesh Kerai who had walked to the back of the premise, opened the door that led down the stairs into the basement and then came back to where I was standing to wait for me. I then heard Mr Naseef who was now positioned on the other side of thew aisle to where I was standing talking in another language on the phone. As I walked to the back of the premise to check the plans, Mr Kerai stated that the door was now locked. I asked Mr Naseef to unlock the door and he replied that his boss had the keys and he had no access. Mr Naseef had become very shakey at this point and his stuttering worsened. I believed that Mr Naseef was hiding something from me and explained that the door had just been unlocked. It seemed at this point that the person Mr Naseef had been on the phone to was in fact one of the persons downstairs telling them to lock the door from the inside so that I could not gain access.

I asked him to open the door immediately and so he started banging on the door after which I heard a voice say hello. It took a few minutes for a male to open the door from the inside of the basement, he appeared to have been sleeping. There was a very strong, stale smell that came from the basement as I moved towards it. For safety reasons I asked Mr Kerai to wait at the top of the steps whilst I went down to check the basement. When I reached the bottom of the steps, there were three bedrooms and a shower (see Appendix 2), the smell was unbearable and I had to cover my nose and mouth whilst I walked through. There was also an area in the corridor where food had clearly been cooked, this looked hazardous (see Appendix 2). There was a door that led to an outside area but it was too dark to check what may be outside. I was also aware that there may have been more people downstairs who may have moved to the outside area and so it felt risky to approach this on my own.

As I came back upstairs I asked why there were bedrooms set up in place of what was clearly marked as a storage area on the plans. Mr Naseef replied by saying they weren't used as bedrooms, it was just somewhere for staff to go down to eat. I left the premise at approximately 01.03hrs.





There were a number of concerns raised during both visits that have prompted me to refuse this application;

- Condition 4 states 'A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol'. Mr Naseef is not a personal licence holder. This is a clear breach of the Premises Licence. Additionally, although Mr Naseef spoke English, in my opinion he was not fluent in English, although he appeared to be hesistant to talk to me so I'm not sure whether this is the reason why.
- The alcohol was clearly still on display for sale when I entered the premises at 00.40hrs yet the licence states that the premise should be closed at 23.00hrs. Mr Naseef confirmed that the premises is normally opened until 02.00hrs on a weekend and 23.00-00.00hrs during the week. This is a clear breach of the Premises Licence.
- In my opinion Mr Naseef was not being honest about the use of the area in the basement and I believe that it was in fact being used as 3 bedroom flat. On checking with Planning, they confirmed that there is no planning permission in place for a change of use from commercial to residential and therefore no Council Tax has been paid for the 3 bedroom flat.

A further visit took place on Friday 19th June at 23.55hrs and I found that the premises was again still open. The premise should have been closed at 23.00hrs as per my previous visit. On this occasion there was a different male behind the counter who I now know to be Mr Malik Mehdi, Mr Hamid Raza's (the owner) brother. I asked to see his personal licence, which he produced and I wrote down the details on the card.

When I asked Mr Mehdi why the premises was open after 23.00hrs, he replied by saying that Mr Raza had attempted to call me but I hadn't returned his call. I explained to Mr Mehdi that whether or not I had spoken to Mr Raza, his duty as a Licence Holder and DPS was to abide by the conditions of his licence and it was clear he had failed to do this. I told Mr Mehdi that this would not be accepted as an excuse for him to open the premises after 23.00hrs. I told Mr Mehdi he would need to close the premise immediately.

There were a number of concerns raised during my second visit that has prompted me to refuse this application;

- When I accessed Brent Council's alcohol Licensing system I was able to verify that Mr Mehdi had failed to notify Brent Council of his change of address contrary to section 127 of Part 6 of the Licensing Act 2003. I became aware of this since Mr Mehdi is a DPS at two other premises in Brent alone and the home address he has given for those premises is different. It is apparent that Mr Mehdi is not aware of his duties as a Personal Licence Holder and this leads me to be concerned about his involvement in Arada Mini Market.
- When I went downstairs to check the basement again I found that all of the room furniture had now been removed and piled up into one room (See Appendix 3). This has caused me to further believe that the basement is being used as a three bedroom flat and it was as a result of my visit that the furniture had been removed.





It appears that if I had not visited in the first instance, the three bedroom flat would still be in use, and no Council Tax would have been paid. I believe that Mr Raza is covering up the use of a residential property with a commercial unit that is governed by a Premises Licence. This is not what I believe a Premises Licence was designed for.

The principle Grounds for Objection – Crime & Disorder & Public Safety.

As reported above, the licensee has failed to comply with the Licensing Act 2003 in varying degrees and I believe this contravenes both the **Crime & Disorder** and **Public Safety** objectives;

- Opening after licensable hours
- Alcohol on display for sale outside of the licensable hours
- No Personal Licence holder present at the premise as per condition 4
- The use of a commercial property as an unauthorised residential property without planning permission which is governed by a Premises Licence
- The safety of those people living in the three bedroom flat and those customers using the premises as the eating area in the flat downstairs appeared to be hazardous
- The dishonesty of the staff at the premise who attempted to hide the three bedroom flat which leads me to question their integrity.



An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a premises licence under section 17 of the act. The Police representations are primarily concerned with crime and disorder.

Police require the following points should be included in the operating schedule or added as conditions on the premises licence.

Personal Licence Holder

The sale of alcohol to drunken people and children is a major cause of concern to police and highlighted in the Governments Alcohol Harm Reduction Strategy. Those who sell alcohol should be fully aware of the legislation and issues around alcohol and should be fully trained to a national standard.

Open Containers & Areas for Consumption of Alcohol

Customers will not be permitted to take open containers outside the premises, as defined in the plan submitted with the operating schedule and approved by Responsible Authorities.

The consumption of alcohol will be restricted to those parts of the premises identified on the plan submitted with the operating schedule and approved by the licensing authority.

Closed Circuit Television (CCTV)

Good quality CCTV is essential as a deterrent for the prevention of crime and the detection of offenders. It allows for both covert and overt monitoring of the premises. With proper signage, this reassures both staff and clientele, that this is a safe environment where illegal activities are not tolerated.

Closed circuit television cameras and recorders of an agreed image standard will be installed at locations on the premises and in accordance with advice from the Police.

All cameras and recording equipment will be installed and maintained in accordance with Home Office Guidance and the manufacturers instructions and will be fully operational when the premises are open to the public.

Notices shall be displayed at the entrance to the premises, and in prominent positions throughout the premises, advising that CCTV is in operation.

Capacity Limit for Premises

Proper control of the numbers of people in the premises is essential to prevent overcrowding and the risk of disorder. It is impossible to conduct any meaningful risk assessment, without knowing the maximum number of people that may be safely accommodated at any one time. There must also be adequate facilities to monitor and control the number of people present The capacity limit will be set by Officers from the Local Authority.

Operating Hours to be displayed on Premises

A notice displaying the opening hours, the type of licensing activity and licence conditions should be clearly displayed and visible to anyone <u>outside</u> the premises. This may be incorporated in the summary of the licence, which must be displayed, or take the form of a separate item.

Likewise the name of the Designated Premises Supervisor (D.P.S.) if required should be similarly displayed.

This will allow the Police and other responsible authorities to readily identify the licence details. Clearly displayed opening hours will also reduce any confusion for customers prior to entering the premises and possible conflict when the premises close/stop selling alcohol. A Summary of the Premises Licence will be displayed at the public entrance to the premises.

Notting Hill Carnival

This must be an important inclusion for any premise in this location on the borough

The conditions that Police require to be added to the Premises Licence are listed below:

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.

A CCTV camera shall be installed to cover the entrance and external terrace area of the premises.

Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

A "Challenge 25" policy shall be adopted and adhered to.

Alcohol shall only be supplied as an accompaniment to a substantial meal, seated at a table or awaiting to be seated at a table. If there is no prospect of a table becoming available then alcohol is not to be supplied.

Alcohol supplied whilst awaiting a table must be consumed in the drinking area as highlighted on the plans submitted with this application

An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.

A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

The outside terrace area shall cease at 2100hours.

Please accept the statement below as my formal representation against the application for a new Premises Licence.

As a Responsible Authority I have been asked to consult on the above application with regards to the licensing objective the Prevention of Public Nuisance. The proposed ground floor licenced establishment forms part of a 5 storey mixed use development comprising of residential units sited directly above. The application is in pursuance of the following licensable activities;

Provision of Late Night refreshment from 23.00hrs – 00.00hrs and The Supply of Alcohol on the Premises 11:00hrs – 00:00hrs on all days.

On 27th February 2015 I discussed my concerns of potential noise / smoke nuisance generated from the use of the front outdoor seating area with the previous licensing agent Mr Beyer and more so at the premises with the proposed applicant Mr Kola William on 11/3/15. During our discussion I suggested the additional conditions mentioned below to alleviate potential public nuisance;

- 1) No amplified sound shall be played outdoors or within the external seating area when premises licence is in operation.
- 2) No vertical drinking shall take place outside the venue or within the designated external seating area.
- 3) A canopy shall be installed over the designed external seating/smoking area, it shall be so designed to ensure that smoke/ smells emissions shall not cause nuisance within any residential or unassociated premises. The canopy shall remain in situ and maintained for the duration of its use.
- 4) The number of patrons utilizing the outside seating area shall be restricted to no more than 10 people at any one time. (this was increased to 15)
- 5) The use of the outdoor seating area shall be restricted up to 21.00hrs on all days.

During further discussions as well receiving confirmation of amended plans a 50% increased on the outside seating numbers from 10 to 15 people was deemed reasonable taking on board the 21.00hrs finish. The applicant has requested a later finish of 22.30hrs on this initial application which he wants to retain with a maximum seating capacity of 18 people. Although the licensing agent was in agreement in principle with points 1,2 and 3 there was no formal amendment to the application to include these as conditions on the licence. There has not been any response from the current Licensing Agent to my last correspondence dated 19/06/15 (attached).

If the Council is mindful to grant this licence in its entirety without suggestions 1-5 forming part of the conditions on the premises licence, I will not be satisfied that the licensing objectives the prevention of public nuisance has been met.
