

Police Representation to the Application for a variation of premises licence for Winemart, 48 High Road, Willesden, London NW10 2QA.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

An officer of the Metropolitan Police Service, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to vary the premises licence under section 34 of the act.

The venue is currently holds a premises licence to supply alcohol Sunday - Thursday 12:00-0100 and 12:00-03:00 Friday - Saturday.

The applicant has applied for the removal of condition number eight (8) which reads, 'No high strength beers, lagers and ciders above 5.5% ABV shall be stocked, with the exception of Guinness Foreign Stout and Dragon Stout'.

The applicant has requested that condition number eight (8) be re-worded to the following: 'No high strength beers, lagers and ciders above 9% ABV shall be stocked as well as the following brands: Kesteral Super, Skol Super, Tennants Super, Special Brew, K Cider, Strongbow Super, Ace Cider, Okocim Black, Crest Super and Warka Strong.'

The Police representations are primarily concerned with crime and disorder and public nuisance.

Street drinking is a major concern in Brent. So much so, the entire borough remains a controlled drinking zone (CDZ). Street drinking is a trigger for crime, disorder and

nuisance to the community. Brent police and our partners have worked extremely hard to lessen this problem, particularly in and around Willesden High Road. One major hotspot being outside Willesden Library, which is very close to the premise in question.

Street drinking in and around the vicinity of the applicants premise remains an issue. The following summaries have been taken from recent police reports in respect of street drinking:

- 1. Criminit QKRT00442685 dated 09/01/2015 refers to a police officer seizing alcohol from a street drinker. The street drinking was issued with a direction to leave the area for 24 hours under s.27 Violent Crime Reduction Act 2006.
- 2. Crimint QKRT00445275 dated 05/03/2015 refers to police officers seizing alcohol from a street drinker on High Road, NW10.
- 3. Crimint QKRT00446266 dated 31/03/2015 refers to people drinking in the toilets of a betting shop on High Road, Willesden.
- 4. Crimint QKRT00445802 dated 17/03/2015 refers to police officers stopping two males street drinking on High Road, Willesden. Both had alcohol seized from them.

Further, I conducted a walk through of the vicinity of the shop. I found numerous discarded alcoholic tin cans on the floor of the alleyway which runs between Ellis Close, NW10, which is directly in front of Winemart and Richmond Avenue, NW10. Quite clearly, this area is still being used for street drinking. I attach a photograph of this area in the supporting document attached.

I understand that this variation application has come about after officers from Brent police licensing unit conducted enforcement visits throughout this year. The first being back in January 2015, when PC McDonald visited the venue and found staff selling, 'vast amounts' of high strength alcohol above 5.5% ABV, breaching condition eight (8) of the premises licence. PC McDonald issued Mr. Singh, who is the premises licence holder and DPS, a warning letter. I then re-visited the premise on 24th September 2015 and again found nineteen (19) beers, lagers and ciders over 5.5% ABV for sale, along with numerous other breaches of the premises licence, despite already being warned by police.

Following these second round of breaches I held a meeting with Mr. Singh at Brent civic centre to discuss the matter. He assured me that these breaches would be rectified immediately. I issued him with a final written warning. He went on to say that he is in the process of submitting to the local authority, a variation application, to amend his high strength condition. He told me that he would like to sell some 'premium Belgian beers'. I was of the understanding that the applicant was wishing to name a few Belgian beer brands to attach to his premises licence. However, the application he actually submitted is not asking for a 'few Belgian beers', but a high strength condition of 9% ABV with the exception of some high strength beers. This condition would allow the applicant to sell a whole host of other high strength beers, lagers and ciders up to 9% ABV.

I visited the premise once again on Monday 7th December 2015, to speak with the applicant about this application, however, he was not there. I conducted another licensing inspection and there were yet more breaches of his premises licence. There

was one high strength product on display, no personal licence holder present, staff had not been given cash minimisation training amongst other breaches.


In summary, I suspect that the grant of this application will fuel the street drinking problem, in and around Willesden High Road area. As such, this will undermine the licensing objectives in respect of crime, disorder and public nuisance. It will undo all the work that has been put into lessening the problem. At this time, I have no confidence in the management of this premise in upholding the licensing objectives. The reason for this being that there have now been THREE separate breaches of their premises licence since January 2015, which amounts to an offence under section 136 Licensing Act 2003, of carrying out unauthorised licensable activity. This is despite two warning letters (attached as supporting documentation) and advice from police. At the time of writing this letter, I am currently in discussions as to what, if any, enforcement action to take against this shop in relation to the most recent breaches.

Having taken all of the above into account, police would respectfully request that this application is <u>refused</u>.

On Friday 9th January 2015 at approximately 2300 hours I visited The Wine Market, 48 High Road, NW10 2QA where you are listed as the designated premises supervisor and premises licence holder. I spoke to the solitary member of staff Mr Getenal Amne, he told me he was not a personal licence

holder. The premises were open to the public and alcohol was being sold.

There was no premises licence displayed.

I noticed there was a vast amount of high strength beers and ciders above 5.5% ABV.

I have obtained a copy of the premise licence and condition 5 reads;

No high strength beers, lagers, and ciders above 5.5% ABV shall be stocked with the exception of Guinness foreign stout and Dragon stout

During my recent visit I identified a vast amount of products above 5.5% ABV that are not on your exemption list. These beers and ciders must be removed from display and not sold in the premises.

In addition there is signage outside the shop advertising free delivery of alcohol. Your authority does not permit this activity, can this be addressed.

FINAL WRITTEN WARNING

Dear Mr. Singh,

I am writing this letter in response to my licensing visit at **Winemart**, **48 High Road**, **Willesden**, **London**, **NW10 2QA** on Thursday 24th September, when the premises was open to the public and alcohol was on sale.

My attention was drawn to your premise, as the front door was wide open and when I walked past, I notice a young child (aged around 7 or 8 years old) stood on her own, behind the serving side of the counter till area. On the opposite side was an adult male stood talking to her. I went inside and spoke with the male who identified himself as a police officer. Mr. Getenet Amene told me that he was the shop manager. He told me that the child was his daughter. I enquired as to why she was not at school. He said that her school had a teacher training day and that his wife had a doctor's appointment. He did not wish to miss his shift, so he took his child to work with him. I pointed out that there is no harm in taking her to work with him, but having her behind the counter area on her own in an off-licence (despite the fact he was stood opposite her) undermines the protection of children from harm licensing objective, in my opinion. My point was proven when a customer came into the off licence and asked her for a packet of cigarettes. Mr. Amene swiftly removed her and served the customer himself. His child was later picked up by his wife and taken home. I appreciate that there were no offences committed on this occasion, but it is something to be mindful of in the future. I would suggest, and best practice would dictate, that no person under the age of 18 is allowed behind the serving side of your counter in the future, and that you make all staff aware of this.

Whilst in your shop, I decided to carry out a full licensing visit. The following breaches of your premises licence were discovered;

1. There was no sign reading, 'No proof of age - No sale'. **This breaches condition number one (1) of your premises licence.** A sign must be placed up at the point of sale reading the exact words as above.

- 2. Mr. Amene was unaware of how your age verification policy works. There were no 'Challenge 21/25' posters displayed. **This breaches condition number two (2) of your premises licence.** Free posters can be found at www.challenge25.org Please ensure that all staff understand your age verification policy and that it is implemented.
- 3. The following were stocked within your premise: IN CHILLER CABINET (BOTTLES): 1. Jaipur Ale (5.9%) 2. Raven IPA (6.6%) 3. Thirsty Cross Cider (6.9%). 4. Aspall Organic Cider (7.0%) 5. Leffe Beer (75cl 6.6%) 6. Desperados (5.9%) 7. Desperados Red (5.9%) 8. Duvel (8.5%) 9. Chimay Ale Red (7.0%) 10. Chimay Ale Blue (9.0%). CANS IN CHILLER CABINET: 1. Warka Strong (6.5%) 2. Zubr (6.0%) 3. Zywier (5.6%) 4. Desperados (6.0%) 5. Perla (6.0%) 6. Debowe (7.0%). ON SHELVES: 1. Guinness West Indies Porter (6%) 2. Torpedo Extra IPA Beer (7.2%) 3. Leffe Beer (6.6% 330ml). This breaches condition number eight (8) of your premises licence. These items are not permitted to be sold in your shop. I am aware that these have now been removed by your staff. I would suggest that you personally oversee all stock purchasing and ensure that only products at 5.5% ABV and under are stocked.
- 4. There was no time delay safe with anti fishing mechanism fitted to your counter till area. This breaches condition number ten (10) of your premises licence. To comply with this condition you need to purchase a safe with the correct requirements and it should be placed under your counter till area. Police cannot recommend suppliers, but these can be found for around £100-£200 on the internet.
- 5. There was no incident book. **This breaches condition number nine (9) of your premises licence.** Licensing incident books can be found on the internet. Alternatively, you can use an A4 book and record incidents, as listed on your premises licence.

On Monday 12th October 2015, I met with you to discuss these breaches in full. You informed me that these issues will be rectified. Further, you told me that you wish to sell premium Belgium beers and as such have submitted a full variation application to the London borough of Brent.

In relation to these breaches, I am aware that you have already been issued a warning letter by PC McDonald back in January 2015. Having given some consideration to the fact that you are addressing these issues and have worked positively with police in order to resolve these issues, please accept this letter as a <u>final written warning</u>. I must point out that any subsequent breach will result in police considering applying to the local authority for a review of your premises license.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to Vary premises licence under section 34 of the act 2003.

The condition they are requesting to be varied is the

Supply of Alcohol - from 06.00 to 24.00 Monday to Sunday.

Hour's premises open to the public - 06.00 to 24.00 Monday to Sunday.

The applicant Mr Sithamparanathan Kirubendran has made an application to vary his premise licence, and is asking to vary the hours for the sale of alcohol.

The premises currently have a licence allowing the sale of alcohol from 08.00 hours until 23.00 hours Monday to Saturday and 10.00 hours until 22.30 hours on Sunday.

The applicant is asking for the hours to be varied for the sale of alcohol, and the hours the premises are open to the public from 06.00 hours until 24.00 hours Monday to Sunday.

On receiving this application I contacted the applicant by phone to discuss it with him, he informed me that he wants to vary his hours to catch the passing trade of Eastern Europeans that are either going to, or leaving work at the nearby industrial estate, he stated that he was losing out to other local shops that sell alcohol to these males, it was pointed out to the applicant that Brent is a controlled drinking zone, and that most of these males would most probably be congregating in the street drinking, and for the premises to sell to street drinkers would be against the licensing objective, namely Prevention of Public Nuisance, the applicant was then asked if he was aware of the licensing objectives and replied 'yeah it's something to do with selling to drunks'.

This was also apparent when reading the application, as in Part P where the applicant is asked to detail how they are going to promote the licensing objectives, the applicant has written in each box 'Nothing beyond existing Health and safety, Fire safety and Etc' this goes to show a complete lack of knowledge and understanding of what is expected of a responsible licensee. The above telephone conversation is a concern as it appears that the applicant has seen a profit making opportunity and has not considered the potential implications to the local community of street drinkers that will congregate to consume their beers at the end of their shifts or even more worryingly males drinking alcohol before the start of their working day.

On the 11/12/2015 police officers conducted a licensing visit at the venue Mr Sithamparanathan Kirubendran was not present, but was called by a member of staff and arrived shortly after and we went through the conditions on the licence, there were numerous breaches to the licence conditions, namely - 1. Alcohol screen not lockable 2. No time delay safe 3. No incident book, Mr Sithamparanathan Kirubendran handed police a refusal book which had one entry in it dated 27/10/2014, it was explained to him that this was not an Incident book. 4. The following high strength was on display: 1. Dragon Stout

(7.5%), Spockie (7%), Warka Strong (6.5%), Okocim (7%), Debowe (7%), Perla Mocne (7.6%), White Star (7.5%) and Tatra (7%). All high strength was removed. Officers also found a half tube of white plastic cups behind the counter, which possibly indicates that the shop is selling the cups to customers to drink their alcohol in.

After considerable consideration I feel that allowing this premises to supply alcohol from this time of the morning will be detrimental to the licensing objectives, the applicant has shown no knowledge or consideration for the licensing objectives and appears to be putting profit ahead of them, allowing the sale of alcohol from a petrol station during these hours with the lack of thought shown by the applicant can only be harmful to the local community as a whole, and as such I will be objecting to this application.

I am writing this letter in response to my licensing visit to Premier/Party Shop, Wood church Filling Station, Church Lane, London, NW9 8SL, on Friday 11th December 2015, when the venue was open to the public and alcohol was being sold.

My licensing visit was as a result of you putting in an application to vary your Licence, during my visit you were present and we went through the current conditions on your licence.

Condition 4 on the licence reads, No High strength beers, lagers, and ciders above 6.0 % AVB shall be stocked. On checking the shops fridge I found seven high strength beers all above 6.0 % AVB, namely Dragon Stout 7.5% AVB, Spockie 7.0% AVB, Warka Strong 6.5% AVB, Okocim 7.0% AVB, Debowe 7.0% AVB, Perla Mocne 7.6% AVB, and Tatra Mocne 7.0% AVB.

I asked you to remove these beers, which you did.

I then asked to see your Incident Book, Condition 5 of the licence states, An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the police, which will record the following (a) all crimes reported to the venue, (b) all ejections of patrons, (c) any complains received, (d) any incidents of disorder, ((e) all seizures of drugs or offensive weapons, (f) ant faults in the CCTV system or searching equipment or scanning equipment, (g) any refusal of the sale of alcohol, (h) any visit by a relevant authority or emergency service. You spent some time looking for the incident book but were unable to find one, you then produced and handed me a refusal book which had one entry in it, dated October 2014, it was explained to you that this was not an incident book and that one would need to be started and used immediately.

I then asked you to show me the shops time delay safe, Condition 9 reads, The following crime prevention measures shall be implemented; A time delay safe with deposit slot and anti fishing mechanisms must be used at the counter till area. You showed me a key safe that was situated under the floor behind the counter area, it was explained to you that this did not meet the condition on your licence.

I then looked at your fridge and shelves that held the alcohol stock, to see if they complied with licence condition number 8, 'Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grades creens or locked cabinet doors so as to

prevent access to the alcohol by customers or staff'. On checking the fridge and shelves, there was only a pull down screen on the fridge, which was not lockable, I made you aware of the condition and what needed to be done. I must point out that these breaches amount to an offence under section 136 Licensing Act 2003, namely conducting licensable activities without authority, which carries a fine of up to £20,000 and/or up to 6 months imprisonment. However, I have taken into account the fact that you removed all the high strength alcohol from the fridge, and that all other conditions will be complied with by the 01/02/2016 As such, please accept this letter as a formal 'warning' on this occasion. Please call me on the above telephone number if you would like to discuss this further.

The protection of children from harm

Jono's is failing to promote three of the licensing objectives, namely The prevention of Crime and Disorder, Public Safety and The prevention of publice nuisance.

As a result of several incidents Police have no faith in the ability of the management to operate the premise responsibily under the current aurthority and therefore wish to bring the matter before the sub-committee for consideration. Police are primarily concerned with the severity of the crime and disorder occurring from the venue as a result of complete disregard of the existing conditions.

On the 5th January 2015 a warning letter was issued after the CCTV was found not to be working, this came to light in the investigation after the assault on 3rd January 2015.

In addition to the existing conditions Police would like the following attached to the licence:

- 1. Door supervisors of a sufficient number and gender mix, shall be employed from 21:00 hours on any day when the premises are open to the public past midnight.
- 2. A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.
- 3. Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.
- 4. Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.
- 5. No entry or re-entry shall be permitted after 23.00 hours.
- 6. Toilet checks hourly which must be logged and signed off
- 7.Drug policy and increased signage
- 8. No use of the back yard
- 9. The rear fire door(which cannot be locked) will be alarmed
- 10. Toilet areas to be treated daily to prevent drug usage
- 11. A personal licence holder is to be on duty at all times throughout the hours of opening.

LONDON, NW9 8UA Glass window was smashed at the front entrance door 03/01/2015 0204

I was driving QK80N and I was assigned to an I grade call along with a couple of other units to attend JONO'S PUB, 458 CHURCH LANE, NW9 8UA. The initial call was to 40 males fighting in the pub. I was first on scene and it was clear a disturbance had taken place at the venue. The front glass doors to the pub had the glass smashed in them and there was broken glass scattered inside the pub. From a licensing point of view the licensee a Mr Kenneth McCORMACK dob 13/12/1962 made himself known to me however he was very vague with information.

The majority of people present in the pub were there for a 21st birthday party, apparently a group of 4-5 males who were not a part of the party were drinking in the pub. An argument between this smaller group and a couple of males from the party has escalated into a fight, as a result one male from the party was hit over the head with a glass and a second male hit over the head with a stool. Both suspects were from this small separate group of males. There were approximately 40 people in the pub on our arrival, they were not local to the area however they seemed convinced the smaller group were local guys who drink in the pub regularly. The landlord and the bar staff stated they did not know the group nor could they provide any kind of descriptions of any of these males despite them having stood close to the bar for much of the evening and ordered drinks. I suspect the landlord and bar staff know more then they were letting on to us. This is partly due to the suspicious behaviour of one barmaid who is the landlords daughter, she took a phone call whilst officers were present and was very quick to take the phone outside to speak out of officers ear shot. Furthermore the pub has no CCTV cameras in place, I asked the landlord Mr McCORMACK if I could see his licence and he stated he had not been sent it yet from the council and he has been waiting since August 2014. When asked what time he had a licence to serve alcohol till he said it was 01:00 and he was doing last orders till 01:20. We arrived on scene around 02:10 and there were full glasses of drinks on tables, I don't think the landlord was being entirely honest with officers regarding what time he served till and I also believe he withheld information about the suspects. In total there was 4 CADs in relation to this incident, 728, 736, 790 and 859. Also for reference Cris 1900147/15 is in relation to this incident. This email is purely for information purposes only, if you require anything further please don't hesitate to contact me. PC Tej Johal

1905532/15. 8/3/15 outside venue - On being searched under S32 PACE a small wrap of white powder was found in his left trouser pokcet. When asked what it is, he replied "That'll be a further arrest."

He was further arrested for possession of a class A drug at 1645 hours. The substance has been EDIT tested in custody and confirmed as cocaine. Summary - D stated that on 8th March 2015 whish he was at his home address he had been drinking a little and he wanted to go to the pub but his wife did not want him to so they got into a verbal argument which took place in the flat and spilt out onto the street up until the taxi took him away. He denied in assaulting V in any way and said that she had done this because she didn't want him going to the pub without her.

With regards to the drugs he fully admitted that it was his and for his own use. He said that he paid £20 for it from an unknown male. He said that he did not have the drugs in his house and he would not do that as his daughter is there.

1911025/15. 13/5/15 outside venue - On 13/05/15 at about 2000 hrs Susp1 was stopped after he was seen getting out of a white Citreon VRM RE13FCA and walking towards JONO'S PH. He was stopped just before he reached the pub and was extremely nervous. He was detained for a seach Sec 23 MDA. Prior to search PC MORRISON 384QK asked - Q: "HAVE YOU GOT ANYTHING ON YOU?" A: "YEA I HAVE" Q: "WHAT HAVE YOU GOT?" A: "JUST A COUPLE OF LINES. FOR MY OWN PERSONAL USE". He was searched and found to be in possession of a yellow KINDER EGG containing a wrap of suspected cocaine. PC MORRISON therefore arrested him at 2003 hrs for possession of Class A drugs. No reply to caution. Susp2 was also detained for a Sec 23 MDA search after getting out of the car shortly afterwards. Nothing was found initially but when he was informed he was going to be strip searched he admitted having cocaine concealed in his underwear. He was therefore arrested by PC SYMONDS 529QK at 2011 hrs for possession of cocaine. After being booked in he was strip searched where he was found to be in possession of a KINDER EGG containing Three (3) wraps of suspected cocaine.

1919785/15. 25/8/15. On the 25.08.15 between the period of 16:15 and 17:00 the victim had their mobile phone stolen from behind the bar whilst it was charging. The victim Rebecca MCCORMACK is a member of Bar Staff who works at the venue. The victim Rebecca left her Iphone 6 behind the bar charging at approx. 16:15 she returned to check it at 17:00 when she realised it was gone with the charge still connected to the wall but the phone missing.

1923232/15. 5/10/15 outside venue. at approximately 1425 hours police were called by VIW1 who stated a male had been attacked outside his pub. The victim was a customer who stepped outside and then came back in with his head spilt open. Hi Nick, I was out with the Gangs unit last night when we went into Jono's PH. This place needs a serious look at it's licence. The female (daughter of landLord) was serving behind the bar. Her attitude, although ok, indicated to me that she was fully aware of what was going on in the pub. She was in conversation with another punter trying to defend the guy who was nicked. Not the behaviour wanted from someone working behind a bar. The bar bench seats were loose with a vast space beneath suitable for hiding drugs. I told her these needed to be nailed down. The bins in the back yrd were also unlocked allowing for dealers to keep their drugs inside (Kinder egg with wraps in found inside by drugs dog). There is no/little lighting in the back allowing for a 'blind eye' to be made re the drug dealing. I have no doubt that the landlord knows exactly what is going on. The bar woman was unable to contact her Father for most of the time there as we wanted the CCTV and she had no idea how to work it. ..apparently. When I told her customer would remain in police custody until we obtained the CCTV she then suddenly was able to make contact with him. From speaking to PS Braithwaite his team have spoken to the landlord in the past about the 'customer' drug dealers he serves but this has not been acted upon.

1926041/15 burglary 03/11/2015 15:00:00 Upon arrival, police spoke to VIW1 who stated that he owns the pub and it was discovered by VIW2 that the pub had been burgled. The pub had been left secure last night 03/11/2015 at 2330 hours by VIW1. VIW2 went to the pub at 0710 hours this morning and found that t had been broken into and informed VIW1. VIW2 stated that he is the cleaner and went to turn on the lights but tripped over wires behind the bar. Upon turning the lights on, he found that the sky and cctv systems had been stolen, there was an untidy search behind the bar, The fruit machines had been smashed and the money had been removed, A vodka bottle had been taken from behind the bar and thrown at one of the fruit machines. VIW2 checked the windows and found that none of them had been broken then realised that the back door was ajar and entry must have been gained that way. There was also a chisel found behind the bar that does not belong to VIW1 or VIW2, it is believed to belong to the suspect. There were wood chippings on the floor by the back door suggesting they used it to enter the building.

Spoke to the occupant upstairs who said that she heard noise at 0300 hours, she heard someone at her door and thought someone might be trying to break in. The door to her flat is also accessed through the back alley.-5/11/18 NM .

No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise):
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).



- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first day ||) would be different from the permitted price on the next day (—the second day ||) as a result of a change to the rat e of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Requirement for a DPS

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.

- 3 No drinks shall be served other than in plastic or toughened glasses.
- 4 A "Challenge 21" policy shall be adopted and adhered to.
- 5 An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (e) all seizures of drugs or offensive weapons

- 6 Signs altering customers to theft shall be displayed.
- 7 A clear and unobstructed view into the premises shall be maintained at all times.
- 8 A suitable intruder alarm shall be fitted and maintained.
- 9 All doors and windows shall remain closed during any licensable activity and where a door is used for patrons to enter or leave the premises the door shall be lobbied and fitted with a self-closing device.
- 10 All regulated entertainment shall conclude 30 minutes before the premises are due to close each day
- 11 The maximum number of persons permitted within the premises shall not exceed 60 including staff if the doors remain inward opening. These doors shall be locked back in the open position whilst the public is on the premises.
- 12 Both front and rear roller shutters shall remain up and in the fully open position whilst the public are on the premises.
- 13 Any locks or flush latches on the exit doors shall be unlocked and kept free from fastenings other than push bars whilst the public are on the premises.
- 14 Any socket outlets (or other power supplies used for DJ equipment, band equipment and other portable equipment) that are accessible to performers, staff or the public shall be suitably protected by a residual current device (RCD having a rated residual operating current not exceeding 30 milliamps).
- 15 The use of external seating area will cease no later than 23:00 hours.
- 16 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 17 No noise or vibration shall be detectable at any neighbouring noise sensitive premises
- 18 All doors and windows shall remain closed during any licensable activity.
