

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the act.

The Police representations are primarily concerned with the prevention of crime and disorder, and the prevention of public nuisance.

**The following hours which differ from the hours stated in the application have been <u>agreed</u> between the applicant and the police: **

Supply of alcohol:

Sunday - Wednesday 12:00 to 23:00 Thursday - Saturday 12:00 to 00:00

Late night refreshment:

Sunday - Wednesday None required as the premise will close at 23:00 Thursday - Saturday 12:00 to 00:00

Recorded Music:

Sunday - Wednesday 08:00 to 23:00 Thursday - Saturday 08:00 to 00:00

Hours premises are open to the public

Sunday - Wednesday 08:00 to 23:00 Thursday - Saturday 08:00 to 00:00

<u>However</u>, having agreed these hours with the applicant, I have realised that the 'supply of alcohol' hours would not provide her flexibility for customers to consume their drinks before closing time and thus we may have a later dispersal time than advertised, with the increased risk of public nuisance. The only change to the agreed hours will be 30 minutes less for the supply of alcohol so customers can 'drink up' with sufficient time before closing. No other changes to the agreement. I have spoken to the applicant, who wished for time to think about this as she has already agreed to a two hour reduction from the proposed hours, which I fully understand and appreciate.

The prevention of public nuisance and the proposed rear garden area

Having met with the applicant and discussing my concerns regarding the use of the rear external garden and the potential it has to cause serious nuisance to residents, particularly those in Churchill Road, the applicant has agreed reduced hours in terms of licensable activity and the hours the premises will remain open. The initial plans submitted to the licensing authority showed no internal access route into the rear garden via the premises itself. Patrons would have had to used the public pavement on Churchill Road and accessed the garden via a wooden gate. I had serious concerns about this particular proposal and the applicant went away and spoke with her architect. She has come back with revised plans and a new access corridor will be constructed to prevent patrons having to use Churchill Road. However, the general noise from this rear garden area will likely travel along the road affecting the Churchill Road residents. In my professional opinion and experience, the only way to mitigate any likely breach of the 'prevention of public nuisance' licensing objective, is

to close the rear garden area late in evening. Failure to do so, generally results in complaints from the residents to the police and the council's noise team.

Having visited the premises I note that the garden, is approximately three (3) metres away from the ground floor front window of a residential property situated at number 1 Churchill Road. The rear garden is wholly situated within a residential area. Given that the close proximity of the rear garden area and residential properties police would ask that the garden are is closed to both patrons and staff after 9.00pm daily. Further, I understand that the applicant wishes to play background/recorded music into the rear garden. This would add to the noise in this area. Police would ask that no music of any nature is played into the rear garden.

Operation of the premises

The applicant has informed me that the premises will be used as a restaurant/bar. As such, the applicant wanted the flexibility of her customers being able to come in and have a drink without food. As such, conditions added below will allow the premises to be used in such a way as the applicant wishes to, but assists her to uphold the licensing objectives at the same time.

Operating Hours to be displayed on Premises

A notice displaying the opening hours, the type of licensing activity and licence conditions should be clearly displayed and visible to anyone outside the premises. This may be incorporated in the summary of the licence, which must be displayed, or take the form of a separate item. Likewise the name of the Designated Premises Supervisor (D.P.S.) should be similarly displayed. This will allow the Police and other responsible authorities to readily identify the licence details. Clearly displayed opening hours will also reduce any confusion for customers prior to entering the premises and possible conflict when the premises close/stop selling alcohol.

The conditions that Police require to be added to the Premises Licence are listed below:

- 1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 2. A CCTV camera shall be installed to cover the entrance of the premises and further cameras installed to cover the rear external garden.
- 3. A "Challenge 25" policy shall be adopted and adhered to at all times.
- 4. A copy of the premises licence summary including the hours which Licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 5. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder

- (e) any faults in the CCTV system
- (f) any refusal of the sale of alcohol
- (g) any visit by a relevant authority or emergency service.
- 6. All alcohol must be kept behind the counter/bar area at all times with the exception of alcohol which has already been purchased/sold/supplied to a patron or alcohol which is in storage rooms on the premises.
- 7. Substantial food and non-intoxicating beverages shall be available during the whole of licensed hours in all parts of the premises where intoxicants are provided.
- 8. The supply/sale of alcohol for consumption on the premises shall be by waiter/waitress service only.
- 9. Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority (Annexe four of the premises licence).
- 10. The playing of live, recorded or background music shall not be permitted in the rear external garden.
- 11. Customers/staff shall not be allowed access/use of the outside rear garden from 21:00hrs daily.
- 12. No vertical drinking shall be permitted ay any time
- 13. All doors and windows shall be closed from 2100 hours daily, so as to prevent noise nuisance to residents. (NB: With the exception of the main entrance located on High Rd, NW10 which must be closed only when not being used for access and egress into or from the premises).

I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance.

On behalf of Regulatory Services (Environmental Health) I would like to make representations to the Application.

On the following grounds:

The operating schedule does not address the prevention of public nuisance from:

- Structure borne noise or vibrations from entertainment.
- Noise generated by patrons in external areas of the premises e.g. beer garden/smoking area.
- Noise generated from deliveries.
- Noise generated from refuse collections.
- Noise from plant and machinery.
- Cooking odour.

Conditions

Structure borne

All speakers are mounted on anti-vibration mountings to prevent vibration transmission of sound energy to adjoining properties.

Outside Areas

No music will be played in, or for the benefit of patrons in the beer garden or other external areas of the premises after 22:00.

No form of loudspeaker or sound amplification equipment is to be sited on or near the exterior premises or in or near any foyer, doorway, window or opening to the premises.

Signs shall be displayed in the beer garden/on the frontage instructing patrons to recognise the residential nature of the area and conduct their behaviour accordingly – The management reserve the right to ask patrons to move inside the premises or leave if it is felt that they could be disturbing neighbours.

The beer garden/frontage will be closed and patrons requested to come inside the main structure of the premises at 22:00 hours

Deliveries and collections

Deliveries and collections associated with the premises will be arranged between the hours 7am - 7pm so as to minimise the disturbance caused to the neighbours.

Glasses will be collected from the beer garden area at 22.00 rather than at closing time when neighbours in close proximity might be unduly disturbed.

Empty bottles and non-degradable refuse will remain in the premises at the end of trading hours and taken out to the refuse point at the start of the working day rather than at the end of trading when neighbours might be unduly disturbed.

Plant and machinery

All plant and machinery is correctly maintained and regularly serviced to ensure that it is operating efficiently and with minimal disturbance to neighbours arising from noise.

I write to object to the proposed licensing hours at the above-stated premises as per the notice posted on 18 Sept 2016. My concerns relate to the opening hours and provision of alcohol until 0200 on Saturday and Sunday mornings (late night opening Friday and Saturday nights).

As a corner business in a primarily residential area, I am deeply concerned that these late hours, complete with an application to play recorded music, will cause undue disruption and noise to the local community and exacerbate existing problems.

Willesden Green ward is already grappling to obtain effective policing across several areas of anti-social behaviour in and around the High Street that continue to disrupt the quality of life of local residents and businesses. They include public drunkenness, patrons spilling out of licenced venues onto the public pavement (both during and after closing time) and disrupting passersby in the evenings, violations of the existing drinking control zone, an increasing presence of rough-sleeping, street level begging, street level drug-dealing and other anti-social behaviour, including public urination in the streets. As you will be aware, a murder investigation is ongoing after an early June attack outside a late-night venue on the High Street in June of this year — that violent crime happened in a venue that is not licensed to serve alcohol.

For these reasons, I feel that the addition of another late night venue serving alcohol and playing music is not conducive to this family-friendly neighbourhood, both from a quality of life and personal safety perspective.

I am contacting your department to register an objection to the late licence application presented to you by Co Co Bs, 110A High Road., NW10 2PN. I believe the latest we can register an object is 28th September 2016. This email is dated 19 September 2016.

The proprietors of Co Co Bs, 110A High Road., NW10 2PN are requesting a late licence. Incidentally, there is very little information provided in the window of these premises or indeed online via the Brent Council for local residents to establish exactly what this new establishment will be. This is unacceptable. However, we have been led to believe that it will be a restaurant.

I strongly object and oppose the late licence that they are requesting. They are asking for a 2am late licence. This is not in line with other businesses in the area and the business is positioned at the top of Churchill Road, a quite residential street full of families and elderly folk. I speak on behalf of my family. I am a resident of Churchill Road and I am a mother of 2 children and do not want to have an establishment with a late licence operating at the top of our road.

There are possible consequences to such an establishment operating this late and into the early house of the morning. For instance, loud disturbances with parking cars, taxis, and of course loud voices. There is the added worry and possibility of attracting criminal elements to our area such as drug dealing and harassment.

I strongly object to the request of Co Co b s. I believe this new restaurant (as we have been informed it will be by a person who was doing the building work) should operate identical opening hours as other restaurant businesses in the area such as *The Social* at 21 Walm Lane NW2 - a Tapas restaurant (this is open until 11pm) and *Sanzio Restaurant* at 26 Station Parade - an Italian restaurant (open until 11pm). No exception should be made and this extended licence should not be granted as this is a residential area and the disturbances are too harmful and impactful to the local residents.

This is based mainly on the late licence for liquor being sought and the outside space creating noise in a residential area.


I also understand that a late music licence is now being sought and am told that it is planned to hire it out as a venue for weddings, party's etc.

I wish to raise the strongest objections to the proposed application for a restaurant on the corner of Churchill Road, from the points of view of the opening hours, late licensing sought by the applicant and outside yard. My objections relate to potential public nuisance, potential crime and disorder and the potential risk to public safety.

Churchill Road is a quiet, residential road. The proposed late opening hours during the working week and at the weekend and the late licence sought will have a severe impact, creating noise disturbance and the potential for rowdiness, loiterers and comings and goings late into the night. It is highly likely that the impact will be be felt further down the street too, as parking spaces are used for cars arriving and leaving at unsocial hours. Residents want to feel safe returning to their homes, whatever the hour or day of the week. With many of the houses divided into flats in Churchill Road, parking is already very limited, with residents finding it difficult to park near their homes.





Response from KS

Dear Linda

Thank you for outlining the concessions offered by the applicant.

I have to say that I don't feel reassured, because under these revised terms Churchill Road is still going to be adversely affected by the comings and goings of an increased number of people, well into the night, both during the week and at the weekend. This has implications for the personal safety and well-being of residents, and will increase the volume of vehicles in an already heavily congested parking area.

The proposed premises opening and closing times are out of step with any similar premises nearby - eg, Poise, the Brazilian restaurant on the corner of nearby Sandringham Road closes by 10pm Wednesday to Saturday, and 9pm Sunday to Tuesday. A licence to serve alcohol until 22.30 Sunday to Wednesday and until 23.30 Thursday to Saturday will make Churchill Road a magnet for the congregation of undesirables and put the safety of residents, leaving and returning to their homes, at risk. At the very least closing times should be brought into line with similar premises in the vicinity.

The area already has problems with drug-pushing, prostitution and general crime and the availability of alcohol at this venue at unsociable hours only risks exacerbating these issues.

Response from LW

Linda,

Thank you for your message but I am still unhappy with the new proposal. I feel it does not fully address my original objections that extended hours are likely to lead to. Therefore, I am will unwilling to withdraw my objection until the drinking and music hours are reduced in line with similar establishments in the neighbourhood.

Response from FS

Thank you for the details regarding above.

I agree that some concessions have been made but not certainly not enough to satisfy my and numerous others' concerns.

But he proposed still late hours for the supply of alcohol and playing of any kind of music will not address my and others original protests. Note, also the possibility of live music has not been addressed.

Objections such as:

- ** Hours significantly later than similar local establishments e.g. The Brazilian cafe/restaurant Poise.
- ** This late night venue will still be an attraction for drinking and partying with the certain associated problems for those living in residential Churchill Road. Already there is factual evidence of drug dealing and rowdy drunken behaviour in the area and this will no doubt add to an already intolerable situation.
- ** The parking situation for permit holders will be be made more acute, particularly for those returning home late in the evening this further deteriorate especially on Friday, Saturday and Sunday when restrictions are lifted.
- ** I'm reluctant to call it a 'restaurant' because I still feel the emphasis will be on drinking and music rather than fine dining. The original application for 2pm closing is a strong indication of intentions.
- · I will be willing to withdraw my objection if this 'establishment's' hours are in line with other similar establishments near by (around 10.30pm) but in the mean time I still have real concerns.

Dear Linda

Thank you for your email.

Please note that I do not want to withdraw my objection.

The times proposed for the supply of alcohol and music are far too late for a residential road and no other establishment close by has these same hours. I worry for the peace of the road which already has it's fair share of noise and can already be a thoroughfare attracting people you don't often - parking is already difficult & I would worry for my safety if I can't park close to my home as a single woman. I also worry about who the restaurant will attract - people leaving late and what this means for the residents on the street. Noise (unless the property has state of the art soundproofing which I doubt, the music will still be heard down the street - why should we even be subjected to noise up until 21.00?) and safety. I also worry about the effect this place will have on the ability to sell property this end of the street.

This establishment and hours proposed put a risk to myself and other residents. It is incredibly unfair.
