Jete Sete Night Club currently has a licence that allows it to open Sunday to Thursday between 10.00 - 02.30 hours, Friday and Saturday between 10.00 - 04.00 hours.

All other licensable activity finishes 30 minutes before the closing time.

The Premise Licence Holder is under a registered company, by the name of MCS INC Limited, and the DPS is Mr Antonio Eugenio Martins.

The premises are failing to promote three of the licensing objectives, namely the prevention of crime and disorder, Public safety, and prevention of public nuisance.

Jete Sete has previously had its licence reviewed before, firstly in June 2010, and then again in May 2015, both after serious crime and disorder, both inside and outside of the venue.

The licence has 44 conditions attached to it, which the majority are not currently being adhered to.

There has been a recent increase in crime and disorder over the last few months, resulting in injury, theft and public disorderly.

**Please provide as much information as possible to support the application** (please read guidance note 2)

Crime report - 1928093/15 dated 22/11/2015 refers to the theft of a wallet, this was taken from the victims pocket, time of offence 02.00 hours.

Crime report -1928382/15 dated 29/11/2015 refers to a male throwing a Champagne bottle at a female, hitting her in the face causing reddening to her nose and cheek.

The victim was dancing inside the club when she was barged by a female, the victim asked the female not to barge her, at which point the females boyfriend threw the Champagne bottle at her, he then threatened the victim by saying 'I will put a bullet in your head'. This incident took place at approximately 03.15 hours.

Crime report - 1928448/15 dated 29/11/2015 refers to an assault and robbery

At 29/11/2015 the victim was in the club with his brother and friends at 04.30 hours he saw Security staff arguing with his brother and trying to make him leave, he went over to help his brother and try and persuade the security staff to allow them to stay, the victim opened his wallet and took out £40 and tried to give it to one of the security staff in an attempt to persuade them to let them stay in the club, he states that it was at this point the security saw that he had a large amount of money in his wallet.

The security staff then escorted the victim and his associates out of the venue and to a nearby bus stop.

The victim then states once at the bus stop one of the security staff punched him in the face causing swelling to his left eye, and then held on to him whilst the second security guard head butted him, causing a cut to the inside of his lip, the victim then fell to the floor, he noticed his wallet on the floor next to him and when he looked saw that £800 was now missing from it.

*It appears from this crime report that the club was open way past its licensable hours and the door staff have assaulted and robbed the victim.*

Crime report - 1904920/16 dated 28/02/2016 refers to an assault.

At 03.50 hours the victim was punched in the face by her ex partners new girlfriend

Crime report - 1910534/16 refers to Possession of an offensive weapon, and Affray.

On the 02/05/2016 at 03.55 hours Police were called to a fight outside JETSET on arrival they were directed towards two males that were sitting on a wall, where they had placed a large metal bar behind them, the metal bar was used in a fight prior to police arrival, involving about 10 people which included door staff from the club who were trying to diffuse the situation.

Both males arrested for possession of an offensive weapon and Affray.

Crime report - 1916612/16 refers to Criminal Damage

This incident happened on the 03/07/2016 at 04:40:00 hours

Male seen to smash a glass bottle and wave it around trying to instigate a fight, he's also seen to kick off a wing mirror on a vehicle. He is also seen to imitate pulling a knife from a boot of a vehicle. He is stopped by police and asked to give his account of events he stated that he had been to Jet Set club in Harlesden, which he had not been to for a while. He had been drinking and had a good time, and when he left there was an argument with a female, and she was being surrounded by a group of males. He went to calm things down but couldn't so walked away. He has walked past the Corsa and has broken the wing mirror, and stated he did this deliberately as he was angry, He has then been approached by two unknown males who came running over to him and started trying to fight him.

CAD 2020 - dated 29/10/2016 police called to the venue to deal with drunk and aggressive revelers leaving the club, this was at 05.20 hours when the club should have been closed. Brent police licensing team contacted the DPS a few days later asking him for an account of what happened he stated that he was unaware of any incident and stated that the club was closed, he was asked for a copy of the clubs CCTV for this time which would prove or disprove if the club was open at this time, Mr Martin came back a few days later and stated

that the CCTV was not working correctly and had deleted the footage requested. It was explained to him that this was not acceptable and he was issued with a **final written** warning.

CAD Report 1512 dated the 05/03/2017 at 03.57 hours - reports of a fight and shots fired, police attended to find large scale public disorder outside the club, but no evidence of a firearm being discharged.

The DPS was contacted by Brent Police licensing team and asked what had happened on the night, he stated that there was two gangs in the club and one of the gangs had been sent to his club from South London to cause problems.

CCTV from inside the club was requested, this shows a fight inside the club and a male being hit with what looks like a bottle.

Crime report - 1905465/17 dated the 05/03/2017 Refers to a Robbery

This is linked to the above CAD 1512

Male has had his gold chain snatched from his neck and hit over the head with a bottle causing cuts during large scale public disorder inside the club.

Crime report - 1905777/17 dated the 05/03/2017 Refers to a Theft

Again this all appears to be linked to the above CAD

There is a fight inside the venue and the victim has tried to intervene and break it up, his watch has come loose at which point an unknown male has taken it off his wrist and made off with it.

Licensing Visit conducted by Brent Police Licensing Team.

Date 18/03/2017

There were two males at the door, one wearing an SIA badge, the other appeared to be door staff but when asked stated that he was not working as SIA.

DPS not present.

A full visit was carried out in response to recent disorder at the venue. The manager. Ms. Tatiana COUTO, claimed the club was holding a 'private function'. We went down the stairs into the bar area, alcohol was being sold from the bar. Recorded amplified music was being played by a DJ. The sound level was high; We then went through all of the licence conditions in the staff office with Tatiana. There were numerous breaches to the 44 conditions. The following were being breached:

Condition 1 - No I.d Scanner, the scanner has not been used for years as it is broken .

Condition 2 - There should be TWO door supervisors present after 2200 hours - there was only one on duty.

Condition 3 - The SIA security log had not been completed for the evening. The last time it was completed was 11/03/2017.

Condition 4 - No entry/re-entry after 0100 hours - People were being allowed in after this time at 0115 hours.

Condition 7 - Manager was unable to give police unhindered access to the cctv via the internet

Condition 9 - No licence summary on display at the entrance.

Condition 11 - No notice regarding admission policy on searching on display at the entrance.

Condition 13 - No notice on display explaining drug policy at the entrance.

Condition 17 - No toilet attendants - The last time there was one was about one year ago apparently.

Condition 22 - No Transport information on display.

Condition 32 - No notices asking customers to leave quietly at the entrance.

Condition 33 - Manager did not know who was the 'dedicated cab firm' for the club.

Conditions breached which were put on by the committee following a review in April 2015:

Condition 40 - SIA officer was not wearing his high visibility jacket.

Condition 41 - No facility provided within the premise for customers to await taxi's.

Condition 43 - Licence holder failing to adhere to existing licence conditions.  
15 breaches in total.

The DPS arrived as officers were finishing their licensing visit and he was informed of the breaches identified a meeting was asked for however he stated that he was going to Turkey for two weeks and would be unable to attend any meeting until his return.

CAD 1662 dated 02/04/2017 - Disorder outside the venue  
CCTV captures people exiting the club, people can be seen outside the venue and in the road the camera then turns around to the opposite side of the road as people can be seen running across the road from outside the club, it then captures a large crowd fighting, people are being pulled apart and dragged away into Furness Road where the disorder and fighting continues, the fighting and Disorder continues until police arrive.  
Two males arrested for Affray.

It is apparent from the above history that there is a lack of management at this venue, since 2010 there have been two previous reviews after serious disorder at the club, the PLH/DPS has been the same for both previous reviews, and it is apparent that no lessons have been learnt.

Police have no faith in the management and it appears that they have no regard for the licensing objectives.

After two previous reviews where conditions were attached to the licence, it is apparent that most have been dismissed and not implemented, and no consideration to the seriousness of the previous reviews has been taken on board.

Numerous conversations have been had with the DPS Mr Martins and each time he makes promises of improvement at the club but this never materializes.

This venue impacts dramatically on police recourses which are limited in the early hours of the morning, this is detrimental to Brent residents as a whole if the limited police recourses are tied up dealing with large rowdy groups from this club in the early hours over the weekends.

The club current has 44 conditions attached to the licence, namely

1 Admission to club by Club Scan, photographic ID to be produced by all patrons (driving licence, passport, oyster card) to staff and electronic records to be kept on Club Scan and checked every time a patron attends the premises.

2 At least 2 door supervisors shall be employed after 22:00 hours on any day when the premises are open for the sale of alcohol past midnight.

3 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

4 No entry or re-entry shall be permitted after 01:00 hours.

5 CCTV shall be installed and maintained in a working condition.

6 All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

7 Police officers shall be given unhindered access via the internet to view live images from the CCTV at any time when the premises is open to the public.

8 Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

9 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

10 The total number of people permitted on the premises including staff and performers shall not exceed 236 (180 in the main club area and 56 in the restaurant).

11 Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.

12 The Portman Group proof of age scheme or similar such scheme shall be adopted.

13 Notices clearly explaining the licensee's drugs policy shall be displayed at the entrance and at suitable places through out the premises.

14 The front smoking area is to be limited to 10 persons at any one time and there is to be no consumption of alcohol, soft drinks or food. Area to be monitored by door staff.

15 The rear fire exit is to remain closed and only be used in the case of emergency.

16 No persons are to be permitted to remain at the rear of the club premises.

17 One toilet attendant in each of the male and female toilets at all times during licensing hours.

18 The management reserve the right to refuse entry to all persons not in smart casual dress. Smart casual dress not to include football tops, hooded tops, sports tops, jeans or trainers.

19 All furniture and soft furnishings shall comply with relevant fire safety standards.

20 A fire detection and warning system together with suitable and sufficient fire extinguishers shall be installed and maintained.

21 An emergency lighting system shall be installed and maintained in good order.

22 Public transport information including night time travel options shall be made available.

23 All windows and doors shall remain closed during licensed activities. Where a door is used for patrons to enter or exit the premises the door shall be fitted with a self closing device and shall not be propped open.

24 Windows and doors shall be fitted with an alarm that instructs staff when the window or door has been opened.

25 Entrance exit to the premises shall be via a lobbied door.

26 All speakers shall be mounted on anti-vibration mountings.

27 No music shall be audible at or within the site boundary of any residential property.

28 All entertainments shall utilise the in-house amplification system, the maximum output of which shall be controlled by the duty manager.

29 The level of amplified entertainments shall be controlled by a sound limiting device set at a level agreed with the licensing authority.

30 No Music shall be played in the beer garden or other external area of the premises.

31 No form of loudspeaker or sound amplification shall be sited on or near the exterior of the premises or in any foyer, doorway, window or opening to the premises.

- 32 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 33 Management to have a dedicated cab firm and must ensure that all cabs are booked via the in-house booking system.
- 34 Notices explaining the licensee's policy on admissions and searching shall be placed at each entrance.
- 35 All deliveries shall take place during the normal working day (i.e. 09:00 to 18:00 daily).
- 36 No children shall be admitted unless accompanied by a responsible adult.
- 37 Nudity, striptease and other entertainment of an adult nature shall not be permitted on the premises.
- 38 The licensee shall undertake a risk assessment agreed by the police and licensing authority of any significant promotion or event, using the Metropolitan Police Service/Event Risk Assessment Form (Form 696) or an equivalent and provide a copy to the Metropolitan Police and Brent Licensing Unit not less than 14 days before the event is due to take place.
- 39 Where an event has taken place the licensee shall complete a Debrief Risk Assessment Form (Form 696A) and submit this to the Metropolitan Police and Brent Licensing Unit within three days of the conclusion of the event.  
Following Licensing review in April 2015
- 40 There shall be a minimum of two SIA qualified supervisors wearing high visibility jackets deployed at the front of the premises away from the door on Friday and Saturday nights. They shall remain in position until the crowd has fully dispersed so as to ensure the safe and quiet dispersal from the premises.
- 41 Facilities within the premises shall be made available for customers to await taxis.
- 42 Regular announcements be made from 03:00 hours reminding patrons to leave in a quiet and orderly manner from the premises
- 43 The Premises Licence Holder shall adhere to all existing conditions on the licence including timings.
- 44 The Premises Licence Holder shall continue to work in partnership with the Police.
- Further Council CCTV footage shows the club allowing patrons in past the no entry / re-entry time of 01.00 hours

#### Summary

This venue is a nightclub which opens predominately at the weekends, the history of violence and disorder over the years is horrendous, and two previous review hearings have done nothing to improve the running of the premises.

Mr Martins seems to have little to no concern when asked about these serious incidents and I believe is under the impression that this is what is expected of what happens when running a nightclub, he is dismissive and nearly always blames everyone else for the problems, but he does not want to take responsibility for his lack of management.

This venue is very near to residential premises which have had to endure the constant crime and disorder along with the Anti-Social behavior from the patrons of JET SET night club.

I have considered all possible options that are open to me under the licensing act, asking for a suspension would have little to no affect as this has been implement previously and even after having this time to improve nothing has changed.

Asking for the DPS to be removed would serve little to no purpose as Mr Martins would in my

opinion still be in day to day charge of the venue and again no real prospect of improvement would be made.

Asking for more conditions to be added to the licence would be unmanageable as the licence already has 44 conditions, most of which are not currently being adhered to.

A reduction in hours would not work as this is a night club which sees most of its patrons arriving at around midnight to party until the early hours of the morning.

After all other options have previously been tried and failed I ask that the committee consider revoking the club's licence, as there is no real prospect that the club is likely to improve its track record and will only continue to have incidents of crime and disorder if allowed to continue operating.

Police have previously submitted two Reviews for this premises, the first being in January 2011. This was an Expedited Review after serious crime and Disorder at the venue.

Having considered the application by the Metropolitan Police to Review the Premises Licence for 'Jet 7 Sete' (248-252 High Street, Harlesden, London, NW10 4TD) ("the premises") pursuant to the provisions of the Licensing Act 2003 the Sub-Committee resolved that the **premises licence continue in force subject to amendments to the premises licence and conditions as follows:-**

- (i) that the following hours for the provision of all licensable activities be specified:-
  - (a) that all licensable activities cease by 02.00 (the following day) Sunday to Thursday and 03.30 (the following day) Friday and Saturday
  - (b) that the premises remain open until 30 minutes past these times
  - (c) that all licensable activities permitted on the existing licence to commence at the hours specified on the licence Monday to Sunday
- (ii) that the following conditions be added to the licence in addition to the existing conditions:-
  - (a) that all conditions as agreed with the police be attached to the licence, subject to the following amendment to condition 7:-

Replace "appropriately dressed" with 'in smart casual dress'. Smart casual dress not to include football tops, hooded tops, sports tops, jeans or trainers.

The conditions are as follows:-

    1. Admission to club by Club Scan, photographic ID to be produced by all patrons (driving licence, passport, oyster card) to staff and electronic records to be kept on Club Scan and checked every time a patron attends the premises.
    2. Police officers shall be given unhindered access via the internet to view live images from the CCTV at any time when the premises is open to the public.
    3. The front smoking area is to be limited to 10 persons at any one time and there is to be no consumption of alcohol, soft drinks or food. Area to be monitored by door staff.
    4. The rear fire exit is to remain closed and only be used in the case of emergency.
    5. No persons are to be permitted to remain at the rear of the club premises.
    6. One toilet attendant in each of the male and female toilets at all times during licensing hours.
    7. The management reserve the right to refuse entry to all persons not in smart casual dress. Smart casual dress not to include football tops, hooded tops, sports tops, jeans or trainers.
    8. Management to have a dedicated cab firm and must ensure that all cabs are booked via the in-house booking system.
    9. Notices explaining the licensee's policy on admissions and searching shall be placed at each entrance.

10. The licensee shall undertake a risk assessment agreed by the police and licensing authority of any significant promotion or event, using the Metropolitan Police Service/Event Risk Assessment Form (Form 696) or an equivalent and provide a copy to the Metropolitan Police and Brent Licensing Unit not less than 14 days before the event is due to take place.
11. Where an event has taken place the licensee shall complete a Debrief Risk Assessment Form (Form 696A) and submit this to the Metropolitan Police and Brent Licensing Unit within three days of the conclusion of the event.

The Alcohol and Entertainment Licensing Sub-Committee (B) felt that the additional conditions and the revised operating hours would meet the licensing objectives (prevention of crime and disorder, public safety, the prevention of public nuisance, the protection of children from harm) and accordingly agreed that the premises licence should remain in force.

The second review was heard on the 21/05/2015 again after serious crime and disorder; the hearing determined that conditions should be added to the licence.

Declarations of personal and prejudicial interests

Application by the Metropolitan Police for the review of a premises licence for 'Club Jet 7 Sete', (248-252 High Street, Harlesden, NW10 4TD) pursuant to the provisions of the Licensing Act 2003 The Alcohol and Entertainment Licensing Sub-Committee (C) having considered the application by the Metropolitan Police to review the premises licence for 'Jet 7 Sete' (248-252 High Street, London NW10 4TD) pursuant to the provisions of the Licensing Act 2003 ("The Act"), the Sub-Committee resolved that the premises licence continue in full force and effect, subject to the following additional conditions and informatives;

**Additional conditions**

An officer of the Licensing Authority, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to review the premises licence under section 51 of the Act. The

Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

## Licensing Visit

As a result of the review application made by the Licensing Police, a meeting with the company director MCS INC Ltd / DPS, Mr Antonio Eugenio Martins was held at the premises on Thursday 27<sup>th</sup> 2017 at approximately 11:00hrs. The premise was not open to the public at the time of inspection. Based on my visit, the following outcome was found based on the existing conditions:

**Condition 1 - Admission to club by Club Scan, photographic ID to be produced by all patrons (driving licence, passport, oyster card) to staff and electronic records to be kept on Club Scan and checked every time a patron attends the premises.**

Mr Martins confirmed that he had ordered a club scan machine from America, which arrived 2 weeks ago but had not been able to operate the machine as the format of the programme was not compatible with the UK. He is awaiting new software but in the meantime, he is using a temporary machine which takes pictures of ID cards and stores the images on a memory card via a camera.

**Condition 2 - At least 2 door supervisors shall be employed after 22:00 hours on any day when the premises are open for the sale of alcohol past midnight.**

Mr Martins stated that he employs five to six door supervisors (all males) and they are on duty from 23:30hrs.

**Condition 3 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.**

Mr Martins presented a register, however there were no indication when the door supervisors end their shifts as the 'Out' column was not filled in. Secondly, the register confirms that door supervisors start their shift between 23:30hrs to 00:00hrs (See Exhibit EC09 & EC10).

**Condition 5 - CCTV shall be installed and maintained in a working condition.**

**Condition 6 - All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.**

In relation to Conditions 5 & 6, Mr Martins was not able to show me footage to demonstrate CCTV recordings are kept for 31 days in order to prove the CCTV system is in good working order. Mr Martins stated he would normally request a CCTV technician to retrieve any required footage.

**Condition 11 - Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.**

There were no visible notices displayed at the entrance to explain the licensee's policy on admission

**Condition 12 - The Portman Group proof of age scheme or similar such scheme shall be adopted.**

Mr Martins stated that he does not supply alcohol to anyone under 18, however there were no prominent Portman Group proof of age scheme posters displayed at the point of sale or around the premises. Mr Martins stated that he wants to adopt Challenge 25 as he believes this will attract a maturer crowd. He is aware that the younger crowd are more prone to instigating physical fights. Mr Martins employs two members of staff to manage the bar and one to two members of staff to manage the floor. However, staff training is not recorded.



**Condition 17 - One toilet attendant in each of the male and female toilets at all times during licensing hours.**

Mr Martins admitted that this condition has not been fulfilled for the past 4 months as he is experiencing difficulties in hiring long term toilet attendants. He stated they do not tend to stay due not to receiving enough tips from customers.

**Condition 18 - The management reserve the right to refuse entry to all persons not in smart casual dress. Smart casual dress not to include football tops, hooded tops, sports tops, jeans or trainers.**

Mr Martins admitted that customers are permitted to enter premises in jeans as long as they are smartly dressed.

**Summary**

The premises is only open every Saturday and on rare occasions on a Friday. Mr Martins stated that this business is his only source of income and he endeavours to keep this 'community club' in operation. His main clientele are regular customers and the majority are from London.

Based on my assessment, there is evidence that the premises is poorly managed. In light of the number of complaints which the Licensing Authority have received and the number of breaches identified during my visit, the Licensing Authority suggest that Mr Antonio Eugenio Martins is **removed** as the **DPS** and a new appointment is made.

To assist the new DPS further in maintaining adequate control over the venue and its customers, the following changes would be necessary and appropriate in order to promote the licensing objectives.

The Licensing Authority suggest that the following conditions be **removed** from the current premise licence:

Condition 2 - At least 2 door supervisors shall be employed after 22:00 hours on any day when the premises are open for the sale of alcohol past midnight.

Condition 5 - CCTV shall be installed and maintained in a working condition.

Condition 6 - All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

Condition 12 - The Portman Group proof of age scheme or similar such scheme shall be adopted.

Condition 17 - One toilet attendant in each of the male and female toilets at all times during licensing hours.

Condition 18 - The management reserve the right to refuse entry to all persons not in smart casual dress. Smart casual dress not to include football tops, hooded tops, sports tops, jeans or trainers.

Condition 42 - Regular announcements be made from 03:00 hours reminding patrons to leave in a quiet and orderly manner from the premises.

***All of the above are out dated.***



The Licensing Authority suggest that the following conditions shall **remain** on the current premise licence:

Condition 1 - Admission to club by Club Scan, photographic ID to be produced by all patrons (driving licence, passport, oyster card) to staff and electronic records to be kept on Club Scan and checked every time a patron attends the premises.

Condition 3 - A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.

Condition 7 - Police officers shall be given unhindered access via the internet to view live images from the CCTV at any time when the premises is open to the public.

Condition 8 - Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.

Condition 9 - A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

Condition 10 - The total number of people permitted on the premises including staff and performers shall not exceed 236 (180 in the main club area and 56 in the restaurant).

Condition 11 - Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.

Condition 13 - Notices clearly explaining the licensee's drugs policy shall be displayed at the entrance and at suitable places through out the premises.

Condition 14 - The front smoking area is to be limited to 10 persons at any one time and there is to be no consumption of alcohol, soft drinks or food. Area to be monitored by door staff.

Condition 15 - The rear fire exit is to remain closed and only be used in the case of emergency.

Condition 16 - No persons are to be permitted to remain at the rear of the club premises.

Condition 19 - All furniture and soft furnishings shall comply with relevant fire safety standards.

Condition 20 - A fire detection and warning system together with suitable and sufficient fire extinguishers shall be installed and maintained.

Condition 21 - An emergency lighting system shall be installed and maintained in good order.

Condition 22 - Public transport information including night time travel options shall be made available.

Condition 23 - All windows and doors shall remain closed during licensed activities. Where a door is used for patrons to enter or exit the premises the door shall be fitted with a self closing device and shall not be propped open.

Condition 24 - Windows and doors shall be fitted with an alarm that instructs staff when the window or door has been opened.





Condition 25 - Entrance exit to the premises shall be via a lobbied door.

Condition 26 - All speakers shall be mounted on anti-vibration mountings.

Condition 27 - No music shall be audible at or within the site boundary of any residential property.

Condition 28 - All entertainments shall utilise the in-house amplification system, the maximum output of which shall be controlled by the duty manager.

Condition 29 - The level of amplified entertainments shall be controlled by a sound limiting device set at a level agreed with the licensing authority.

Condition 30 - No Music shall be played in the beer garden or other external area of the premises.

Condition 31- No form of loudspeaker or sound amplification shall be sited on or near the exterior of the premises or in any foyer, doorway, window or opening to the premises.

Condition 32 - Notices asking customers to leave quietly shall be conspicuously displayed at all exits.

Condition 33- Management to have a dedicated cab firm and must ensure that all cabs are booked via the in-house booking system.

Condition 34 - Notices explaining the licensee's policy on admissions and searching shall be placed at each entrance.

Condition 35 - All deliveries shall take place during the normal working day (i.e. 09:0 to 18:00 daily).

Condition 36 - No children shall be admitted unless accompanied by a responsible adult.

Condition 37 - Nudity, striptease and other entertainment of an adult nature shall not be permitted on the premises.

Condition 38 - The licensee shall undertake a risk assessment agreed by the police and licensing authority of any significant promotion or event, using the Metropolitan Police Service/Event Risk Assessment Form (Form 696) or an equivalent and provide a copy to the Metropolitan Police and Brent Licensing Unit not less than 14 days before the event is due to take place.

Condition 39 - Where an event has taken place the licensee shall complete a Debrief Risk Assessment Form (Form 696A) and submit this to the Metropolitan Police and Brent Licensing Unit within three days of the conclusion of the event.

Condition 40 - There shall be a minimum of two SIA qualified supervisors wearing high visibility jackets deployed at the front of the premises away from the door on Friday and Saturday nights. They shall remain in position until the crowd has fully dispersed so as to ensure the safe and quiet dispersal from the premises.



Condition 41- Facilities within the premises shall be made available for customers to await taxis.

Condition 43 - The Premises Licence Holder shall adhere to all existing conditions on the licence including timings.

Condition 44 - The Premises Licence Holder shall continue to work in partnership with the Police.

The Licensing Authority suggest the following conditions be **added** to the current premise licence:

### **CCTV**

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council. This must comply with the Data Protection Act including signage.

2. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulder image of every person entering or leaving the premises.

3. The licence holder, DPS or nominated duty manager must inspect and test that the CCTV is operational and working correctly on a weekly basis. A signed and dated recorded of the CCTV examination and any findings shall be kept on the premises and made available to the police and licensing authority upon request.

### **Proof of Age**

4. A "Challenge 25" policy shall be adopted and adhered to at all times.

5. Regular documented staff training on licensing legislation and operating procedures shall be given. The training shall be signed and dated and a copy of these training records available for inspection by Police and local authority enforcement officers.

6. A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for inspection at the premises.

### **Drugs & Weapons**

7. Toilets shall be checked every 1 hour for the use of drugs and other illegal activities.

8. A toilet checklist shall be displayed on the wall in all toilets. Staff shall use these checklists to record their name and certify the time of the check. Checklists are to be replaced daily and all old checklists must be retained and made available for inspection by the police and authorised officers from Brent Council.

9. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:

- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder



- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service

**General**

10. Substantial food and non-intoxicating beverages shall be available during the whole of licensed hours in all parts of the premises where intoxicants are provided.

11. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

12. At least 3 door supervisors shall be employed after 21:00 hours on any day when the premises is open for the sale of alcohol past midnight.

13. No entry or re-entry shall be permitted after 00:00 hours (midnight).

14. Regular announcements be made from 01:00 hours reminding patrons to leave in a quiet and orderly manner from the premises.

**Reduction of Permitted Hours.**

The Licensing Authority suggest the committee consider a reduction of permitted hours in order to prevent any late night incidents and public nuisance.

The Licensing Authority suggest the following hours are applied:

**All Permitted Regulated Entertainment:**

Monday – Sunday : 10:00hrs to 01:30hrs

**Provision of Late Night Refreshment:**

Monday – Sunday: 10:00hrs to 01:30

**Supply of Alcohol:**

Monday – Sunday: 10:00hrs to 01:30hrs

**The Opening Hours of the Premises:**

Monday – Thursday: 10:00hrs – 02:00hrs (no change)  
Friday: 10:00hrs – 02:00hrs (changed)  
Saturday: 10:00hrs – 02:00hrs (changed)  
Sunday: 10:00hrs – 02:00hrs (changed)

The above hours would allow customers half an hour of drinking up time.

In order for the Licensing Team to withdraw this representation, it will be necessary for you to confirm in writing that you are willing to accept the above conditions and carry out any necessary works.

### **LICENSING ACT 2003- Inspection visit 252 High Street, London, NW10 4TD**

A visit was carried out on 1<sup>st</sup> September 2011. The visit was an annual inspection and for Alpesh Kerai from information Systems Analyst, Environment & Culture Directorate to determine the correct address of the building. On the system and on all paper work the address is known as 252 High Street Harlesden NW10 4TD. When checked by Alpesh, that door number is for the empty carpet shop next door. Alpesh has advised Paulo (your son) to change all records for the purpose of safety issues. Alpesh will write to you with regards to this issue.

On inspections the following was found. Below are the areas that need to be corrected to meet the conditions on your license. You will find the action points in brackets.

- The fire exit off the main dance floor was not in a sterile condition. Behind the fire doors in a gap there were flammable goods stored. There was also a type of cylinder found under the emergency stair well which leads down from the flats above. **(This needs to be removed and cleared as soon as possible)**.
- The lighting in the emergency exit area was inadequate and in disrepair. **(The light needs to be repaired and add another light to increase clear vision of the escape route)**.
- In the emergency fire escape area there were two broom sticks which will cause a potential hazard. **(Clear this area as soon as possible)**.
- In the emergency fire escape, there was a mat that had been placed over the drain service cover. This will cause a trip or fall hazard. When the mat was picked up, it was revealed that the drain service cover was in disrepair. This is why the mat was placed over the drain cover. **(Repair the drain cover and remove the mat as soon as possible)**.
- The Fire Exit in the VIP lounge area (This used to be the restaurant) was secured with a metal shutter from the outside. I was advised by Paulo that this is open during operating hours. **(An evening visit will be made to ensure that this is opened)**.

- Fire extinguishers were out of date and were not strategically placed around the club. (I have advised Paulo to get the fire system and extinguishers checked and serviced as soon as possible).
- The fire exit in the VIP lounge was not illuminated and clearly marked. (Please have the fire exit sign changed and clearly marked).
- In the kitchen (which is no longer in use) it was noted that the door leading into the fire escape was not clearly marked for the purpose of the kitchen staff (when the kitchen is in use). (Please have this door clearly marked).
- Paulo stated that part of the kitchen area was used as a cloakroom for a short period of time. Although this is no longer in use either, the curtain used to hide the kitchen is still considered to be a fire hazard if it has not been fire checked. (Paulo has been advised to remove this).

On inspection I asked to see a copy of the public liability insurance but Paulo was unable to produce this or any other documentation related to the premises. On your conditions it states that A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises. On inspection this was not visible.

I would advise you to adhere to the points above before another inspection is carried in due course. I realise that it is not possible for you to always be available on the premises. In this case I would suggest that you have a file on site of all licensing documentation so that on a future visits an inspector or the Police can gain the necessary information needed.

If the above is not carried out you will be in breach of your conditions and further action will be taken against you. If you have any issues to discuss please do not hesitate to contact me on 0208 937 5359.

I am aware of your complaints, I have received sporadic in the past usually in the nice weather. I have made observations in the area on numerous occasion and have found it difficult to put blame on the congregation and noise on Jet Set customers alone. Legislation would only allow direct connection to the premises to be used as evidence in a review of the Jet Set premises licence.

Today I have spoken to the owner and warned him of the noise nuisance. He will be getting the door supervisors to be more proactive in the vicinity of the venue and make sure all doors/windows remain closed whilst the music is playing. He informs me there is a noise limiter on the equipment (out of my knowledge remit).

The owners solution to the disturbance made by customers at closing time, is to extend the opening hours of the venue to 6am.

The reason being there is more public transport, especially the train station next to the premises that would cater to his customers needs. The music played at the venue caters for a specific culture and many of these reside in South and East London. The owner is entitled to make an application to extend the licensable hours, however there would be a 28day consultation period for responsible authorities and residents to make representations. What is your opinion?

I recommend you keep a diary of dates/times you are disturbed and how you know they are Jet set customers, this would help build a case for review of the premises licence if required. Please email any nuisance you experience.

Dear Environment and Protection Team

I am writing to make a complaint about Club Jet Set on the Harrow Road. I live on Palermo Road (at the Harrow Road end) and every weekend my partner and I are disturbed by the night club. Aside from the music which can be heard, each Saturday, when the club closes at 4am it seems that the clientèle congregate outside of the club for at least an hour, shouting at each other. The management and door staff seemingly do nothing to move them on (or clear up the vomit that the clubbers kindly leave in the area too).

Three weeks ago the police were called due to the trouble that was being caused – this is not an isolated incident and in the 18 months I have lived in the area, the police have been called regularly.

Aside from the noise pollution and litter that is evident post club nights, within one mile of the venue there have been three stabbings in the last few weeks. The area has more than its fair share of violent crime already and judging by the shouting and arguing that occurs every weekend outside the club, it seems quite possible that more violence will erupt in the near future.

I fully appreciate that people need to have somewhere to go for entertainment, but the management is clearly not responsible enough to handle such a late license in a primarily residential area. Added to this there is no public transport at the time the club closes or a local cab office in the vicinity, so I do wonder the extent to which drink/drug-driving is being encouraged, and drug dealing within very close proximity to the school on Furness/Palermo Road.

I'd be keen to know on what basis a late license has been granted to this club, what checks are made to ensure that it is operating in a professional manner, and what steps will be taken to reduce the extent to which the club is disturbing its residential neighbours. It is simply not fair that my weekends (and I expect those of many other local residents) should be ruined on a regular basis.

- **that the premises licence continue in full force and effect, subject to the following interim steps being taken by way of additional conditions and informatives on the grounds of serious crime and disorder under section 53B 3 (a) of the Act (as inserted by Section 21 of the Violent Crime Reduction Act 2006) pending the full review;**

#### **Additional conditions**

- A1) To ensure the safe and quiet dispersal from the premises, there should be a minimum of two SIA qualified supervisors deployed at the front of the premises, away from the door on Friday and Saturday nights who are to remain in position until the crowd has fully dispersed.
- A2) To ensure the safe and quiet dispersal from the premises facilities within the premises shall be made readily available for patrons to await cabs.

- a) Regular announcements should be made from 03.00 hours reminding patrons to leave the premises in a quiet and orderly manner so as to prevent congestion and disturbance occurring.
- b) The Premises Licence Holder shall adhere to all existing conditions on the licence including timings.

- c) The Premises Licence Holder to continue to work in partnership with the Police so as to improve the overall management of the premises

The Sub-Committee when arriving at its decision considered all of the evidence having regard to the Council's Statement of Licensing Policy, amended guidance issued from time to time under Section 182 of the Act, and the licence holders human rights under the Human Rights Act 1998 (namely Article 6, Article 8 and Article 1 of the First Protocol. Accordingly, in all of the circumstances of the case it was felt that the decision of the Sub-Committee was reasonable, proportionate and necessary in all of the circumstances of the case.

This condition will remain on your licence until the matter is addressed at the full review hearing. Full details of the date and time of the review will be sent to you in due course.

Heard loud shouting and laughing as I was walking along Rucklidge Ave, however unable to ascertain where the noise was coming from. Noise became louder on top of Furness Road. Observed a female singing aloud o/s premise, male SIA staff did not appear to be stopping female guest causing nuisance. As I approached the venue, the male and female guests entered premise, followed by another 2 females who were seen being searched inside the front entrance. Whilst door staff went to alert the manager, I noted that the front entrance door was propped open, loud music was emanating from the premise (Justin Timberlake's Rock with You was playing) contravening condition 20.  
Spoke to the manager known to be Ms Tatianna Couto of [REDACTED] who confirmed she has been working in the premises for 5 years undertaking different roles.  
I asked her to confirm the last entry and re-entry time, she stated 3am. I requested her to show the Door Register, which she went to collect from the office. Female staff behind the ticket booth alerted the male SIA staff that music was loud and requested him to get music volume lowered.  
A female door supervisor known to be Ms Amelia Oliveri of [REDACTED] confirmed she was on duty, however she was not wearing her SIA badge as she is awaiting for a replacement as she had lost it. When Ms Couto returned with the door register, Ms Oliveri confirmed the last entry/re-entry time is 1:30hrs. Checked register, noted 2 in 2 time not logged, 2 males and 1 female SIA staff including Ms Oliveri recorded. Opening and closing checks not logged. Ms Oliveri stated toilets are checked every 10 - 30 minutes but not documented.  
Premise Licence displayed at the bar contrary to condition 7. At 1:28hrs, LH Mr Antonia Martins arrived. Explained the contraventions identified and noise emanating from premise and guests causing nuisance by singing outside premise. Mr Martin stated that he has changed SIA company and they are much better than the previous company. No notices displayed related to admissions, drugs policy contrary to condition 9, 13 and 29.  
During our conversation outside the premise, I noticed a vehicle parked in front of the neighbouring property, a female left the vehicle and approached the staff members who were standing outside the premise behind the barred area 2 she did enter premise. A few minutes later 2 black females approached Mr Martins and spoke to him in Portuguese. It appeared that the 2 females wanted to enter the premise but was refused by Mr Martins. Shortly after, another group of females was stopped by Mr Martins and were refused entry.  
Mr Martin told me that the last entry and re-entry time is 1-1:30hrs. I told him that the last entry/re-entry time is in fact 1am. It was apparent that customers are arriving at the venue after 1am, thus condition 3 is being breached. Mr Martins stated that customers prefer to drink beforehand elsewhere as its cheaper then turn up at the venue. I advised Mr Martins that it is in his interest to point out to customers that the last entry time is 1am via announcements, signage and social media. To change any of the conditions, he will need to apply for a variation. Condition

### Annexe 1 - Mandatory Conditions

#### No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

#### Free Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

### Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.

### Small Measures to be Available

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

### Minimum Price of Alcohol

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1—
  - (a) —duty<sup>ll</sup> is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) —permitted price<sup>ll</sup> is the price found by applying the formula—
$$P = D + (D \times V)$$
where—
    - (i) P is the permitted price,
    - (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
    - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
  - (c) —relevant person<sup>ll</sup> means, in relation to premises in respect of which there is in force a premises licence—
    - (i) the holder of the premises licence,
    - (ii) the designated premises supervisor (if any) in respect of such a licence, or
    - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
  - (d) —relevant person<sup>ll</sup> means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - (e) —value added tax<sup>ll</sup> means value added tax charged in accordance with the Value Added Tax Act 1994.
3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first day<sup>ll</sup>) would be different from the permitted price

on the next day (—the second day)) as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

### **Requirement for a DPS**

- (1) No supply of alcohol may be made under the premises licence-
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Door Supervisors and Security Staff to be Licensed by the SIA (when required)**

Where the licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each individual must be licensed by the Security Industry Authority, with the following exceptions:

- a) premises where the premises licence authorises plays or films

## **Annexe 2 - Conditions Consistent With the Operating Schedule**

- 1 Admission to club by Club Scan, photographic ID to be produced by all patrons (driving licence, passport, oyster card) to staff and electronic records to be kept on Club Scan and checked every time a patron attends the premises.
- 2 At least 2 door supervisors shall be employed after 22:00 hours on any day when the premises are open for the sale of alcohol past midnight.
- 3 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.



- 4 No entry or re-entry shall be permitted after 01:00 hours.
- 5 CCTV shall be installed and maintained in a working condition.
- 6 All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.
- 7 Police officers shall be given unhindered access via the internet to view live images from the CCTV at any time when the premises is open to the public.
- 8 Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 9 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 10 The total number of people permitted on the premises including staff and performers shall not exceed 236 (180 in the main club area and 56 in the restaurant).
- 11 Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.
- 12 The Portman Group proof of age scheme or similar such scheme shall be adopted.
- 13 Notices clearly explaining the licensee's drugs policy shall be displayed at the entrance and at suitable places through out the premises.
- 14 The front smoking area is to be limited to 10 persons at any one time and there is to be no consumption of alcohol, soft drinks or food. Area to be monitored by door staff.
- 15 The rear fire exit is to remain closed and only be used in the case of emergency.
- 16 No persons are to be permitted to remain at the rear of the club premises.
- 17 One toilet attendant in each of the male and female toilets at all times during licensing hours.
- 18 The management reserve the right to refuse entry to all persons not in smart casual dress. Smart casual dress not to include football tops, hooded tops, sports tops, jeans or trainers.
- 19 All furniture and soft furnishings shall comply with relevant fire safety standards.
- 20 A fire detection and warning system together with suitable and sufficient fire extinguishers shall be installed and maintained.
- 21 An emergency lighting system shall be installed and maintained in good order.
- 22 Public transport information including night time travel options shall be made available.

- 23 All windows and doors shall remain closed during licensed activities. Where a door is used for patrons to enter or exit the premises the door shall be fitted with a self closing device and shall not be propped open.
- 24 Windows and doors shall be fitted with an alarm that instructs staff when the window or door has been opened.
- 25 Entrance exit to the premises shall be via a lobbied door.
- 26 All speakers shall be mounted on anti-vibration mountings.
- 27 No music shall be audible at or within the site boundary of any residential property.
- 28 All entertainments shall utilise the in-house amplification system, the maximum output of which shall be controlled by the duty manager.
- 29 The level of amplified entertainments shall be controlled by a sound limiting device set at a level agreed with the licensing authority.
- 30 No Music shall be played in the beer garden or other external area of the premises.
- 31 No form of loudspeaker or sound amplification shall be sited on or near the exterior of the premises or in any foyer, doorway, window or opening to the premises.
- 32 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
- 33 Management to have a dedicated cab firm and must ensure that all cabs are booked via the in-house booking system.
- 34 Notices explaining the licensee's policy on admissions and searching shall be placed at each entrance.
- 35 All deliveries shall take place during the normal working day (i.e. 09:0 to 18:00 daily).
- 36 No children shall be admitted unless accompanied by a responsible adult.
- 37 Nudity, striptease and other entertainment of an adult nature shall not be permitted on the premises.
- 38 The licensee shall undertake a risk assessment agreed by the police and licensing authority of any significant promotion or event, using the Metropolitan Police Service/Event Risk Assessment Form (Form 696) or an equivalent and provide a copy to the Metropolitan Police and Brent Licensing Unit not less than 14 days before the event is due to take place.
- 39 Where an event has taken place the licensee shall complete a Debrief Risk Assessment Form (Form 696A) and submit this to the Metropolitan Police and Brent Licensing Unit within three days of the conclusion of the event.

### **Annexe 3 - Conditions Attached After a Hearing by the Licensing Authority**

#### Following Licensing review in April 2015

40 There shall be a minimum of two SIA qualified supervisors wearing high visibility jackets deployed at the front of the premises away from the door on Friday and Saturday nights. They shall remain in position until the crowd has fully dispersed so as to ensure the safe and quiet dispersal from the premises.

41 Facilities within the premises shall be made available for customers to await taxis.

42 Regular announcements be made from 03:00 hours reminding patrons to leave in a quiet and orderly manner from the premises.

43 The Premises Licence Holder shall adhere to all existing conditions on the licence including timings.

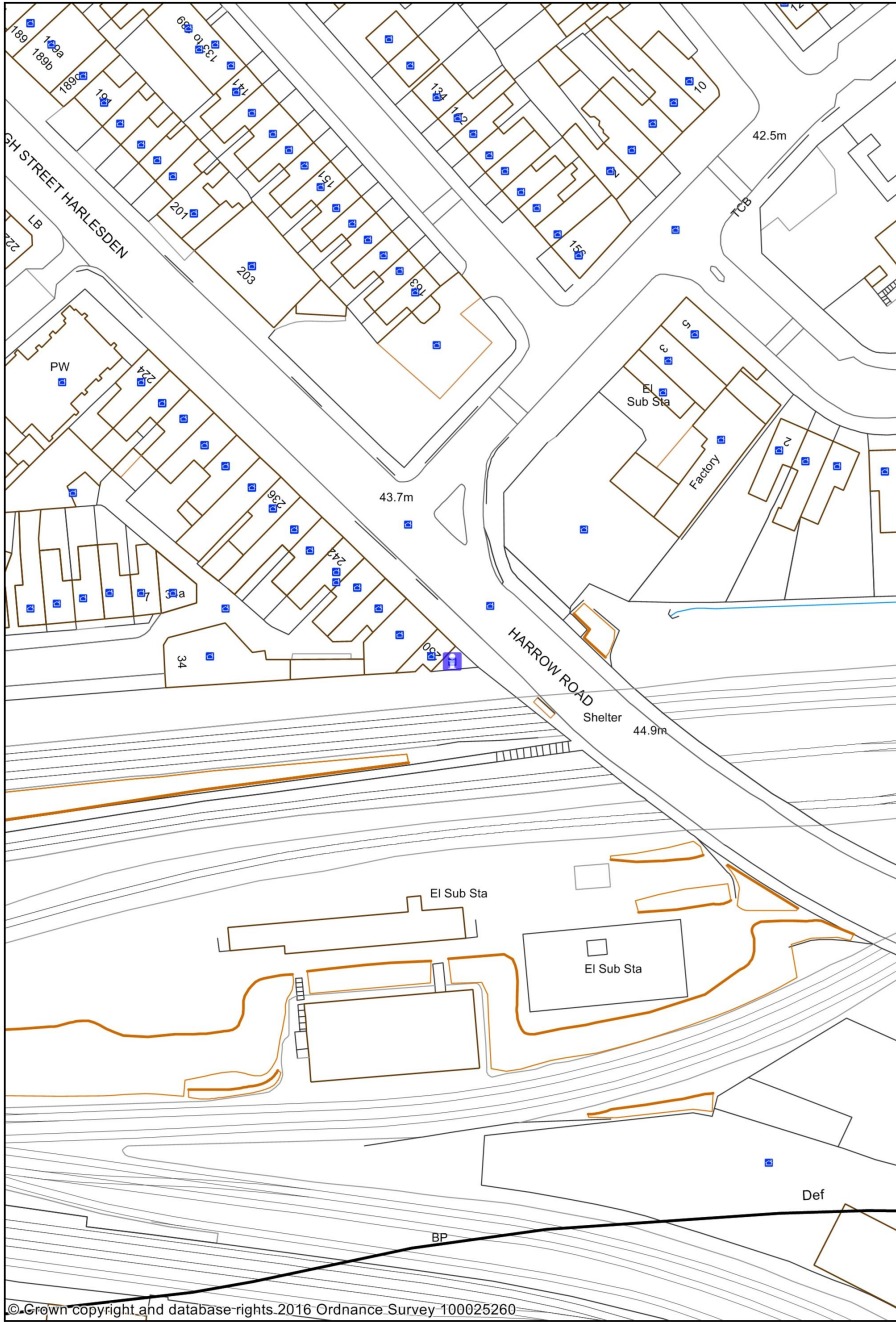

On the 21/05/2017 police were called to Greene's Bar Neasden to a large disturbance and one male unconscious and another male with a facial wound, on police arrival they found a male with head injuries and unresponsive, male was treated by ambulance crew and taken to St Marys Hospital, it later transpired that he had serious head trauma, collapsed lung and several broken ribs.

A fight started in the pub after the barmaid asked a group of six Eastern Europeans to drink up and stop playing pool they became aggressive and threw something at her which hit her in the face, one of the males then threatened her with a pool cue and a pint glass, other people became involved and tried to help the barmaid who by this time was trying to get the males out of the door, one of the group grabbed the barmaid around the throat and it was at this point other patrons picked up pool cues and started to fight the group of six males, fighting continued and another male had a glass thrown at him causing a deep cut to his face the fight continued outside where one of the group who was helping the barmaid got locked outside the pub and was punched and kicked to the floor, the group can be seen on the pub's CCTV footage kicking and punching the male in the head as he lay unconscious on the floor.

The pub was recently the subject of a licensing review after serious disorder and numerous breaches to its licence conditions, and opening way beyond its licensable hours, police on that occasion asked for the licence to be revoked however the committee decided to suspend the licence for three months, this incident has happened during the 21 appeal process allowed by the legislation.

Police would ask that several interim steps be put in place to reduce any further risk of serious Violence until a full review hearing can take place, namely 1. An ID scanner shall be utilised at the premises to check all customers who wish to gain entry to the premises. The customer will provide appropriate proof of identification. The information collected shall include photo ID, the person's name, and date of birth shall be added to the database. Any person refusing to allow their data to be added to the database shall be refused entry.


This will assist police with any enquires if an incident occurs, and help deter and person from causing trouble.

2. A door supervisors shall be employed from one hour before closing time on Friday, Saturday and Sunday until the pub closes and all patrons are off the premises

. This will assist bar staff in closing the bar where patrons are refusing to leave.

This is deemed an appropriate and proportionate measure in view of the above evidence and to reduce any further threat to the public's safety and the prevention of crime and disorder licensing objectives.

**2. The Application**

The application is for a Police Review of the premises.

**3. Representation**

The Police were represented by PC Sullivan. The licence holder Mr Sheahan was present and represented by Mr Sutherland. Ms Sharon Mullarkey was also present.

**4. The Hearing**

PC Sullivan explained that in July 2015 a review of the premise was undertaken. The concern at that point was that the premises were opening outside their operating hours. As a result of that review, Mr Sheahan was removed as the DPS.

It was submitted that, since then, the Police have seen a reoccurrence of the same problems i.e. failure to adhere to the licensing hours.

On the 8 August 2015, which was less than a month after the first review, the Noise Team visited the premises at 23:19 and observed a two piece band playing which was clearly audible from the street. Mr Sheahan indicated that that there was security present, however on inspection it transpired that security present were not SIA registered.

The following week on 15 August at 23:05 music was emanating from within the premises again. PC Sullivan explained that the licence only provides for sale of alcohol, not regulated entertainment.

Furthermore, the police stated that on the 28 and 29 October the premise was open long passed the 23:30 closing hours. It is notable that a TEN had been applied for in relation to these dates and was refused. However it is clear that the premises still held the event. The police submitted that this showed a total disregard for the Licencing procedures and adherence to the terms of their licence.

On the 05 December 2016 an allegation was made to the police that a female patron had her handbag stolen. CCTV footage for the evening showed that the premises was open at 01:00, again a clear breach of the licence.

On the 07 November 2016 the police held a meeting with Mr Sheahan who indicated that he was aware of the breaches and that he would address these. He was informed that the Police would be issuing an action plan, which was done the next day. The Action plan made very clear the operating hours of the venue.

In and around December 2016, the police viewed Council operated CCTV covering the premises. On the 16 December the premises was open past 23:30. Again a TEN had been applied for that evening and refused. Again on the 17 December the premises were open until the very early hours of the morning. A serious assault took place during this evening.

On the 03 December the premises was open until 06:00 and Mr Sheahan was present throughout this. On New Years' Day 2017 the premises was still open at around 02:00. Police suspect that patrons were being let into the premises via the back door.

Just after a month after the Review was submitted, on the 17 March, the premises was open past 23:30. Mr Sheahan attended and appeared very intoxicated. Police viewed the CCTV footage of that evening, in which patrons are seen leaving in the early hours. Several fights broke out, including an injury to a young girl.

Police investigations have discovered that in December 2016 the premises were promoting, via Facebook, a free-bar during a Christmas party which was open to the public. This again demonstrated an irresponsible approach and is another breach of the licence.

The sub-committee viewed the CCTV footage for the 17 March 2017.



The Police submitted that, even with the threat of a review pending, Mr Sheahan showed a complete disregard of his licence conditions.

Under questioning the Police were asked to clarify the nature of the police objection for the TEN for 28/29 October. It was accepted by PC Sullivan that St Patrick's Day was a busy day for the premises.

PC Sullivan clarified that there were no real problems from the premises prior to 23:00. He further stated however that he did not have confidence in the current door supervisors.

Before presenting the case for the licence holder, Mr Sutherland asked members of the sub-committee to read a letter from a medical expert regarding Mr Sheahan's health. It was explained that part of the case of the Licence Holder today was for Mr Sheahan not to be involved in the running of the premises and that he would be returning to Ireland.

The sub-committee agreed to read the letter and a copy was taken.

Mr Sutherland noted that there are a number of issues that have been raised by the police however in moving forward what the licence holder was proposing that Mr Sheahan play no part in the running of the premises. Mr Sutherland explained that it was proposed the licence be transferred into Ms Malarky's name and that she would become the licence holder and DPS.

It was submitted that, generally speaking, the premises operated lawfully up until 23:00 – but it is after this hour that problems exist. Mr Sheahan accepted on a number of occasions that the premises had operated outside the licensable hours. My submission is that, Mr Sheahan will return to Ireland, but should he interfere with the running of the premises, Ms Malarky can satisfy you that she won't allow it.

In relation to the 17 March 2017, the latest allegation, it was not accepted by Mr Sheahan that he was operating outside the permitted hours.

Re the 17 February incident, Mr Sheahan had dealt with the patron and had now banned him.

Finally, with regard to the 28 and 29 of October events it was submitted that the TEN objections by the Police were wrong in law. The Act allows a number of "events" as long as they take place within the 168 hour period. As such, there should have never been any objection by the police.

The voluntary action plan was put into place. Training is taking place. The door supervisors are SIA registered. Incident books and refusal books are maintained.

As can be seen from the letters of support Greene's can be seen as a community hub. Many of the writers live locally. The local residents are saying here that this public house does not cause a problem.

Ms Mullarkey then gave evidence. She stated that she lives in Willesden and has done so all her life. She explained that she intended to be present more often to run the premises properly, not just be a member of staff.

She acknowledged that Mr Sheahan demonstrated a lot of influence over the public house and if he did interfere she would withdraw from the premises. Ms Mullarkey stated that she could take on the premises within 4 weeks. Mr Sheahan gave evidence to the sub-committee and explained that he intended to go back to Ireland and deal with some personal issues.

Under questioning Ms Mullarkey confirmed that she was DPS for Sals Bar. She also confirmed that she had struggled spending time at Sals bar because of her pregnancy. Ms Mullarkey accepted that she had never run a "difficult" bar.

It was clarified that she had held a personal licence for 9 years and hadn't had any formal training for 9 years. Ms Mullarkey could not name any of the four licensing objectives.

Mr Sheahan confirmed that he currently lives above Greenes. He could not answer where he would live on his return to England. Mr Sheahan accepted that he had operated outside of the permitted hours.

Mr Sheahan explained that he was aware that the TEN for the 28/29 October had been refused. He explained that it was a local group who had booked the public house and that he hoped to have "stayed under the radar".

In summing up the Police noted that this was the second Review within 2 years. The licensee had clearly no regard for the licence conditions or the decisions of the sub-committee.

Mr Sutherland submitted that it was accepted by Mr Sheahan that breaches had taken place. However, the sub-committee were asked to look at the way forward. This premises is an asset to the local community. The Action Plan has been complied with to

a large extent. The committee can be satisfied that with Ms Mullarky as the licensee of these premises she will promote the licensing objectives.

## **5. Determination of the Application**

The sub-committee determined the application in accordance the provisions of the Licensing Act 2003. Further the sub-committee considered the matter with a view to promoting the licensing objectives, namely:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm.

In making its decision the sub-committee also had regard to the Guidance issued under Section 182 of the Licensing Act 2003 and Brent's licensing policy. In addition, the sub-committee took account of its obligations under section 17 of the Crime and Disorder Act 1998.

The sub-committee were mindful of the need to reach a decision that was necessary, proportionate, and justified on the evidence before them.

## **6. Decision**

The sub-committee have listened carefully to the submissions made by all parties. We have also listened to the evidence of Ms Mullarky and read all the letters of support from the local residents

This premises has an extremely poor history. This is the second time that it has been reviewed in 2 years.

The clear evidence before the sub-committee shows persistent and flagrant breaches of the licence conditions. These are accepted by Mr Sheahan.

Furthermore, there are a number of occasions where Mr Sheahan has applied for late TENs, which have been refused, and yet he has gone on to hold the event. This shows a total disregard for this sub-committee's decisions.

It has been suggested by Mr Sutherland that the police objection to at least one of those TENs was unlawful. The sub-committee make no determination on this issue but regard it as totally irrelevant to the determination of the application before it today. The TEN in

question was refused with Mr Sheahan stating to us today that he was aware of that refusal. Regardless he operated outside his permitted hours.

Mr Sheahan has indicated that he intends to return to Ireland and play no further part in the running of this premises. It is suggested that Ms Mullarkey take over as Licence Holder and DPS. The sub-committee do have grave concerns as to whether Mr Sheahan will remove himself from involvement in this premises.

The sub-committee do not consider the imposition of further conditions, removal of the current DPS or exclusion of licensable activities will assist in promoting the licensing objectives.

However, whilst the history of poor management is serious we do not consider a complete revocation to be a proportionate response to this application.

The sub-committee has decided to suspend the licence for a period of 3 months.

This, we hope, will give sufficient time for the transfer application to be made and for Mr Sheahan to remove himself from the premises. We hope that this premises will not come before the sub-committee again.

## **7. Right of Appeal**

The parties have a right of appeal to Brent Magistrates' court against this decision

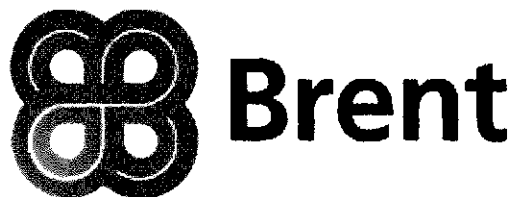

### Annexe 1 - Mandatory Conditions

#### No Irresponsible Drinks Promotions

(1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

(a) games or other activities which require or encourage,

or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

#### Free Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

### Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
  - (a) a holographic mark, or
  - (b) an ultraviolet feature.

### Small Measures to be Available

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

### Minimum Price of Alcohol

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1—
  - (a) —duty is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) —permitted price is the price found by applying the formula—
$$P = D + (D \times V)$$
where—
    - (i) P is the permitted price,
    - (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
    - (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
  - (c) —relevant person means, in relation to premises in respect of which there is in force a premises licence—
    - (i) the holder of the premises licence,
    - (ii) the designated premises supervisor (if any) in respect of such a licence, or
    - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
  - (d) —relevant person means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
  - (e) —value added tax means value added tax charged in accordance with the Value Added Tax Act 1994.
3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first day) would be different from the permitted price

on the next day (—the second day)) as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

### **Requirement for a DPS**

(1) No supply of alcohol may be made under the premises licence-

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Door Supervisors and Security Staff to be Licensed by the SIA (when required)**

Where the licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each individual must be licensed by the Security Industry Authority, with the following exceptions:

a) premises where the premises licence authorises plays or films

b) any occasion mentioned in paragraph 8(3)(b) or (c) of Schedule 2 to the Private Security Industry Act 2001 (premises being used exclusively by a club with a club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or

c) any occasion within paragraph 8(3)(d) of Schedule 2 to the Private Security Industry Act 2001

### **Embedded Conditions**

#### **Alcohol On Sales**

Alcohol shall only be sold during the hours specified below:

On weekdays, other than Christmas Day, Good Friday or New Year's Eve, between 10:00 and 23:00 hours.

On Sundays, other than Christmas Day or New Year's Eve, between 12:00 and 22:30 hours.

On Good Friday, between 12:00 and 22:30 hours.

On Christmas Day, from 12:00 to 15:00 and 19:00 to 22:30 hours.

When New Year's Eve is on a weekday, from 10:00 on New Year's Eve until 23:00 hours on New Year's Day, except when New Year's Day is on a Sunday, then the sale of alcohol shall cease at 22:30.

When New Year's Eve is on a Sunday, from 12:00 on New Year's Eve until 23:00 hours on New Year's Day

- 1 CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 2 A "Challenge 21" policy shall be adopted and adhered to
- 3 A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for inspection at the premises.
- 4 An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
  - (a) all crimes reported to the venue
  - (b) all ejections of patrons
  - (c) any complaints received
  - (d) any incidents of disorder
  - (e) all seizures of drugs or offensive weapons
  - (f) any faults in the CCTV system or searching equipment or scanning equipment
  - (g) any refusal of the sale of alcohol
  - (h) any visit by a relevant authority or emergency service.
- 5 No entry or re-entry shall be permitted after 2230 hours.
- 6 Customers shall not be permitted to take open drink containers outside the premises as shown on the plan submitted to and approved by the Licensing Authority.
- 7 No drinks shall be served other than in plastic or toughened glasses.
- 8 Customers carrying open or sealed bottles or glasses shall not be admitted to the premises.
- 9 Every 6 (six) months staff training on the Licensing Act 2003 and the premises operating procedures shall be provided. This training shall be documented, signed and dated. Training records shall be made available for inspection by the Police and Licensing Authority Enforcement Officers and copies shall be provided on request.
- 10 The inward opening front entrance/exit door to the bar area shall be fixed back in the open position when the public are on the premises.
- 11 Any locks or latches on exit doors, shutter or gates shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.

- 12 Appropriate emergency exit signage shall be installed within both bar and pool room areas and on exit doors to ensure any person on the premises is aware of emergency exit routes.
- 13 The exit door from the pool room area shall only be used as a fire/emergency exit if an appropriate push bar door is installed or the door is locked in the open position at all times whilst public are on the premises
- 14 Any socket outlets (or other power supplies used for DJ equipment, band equipment and other portable equipment) that are accessible to performers or staff shall be suitably protected by a residual current device (RCD having a rated residual operating current not exceeding 30 milliamps).

#### 1. Members of the Sub-Committee

Councillors Long (Chair), Harrison and McLeish.

#### 2. The Application

The application is for a summary review of the premises licence held by Mr Timothy Sheahan under section 53A of the Licensing Act 2003.

The application was brought by PC Michael Sullivan on behalf of the chief officer of police for the Metropolitan Police.

#### 3. Representation

The applicant was represented by PC Michael Sullivan.

The licence holder, Mr Sheahan, attended unrepresented.

Mrs Sheahan also attended.

#### 4. The Hearing

PC Sullivan set out the police representations. There was a serious incident on the 21<sup>st</sup> May 2017 which started inside the premises and ended up with a gentleman being seriously injured outside.

Police attended to find an unconscious male outside and another male with facial injuries. The male who was unconscious was taken to St. Mary's and has serious injuries. It started inside when a group of Eastern Europeans were asked to drink up.

Something was thrown at the bar maid and she was then grabbed around the throat. Others picked up pool cues to help her. They hit the Eastern Europeans with the pool cues. Punches and glasses were thrown. One glass hit a male causing the facial injuries. It was initially thought he had serious injuries but they have transpired to be more superficial. One elderly male helping the bar maid was accidentally shut outside with the Eastern Europeans. They started kicking the door trying to get back in. They then turned on the elderly man who had fallen to the floor.

The CCTV was shown of the outside of the bar. The time shown is incorrect. The call to the police was just before midnight. The males can be seen being pushed out. The elderly man falls out of the door with them and goes to the floor. Punches can be seen being thrown as the males are ejected. The males then start kicking the man on the ground. Although it was a short incident, a number of hard kicks were aimed at his head. He was also jumped on by one male. After the males ran off two members of the public came to his assistance.

The incident happened 18 days after the review on the 4<sup>th</sup> May. PC Sullivan has discussed the matter with Mr Sheahan who has already purchased an ID scanner. He has three doormen at Sal's Bar (now called The Field). It was suggested that one of the doorman will come and assist to close the pub up.

Photos were shown of the injured gentleman. He has suffered a collapsed lung. According to Mr Sheahan he is now out of hospital.

PC Sullivan proposed the two conditions be imposed as interim steps.

In answer to questions from the sub-committee, PC Sullivan confirmed it was a Sunday evening and the police were called at 23.54. Mr Sheahan has been told to rectify the time on the CCTV. The bar maid is believed to be the person who called the police. The supply of alcohol on a Sunday is until 22.30. Mr Sheahan had told him that they had stopped serving but were struggling to remove people. PC Sullivan has not yet had a chance to check the internal CCTV to see if that is correct. He did confirm that the pint thrown did look to be almost full. PC Sullivan said that his understanding was that the European men had been sitting on the benches outside drinking cans of their own beer. The bar maid said they could not do that and told them they needed to buy alcohol which they did. There were some problems with them using the pool table but the locals left them alone. The problems only started when she asked them to go at closing time. There appears to have been one bar maid working on her own. That is why doormen are needed to assist.

Mr Sheahan presented his case and started by apologising for what he acknowledged was a terrible and serious incident. He pointed out that the locals did not start the fight but were trying to protect the bar maid. They were outnumbered. There would not usually be such problems at Greene's as the clientele is usually Irish. The ID machines cost £4,500 plus maintenance costs. He bought two of them as soon as he heard of the incident. Anyone unknown will be asked for ID before they are allowed in. It has facial recognition too. As far as he is aware, no other bars in the area have such a machine. He would be prepared to send extra security down from his other bar.

In response to questions from PC Sullivan, Mr Sheahan confirmed that the bar was open over the Bank Holiday weekend. He did not have security staff on because it closed at 22.00 hours on Saturday and Mr Sheahan was there himself on Sunday. The ID scanner is in place and was used at the weekend. The staff have been trained on how to use it. In future, on Friday, Saturday and Sunday nights a member of door staff from Sal's would be sent down.

In response to questions from the sub-committee, Mr Sheahan confirmed that the man who was seriously injured is a regular and was being a good Samaritan. Mr Sheahan has never seen the Eastern Europeans on the CCTV before. He hopes they will be brought to justice.

When he was asked why there were still people there nearly an hour after closing Mr Sheahan said the three regulars still there were waiting for taxis.

Mr Sheahan said he was in Ireland at the time. The Designated Premises Supervisor was at Sal's Bar. The bar maid did not call anyone; she tried to deal with it herself.

When asked about the drunkenness of the customers, Mr Sheahan said the regulars had to stay in the pub until 6am in order to give statements. They were told by the police that they could have a drink but could not leave.

Mr Sheahan said they had not previously had problems with the benches outside.

Mr Sheahan was asked whether he thought it was ridiculous that his bar had some of the earliest closing hours in Neasden and yet they needed an ID scanner. He said there were gangs in Neasden and problems with drugs. He said that this weekend, people he would not be happy with had stayed away because of the ID scanner.

Mr Sheahan said he was appealing the suspension imposed on the 4<sup>th</sup> May. He did not think shutting the place was a good way of dealing with it.

Mr Sheahan was asked how the scanner works. He said that it's operated by the bar maid. It's kept at the bar. If someone comes in that she's not happy with, she asks them to put their ID in. At the weekends, everyone will be scanned after 9pm.

Mr Sheahan said that the bar maid who was working on the 21<sup>st</sup> May 2017 is in her mid-40s and is very competent.

PC Sullivan summed up by saying it was a serious incident. There are a number of outstanding questions that he has had insufficient time to deal with. He reminded the sub-committee that, according to the CRIS, victims 1 and 2 were too drunk to provide statements as was the brother of victim 1. He asked that the ID scanner be used to check all customers and that door staff were present from one hour before closing at the weekend.

Mr Sheahan had nothing to add to what he had already said.

## **5. Determination of the Application**

Pursuant to sections 53A and 53B of the Licensing Act 2003, the sub-committee considered whether it was necessary to take interim steps pending the determination of a review of the premises licence. The sub-committee considered whether to modify the conditions of the premises licence, to exclude the sale of alcohol by retail from the scope of the licence, to remove the designated premises supervisor from the licence, or to suspend the licence.

Those matters were considered with a view to promoting the licensing objectives, namely:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm.

In making its decision the sub-committee also had regard to the Home Office Summary Review Guidance and Brent's licensing policy. In addition, the sub-committee took account of its obligations under section 17 of the Crime and Disorder Act 1998.

The sub-committee were mindful of the need to reach a decision that was necessary, proportionate, and justified on the evidence before them.

## **6. Decision**



The sub-committee listened carefully to the submissions made by both parties.

They found it necessary to suspend the licence as an interim step with immediate effect.

The sub-committee were concerned that the incident took place nearly an hour and a half after alcohol should have ceased being served and nearly an hour after closing time. One of the drinks seen being thrown on the CCTV was almost a full pint. The sub-committee was also concerned that three of the witnesses in the pub were considered to be too drunk to give statements to the police.

The sub-committee took into account the history of problems at the venue and the fact that this incident took place shortly after a review.

The sub-committee was concerned that the Designated Premises Supervisor was, yet again, not on site and was not contacted by the bar maid when the problems started.

The sub-committee did not consider the steps proposed by the police to be sufficient to allay their concerns because they will not address the main concerns which relate to drunkenness and non-compliance with licensable hours.

## **7. Review Hearing**

A review of the premises licence will take place on a date to be notified.

## **8. Right of Appeal**

The holder of the premises licence has the right to make representations against this decision.
