Shree Superstore (also known until recently as Sunny Superstore) currently has a Premise Licence to sell alcohol 24 hours daily.

Since 5th October 2017 the Premises Licence holder (PLH) and Designated Premises supervisor (DPS) are one and the same, a Mr Ankitkumar BHATT.

Alcohol is authorised to be supplied for consumption off of the premises and should not be sold in open containers.

The following conditions are attached to annex 2 of the licence:

1.CCTV shall be installed and maintained in a working condition.

2. All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

3. 'Raid Control' crime prevention measures shall be installed and all staff given suitable training.

4. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

5. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises. 6. Photographic proof of age shall be required from all persons appearing to be under the age of 21.

7. A sign stating 'No proof of age - No sale' shall be displayed at the point of sale.

8. A refusal book shall be kept and maintained.

9. On major event days at Wembley Stadium the following shall apply:

Customers shall not be allowed to congregate outside the premises.

No glass bottles shall be sold, all drinks shall be sold in plastic bottles or cans.

The current operation in the shop if failing to promote all four of the licensing objectives due to consistent violation of licensing legislation and disregard to the safety and welfare of the public. Sitting within the footprint of the National stadium, when alcohol fuelled crime and disorder are a major issue at some events, Mr BHATT fails to assist Police by repeatedly selling large quantities of alcohol and in glass vessels. He refuses to improve the operation of his shop despite Police intervention and advice from a licensing agent. His mistakes continue and have worryingly escalated in a very short period of time.

Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.

18th May 2017

Warning letter to the previous premise licence holder for breaches of the licensing conditions relating to major events at Wembley Stadium. Exhibit NM/1.

Mr BHATT admitted to Officers he worked alongside the previous licence holders for at least six months before purchasing the business.

During a meeting with Mr BHATT on 14/4/2018, he admitted he had worked alongside the previous owners in the shop for six months prior to purchasing the shop in September 2018. He did this to gauge the profitability of the shop.

22nd September 2017

Mr BHATT officially becomes the premises licence holder. Mr BHATT officially becomes the designated premises supervisor.

28th February 2018

Brent Police licensing officers visited the shop at approximately 1600hrs, it was a major football event at Wembley stadium, the shop was open to the public and alcohol was being sold.

There was one member of staff present, he gave his name as

he was

not the owner of a personal licence. He had no knowledge of licensing legislation. claimed he often "helps out" but doesn't get paid to work, as his Visa doesn't allow him employment in the UK.

The following premise license conditions were in breach:

1. "Raid Control" crime prevention measures shall be installed and all staff given suitable training.

2. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

3. A sign stating 'No Proof of age- No sale' shall be displayed at the point of sale.

4. A refusal book shall be kept and maintained.

5. On major event days at Wembley Stadium the following shall apply:

- No glass bottles shall be sold, all drinks shall be sold in plastic bottles or cans.

was told not to sell any alcohol and to cover or remove all the alcohol from display.

We returned to the shop approximately two hours later and Mr BHATT was in the shop. He explained he had to leave the shop for an emergency and had asked **Example** to keep the shop open to serve customers. Mr BHATT said there was no other personal licence holder that worked in the shop. Mr BHATT was told that in that case when he was not on the premises he must not permit sales or display of alcohol. The shop has a 24 hour licence but Mr BHATT said he never opens 24 hours.

Mr BHATT had no knowledge of the 'Raid Control' measures.

Mr BHATT was unaware of the major events at Wembley stadium, he had a negative attitude to the events claiming 'they are always changing'. This was correct with the Tottenham football matches but he was advised it is his responsibility to monitor the Stadium events calendar to prevent breaches of the premises licence.

Officers examined the refusal book, there were only two entries both in November 2017. Mr BHATT admitted he did not bother to fill it and maintain it as required by the licencing conditions.

There was no sign displayed stating "No Proof of age-No Sale".

Officers had a telephone conversation whilst in the shop with Mr BHATT's licensing agent, Mr Panchal, Personal licence courses ltd. He was informed of what officers had witnessed and advised Mr BHATT not to sell or display alcohol until the breaches had been rectified. Mr

Panchal said he would contact Police when the issues were all resolved.

6th March 2018

Mr BHATT issued with a formal written warning by Police for events on 28th February 2018 and offences under section 136 Licensing Act 2003, namely conducting licensable activities without authority, which carries a fine of up to £20,000 and/or up to 6 months imprisonment. Exhibit NM/2

31st March 2018

Crimint QKRT00481809

Police were called to the SUNNY SUPERSTORE 11 WEMBLEY HILL ROAD HA9 8AF to reports of a civil dispute.

A male who was with 3 friends had bought a 1.5 litre bottle of brandy from the shop. They had negotiated a price of £40 and taken it back to the Holiday Inn, where they had been drinking it mixed with water. There was less than 100ml left in the bottle when they realised they weren't drunk. They tasted the liquid and said it tasted like water with sugar in it, and took it back to the shop. The male added that they had struggled to open the bottle as there was something wrong with the lid.

The shop refused to give a refund or exchange it as it was almost all gone. The male was unable to provide a receipt. He was informed it was a civil dispute and to contact either trading standards or take them to small claims court.

14th April 2018

Brent Police licensing officers visited the shop at approximately 1300hrs, it was a major football event at Wembley stadium, the shop was open to the public and alcohol was being sold.

There was one member of staff present behind the counter he gave his name as

he was not the owner of a personal licence. He had no knowledge of licensing legislation. He said he was not working, but there was no other member of staff in particular no personal licence holder present. There was glass bottles of beer on display. Said the owner had just popped home.

The following premise license conditions were in breach:

2. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

5. On major event days at Wembley Stadium the following shall apply:

- No glass bottles shall be sold, all drinks shall be sold in plastic bottles or cans.

2nd May 2018

Mr Ankitkumar Bhatt attended a meeting at Brent Civic Centre with Brent Police Licensing Officers.

Mr BHATT was asked why he was not at the shop on 14th April 2018 or why a personal licence holder was not present. Mr BHATT stated that his baby had been rushed to hospital, he had no answer when asked why he did not just cover and stop selling alcohol. When Officers probed him about the emergency with his child it became apparent that he was lying and that he child was not ill or rushed to hospital. Mr BHATT then began to claim he was unaware of the conditions on his premises licence, however Police are fully aware Mr Panchal 'licensing agent' had gone over the conditions with him in February and rectified any anomalies . Mr BHATT attempted to blame the previous owner whom he worked under for more than six months, stating they had told him he was permitted to sell glass bottles on event days. Mr BHATT was reminded of the warning letter issued to him at the beginning of March 2018 that echoed these breaches. Mr BHATT then asked for a second chance that there would be no more issues at the shop. Police informed him that a premises licence review was a realistic option.

7th May 2018

At approximately 1400hours PC Sullivan and Pc Cowley from Brent Police Licensing team conducted a licensing visit. On entering the shop Pc Sullivan saw Mr Ankitkumar BHATT

behind the serving counter. When Mr BHATT saw the Officers he turned his head towards the rear of the shop and shouted something in a foreign language. PC Sullivan looked to the rear of the shop and saw three Asian males standing at the rear of the shop drinking from plastic cups. Officers walked to the back of the shop where they saw a large open high strength cider bottle and an open can of Budweiser beer on top of a large blue barrel next to where the males were standing. There were three other Asian males and a Somali male discovered standing in a side room also drinking alcohol. Photographs taken by PC Sullivan Exhibits NW/3 – NM/6.

PC Sullivan went back to Mr BHATT at the counter, he was selling a bottle of cider to a male, the male asked for a plastic cup. Mr BHATT removed a clear plastic cup from a plastic sleeve containing new plastic cups lodge next to the till area see photo Exhibit NM/7 and gave a cup to him. PC Sullivan pointed out that this was not acceptable, encouraging street drinking, Mr BHATT replied 'all the shops do it'. PC Sullivan then asked why there was people standing drinking alcohol in his shop, pointed out he had authority to sell alcohol for consumption off the premises only. The only reason Mr BHATT could recognise for this was that 'the shop was busy and he was on his own'. PC Sullivan told the males to leave the premises and asked Mr BHATT for a copy of the CCTV recording for 1 hour prior to Police arrival. Mr BHATT was advised strongly to operate in accordance with his authority.

Mr BHATT provided a memory stick apparently containing the footage, however did not work correctly and did not have all the shops cameras on it.

18th May 2018

At 1400 hours Brent Police Licensing Officers visited the shop. Mr BHATT was present. . PC Sullivan spoke to Mr BHATT and said 'no more people drinking in your shop?' Mr BHATT was confident in his response 'No, No one at the back'. PC Sullivan asked if I could take a look, Mr BHATT then nervously said 'yes' however remained standing at the counter looking sheepish. PC Sullivan and PC Cowley went to the rear of the shop. In the stock room officers discovered an Asian male with a woolly hat and anorak drinking high strength cheap cider from a 2 litre bottle, there was other opened bottles of alcohol. Photo Exhibit NM/8,9 & 10. Officers called Mr BHATT to the rear of the shop and expressed their disappointment upon finding the male. Mr BHATT accompanied Officers up a narrow staircase at the rear of the shop that lead to a locked door. Mr BHATT oddly knocked on the door, he then produced keys and unlocked the door that revealed a hidden room/makeshift residential accommodation. Mr BHATT informed officers he was renting the room out for residential purposes. Photos Exhibit NM/11,12,13,14,15,16,17.

Officers asked Mr BHATT if he was authorised to rent out part of the shop. Mr BHATT admitted to officers he was NOT permitted to have people living in the shop and he showed officers an email on his phone that he forwarded to Police. Exhibit NM/18.

Since that date Brent Police Licensing have had verbal communications with Mr BHATT's licensing consultant Mr Panchal. He informed Police he had reiterated on several occasions to Mr BHATT his premises licence conditions, licensing legislation and best practice. Mr Panchal informed Officers he is no longer representing Mr BHATT.

23rd May 2018

The shop was visited by Brent trading standards Officers in company with HMRC Officers. Numerous items were seized by both authorities with reference to illegal age restricted products, alcohol and cigarettes.

26th May 2018

This date was a major football event at Wembley Stadium, the Championship league play off with a 1700 hour kick off. The shop was open to the public and alcohol was being sold At approximately 1450 hours PC177QK and PC 59QK who were on foot patrol in full uniform around the stadium surrounds, attended the store. The shop was very busy and Officers noticed a long queue of customers some holding glass bottles of beer waiting to pay. As officers entered the shop they saw a customer pay for two glass bottles of alcohol. Police spoke to Mr BHATT working behind the counter who stated that he WAS aware of the restrictions but he was waiting for another member of staff to attend the shop to assist with stopping customers taking glass bottles from the fridge. The Officers explained the licensing requirements on football event days and told Mr BHATT to remove from display or cover all

glass bottles of beer cider and alcohoop style drinks and not to sell more than four cans of beer to anyone person. Officers conducted other licensing visits and then returned to the shop some minutes later. As officers walked in to the shop they saw a customer walking away from the till point having purchased six cans of beer. This information was passed to Brent Police licensing officers also working at the football event. PC Sullivan entered the shop on the same day after reiving the information. He saw Mr BHATT behind the counter. He asked Mr BHATT for an explanation and he said 'I was very busy working here by myself'. He then went on to show PC Sullivan that the glass bottles of beer cider and alcopop style drinks had now been removed from display.

The following premise license conditions were in breach:

5. On major event days at Wembley Stadium the following shall apply:

- No glass bottles shall be sold, all drinks shall be sold in plastic bottles or cans.

Mr BHATT has shown a lack of management in the running of his business, the above evidence shows he has no understanding of what is required of him as the Premises licence holder and Designated premises supervisor. He clearly has no regard to the Licensing regime.

MR BHATT evidently considers making a profit above the good of the local community and licensing objectives.

It is clear that Mr BHATT is not able to abide by the minimal conditions attached to such an extreme authority (24 hours).

It is obvious that Mr BHATT has not taken on board the seriousness of the Police interactions and warnings, or those from his licensing agent Mr Panchal. In my experience as a Licensing Officer I have never dealt with a DPS who in such a short space of time has continuously and shamelessly flouted the legislation with no genuine regret. If Mr BHATT was removed as DPS, he would still have dealings will the day to day operation of the shop because he is the premises licence holder and has a financial interest.

Police do not consider a suspension of the premises licence would produce any improvement. After Police visited the shop on 28th February 2018 Mr BHATT was unable to sell/display alcohol for over a week until he implemented the premises licence conditions, in particular the installation of a time delay safe. As evidenced he then went on to continue breaking the law.

Mr BHATT does not require training, he is aware of legislation but chooses to ignore it. This is also demonstrated by knowingly breaching the lease agreement, the insurance policy of the building and local authority planning consents.

Police have no trust in Mr BHATT's integratory he has failed to show any commitment to improving and this leads me to feel there is no other alternative, to uphold the licensing objectives, than to ask the committee to revoke the premise licence.

I write to summarise a recent licensing visit made to your premises on Sunday 14th May 2017. On this day it was a designated Wembley Event Day.

There was a football match at Wembley Stadium, namely the Vanarama League Final game between Tranmere and Forest Green Rovers.

Your shop was open to the public and alcohol was being sold.

During the visit glass bottles of alcohol were being sold and on display for sale. This breaches condition 9 of your premises licence 'on major event days at Wembley Stadium the following should apply: customers should not be allowed to congregate outside the premises and no glass bottles shall be sold, all drinks sold should be in plastic bottles or cans'.

Disappointingly this is not the first time you have breached this condition of your premises licence.

It is just as important to maintain this condition on games with lower capacitates where sporadic violence is just as common. It is crucial that glass bottles are not accessible and able to be used as weapons

Police insist that the glass bottles are totally covered or removed from display to assist you and your staff from football fans who may persevere in their attempts to purchase them. Glass bottles can cause serious injuries if used as a missile or weapon during disorder.

I am writing this letter in response to my two visits to your shop on Wednesday 28th February 2018, along with PC McDonald 157QK, when the venue was open to the public and alcohol was being sold.

During that visit to your shop, I discovered the following breaches of your premises license number: 251453.

1. "Raid Control" crime prevention measures shall be installed and all staff given suitable training.

2. A personal licence holder shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

3. A sign stating 'No Proof of age- No sale' shall be displayed at the point of sale.

4. A refusal book shall be kept and maintained.

5. On major event days at Wembley Stadium the following shall apply:

- No glass bottles shall be sold, all drinks shall be sold in plastic bottles or cans.

I must point out that these breaches amount to an offence under section 136 Licensing Act 2003, namely conducting licensable activities without authority, which carries a fine of up to £20,000 and/or up to 6 months imprisonment.

We visited your shop twice on Wednesday 28th February, which was a Wembley Stadium major event day. On the first visit, the person you left in charge to serve customers, Mr

was found not to hold a personal licence. He had no knowledge of any Raid Control measures, such as the need to have a time delay safe and did not know there was a refusals book, or where it might be located. Only some of the glass bottles of beer, cider and alcopops in the fridges were covered to prevent display and sale.

However, as there was no personal licence holder in the store, all the alcohol should have been either taken from the shelves and put out of view or covered entirely, as you cannot display or sell alcohol without a personal licence holder present in the shop. claimed he often "helps out" but doesn't get paid to work, as his Visa doesn't allow him employment in the UK.

We returned to the shop later on to speak to you directly. You explained you had to leave the shop for an emergency and had asked to keep the shop open to serve customers. The shop has a 24 hour licence to sell alcohol and you said you couldn't be there the whole time to sell alcohol. You also said you did not have anyone else who works for you that is a personal licence holder, when you aren't there. Therefore, whenever you are not in the shop when it is open, you are breaching your licencing conditions by continuing to display ANY of the alcohol, or sell it.

You stated you didn't know you had to have a time delay safe, as per the Raid Control licencing condition.

When you asked what day the next Wembley Event day was, you didn't know and said its impossible to know as the times and dates keep changing. It was pointed that that you need to keep checking, as selling bottles of beer & ciders and alcopops on Event days is not permissible and you

You did locate your refusals book, which had two entries dated in November 2017. You admitted you did not bother to fill it and maintain it as required in your licencing conditions. Finally, you did not have a sign on display stating "No Proof of age-No Sale".

This letter is a written warning. The Metropolitan Police as a Responsible Authority under the Licensing Act 2003 reserves the right to initiate a Review of your Premises License and take enforcement action with reference to the commission of offences under the 'Act'







Bacovia Supermarket currently has a Premise Licence to sell alcohol from 0700 hours to 2300 hours 7 days a week.

The Premises Licence holder (PLH) has been held by Mr Mihail LUPES since the licence was first granted on 8th January 2009.

The Designated Premises supervisor (DPS) since 21st January 2015 is Ms Lavinia Victoria Illeanu

Alcohol is authorised to be supplied for consumption off of the premises and should not be sold in open containers.

The current operation in the shop if failing to promote three of the licensing objectives Protection of Children, Public safety and prevention of Crime and Disorder.

During the initial premises licence application process in 2009 Police requested several conditions be attached to the licence that would promote all the licensing objectives. In April 2011 Police discovered during a visit to the shop several of the premises licence conditions were being breached.

After hearing an application to review of the premises licence for Bacovia, the Licensing Committee decided to add further conditions to encourage improvements at the shop. However in July 2017, Mr Lupes applied to remove significant conditions from the premises licence stating his reasoning 'as a small business the cost of putting on training courses is too expensive. I will do regular training with all staff which will be recorded and signed for by DPS and staff'. Mr Lupes is not a personal License holder, his knowledge of licensing legislation is limited and Police question what he can impart to his staff. Police believe this has had a adverse impact on the running of the shop and as a result the recent sale of alcohol to a child has arisen.

Located within an area of alcohol fuelled crime and disorder, Mr Lupes fails to assist Police and partners by selling and stocking illegal age restricted goods.

Police intervention via these means so quickly is to prevent a rapid escalation and risk of putting the public and children at harm.

Removal of conditions from the premises licence has been a catalyst for further offences.

Police request the Licensing Committee add conditions to the premises licence and consider a significant suspension of the premises licence to allow time for more staff to become personal licence holders.

The recommended conditions are:

- (i) That a personal licence holder who speaks fluent English be on the premises at all times that it is open to the public and if such times they are not on the premises, then there shall be no sale or display of alcohol.
- (ii) A clear and unobstructed view into the premises shall be maintained at all times.
- (iii) An incident log shall be kept at the premises and made available for inspection on request of an authorised officer of Brent Council or the Police which will record the following:
 - a. all crimes reported to the venue
 - b. any complaints received
 - c. any faults in the CCTV system or searching equipment or scanning equipment
 - d. any refusal of the sale of alcohol
 - e. any visit by a relevant authority o emergency service
- (iv) No miniature bottles of wine or spirits in units of less than 35cl should be sold at the premises.
- (v) No single cans or bottles of beer lager or cider shall be sold.
- (vi) Any staff directly involved in selling alcohol for retail to consumers, staff who provide training and all managers will undergo regular training of Licensing Act 2003 legislation. This will be documented and signed for by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.
- (vii) Stock shall be purchased only from established traders.
- (viii) Copies of invoices and receipts for stock shall be kept for a minimum of eighteen months and made available to authorised officers.

When the premises licence was initially granted in 2009 Police requested the following conditions to be attached to annex 2 of the premises licence

1 CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.

2 A CCTV camera shall be installed to cover the entrance of the premises.

3 A "Challenge 21" policy shall be adopted and adhered to.

4 A refusal book shall be kept and maintained.

5 Promotions that encourage irresponsible drinking shall not be permitted.

6 No high strength beers, lagers, and ciders above 5.5% ABV shall be stocked with the exception of premium beers.

7 "Raid Control" crime prevention measures shall be installed and all staff given suitable training.

8 A clear and unobstructed view into the premises shall be maintained at all times.

9 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

10 A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

11 On major event days at Wembley Stadium the following shall apply:

Customers shall not be allowed to congregate outside the premises.

No glass bottles shall be handed over the bar but decanted into plastic vessels.

The DPS shall work in partnership with the Police and if necessary comply with any direction given by the most senior Police Officer on duty at the event.

No alcohol or "alcopop" type drinks shall be displayed or sold in glass containers with the exception of wines and spirits.

October 2012

Brent Trading standards Officers made an application to review the premises licence for Bacovia. Their evidence included the sale of alcohol to a child.

Police supported the review application highlighting during a visit to the premises on 12 April 2011 the following breaches of the premises licence were identified

8 A clear and unobstructed view into the premises shall be maintained at all times.

9 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

10 A personal licence holder fluent in English shall be present on the premises and supervise the sale of alcohol throughout the permitted hours for the sale of alcohol.

The Licensing sub-committee heard the review application and their decision was to add three further conditions to Annexe 3 of the Premises Licence:

- (i) That an application be made to vary the designated premises supervisor within three months of this hearing
- (ii) That a personal licence holder who speaks fluent English be on the premises at all times that it is open to the public and if such times they are not on the premises, then there shall be no sale of alcohol.
- (iii) That signage be displayed at the point of sale stating 'No proof of age, no sale of alcohol'.
- (iv) That alcohol products located behind the counter be covered by a screen at times when they are not for sale.

August 2015

Due to high levels of alcohol fuelled anti-social behaviour and street drinking a multi-agency proactive operation commenced around the Neasden circle area. Police initiated a voluntary agreement not to sell the high strength cheap beers and ciders predominately consumed by habitual street drinkers, for those licensed premises lacking the condition on their licence.

Neasden Circle remains an organic project that is constantly monitored by Police and Partners.

7th February 2017

Police conduct a test purchase operation with a child under the age of 18 years at Bacovia. The child was able to buy alcohol. The member of staff who sold the alcohol was issued with a fixed Penalty Notice for Section 146 Licensing Act 2003.

25th July 2017

The Premise Licence holder Mr LUPES made an application to make minor variations to the premises licence. Significantly Mr LUPES requested the removal of conditions some that are Namely:

- A clear and unobstructed view into the premises shall be maintained at all times.
- A personal licence holder fluent in English shall be present on the premises and

supervise the sale of alcohol throughout the permitted hours for the sale of alcohol. Exhibit NM/1 minor variation application.

6th February 2018

Brent Trading Standards conducted a visit to the above premises which resulted in the seizure of over illicit, unlicensed medicine.

The store room also had unlabelled 2 litre plastic bottles of red wine and 10 litre plastic bags in cardboard containers they type used for selling boxed wine.

4th April 2018

At approximately 1615 hours Police conduct a test purchase operation with a child under the age of 18 years at Bacovia.

The child was able to purchase two cans of Stella Artois for £2.40,

The member of staff who sold the alcohol was issued with a fixed Penalty Notice for Section 146 Licensing Act 2003.

2nd May 2018

Meeting at Brent Civic Centre with Mr Lupes PLH and Ms Illeanu.

Police discovered that Ms Illeanu has three members of staff working under her at the shop, however she is the only personal licence holder. Ms Illeanu works in the shop 5 days a week but the shop is open every day.

I certify that I have considered the application shown above and I wish to make representations that the likely effect of the review of the application is detrimental to the Licensing Objectives for the reasons indicated below.

Licensing Inspector: Esther Chan

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made to review the premises licence under section 51 of the Act.

Following the review application related to Bacovia Supermarket, 296 Neasden Lane, London, NW10 0AD, I conducted a visit to the premise on Wednesday 20th June 2018 at approximately 10:49hrs to carry out an inspection.

During my visit, the DPS, Ms Lavinia Victoria Lieanu and the manager Mrs Maria Ana were both present.

The following conditions which are embedded on the premise licence were breached whereby various conditions were not met or fully complied with:

Condition 1 - CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.





I was informed that CCTV recordings are only kept for 30 days.

Condition 3 - A `Challenge 21' policy shall be adopted and adhered to.

During my inspection, I observed a 'Challenge 25' poster displayed on the glass window by the front counter. Ms Lieanu confirmed that the premise adopts a 'Challenge 25' policy and a refreshers training is conducted once every month. She then showed me staff training records, which did not stipulate Challenge 25 is adopted. The training records states that no persons under 21 years of age regardless of circumstances is allowed to buy alcohol and tabaco. This was pointed out to Ms Lieanu that training records does not appear to correspond with the age verification policy adopted at the premises. Ms Lieanu admitted the error and stated she will update the training records.

Condition 9 - A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

This condition has not been met. An old copy of the premise licence dated 31st July 2013 showing part of the licence was displayed. Ms Ana was advised to ensure the most recent copy of the summary licence (Part B) of the premise licence is displayed facing outside the premise.

Condition -14 Alcohol products located behind the counter be covered by a screen at times when they are not for sale.

During my observation, it was noted that there was no screen located behind the counter to cover the alcohol. Both Ms Lieanu and Ms Ana were unaware of this condition.

<u>Summary</u>

To summarize, the Licensing Authority makes representation against this application as we are not confident that the licensee and DPS have a full understanding of the requirements under the Licensing Act. Based on the number of breaches identified at my inspection, the licence holder is unable to fully uphold the licensing objectives.

The Licensing Authority agree with all the conditions imposed by the Licensing Police in this review application.

- The DPS shall work in partnership with the Police and if necessary comply with any direction given by the most senior Police Officer on duty at the event.

- No alcohol or `alcopop? type drinks shall be displayed or sold in glass containers with the exception of wines and spirits.

12 An application be made to vary the designated premises supervisor within three months of the hearing (hearing date 7/6/13)

13 A personal licence holder who speaks fluent English be on the premises at all times that it is open to the public and if such times they are not on the premises, then there shall be no sale of alcohol.

14 Alcohol products located behind the counter be covered by a screen at times when they are not for sale.
