Police Representations to the Temporary Event Notices for

The Arch 324 Harrow Road, Wembley, HA9 6LL.

I certify that I have considered the notices shown above and I wish to make representations that the use of the premises for the temporary event would undermine the crime prevention initiative, for the reasons indicated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

A Temporary Event Notices have been given under section 100 Licensing Act 2003 by

Mr Savan Patel for Regulated entertainment, late night refreshment and sale of alcohol on 25th December 0100 hours to 0300 hours.

Police are formally making representations to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the prevention of crime and disorder and public nuisance licensing objectives.

This premise was issued with a formal Police warning by PC Norton in May 2018 for two accounts of exceeding the public safety capacity limit attached to the premises licence.

On 17th August 2018 there was an attempted murder in the vicinity of The Arch.

This was the night a Temporary Event was being held at The Arch.

Detectives investigating the crime attended the premises on 18th August and attempted to obtain CCTV footage from the venue. Unfortunately at the time of their visit there was no one able to operate the CCTV system so a formal request was left for Mr Savan the Designated Premises Supervisor to download the footage.

Investigating officers then phoned and left a voice mail for Savan Patel on 20th August, visited the premises and left an urgent message for him to contact them on 21st August, phone three times on 22nd August leaving urgent messages and re attended the venue on 24th August. The investigating officers were unable to obtain best evidence and came up against uncoperation.

Licensing Police were contacted and on 4th September I text Mr Patel and we subsequently had a conversation about this footage. He agreed to be at The Arch at 1400hrs on that day for the officers to download the footage.

Unfortunately when officers examined the hard drive for the CCTV system in The Arch it only held 14 days of footage. Mr Patel said the remainder of the footage would be on the 'cloud' however he did not know how to access that. The investigating officer left his details and Mr Patel said he would inform him of progress the following day.

On 5th September the investigating officer informed me that Mr Patel had not made contact with him. I text Mr Patel and he told me he was waiting for CCTV engineer to attend the venue and hopefully would have something at some point that day.

Neither licensing Police nor the investigating Officers heard anything from Mr Patel on 6th September.

On 7th September at 1127hours I text Mr Patel asking if he have managed to obtain the footage but heard nothing.

On 11th September 2018 I visited the premises with PC Sullivan. I had taken premises licence dated 9th September 2015 with me.

The Premises licence summary that was displayed was incorrect, dated 2014, premises licence holder named as star pubs.

I asked to see the full part A of the licence, Mr Patel produced the incorrect licence dated 2014 with no full set of plans.

Savan Patel had no idea of the conditions of the premises licence with the exception of the football match day conditions.

I went through all the conditions with him the following breaches of Annex 2 were identified:

condition 1. CCTV had only been recording for 14 days breaching

condition 3. Door supervisors not working 4 hours prior to designated kick off

condition 7. No incident log

condition 9. Outside areas are open until 0100hrs

condition 11. Not one visible

condition 12. No noise limiter

condition 14. Not sure if this is a true capacity, one fire exit locked and not in use as it leads on to a new structure.

condition 15. No entry re-entry policy.

condition 18. No notices

Breaches from Annexe 3

condition 4. No signs.

There was a new structure that I was unaware if it was on the plans and other building alterations. Mr Patel was advised to contact licensing authority immediately to obtain the correct premises licence with plans. Without this he has no idea of his conditions.

On Wednesday 12th September 2018 Miss Chan Local authority Licensing Officer and Chris Pearce from the Public health Dept visited The Arch and spoke to Mr Patel. It was confirmed that the plan connected to the premise licence was not accurate. The premises layout has been reconfigured and structural changes which would have an impact on public safety.

The outside area (facing Oakington Manor Drive) is being used as a car park and area for customers for shisha smoking and the consumption of alcohol. According to the plan, the outside area is not shown, therefore customers cannot take open drink containers outside and no licensable activities can take place.

Mr Patel was advised to submit a variation application to vary the plan immediately. However this application has not been made despite Miss Chan sending several reminders.

The prevention of crime and disorder and public safety are licensing objectives. From his lack of engagement and willingness to provide CCTV on the night there was an event at his premises, or take advise from Miss Chan I must challenge Mr Patel's integrity to uphold these objectives.

Police suggest the variation application should be submitted and approved by all the relevant authorities and that by operating under the TEN public safety and crime prevention objectives are undermined.

Based on these existing issues and considerations, Police request this TEN be rejected.

The Nuisance Control Team (NCT) object to this TEN due to concern that regulated entertainment over the period applied for may give rise to public nuisance.

On 17 June 2018, we received the following complaint via email:

The pub has recently started playing excessively loud music on event days (which is frequently). The music is so loud I'm unable to watch a movie or read a book - the music starts around 3pm in the afternoon and plays until the evening. I can literally hear every beat of the bass and every word that is sang from my living room with the double glazed windows closed.

The volume of the music is preventing me from enjoying quiet use of my home. Even today on a Sunday evening I can't sit and read quietly anywhere in my flat, and certainly not my balcony. I'm just off the phone to the pub and when I asked them to turn the music down they said they were busy and hung up.

The pub is not even next door to me! It's across the street and down the road.

A letter was sent to the premises that same months with a request that the business proprietor contact us to discuss this. No contact was received.

NCT will consider withdrawing this objection if you agree to the following conditions:

- 1. Doors and windows must remain closed during periods of regulated entertainment (other than for access and egress and in case of emergencies).
- 2. The volume and frequency of music (with special consideration given to low frequency sound) shall be arranged in such a manner that public nuisance is not experienced by the occupiers of neighbouring and nearby residential units.
- 3. Regulated entertainment will cease at 02:30hrs.

Annex 1 - Mandatory conditions

No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

1. (a)games or other activities which require or encourage,

or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Free Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.

Small Measures to be Available

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

Minimum Price of Alcohol

- 1.A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1—
- (a)—dutyll is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b)—permitted pricell is the price found by applying the formula—

$$P = D + (D \times V)$$

where—

- (i)P is the permitted price,
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c)—relevant personll means, in relation to premises in respect of which there is in force a premises licence—
 - (i)the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or



Annex 2 - Conditions consistent with the operating schedule

- Customers shall not be permitted to take open glass containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- Notices clearly explaining the licensee's drugs and weapons policy shall be displayed at the entrance and at suitable places throughout the premises.

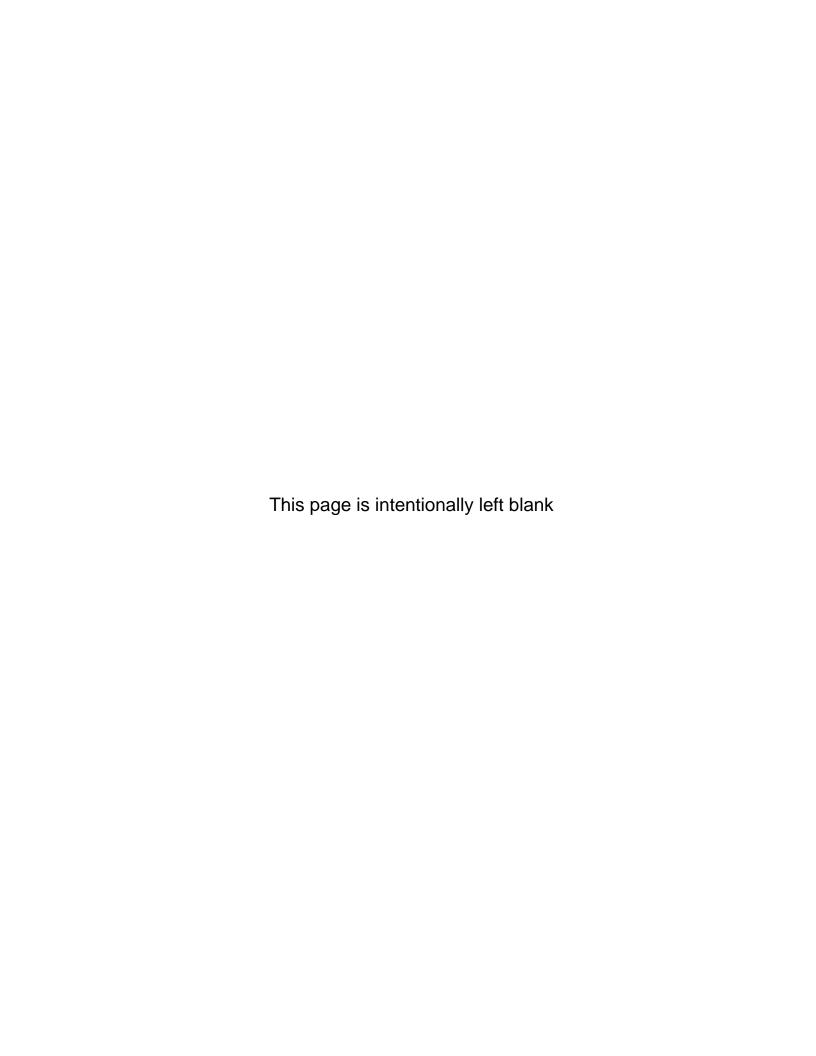

A Temporary Event Notices have been given under section 100 Licensing Act 2003 by

Mr Nihat ALGUL for the provision of late night refreshments on 4th of December 2018 from 0000 to 0400hrs.

Police are formally making representations to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the prevention of crime and disorder and public nuisance licensing objectives.

The restaurant is situated in a parade of shops in a densely populated residential area and had operated as a smaller premises for a number of years on Walm Lane. Due to its increasing popularity and the owners desire to make more of the economic opportunities, he purchased the premises next door and gained planning permission to knock through and completely redesign the old and new

premises into a brand new one. They applied for a New Premises Licence whilst the building work was nearing completion, as the old was no longer valid. The Police received this on 3rd August 2018. This had two notable changes to the old licence. An application for an even later time to offer late night refreshments and the addition of the sale by retail of alcohol.

This would have the effect of increasing late night refreshments and closing times from 0300hrs to 0400hrs from Sunday to Thursday and from 0400hrs to 0500hrs on Friday and Saturday. The sale by retail of alcohol was requested until 0200hrs.

As a Police Licensing officer, PC Norton had concerns over the extended hours as well as the introduction of alcohol sales, an obvious potentially aggravating factor to licensing concerns. I made representations on 16th August 2018 stating his concerns under the licensing objectives.

Part of the representations read:

"The applicant for the Lezziz Charcoal Grill has experience in running a similar business in the immediate area, but this was without supply of alcohol and with an earlier closing time.

Willesden Green/Mapesbury wards have prevalent Anti-Social Behaviour (ASB) problems, drug dealing/user issues and other crime related problems. Due to these ongoing issues, it was necessary for the Metropolitan Police Service to authorise a temporary dispersal zone in an attempt to prevent and disrupt ASB and criminal activity in early 2018.

The combination of closing times at very late times and the extensive supply of alcohol often lead to a detrimental impact on licensing objectives, especially in areas already suffering issues. Extending alcohol supply into the early hours of the morning will add to crime, disorder and public nuisance and would likely exacerbate these existing problems in the area. Customers who drink alcohol over longer periods are likely to become more inebriated and less inhibited, leading to irrational and violent behaviour i.e. increased drunken disorder, crime and noise. Even if the premises patrons have no intention to commit crime, or cause ASB, they may find themselves a vulnerable victim of criminality, robbed, assaulted or involved in an affray in a hot spot area already known for such issues. Criminals often target prey upon the vulnerable, such as the heavily intoxicated out late at night. If the premises were open until 0500hrs, it would increase the possibility of disturbing the peace. Customers coming and going from the restaurant after finishing a meal or collecting a takeaway; inebriated patrons coming out to smoke; car doors banging and engines revving will all increase public nuisance issues. Therefore, Police would wish to have the opening times for the premises to match the applicant's previous establishment. We would also wish to reduce the licensable supply of alcohol hours as well for reason stated above. The plan is not clear as to whether or not there is a bar area, further clarification is needed. However, the conditions below assume a bar area of some kind is present in the application plans."

Police requested the sale of alcohol to cease at 2300hrs rather than 0200hrs. The applicant and Police could not come to an agreement and the matter went to a hearing on 25TH September 2018. Prior to this date, it became apparent that as the premises was already open and continued to provide similar late night refreshments to the old premises, despite having no license. Therefore, I visited the premises on 24th August 2018 in the interests of transparency and fairness to avoid any misunderstandings.

PC Norton recorded the meeting via Body Worn Video with the applicant's son, and clearly explained that no alcohol could be sold or displayed and that late night refreshments should cease at 2300hrs. He was clearly taken aback, but Police offered him a possible solution in that they could consider Temporary Event Notices (TEN) to tide them over. Police also sent this information to his father, the applicant, on the 24/08/2018. Again, PC Norton stipulated the need to apply for TEN's whilst we awaited the outcome of the hearing.

Despite Police efforts to cooperate and offer this permissive assistance in the spirit of good relations, the premises continued to operate without a license, both in staying open until 0300/400hrs and by selling alcohol. This was borne out by a large number of residential complaints that I was made aware of by Brent Council. In fact, it highlighted a ground swell of complaints by residents who essentially were sick of years of ASB, noise, strong smells and as a result of the premises being open as late as 0300 & 0400hrs.

Police asked the Hearing Committee members to consider the residents on the closure time of the premises, rather than just PC Norton's initial representations (which had allowed them a similar time to before). Police reasons for this was we hadn't been aware of the level of discord amongst residents until the hearing approached, after Police representations were submitted.

The hearing led to the Committee granting a New Premises licence, but after weighing up the various sides of the argument, the times for late night refreshments and sale of alcohol were reduced- not extended.

The New Premises Licence timings were granted as:

Opening times
Sun-Thu 1100-0000hrs
Fri-Sat 1100-0100hrs

Sale of alcohol Sun-Thu 1100-2330hrs Fri-Sat 1100-0030hrs

<u>Late Night Refreshments</u> Sun-Thu 2300-0000hrs

Fri-Sat 2300-0100hrs

Since the hearing, the Lezziz has repeatedly continued to breach their new license and had numerous written warnings from the council for doing so. Police also have body worn evidence of such a breach on Saturday 27th October 2018 at 0140hrs. Not only this, but when Sgt Volrath spoke to a member of staff (believed to be the applicants son), he was shown a copy of the old invalid license on the Council website via a mobile phone. This isn't simply a misunderstanding, it is blatant attempt to contravene licensing laws.

The applicant has lodged an appeal against the committee decision and this is due to be heard by Magistrates on 7th February 2019.

In the intrim the applicant has submitted TEN's for 1st and 2nd December 2018 from 0100 – 0400 hours that were rejected.

Clearly driven by economic motives, the applicant is now attempting to use this notification to circumvent the findings of the Committee from the 25th September 2018 and extend the licensing hours for the lucrative night trade. All this at the expense of local residents who thought they might avoid further nuisance and have some quality of life late at night.

<u>Based on these existing issues and considerations, Police request this TEN be rejected.</u>

I certify that I have considered the notices shown above and I wish to make representations that the use of the premises for the temporary event would undermine the crime prevention initiative, for the reasons indicated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

A Temporary Event Notices have been given under section 100 Licensing Act 2003 by

Mr Nihat ALGUL for the provision of late night refreshment on 31st December – 1st January 2019 from 0000 to 0500hrs.

Police are formally making representations to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the prevention of crime and disorder and public nuisance licensing objectives.

The restaurant is situated in a parade of shops in a densely populated residential area and had operated as a smaller premises for a number of years on Walm Lane. Due to its increasing popularity and the owners desire to make more of the economic opportunities, he purchased the premises next door and gained planning permission to knock through and completely redesign the old and new

premises into a brand new one. They applied for a New Premises Licence whilst the building work was nearing completion, as the old was no longer valid. The Police received this on 3rd August 2018. This had two notable changes to the old licence. An application for an even later time to offer late night refreshments and the addition of the sale by retail of alcohol.

This would have the effect of increasing late night refreshments and closing times from 0300hrs to 0400hrs from Sunday to Thursday and from 0400hrs to 0500hrs on Friday and Saturday. The sale by retail of alcohol was requested until 0200hrs.

As a Police Licensing officer, PC Norton had concerns over the extended hours as well as the introduction of alcohol sales, an obvious potentially aggravating factor to licensing concerns. I made representations on 16th August 2018 stating his concerns under the licensing objectives.

Part of the representations read:

"The applicant for the Lezziz Charcoal Grill has experience in running a similar business in the immediate area, but this was without supply of alcohol and with an earlier closing time.

Willesden Green/Mapesbury wards have prevalent Anti-Social Behaviour (ASB) problems, drug dealing/user issues and other crime related problems. Due to these ongoing issues, it was necessary for the Metropolitan Police Service to authorise a temporary dispersal zone in an attempt to prevent and disrupt ASB and criminal activity in early 2018.

The combination of closing times at very late times and the extensive supply of alcohol often lead to a detrimental impact on licensing objectives, especially in areas already suffering issues. Extending alcohol supply into the early hours of the morning will add to crime, disorder and public nuisance and would likely exacerbate these existing problems in the area. Customers who drink alcohol over longer periods are likely to become more inebriated and less inhibited, leading to irrational and violent behaviour i.e. increased drunken disorder, crime and noise. Even if the premises patrons have no intention to commit crime, or cause ASB, they may find themselves a vulnerable victim of criminality, robbed, assaulted or involved in an affray in a hot spot area already known for such issues. Criminals often target prey upon the vulnerable, such as the heavily intoxicated out late at night. If the premises were open until 0500hrs, it would increase the possibility of disturbing the peace. Customers coming and going from the restaurant after finishing a meal or collecting a takeaway; inebriated patrons coming out to smoke; car doors banging and engines revving will all increase public nuisance issues. Therefore, Police would wish to have the opening times for the premises to match the applicant's previous establishment. We would also wish to reduce the licensable supply of alcohol hours as well for reason stated above. The plan is not clear as to whether or not there is a bar area, further clarification is needed. However, the conditions below assume a bar area of some kind is present in the application plans."

Police requested the sale of alcohol to cease at 2300hrs rather than 0200hrs. The applicant and Police could not come to an agreement and the matter went to a hearing on 25TH September 2018. Prior to this date, it became apparent that as the premises was already open and continued to provide similar late night refreshments to the old premises, despite having no license. Therefore, I visited the premises on 24th August 2018 in the interests of transparency and fairness to avoid any misunderstandings.

PC Norton recorded the meeting via Body Worn Video with the applicant's son, and clearly explained that no alcohol could be sold or displayed and that late night refreshments should cease at 2300hrs. He was clearly taken aback, but Police offered him a possible solution in that they could consider Temporary Event Notices (TEN) to tide them over. Police also sent this information to his father, the applicant, on the 24/08/2018. Again, PC Norton stipulated the need to apply for TEN's whilst we awaited the outcome of the hearing.

Despite Police efforts to cooperate and offer this permissive assistance in the spirit of good relations, the premises continued to operate without a license, both in staying open until 0300/400hrs and by selling alcohol. This was borne out by a large number of residential complaints that I was made aware of by Brent Council. In fact, it highlighted a ground swell of complaints by residents who essentially were sick of years of ASB, noise, strong smells and as a result of the premises being open as late as 0300 & 0400hrs.

Police asked the Hearing Committee members to consider the residents on the closure time of the premises, rather than just PC Norton's initial representations (which had allowed them a similar time to before). Police reasons for this was we hadn't been aware of the level of discord amongst residents until the hearing approached, after Police representations were submitted.

The hearing led to the Committee granting a New Premises licence, but after weighing up the various sides of the argument, the times for late night refreshments and sale of alcohol were reduced- not extended.

The New Premises Licence timings were granted as:

Opening times
Sun-Thu 1100-0000hrs
Fri-Sat 1100-0100hrs

Sale of alcohol Sun-Thu 1100-2330hrs Fri-Sat 1100-0030hrs

<u>Late Night Refreshments</u> Sun-Thu 2300-0000hrs

Fri-Sat 2300-0100hrs

Since the hearing, the Lezziz has repeatedly continued to breach their new license and had numerous written warnings from the council for doing so. Police also have body worn evidence of such a breach on Saturday 27th October 2018 at 0140hrs. Not only this, but when Sgt Volrath spoke to a member of staff (believed to be the applicants son), he was shown a copy of the old invalid license on the Council website via a mobile phone. This isn't simply a misunderstanding, it is blatant attempt to contravene licensing laws.

The applicant has lodged an appeal against the committee decision and this is due to be heard by Magistrates on 7th February 2019.

In the intrim the applicant has submitted TEN's for 1st and 2nd December 2018 from 0100 – 0400 hours that were rejected and Christmas Eve which Police have also objected to.

Clearly driven by economic motives, the applicant is now attempting to use this notification to circumvent the findings of the Committee from the 25th September 2018 and extend the licensing hours for the lucrative night trade. All this at the expense of local residents who thought they might avoid further nuisance and have some quality of life late at night.

Based on these existing issues and considerations, Police request this TEN be rejected.

The notice was received in this office on Monday 7th December 2018. Police are formally objecting to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the crime and disorder, public safety and public nuisance objectives.

The (TEN) notice is to allow for the use of the premises from 24th December through until the 30th December 2018 from 0200 to 0400 hours each day. The licensable activity is for the sale of alcohol.

Police believe the premises would not be upholding the licensing objectives if it were to sell alcohol beyond the existing licence conditions and believe that beyond 0200 hours would create unnecessary noise and anti-social behaviour and increase the opportunity for crime and disorder.

In view of the request the venue is situated in a residential area and close to student accommodation. The request falls within the Christmas festivity period and students will be on leave.

The premises currently operate from 0700 hours daily and close at 0200 hours. They are seeking to remain open selling alcohol until 0400 hours and this would not afford the residents any quality 'quiet' time. Police are concerned at the staffing requirements and quick turn-around in between shifts and believe this will affect the individuals responsible for selling alcohol to the public.

Police believe that 0200 hours each day is sufficient enough to sell alcohol. Police would require the existing licence conditions to be affixed to this Temporary Event Notice.

The Christmas period is a busy and demanding time for the Police. Response times are affected by these demands and staffing the response teams is calculated by service demand.

Police suggest the application should be submitted and approved by all the relevant authorities and that by operating under the TEN public safety and crime prevention objectives are undermined.

If this cannot be agreed it is my opinion that the licensing objectives would be breached and complaints about public nuisance and public safety will follow.

- A time delay safe with deposit slot and anti fishing mechanisms must be used at the counter till area
- Regular robbery awareness and cash minimisation training shall be given to all staff
- 8 An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) any faults in the CCTV system
- (f) any refusal of the sale of alcohol
- (g) any visit by a relevant authority or emergency service.

- 9 Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind grills, screens or cabinet doors so as to prevent access to the alcohol by customers or staff.
- 10 On All major event days at Wembley Stadium the following shall apply:
- (a) Customers shall not be allowed to congregate outside the premises.
- (b) No glass bottles shall be sold or displayed
- (c) The DPS shall work in partnership with the Police and if necessary comply with any direction given by the most senior Police Officer on duty at the event.
- (d) No more than four (4) cans of alcohol per person shall be sold.
- (e) Alcoholic beverages shall not be sold or supplied one (1) hour before the designated kick off or start time of a game or event and will not resume until 15 minutes after the game or event has started.

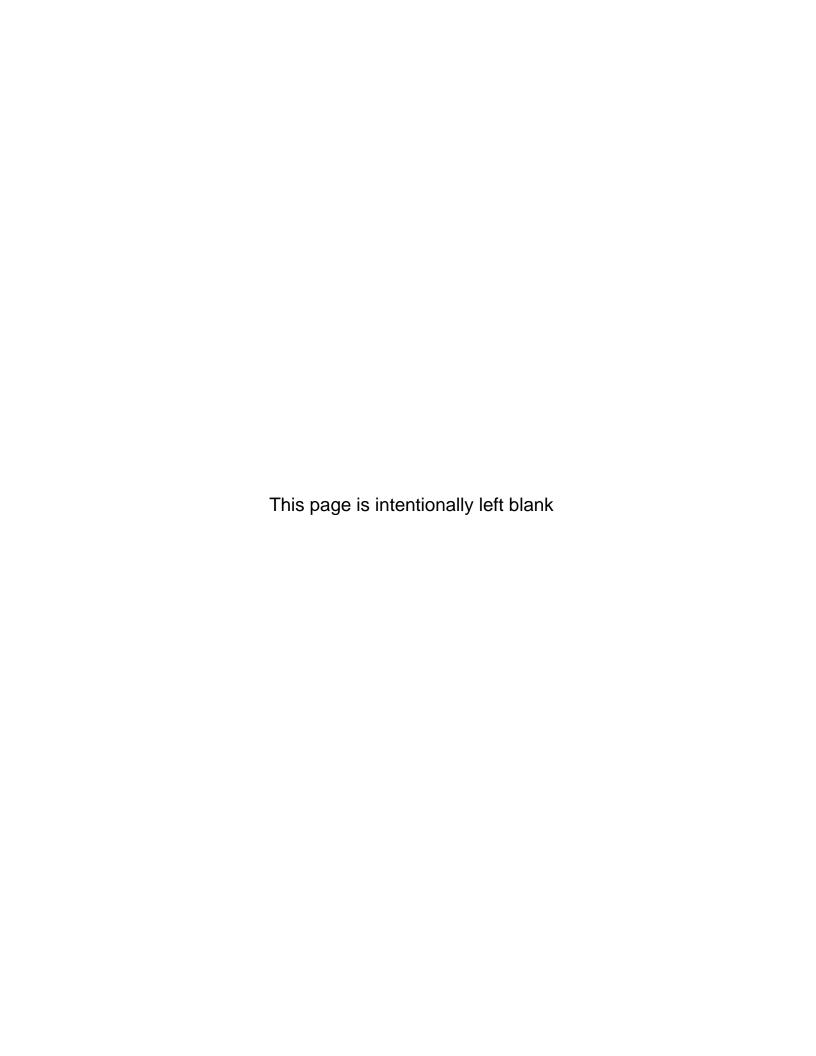

No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.(2) In this paragraph, an irresponsible promotion means any one or more of the
- following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

Minimum Price of Alcohol

- **1.** A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1—
- (a) —duty is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) —permitted price is the price found by applying the formula—

$P = D + (D \times V)$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

- —relevant person means, in relation to premises in respect of which there is in force a premises licence
 - the holder of the premises licence

 - (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- —relevant person means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- —valued added tax means value added tax charged in accordance with the Value Àdded Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first day) would be different from the permitted price on the next day (—the second day) as a result of a change to the rat e of duty or value added tax.
- The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.



A Temporary Event Notices have been given under section 100 Licensing Act 2003 by

Mr Peter CRO for the provision of late night refreshments, sales of alcohol and regulated entertainment on 31st of December 2018 from 2300 to 1st January 2019 at 0230hrs.

Police are formally making representations to the notice under section 104 Licensing Act 2003. The Police objection is primarily concerned with the prevention of crime and disorder and public nuisance licensing objectives.

I am completing one letter of representation however it is relevant for each of the four TEN's submitted by Mr Cro.

An event risk assessment would be beneficial to answer Police concerns.

There is some confusion in these four applications. Apart from the location they are identical, however I am unsure if there is one stage in each are, DJ's in each area. Could details of the type

Each TEN permits a maximum of 499 persons, there is no indication how the applicant will maintain capacities in each TEN area and prevent open drinking vessels from one licensable area to another. It is not best practice to allow entry to a licensable area with alcohol purchased elsewhere.

Police require more details of a dispersal plan as at 0230 hours there could be almost 2000 customers leaving the venue.

Will there be a search regime, will this be upon entry to the building or each individual TEN area.

Is the event advertised, is it ticket entry, can tickets be bought on the door.

Police await response from the applicant, without further details Police are unable to assess whether the licensing objectives will be upheld.

No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - 1. (a)games or other activities which require or encourage,

or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Free Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

- (a) a holographic mark, or
- (b) an ultraviolet feature.

Small Measures to be Available

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

Minimum Price of Alcohol

- 1.A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2.For the purposes of the condition set out in paragraph 1—
- (a)—dutyll is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b)—permitted pricell is the price found by applying the formula—

$$P = D + (D \times V)$$

where-

- (i)P is the permitted price,
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c)—relevant personII means, in relation to premises in respect of which there is in force a premises licence—
 - (i)the holder of the premises licence,
 - (ii)the designated premises supervisor (if any) in respect of such a licence, or
 - (iii)the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) —relevant person means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e)—valued added taxll means value added tax charged in accordance with the Value Added Tax Act

1994.

- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4.(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first dayll) would be different from the permitted price on the next day (—the second dayll) as a result of a change to the rat e of duty or value added tax.
- (2)The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Requirement for a DPS

(1) No supply of alcohol may be made under the premises licence-

(a)at a time when there is no designated premises supervisor in respect of the premises licence, or

(b)at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Door Supervisors and Security Staff to be Licensed by the SIA (when required)

4 The CCTV images shall be kept in an easily downloadable format.
5 Door supervisors of a suitable gender mix, shall be employed on any day when the Boxpark venue is open for the sale of alcohol.
6 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.
7 Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
8 No drinks shall be served other than in plastic/polycarbonate/cardboard or toughened glasses.

9 An incident log shall be kept at the premises, and made available for inspection on request to a authorised officer of Brent Council or the Police, which will record the following:
(a) All crimes reported to the venue
(b) All ejections of patrons
(c) Any complaints received
(d) Any incidents of disorder
(e) All seizures of drugs or offensive weapons
(f) Any faults in the CCTV system or searching equipment or scanning equipment
(g) Any refusal of the sale of alcohol
(h) Any visit by a relevant authority or emergency service.
10 A personal licence holder shall be present on the premises and supervise the sale of alcohol fe all promoted ticketed events.
11 A "Challenge 25" policy shall be adopted and adhered to.
12 A sign stating "No proof of age No sale" shall be displayed at the point of sale.
13 No children under the age of 18 shall be allowed on the premises after 21.00 hours unless accompanied by an adult.
14 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.
15 SIA Security shall wear clothing that can be clearly and easily identified on CCTV.
16 Substantial snacks and non-intoxicating beverages shall be available during the whole of licensed hours in all parts of the premises where intoxicants are provided.
17 The premises shall provide chairs and tables for customer use.
18 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.


A clear and unobstructed view into the premises shall be maintained at all times. 20 Any staff directly involved in selling alcohol for retail to consumers and staff who provide training including managers shall undergo regular training of the Licensing Act 2003 legislation (at least every 12 months). The training shall be documented and signed off by the DPS and the member of staff receiving the training. This training log shall be kept centrally and made available for inspection by police and relevant authorities upon request. No noise or vibration shall be detectable at any neighbouring noise sensitive premises. The level of music shall be arranged so as not to cause a nuisance to local residents. The premises dispersal policy shall be kept and made available to police and authorised officers from Brent Council. 24 There shall be no more than one mobile bar and one static bar on each floor of the atrium communal space. 25 No person shall be permitted to sit on the floor, on stairs or in gangways and passageways. 26 Notices asking customers to leave quietly shall be conspicuously displayed at all exits. Suitable receptacles for rubbish shall be made available inside the premises for customers to use and they shall be emptied regularly to prevent overflow or odours. 28 The licensee shall ensure all public areas within 3 metres of the premises are cleared of litter arising from the premises daily. 29 The number of persons permitted to use the smoking area shall be risk assessed. 31 On non-event days the use of the smoking area (first floor front & rear balconies) shall be checked hourly by SIA, and on event days a member of SIA shall be positioned in the smoking area (rear balcony and external ground floor area only).
On Wembley Stadium event days, SIA door supervisors of a suitable number and gender and other suitable measures shall be put in place after undertaking a sufficient and suitable risk assessment based on the proposed event at the Stadium, which promotes all four licensing objectives. This risk assessment shall be provided to the Licensing Police and authorised Council officers at least 7 days before the event.
33 On Wembley Stadium event days there shall be suitable measures in place to ensure there is a free flow of access and egress for customers. As such, the area between the exit doors from the premises to the external part of the building out on the public highway shall be free from any obstruction including persons.
34 On Wembley Stadium event days, a risk assessment shall be undertaken based on the proposed event and will be provided to police or authorised council officers at least 7 days before the event.
35 The locks and flush latches on the exit doors and gates shall be unlocked and kept free from fastenings other than push bars or pads whilst the public are on the premises.
36 The socket outlets (or other power supplies used for DJ equipment, band equipment and other portable equipment) that are accessible to performers, staff or the public shall be suitably protected by a residual current device (RCD) having a rated residual operating current not exceeding 30 milliamps).
37 Exits must not be obstructed (including by curtains, hangings or temporary decorations), and shall be accessible via non-slippery and even surfaces, free of trip hazards and clearly identified.
38 Where chairs and tables are provided, internal gangways shall be kept unobstructed.
39 Temporary electrical wiring and distribution systems shall not be provided without notification to the licensing authority at least ten days before commencement of the work and/or prior inspection by a suitable qualified electrician.
40 The maximum capacity for box park as a whole to include each individual unit will be set when the building work is nearing completion.

47 The DPS or deputy shall work in partnership with the Police and if necessary comply with any direction given by a senior Police Officer on duty at the event.
48 A personal licence holder shall be present on the premises and supervise the sale of alcohol.
49 On football event days at Wembley the premises shall stop the sale of alcohol (1) one hour before the advertised kick off time, and shall not resume the sales of alcohol until (15) fifteen minutes after the kick off time.
50 On Football event days at Wembley stadium the venue shall only take one set of supporters (Fan Zone) on the production of a valid ticket for the game, the designated team shall be allocated by the Metropolitan Police after a risk assessment have been undertaken.
51 The venue shall not show televised football matches on football event days.
52 On football event days, the designated smoking areas shall be the first floor rear balcony and the area behind the hoarding on Olympic Way. No alcohol shall be allowed in the smoking area. The

No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - 1. (a)games or other activities which require or encourage,

or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

- 4.(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first dayll) would be different from the permitted price on the next day (—the second dayll) as a result of a change to the rat e of duty or value added tax.
- (2)The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Requirement for a DPS

- 6 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.
- 7 Customers will not take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 8 No drinks shall be served other than in plastic/polycarbonate/cardboard or toughened glasses.
- 9 An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) All crimes reported to the venue
- (b) All ejections of patrons
- (c) Any complaints received

(d) Any incidents of disorder (e) All seizures of drugs or offensive weapons (f) Any faults in the CCTV system or searching equipment or scanning equipment (g) Any refusal of the sale of alcohol (h) Any visit by a relevant authority or emergency service. 10 A personal licence holder shall be present on the premises and supervise the sale of alcohol for all promoted ticketed events. A "Challenge 25" policy shall be adopted and adhered to. A sign stating "No proof of age -- No sale" shall be displayed at the point of sale. 13 No children under the age of 18 shall be allowed on the premises after 21.00 hours unless accompanied by an adult. 14 Notices asking customers to leave quietly shall be conspicuously displayed at all exits. 15 SIA Security shall wear clothing that can be clearly and easily identified on CCTV. 16 Substantial snacks and non-intoxicating beverages shall be available during the whole of licensed hours in all parts of the premises where intoxicants are provided. 17 The premises shall provide chairs and tables for customer use. 18 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises. 19 A clear and unobstructed view into the premises shall be maintained at all times. 20 Any staff directly involved in selling alcohol for retail to consumers and staff who provide training including managers shall undergo regular training of the Licensing Act 2003 legislation (at least every 12 months). No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - 1. (a)games or other activities which require or encourage,

or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Free Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
- (a) a holographic mark, or
- (b) an ultraviolet feature.

Small Measures to be Available

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;

- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

Minimum Price of Alcohol

- 1.A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2.For the purposes of the condition set out in paragraph 1—
- (a)—dutyll is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b)—permitted pricell is the price found by applying the formula—

$$P = D + (D \times V)$$

where—

- (i)P is the permitted price,
- (ii)D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii)V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c)—relevant personII means, in relation to premises in respect of which there is in force a premises licence—
 - (i)the holder of the premises licence,
 - (ii) the designated premises supervisor (if any) in respect of such a licence, or
 - (iii)the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) —relevant personll means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e)—valued added tax means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3.Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4.(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first dayll) would be different from the permitted price on the next day (—the second dayll) as a result of a change to the rat e of duty or value added tax.
- (2)The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Requirement for a DPS

(1) No supply of alcohol may be made under the premises licence-

(a)at a time when there is no designated premises supervisor in respect of the premises licence, or

(b)at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Door Supervisors and Security Staff to be Licensed by the SIA (when required)

Where the licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each individual must be licensed by the Security Industry Authority, with the following exceptions:

- a) premises where the premises licence authorises plays or films
- b) any occasion mentioned in paragraph 8(3)(b) or (c) of Schedule 2 to the Private Security Industry Act 2001 (premises being used exclusively by a club with a club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
- c) any occasion within paragraph 8(3)(d) of Schedule 2 to the Private Security Industry Act 2001

Film Classification When required

- (i) The admission of children to the exhibition of any film must be restricted in accordance with the recommendation of the designated film classification body unless section (ii) applies.
- (ii) Where the licensing authority notifies the holder of the licence that this subsection applies the admission of children must be restricted in accordance with any recommendation made by the licensing authority.

- 37 On Football event days at Wembley stadium the venue will only take one set of supporters (Fan Zone) on the production of a valid ticket for the game, the designated team will be allocated by the Metropolitan Police after a risk assessment has been conducted.
- 38 The venue will not show televised football matches on football event days.
- 39 On football event days the designated smoking areas will be the first floor rear balcony and the area behind the hoarding on Olympic way. No alcohol will be allowed in the smoking area. The smoking area will be supervised by SIA.

Restaurant Conditions:

- 40 Alcohol shall only be supplied as an accompaniment to a substantial meal, and seated at a table.
- 41 The supply/sale of alcohol shall be by waiter or waitress service only.
- 42 Customers must not be allowed to sit, stand or be served from the bar area or any other staff area used for the preparation of alcoholic beverages.
- 43 Signs must be displayed at suitable points along the bar reading, 'Service is by waiter/ waitress service only. Customers are not permitted to sit, stand or be served from the bar'
- 44 Substantial food and non-intoxicating beverages shall be available during the whole of licensed hours in all parts of the premises where alcohol is provided

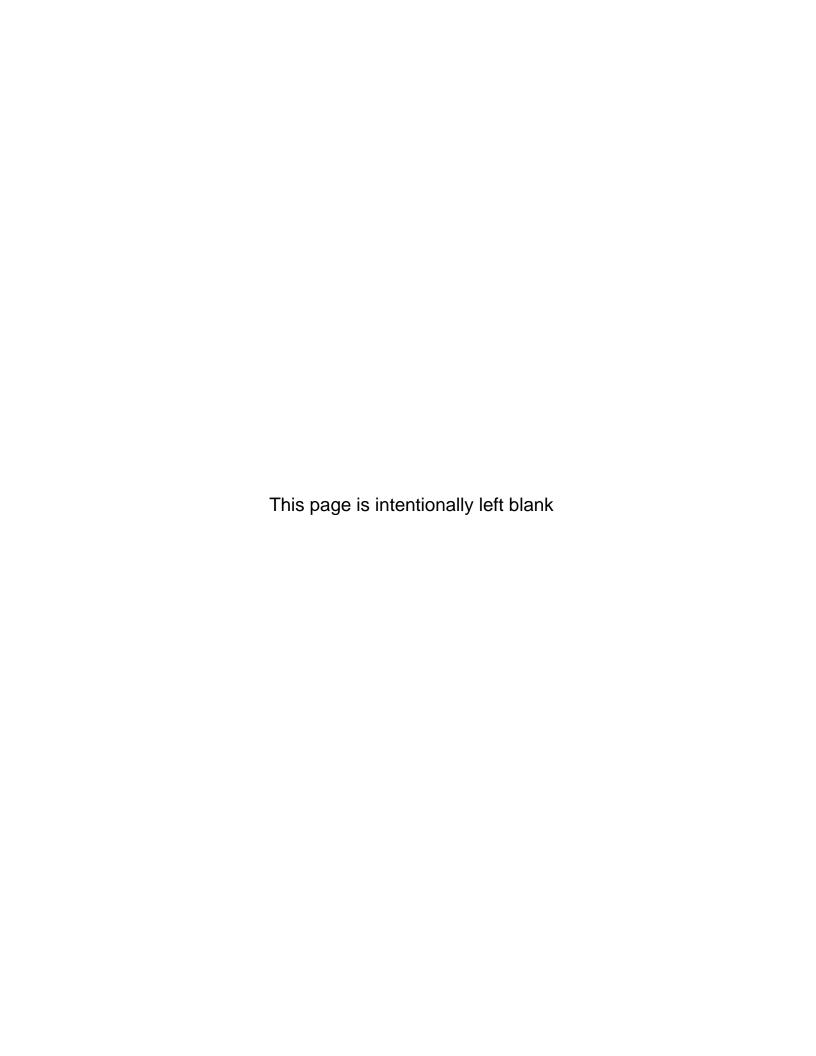

Annexe 1 - Mandatory Conditions

No Irresponsible Drinks Promotions

- (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to— (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Free Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy

- (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a) a holographic mark, or
- (b) an ultraviolet feature.

Small Measures to be Available

The responsible person must ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml;
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

Minimum Price of Alcohol

- A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- For the purposes of the condition set out in paragraph 1-2.
- (a) 1979; —dutyll is to be construed in accordance with the Alcoholic Liquor Duties Act
- -permitted price is the price found by applying the formula— (b)

 $P = D + (D \times V)$

where-

- P is the permitted price,
- (i) (ii) (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- —relevant person means, in relation to premises in respect of which there is in force a premises licence
 - the holder of the premises licence.
 - the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- -relevant person means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in
- -valued added tax∥ means value added tax charged in accordance with the (e) Válue Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph
- rounded up to the nearest penny.

 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (—the first dayll) would be different from the permitted price

on the next day (—the second dayll) as a result of a change to the rat e of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Requirement for a DPS

- (1) No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Door Supervisors and Security Staff to be Licensed by the SIA (when required)

Where the licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each individual must be licensed by the Security Industry Authority, with the following exceptions:

- a) premises where the premises licence authorises plays or films
- b) any occasion mentioned in paragraph 8(3)(b) or (c) of Schedule 2 to the Private Security Industry Act 2001 (premises being used exclusively by a club with a club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
- c) any occasion within paragraph 8(3)(d) of Schedule 2 to the Private Security Industry Act 2001

Film Classification When required

- (i) The admission of children to the exhibition of any film must be restricted in accordance with the recommendation of the designated film classification body unless section (ii) applies.
- (ii) Where the licensing authority notifies the holder of the licence that this subsection applies the admission of children must be restricted in accordance with any recommendation made by the licensing authority.

In this section-

"children" means persons aged under 18; and

"film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c. 39) (authority to determine suitability of video works for classification).

Annexe 2 - Conditions Consistent With the Operating Schedule

- 1 CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.
- 2 A CCTV camera shall be installed to cover the entrance of the premises and
- 3 Customers shall not be permitted to take open drink containers outside the premises as defined on the plan submitted to and approved by the Licensing Authority.
- 4 A "Challenge 25" policy shall be adopted and adhered to
- 5 Alcohol shall only be provided as an accompaniment to a main meal, seated at a table or awaiting to be seated at a table. If there is no prospect of a table becoming available then alcohol is not to be supplied.

Alcohol supplied whilst awaiting a table meal must be consumed in the drinking area as highlighted on the plans submitted with this application.

- 6 An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
- (a) all crimes reported to the venue
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) all seizures of drugs or offensive weapons
- (f) any faults in the CCTV system or searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any visit by a relevant authority or emergency service.
- 7 A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.
- 8 The use of outside terrace area shall cease at 2100 hours.
- 9 The maximum number of persons within the premises shall not exceed 100 including staff.
- 10 The maximum number of persons on the outside terrace shall not exceed 20.
- 11 Any locks and flush latches on the exit doors shall be unlocked and kept free from fastenings other than push bars whilst the public are on the premises.
- 12 Any socket outlets (or other power supplies used for DJ equipment, band equipment and other portable equipment) that are accessible to performers, staff or the public shall be suitably protected by a residual current device (RCD having a rated residual operating current not exceeding 30 milliamps).
- 13 No amplified sound shall be played outdoors or within the external seating area when premises licence is in operation.
- 14 No vertical drinking shall take place outside the venue or within the designated external seating area.
- 15 A canopy shall be installed over the designated external seating/smoking area, it shall be so designed to ensure that smoke/smells shall not cause nuisance within any residential or un-associated premises. The canopy shall remain in situ and maintained for the duration of its use.
- 16 The number of patrons utilizing the outside seating area shall be restricted to no more than 15 people at any one time.
- 17 The use of the outdoor seating area shall be restricted to 21:00 hours on all days.
- 18 The Designated premises Supervisor (DPS) shall provide comprehensive training for staff on the Licensing Act and its implications for making and authorising sales of alcohol. 19 Clear and conspicuous notices shall be displayed warning of potential criminal activity affecting customers, such as theft.

- 20 Vigilance shall be shown in preventing illegal drug use in the retail unit area.
- 21 Staff shall be trained in engaging with customers to prevent them from leaving the premises with alcohol purchased at the premises and to prevent prohibited alcohol consumption in the retail unit (such as canned or bottled beer procured elsewhere).
- 22 Deliveries of goods necessary for the operation of the business shall be carried out at such a time and in such a manner so as to prevent nuisance and disturbance to nearby residents.
- 23 Notices asking customers to leave quietly shall be conspicuously displayed at all exits. Customers shall be asked not to stand around talking loudly in the street outside the premises.
- 24 Customers shall not be admitted to the premises outside the opening hours.
- 25 The movement of bins and rubbish outside the premises shall be kept to a minimum after 2300 hours.
- 26 Any lighting on or outside the premises shall be positioned and screened in such a way as not to cause a disturbance to nearby residents.
- 27 Adequate waste receptacles for use by customers shall be provided in the local vicinity.
- 28 Full details of training shall be provided in the Training Record Book which shall be kept available at the venue.
