Notes for Members - Declarations of Interest:

If a Member is aware they have a Disclosable Pecuniary Interest* in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent and must leave the room without participating in discussion of the item.

If a Member is aware they have a Personal Interest** in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent.

If the Personal Interest is also significant enough to affect your judgement of a public interest and either it affects a financial position or relates to a regulatory matter then after disclosing the interest to the meeting the Member must leave the room without participating in discussion of the item, except that they may first make representations, answer questions or give evidence relating to the matter, provided that the public are allowed to attend the meeting for those purposes.

- (g) **Securities** Any beneficial interest in securities of a body which has a place of business or land in the council's area, if the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body or of any one class of its issued share capital.

If situations arise where the licensing objectives may be undermined but cannot be dealt with by the use of appropriate conditions the Licensing Authority will consider whether it is appropriate for a licence to be granted or continue to operate.

- Staff will be trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18, the signs and symptoms of drunk persons and the refusal of sale due to intoxication. Staff will also be trained to recognise the signs of proxy purchases.
- Electronic records will be kept of such training for the member of staff who
 has received that training.
- All staff will receive refresher training every six months as a minimum and electronic records are to be kept of this refresher training.
- Confirmation of training can be made available to the Licensing Authority or Police within 7 days of a request.
- Any person found to be in breach of the Company alcohol policy is subject to disciplinary proceedings

b) The prevention of crime and disorder

- The operators of the premises will maintain a good relationship with the local police and other relevant authorities
- Lidl store management will be trained to view and download CCTV footage
 on receipt of an internal authorisation code. For urgent matters, at all times
 officers will be able to view CCTV footage to verify if a reported offence is
 covered and, whenever required, CCTV will be downloaded and made

d) The prevention of public nuisance

 Alcohol will not be sold in an open container and the consumption of alcohol on the premises will not be permitted

e) The protection of children from harm

 There will be a Challenge 25 policy operating at the premises. Challenge 25 means that the holder of the premises licence shall ensure that every individual, who visually appears to be under 25 years of age and is seeking to purchase or be supplied with alcohol at the premises or from the premises, shall produce identification proving that individual to be 18 years of age or older. Acceptable identification for the purposes of age verification will include a driving licence, passport or photographic identification bearing the "PASS" logo and the person's date of birth. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.

- In the event that an employee suspects that a person attempting to purchase alcohol is under the age of 25, is a street drinker or is attempting a proxy purchase they will immediately call the duty manager. The duty manager will make appropriate enquiries and will determine whether the sale should be permitted.
- 'Challenge 25' posters shall be displayed in prominent positions at the premises.
- Other than where sold as part of a multipack or gift pack, spirits shall not be sold in bottles of less than 50cl.
- No super-strength beer, lager or cider of 6.5% ABV or above shall be sold at the premises other than speciality/ artisan beer, lager or cider.
- An automated till prompt will be set up so that the operator has to positively confirm that Challenge 25 has been complied with when the first item of alcohol has been scanned.



I certify that I have considered the application shown above and I wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

An application has been made to apply for a premises licence under section 17 of the Licensing Act 2003.

The Police representations are primarily concerned with all four licensing objectives:

Prevention of Crime & Disorder; Prevention of Public Nuisance; Public Safety & The Protection of Children from Harm.

The premises site is within the Cumulative Impact Zone (CIZ), areas that have had repeated issues that undermine the licensing objectives, despite numerous conditions and action taken to reduce these problems. Therefore, as stated in Brent Councils guidance, "the presumption is that the application will be refused, unless the applicant can satisfactorily evidence that their application or variation will not negatively impact on the licensing objectives."

The application states a number of standard conditions in attempting to adhere to the licensing objectives, but not enough in my opinion to suggest this would mitigate the additional licensing issues in an area already saturated with premises offering alcohol sales.

However, a business renowned for its low cost quality products selling alcohol at 0700hrs in the morning does nothing to reassure me that anything other than more licensing concerns will result.

Therefore, I oppose the premises license application.

Looking at the premises licence application and weighing up the pros and cons, I obviously can see the positive economic effects of having Lidl in the Ealing Road area. However, given the saturation of premises that supply alcohol in the area, I cannot offer support to the premises licence application, or offer additional conditions that suitably address the existing licensing concerns.

The CIZ has been implemented for very serious reasons. The area in question was already part of a Public Space Protection Order (PSPO), but the ongoing issues revolving around alcohol supply in and around Brent called for tighter restrictions to be put in place.

Representations against the sale and supply of alcohol does not mean the store wouldn't be economically viable and I welcome them to the area, but I cannot offer conditions that I feel would mitigate the licensing concerns sufficiently to allow it.

I certify that I have considered the application shown above and I wish to make a representation that the likely effect of the grant of the application is detrimental to the Licensing Objectives for the reasons indicated below.

An officer of the Licensing Authority, in whose area the premises are situated, who is authroised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

Cumulative Impact Zone (CIZ)

The Council's current Licensing Policy came into effect in January 2020. Crime and complaints assessments in 2015, did not identify any requirement for a CIZs. However, since 2016 there has been a significant and notable increase in alcohol related crime and anti-social behaviour which is having an adverse impact in some areas and neighbourhoods generating complaints from residents, councillors and the Police. This is undermining the licensing objectives and also has potential to undermine the vitality of Brent's town centres.

Wembley Central which includes Ealing Road has been identified as one of ten Cumulative Impact Zones (CIZs) in Brent, where the authorising of further licences may undermine the promotion of the licensing objectives.

The Statement of Licensing Policy states: -


'Ealing Road

There are low level anti-social behaviour issues related to street drinking such as urination, defaecation etc. in this area. It is one of the areas where highest number of warning letters and fixed penalty notices have been issued to street drinkers. Further evidence has been provided by residents in the form of petition received during one of the licensing hearings. Therefore, it is proposed that a CIZ be introduced for off-licences on Ealing Road from the junction of High Road Wembley up to the junction of Bridgewater Road. The CIZ area includes Atlip Road, Mount Pleasant Road up to the junction of Orchard Close, Montrose crescent, Union Road and Coronet Parade'.

Data captured from various sources including alcohol related police and ambulance call outs has been mapped and shown sufficient evidence to implement CIZs in the specified area. In particular crime data and evidence shows a correlation between concentrations of off-licences and alcohol related anti-social behaviour, particularly that associated with street drinking.


Street Drinking Hotspots

There are relatively few calls to police specifically about street drinking. This may be because they are recorded as other ASB types such as littering or noise. Between 01/06/2017 and 31/05/2018, there were only 53 calls to police. The following year, there were 142. This represents an increase of 168%. Part of this increase may be attributed to callers being aware of the borough wide PSPO on drinking in public which came into effect in October 2017.




Calls to police specifically related to street drinking between 01/06/2017 and 31/05/2019

Hotspot of Violence with Injury Crimes




All violence with injury crimes and offlicences in Wembley (01/06/2017 and 31/05/2019)


Brent Index of Multiple Deprivation (IMD) score 2015 by Lower Super Output Areas

The purpose of the CIZ in Wembley Central and Ealing Road, is to address the issues mentioned above.


Evidencing the premises as being located in the CIZ

I am aware that the applicant questioned whether this premises fell within a CIZ because of its location. Below is the information taken from the Licnsing Policy which confirms that the application for this off-licence does in fact fall within the CIZ.

'Any premises that are physically located, whereby any part of a building faces onto any of the above main roads and although the address does not form part of the above named road, it will be included in the CIZ. For e.g. a premises building that is positioned on the corner of Ealing Road and Braemar Avenue but where the address is Braemar Avenue, this premises will be included in the CIZ'.




In this case the building is located on Ealing Road and although it is unclear from the premises plan whether the entrance faces onto the section of Ealing Road that is included in the CIZ or not, the actual building falls within the CIZ.

The Premises

The premises, namely Lidl, Minavil House, Ealing Road, HA0 4EL, falls within one of Brent's ten CIZs.




Proposed site for Lidl, Minavil House, Ealing Road, HA0 4EL

The premises itself is located at the junction of Ealing Road and Bridgewater Road.

Historically there have been existing issues of street drinking within a 1 minute walk from the proposed premises (more or less opposite Alperton station). The photograph below shows

where the proposed premises (marked in blue) is located in relation to where street drinking issues took place (marked in yellow). A sea of empty beer cans were frequently left behind a sectioned off brick wall shown in the photographs further below.

The proposed application is for the building marked near 'HG' in the photograph below, which shows where street drinkers used to frequent.

As a result of an increase in complaints and enforcement action, the street drinkers no longer frequent this area. This however has not resolved the problem, but instead moved it to another location. The local Anti-Social Behaviour officer has advised that the street drinkers have now

moved off the main thorough-fare onto the end of Atlip Road, where they drink on top of and underneath the canal bridge.


The street drinkers then use this bridge to cross over back down the side roads and then onto Ealing Road or go back up Atlip Road to return to the other side of Ealing Road, creating a square like area where the problem persists.

Public Space Protection Order (PSPO)

The entire Borough of Brent is subject to a Public Space Protection Order for street drinking and therefore it is an offence to drink alcohol in any public place.

If a police officer reasonably believes that a person is, or has been, consuming intoxicating liquor within these areas, the officer may require the person concerned:

- a) not to consume in that place anything which is, or which the officer reasonably believes to be, intoxicating liquor
- b) to surrender anything in his/her possession which is, or which the officer reasonably believes to be, intoxicating liquor or a container for such liquor (other than a sealed container)
- c) An officer may dispose of anything surrendered to him/her as above.
- d) Issue fixed penalty notices on offenders
- e) Prosecute persistent offenders

However, in reality there are limited police officer resources, which in practice would prevent the above from being enforced. This therefore places a greater emphasis on the responsibility of those premises that are selling alcohol for consumption off the premises. It is clear that if off licences did not exist, the number of street drinkers would decline.

Therefore simply selling alcohol to customers who once off the premises, are no longer the responsibility of the licence holder, the Designated Premises Supervisor (DPS) and/or members of staff is no longer a viable option.

Linking Street Drinkers to Off-Licences

It is increasingly difficult to link issues with off-licences who serve street drinkers. Street drinkers are reluctant to give up information on where they have purchased their alcohol so as not to alert enforcement officers.

In the case of the locality of this premises, it is clear that street drinkers are happy to walk some distance to ensure they can drink without being seen. It can therefore be difficult to know where street drinkers have purchased alcohol when they no longer stay close to the premises where they have purchased the alcohol.

Historically street drinkers were also obvious in appearance. This is no longer the case, making it diffcult for check-out staff to differentiate, therefore creating a pressure on them when selling alcohol.

Premises Licence Application

Operational Plan, Local Research & Conditions

The application which proposes a number of conditions, does not appear to consider customers once they leave the premises.

Simply listing a number of conditions without any type of substantive operational plan for example, appears inadequate. The Licensing Authority would expect to see information on how the business plans to ensure that their particular premises will go above and beyond in promoting the licensing objectives in an area located within a CIZ.

There has been no indication that the premises has done any research on issues such as street drinking in the immediate area and presented the outcome of those findings with the application. Even if it is the case that the street drinkers who drink on Atlip Road weren't discovered during such research, it would go a long way in showing that the premises had attempted to understand the local issues.

This would go some way in reassuring the Licensing Authority that the business has tried to consider whether the impact of adding an additional off licence would in fact impact the area before signing a lease (an assumption is made here that this has already taken place) to add a further supermarket to this area.

Safeguarding the Local Area

The Statement of Licensing Policy lists considerations to be made when applying for a new premises licence, particularly those considerations relating to street drinking.

However, the conditions that are mentioned in the application fail to address the likes of such things outside of the premises that could be directly linked back to the premises. This includes items such as the clearing up of litter which may be left outside the premises by customers, the labelling of alcohol with the premises name in order to link street drinkers back to the premises or measures to discourage street drinkers from loitering outside the premises.

The application also suggests an alcohol content of up to 6.5%, despite Brent's pool of model conditions setting a suggested limit of 6%. Although the applicant would not necessarily know that a suggested limit exists, they could have made enquiries prior to making an application.

Although 6.5% is not the same as some of the higher strength alcohol that exisits, Brent Council's Statement of Licensing Policy makes it clear that a voluntary offering of a ban on high strength alcohol sales does not necessarily address the requirements under a Cumulative Impact Zone.

Further, there is no defintion of 'speciality/artisian' when referring to beer, lager or cider and there fore it would be impossible to enforce this. A number of beer suppliers have for example included the word 'premium' on their products in order to get around local authority conditions.

The application proposes that alcohol is sold from 07.00hrs which again does not give the Licensing Authority any reassurance that the premises has taken any of the local issues into consideration.

Summary

The Statement of Licensing Policy states that any licence application in a CIZ area will need to demonstrate with evidence that its operation will not add to any cumulative impacts that the CIZ is seeking to address. Further, new applicants and those applying for variations would be required to demonstrate how their premises will not contribute to street drinking in those areas.

The effect of adopting a CIZ is to "create a rebuttable presumption" that applications for licences which are likely to add to the existing cumulative impact will normally be refused (or subject to certain limitations) unless the applicant can demonstrate that there will be no negative cumulative impact on the licensing objectives.

Other than the list of proposed conditions, the application and operating schedule fails to demonstrate that a grant will not lead to a negative cumulative impact on one or more of the licensing objectives and to the contrary add to the issues of an existing saturated area.


It is on this basis, that the Licensing Authority ask that the application for a new premises licence is refused by the Licensing Sub-Committee. Adding conditions to a premises licence, in the Licensing Authority's opinion is not adequate when the application does not demonstrate what is being put in place in order to avoid further cumulative impact. Adding an off licence to to the immediate area, will no doubt be detrimental to the local area.





Population by ethnic group, South Kilburn, 2011







An officer of the Metropolitan Police, in whose area the premises are situated and who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Gambling Act 2005.

The application has been made for a premises licence.

Brent Police are making <u>representations</u> to this application in accordance with Section 1 of the Gambling Act 2005 licensing objectives:

- a) Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime.
- b) Ensuring that gambling is conducted in a fair and open way.
- c) Protecting children and other vulnerable persons from being harmed or exploited by gambling.

Police are very familiar with the area and the number of street drinkers consistently heavily under the influence of alcohol.

Police understand that the problems in the area are not enough to object to this application but strongly believe that these conditions would assist in upholding the licensing objectives.

The conditions that Police require to be added to the Premises Licence are listed below:

CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for <u>31 days</u> and shall be made available to police and licensing officers if requested.

A CCTV camera shall be installed to cover

- a) All entry and exit points to and from the premises enabling frontal identification of every person entering under any light conditions
- b) The areas of the premises to which the public have access (excluding toilets)
- c) Gaming machines and the counter area

An overt CCTV monitor to be installed, able to be seen by customers

CCTV shall be made available for the police viewing at any time with minimum delays when requested.

The following crime prevention measures shall be implemented:

- A time delay safe with deposit slot and anti-fishing mechanisms must be used at the counter till area
- Regular robbery awareness and cash handling training shall be given to all staff.

The Licensee shall maintain a bound and paginated 'Challenge 25 Refusals' register at the premises. The register shall be produced to the police or licensing authority forthwith on request.

Prominent signage and notices advertising the Challenge 25 will be displayed showing the operation of such policy.

Third party testing on age restricted sales systems purchasing shall take at least twice a year and the results shall be provided to the Licensing Authority upon request.

A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.

A magnetic locking device, commonly referred to as a Maglock will be installed and maintained on the main entrance/exit to the premises which will be operable from the ground floor cashier counter by staff.

All doors and windows shall remain closed during any licensable activity.

There shall be no pre-planned single staffing/lone working at any time.

There will be a minimum of **two** staff present at all times when the premises are open.

The licensee shall ensure that all seating within the premises are either secured to the floor or are weighted to prevent lifting.

A suitable intruder alarm complete with panic button shall be fitted and maintained.

A fire alarm and smoke detection system shall be installed.

The licensee will ensure that customer toilets are checked every hour for evidence of drug taking and alcohol consumption. Toilet checks are to be documents stating the time and member of staff who made the checks.

Toilet doors remain locked, fitted with a magnetic style-locking device and access given by staff only.

An incident log shall be maintained and made available on request to an authorised Local Authority officer or the Police, which will record the following:

- a) All crimes reported to the venue.
- b) Any complaints or incidents regarding crime and disorder.
- c) Refusals and banned customers.
- d) Any faults in the CCTV system.
- e) Any visit by a relevant authority or emergency service.

The Licensing Authority representations are primarily concerned with the three licensing objectives;

- Preventing gambling from being a source of crime and disorder, being associated with crime or disorder or being used to support crime
- Ensuring that gambling is conducted in a fair and open way
- Protecting children and other vulnerable persons from being harmed or exploited by gambling.

As a result of the premises licence application being received by Brent Council for an **Adult Gaming Centre (AGC)**, the licensing authority have examined the area of where the AGC will be sited. Kilburn High Road is a busy large shopping parade, which runs along the border of Brent and Camden. Kilburn High Road is predominately in an area of medium levels of deprivation apart from South Kilburn Estate,

which has high levels of deprivation. Kilburn High Road is a hotspot for alcohol flagged calls to the Police for crime and anti-social behaviour, and to the ambulance service for call outs.

With the above taken into consideration, Licensing Authority wish to propose the following conditions:

CCTV

- 1. A comprehensive CCTV system shall be installed and maintained on the premises as required by the Metroplitan Police Licensing Team. CCTV should cover the following:
 - a) All entry and exit points to and from the premises enabling frontal identification of every person entering under any light conditions
 - b) The areas of the premises to which the public have access (excluding toilets)
 - c) Gaming machines and the counter area
- 2. The CCTV shall continue to record activities 24 hour a day for 31 days.
- 3. CCTV shall be made available for the police viewing at any time with minimum delays when requested.
- 4. The premises shall display notices near the entrance of the venue stating that CCTV is in operation.
- 5. A monitor shall be placed inside the premises above the front door showing CCTV images of customers entering exiting the premises.

Children and Young People

- 6. The Licensee shall maintain a bound and paginated 'Challenge 25 Refusals' register at the premises. The register shall be produced to the police or licensing authority forthwith on request.
- 7. Prominent signage and notices advertising the Challenge 25 will be displayed showing the operation of such policy.
- 8. Third party testing on age restricted sales systems purchasing shall take at least twice a year and the results shall be provided to the Licensing Authority upon request.
- 9. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.

Staffing levels

- 10. There shall be no pre-planned single staffing at any time.
- 11. There will be a minimum of 2 staff present at all times when the premises is open.

Identification of Offenders or Problem Persons

- 12. The Licensee shall implement a policy of banning any customers who engage in crime or disorder within or outside the premises.
- 13. The licensee will refuse entry to customers who appear to be under the influence of alcohol or drugs.

Seating

14. The licensee shall ensure that all seating within the premises are either secured to the floor or are weighted to prevent lifting.

Alarms

- 15. The licensee shall install and maintain an intruder alarm on the premises.
- 16. The premises shall install and maintain a panic button behind the cashiers counter.

Toilets

17. The licensee will ensure that customer toilets are checked every hour for evidence of drug taking. Toilet checks are to be documents stating the time and member of staff who made the checks.

Signage, Promotional Material and Notices

18. Prominent GamCare documentation will be displayed at the premises.

Staff Training

- 19. The licensee shall provide training on the specific local risks to the licensing objectives that have been identified for these premises as part of the staff induction training programme. periodically provide refresher training to all of its staff working at these premises on the specific local risks to the licensing objectives.
- 20. The Licensee shall train staff on specific issues related to the local area and shall conduct periodic refresher training. Participation in this training shall be formally recorded and the records produced to the police or licensing authority upon request.
- 21. New and seasonal staff must attend induction training and receive refresher training every six months. Participation in this training shall be formally recorded on each member of staffs training records which, if requested will be presented to the Licensing Authority as soon as practicable.

Homeless and Street Drinking

- 22. The Licensee shall take all reasonable steps to prevent street drinking of alcohol directly outside the premises and to ban from the premises those who do so.
- 23. The Licensee shall place a notice visible from the exterior of the premises stating that customers drinking alcohol outside the premises is not permitted and those who do so will be banned from the premises.

Recording of Incidents and Visits

- 24. An incident log shall be kept for the premises and made available on request to an authorised officer of the Council or the Police which will record the following;
 - a) All crimes reported to the venue;
 - b) Any complaints received regarding crime and disorder;
 - c) Any incidents of disorder;
 - d) Any faults in the CCTV system; and
 - e) Any visit by a relevant authority or emergency service.

In order for the Licensing Authority to withdraw this representation, it will be necessary for you to confirm in writing that your client is willing to accept the above conditions.

I would like to object to the application for a gambling license at the above address. I would like to object in my capacity as one of the locally elected Councillors for Kilburn and as a local resident that lives near the address for the proposed business.

My grounds of objection are around those permitted by the Gambling Act:

- -Preventing gambling from being a source of crime or disorder and
- -Protecting children and other vulnerable persons from being harmed or exploited by gambling.

From my experience of the cluster of betting shops and gaming centres on KilburnHigh Road. The gambling establishments have been at the centre of ASB and of other disturbances some of which are reported to the police and are therefore recorded.

Some of the existing betting establishments locally have been used as a focal point for gangs of youth and some of whom are exploited to distribute and sell drugs.

My concern is for these underage and vulnerable members of the community that could be exploited by criminal elements to pick up the habit of gambling and coerced to undertake further illegal activity for example by being given funds to gamble and when they become indebted being asked to pay off debts accrued by being forced to commit drug dealing.

It is well known that Kilburn is one of the poorest wards in Brent, and we have recently had a spate of muggings.

A significant contributing factor to poverty, is the number of individuals who have a gambling problem. Recent research has put the figure of problem gamblers Nationally at 500,000 individuals. It is not unheard of, for gambling addicts to commit crime in order to fund their addition. Given the high incidents of mugging and crime on KilburnHigh Road, a further gambling establishment will undoubtedly attract gamblers some of who are addicted to gambling and are vulnerable for other reasons and this can lead them either to be perpetrators, or victims of crime.

I'm writing to object to the application for a premises license on 141 Kilburn High Road, corner of Glengall Road, where there was a William Hill gambling shop, and now has been converted into two empty premises.

As a nearby resident (living on reasons:

- 1. There is already a large number of gambling/betting shops, alongside coin/arcade shops up and down kilburn high road. There is absolutely no need for another one, fueling the rise the gambling addiction and preying on the most vulnerable in our society. Under your own draft19-22 Statement of Gambling Principles* for Brent you state: "An estimate provided by the Campaign for Fairer Gambling suggests that £96,334,680 was spent in the borough's B2 machines in 20161. The cost to society (i.e. the excess fiscal costs caused by people who are problem gamblers beyond that are normally incurred otherwise by members of the public) are felt through health, housing and homelessness, unemployment and imprisonment. Using the 2012 Health Survey for England as a basis the total excess costs in Brent exceed £2 million." That £2M would be better spent on improving impoverished areas of Brent including parts of Kilburn High Road which have faced years of neglect, protecting our most vulnerable residents, let alone helping to eliminate the non-financial impacts you yourself call out above.
- 2. Gambling shops attract people that are more likely to be involved in anti-social behaviour, and with this shop just next to Glengall Passage which is out of the view of Kilburn High Road, it has always drawn characters that have historically caused trouble. Whilst this sounds like anecdotal evidence, a quick search on Data.Police.UK for March 2020 alone AFTER William Hill was closed and the shop was empty shows 17 counts of Anti-Social behaviour, violence and sexual offences and others near or on Glengall Passage. This is compared to 5 crimes reported on the whole of Kilburn High road. So in 1 month alone, when William Hill was closed, there were more than 3x the crimes reported on/near Glengall Passage than there were on the whole of Kilburn High Road. This is a reason by itself not to grant them a licence. If you compare this to data from prior months in 2019 when the William Hill store was open, you will see there were more reports of crimes/antisocial behaviour on/near Glengall Passage for example, 21 counts of crimes reported in July 2019*

In summary - there are already a number of betting shops on Kilburn High Road, in order to improve the high road, we do not need another one. This would be a real result for Brent to show actions rather than words when it comes to tackling the problem of gambling addiction and the resulting health impact on our most vulnerable residents, not to mention a continue drive to tackle crime and anti-social behaviour. An approval of this licence would show that those two things are just not a priority for Brent.

I would like to object – because a business like this would make me feel unsafe. My flatmate and I are young women in our early 20s – we both work outside of normal working hours, so most days we have to walk down Kilburn High Road late at night, or in the early hours in the morning.

On our current 10 minute walk to our flat from Kilburn Park tube station we already pass three 'Adult Gaming Centres'. There's one at 40 Kilburn High Road, one at 108 Kilburn High Road and there's a 'Cashino' at the corner of Quex Road (which is only 50 meters away from the proposed 'Adult Gaming Centre' at 141 Kilburn High Road). We also have to walk past two betting shops.

We are frequently cat-called and leered at by men hanging around outside these establishments. I have been followed home on multiple occasions. If there are any women on your team, I am sure they will understand that behaviour is endemic to establishments like this — and I do not want to feel threatened going in and out of my own home.

These fears are not unfounded. These establishments are most likely to attract men aged 45-64 and 85% of women aged 18-24 have faced sexual harassment in public spaces. I think it would be irresponsible and sexist to ignore these concerns.

Moreover these same customers have engaged in fights (police has been called many times and in some cases the police car needs to remain parked there to avoid more trouble), disturbing pedestrians that have to walk around them to avoid them.

The fact that there are 3 primary schools and 1 nursery in the near proximity expose children and young parents on a daily basis to this anti-social behaviour.

(b) protecting children and vulnerable persons from being harmed or exploited by gambling.

The fact that there are several schools around this location and the fact that the exterior of these shops are normally advertising substantial prizes can influence young children to think gambling is a potential source of revenues. It does not show the reality that the odds are in favour of the "house". (Just check the profitability of these businesses to know that this is the case). There are also may vulnerable people living on Glengall Rd.

(c) the fact that there are already 4 betting shops in the area.

I acknowledge that there people who like to gamble and they may need a regulated facility to do this. But there are already enough places to do that in the area. In fact there is one "Cashino" shop already across the street on Kilburn High Road and 3 more sport bet shops 5 minutes walk from this location. I believe that all those are more than enough to cover the demand for gambling in the area.

I hope you reconsider the licence and help us to make our neighbourhood a safer and a better place to live.

I write in respect of the application for a licence at premises at 141-143 Kilburn High Road. I am a resident of which joins the Kilburn High Road at the corner where these premises are located.

I object to provision of a licence for Adult Gaming Centre premises at this location. My primary concern is that it will result in an increase in street crime in the area.

It is in a prominent location on the Kilburn High Road and will draw in a number of young and vulnerable people. I note that it is located very close to Kilburn Grange School – 1 minute's walk away on Priory Park Road. I do not understand how that close proximity is compatible with the objective of "protecting children and other vulnerable persons from being harmed or exploited by gambling."

Moreover, it is also located on the corner with Glengall Road. This road, because it is connected to Willesden Lane by roads that are only accessible to foot and two-wheeled traffic has proved to be a magnet for street crime: the geography allows for criminals to evade police vehicle pursuit. It is notorious that drug-users and criminals move from the busy Kilburn High Road to the more isolated, residential streets. For this reason the Council will be aware that the Kilburn SNT supported the placement of CCTV cameras in 2019 to cover the BT phonebox on the corner of Hazelmere Road and Victoria Road, which quickly adjoins Glengall Road.

Glengall Road has seen significant street crime since late 2018. There is a particular cluster of antisocial behaviour crime at Glengall Passage right by the proposed licensed premises. I am concerned the presence of an activity notorious for addictive behaviour will exacerbate that anti-social behaviour.

I note that there has been consistent complaint about gambling premises at this location because of the effect on crime in the local area http://democracy.brent.gov.uk/documents/s19314/Application-Resident%20Rep1.pdf

Finally, I do not understand how the presence of another Adult Gaming Centre is necessary. There is already the "Merkur Cashino Kilburn" almost immediately opposite on the Camden side of Kilburn High Road, at the corner of Kilburn High Road and Quex Road. There would, if this license is approved, be two within less than 25 metres of each other. Inbetween them, on the opposite side of Glengall Road would be "H&T Pawnbrokers". I do not understand how a cluster of pawnbrokers and AGC can be anything but a magnet for cash based street crime, anti-social behaviour and exploitation of the vulnerable. Please accept this email as our objection to the application for an Adult Gaming Centre at 141 Kilburn High Road (Kilburn High Road/Glengall Road) for the following reasons:

- The building borders two street and is extremely close to quiet residential housing. Glengall Road (less than 200 meters from 141 Kilburn High Road) is a residential street with extremely high apartment occupancy rate including a five story block of flats in close vicinity.
- The business will be located almost directly in front of a bus stop. Many families use the bus stop directly outside 141 Kilburn High Road to commute to and from schools in the area, meaning that children will be exposed to the business throughout the day.
- The business will be located next to a row of convenience stores which are a focal point of the local community which are used consistently throughout the day and the evening (we frequently use these to buy daily essentials). It is completely inappropriate that a business of this type be situated here.
- A business whose principle hours of business are late at night is not compatible with this location and will encourage noise and disorderly behaviour.
- For residents living on Glengall Road, there is only one access point to local amenities and recreational services, such as cinemas, shops and local restaurants. Access to all of these would mean having to walk directly outside this establishment through all hours of the day - and it is not right that they should be made to do this.
- Apart from the security risks which are associated with these types of businesses, it is well known that gambling establishments pose a high risk to vulnerable members of the community. It would be dangerous and irresponsible therefore to locate this business at 141 Kilburn High Road.
- Furthermore and related to the previous, this business will be located less than 200 yards from three major high street banks (Santander, Halifax and Lloyds Bank) placing vulnerable persons at risk of exploitation
- This business will be located away less than 200Ft from a MacDonalds, where many young people gather in the evenings
- There are a number of adult gaming centres stationed along Kilburn High Road already. This business is highly likely to increase anti-social behaviour and possible risk of crime, as already evidenced by a number of incidents of antisocial behaviour outside such establishments including fighting and aggression, loitering, urination and theft. However, it is worth stressing that due to the factors referred to above, out of all establishments of this nature located on Kilburn High Road, this would be the most poorly positioned in terms of its risk to public health and the wellbeing of the local community.

I am writing to make representation about a notice of application for a premises licence under the Gambling Act 2005.

This is an application by the company Future Leisure Limited for an Adult Gaming Centre Premises Licence under section 159 of the Gambling Act 2005. This relates to the premises at 141 Kilburn High Road, Kilburn, London, NW6 7HT.

I note that the application has been made to the London Borough of Brent Licensing Service (Regulatory Services), specifically 'Regeneration and Growth'. I have to say that the granting of this premises licence would do little to assist in regeneration and growth in Kilburn in particular or Brent in general. I am happy to expand on that viewpoint.

I have been a resident of since 2015 and am very familiar with the business premises at 141 Kilburn High Road and its former incarnation as a branch of William Hill Bookmakers. What I witnessed was how significantly these premises contributed to the antisocial behaviour that is such a negative part of living in Kilburn.

While operating under the William Hill name, 141 Kilburn High Road attracted a constant stream of alcoholics and various other unsavoury individuals and groups. They did not congregate on the High Road but instead would gather along the Glengall Road side of the building, extending from the entrance door to the premises down to (and indeed, into) Glengall Passage.

These gatherings took place at all hours of the day and night and were characterised by swearing and shouting, public drinking, frequent physical altercations and littering. Of particular concern was the frequent public urination that came with these gatherings, due to the alcohol being consumed but with no access to public lavatories. The level of brazenness was such that I once witnessed an inebriated individual leaning with his back to the wall of number 141 and urinating almost half the width of the pavement, in full view of anyone walking past. The reaction of customers sitting outside La Diva Café echoed my own revulsion on that occasion.

A more disgusting example of this behaviour involved my children. I have and who are pupils at Kilburn Grange School on Priory Park Road. Glengall Passage is the shortest route from Glengall Road through to the school but it was not feasible to use it as many of those gathering outside number 141 would urinate there. Consequently, Glengall Passage became akin to an open sewer and the smell was truly dreadful even when simply passing by and having to take the longer route round to the school via Kilburn High Road. One morning in particular, I went to walk my children down Glengall Passage and we were confronted by the sight of a drunken middle aged man, with a can of beer in one hand and his penis in the other, urinating openly against the wall barely

two feet from Glengall Road. I quickly moved my children away and was genuinely furious to have witnessed this sort of behaviour being displayed on the street that we call home.

The area outside Number 141 was also a focal point for criminal activity when it was a bookmakers, with several individuals openly exchanging drugs and money. An organised gang of Eastern European beggars has been operating on Kilburn High Road for the past year and several of their members would also congregate outside 141. They would walk further down Glengall Road asking people for money and I have witnessed them sitting outside the main door of Academy Court, the residential flats, arguing with each other.

Since the closure of William Hill at 141 Kilburn High Road and the premises remaining vacant, there have been no further gatherings on Glengall Road. I have not witnessed any further instances of public exposure or urination in the vicinity of Glengall Passage and the level of littering, primarily empty bottles and cans and cigarette ends, is now almost non-existent. Granting a premises licence for 141 Kilburn High Road would inevitably attract the same type of characters back to the area and would make Brent Council directly responsible for any anti-social behaviour that was subsequently to occur.

Kilburn High Road already has an excess of gambling establishments. These range from several outlets of William Hill, Ladbrokes and Paddy Power through to several 24 hour slot machine arcades. Therefore, the granting of a premises licence for 141 Kilburn High Road would be a regressive decision that would facilitate greater access to gambling opportunities in an area of London where many parts of the community suffers from social disadvantage and destructive addictions.

In closing, I would urge Brent Council to reject the application for 141 Kilburn High Road to become an Adult Gaming Centre Premises. Instead, number 141 could and should become a key part of the wider efforts to regenerate Kilburn. I would welcome most any other type of business taking over 141 Kilburn High Road and, for the reasons listed above (among others), I am sure my fellow residents in Glengall Road will overwhelmingly share this view.

I would like to raise my concerns and objections to the proposed opening of a new gambling premises on the corner Glengall Road and Kilburn high road. I have lived on for 12 years less than from the proposed venue

The most obvious challenge is to do with street nuisance around the venue. The new premises proposes to occupy (all or part of) the site of a previous William Hill bookmaker. This venue was routinely associated with informal gathering of patrons, street drinking, acute drunkenness, littering and broken glass. There was frequent disorder and fighting that required police interventions as the police will no doubt corroborate. This is particular concern with the immediate proximity of a primary school - and near proximity of several other schools and nurseries.

More subtly, but perhaps more seriously - is the overwhelmingly negative impact of welcoming yet more gambling venues in Kilburn. we already have 4 bookies and 3 other fruit-machine gambling venues in the immediate vicinity on Kilburn Highroad

- Betfred at 127 Kilburn High Road, NW6 6JH,
- Ladbrokes at 205 Kilburn High Rd, NW6 7HY,
- Ladbrokes at Kilburn Bridge House, Kilburn High Rd, Kilburn, NW6 6HY
- William Hill at 40A Kilburn High Rd, NW6 5UA
- Cashino at 130 Kilburn High Rd, Kilburn, London NW6 4JD
- Palace Amusements at 108 Kilburn High Rd NW6 4HY
- City Slots, 89 Kilburn High Rd, London NW6 6JE

Like off-licenses and levels of alcohol consumption there is a clear and link between the geographical density of gambling venues and the amount of gambling. The presence of so many venues increases impulse gambling and normalises gambling for the wider community. The shops themselves serve as huge billboards that are visible to all, including children and young people, and other vulnerable people. Why else would they seek to open more shops in an area already seemingly saturated with them?

Despite the attempts at PR from the gambling industry that it is just a bit of harmless fun - the harms of gambling are well documented by numerous independent academic and NGO research and government agencies (indeed growing concerns have led to a major new inquiry into gambling related harms being

launched https://www.gov.uk/government/publications/gambling-related-harms-evidence-review-gambling-related-harms-evidence-review-scope)

They are fundamentally exploitative - preying on vulnerable and economically marginalised individuals and actively locating in higher densities in areas with high populations of economically vulnerable individuals. The rising economic challenges created by the coronavirus pandemic have only served to increase such vulnerability - that such gambling venues are so effective at exploiting by holding out the fantasy prospect of an escape from

poverty that they invariably only entrench. They bring nothing positive whatsoever to the local community, only hardship and misery. There is never a good place to add yet another bookie in Kilburn, but this moment in time would be particularly negligent and irresponsible.

Almost any business would be preferable. Please respect the concern to the immediate locals residents, families, schools, and the wider community and reject this application.

Future Leisure Limited, application for an AGC premises licence, 141 Kilburn High Road, London, NW6 7HT.

I am a solicitor and represent City Gaming Limited and Family Leisure Holdings Limited, which operate the businesses City Slots, 89 Kilburn High Road, London NW6 6JE and Palace Amusements, 108 Kilburn High Road, Hampstead, London NW6 4HY, i.e. near the applicant site. As such, they have business interests that might be affected by the above mentioned application and the companies are both an "interested party" pursuant to section 158 of the Gambling Act 2005. The fact that they operate the same nature of business as the applicant, does not alter this fact.

In their capacity of interested parties they wish to make the following representations.

- 1. Which operator is the applicant? Within the application form the applicant refers to a different operating licence number from that contained in the notice to the Responsible Authorities. As such proper notice may not have been given to the Responsible Authorities or Notice of the Application to the Licensing Authority.
- 2. Have notices been given to the Responsible Authorities by the applicant (as it is expressly required to do regardless of whether the Authority itself provides copies to the Responsible Authorities)?
- 3. I note that the applicant has confirmed that it has the right to occupy the building i.e. a legal right. While that may be the case, it is often the case that applications are made prior to the acquisition of the site i.e. before a right to occupy has been acquired. In such circumstances, the appropriate application could be for a provisional statement as is confirmed in the Licensing Authority's Statement of Policy. Without a right to occupy, an application for a premises licence cannot be made.
- 4. The address of the premises subject to the application refers to 141 Kilburn High Road yet the vacant betting shop that the application proposes to occupy, previously a William Hill, had the address of 141-143 Kilburn High Road. Which is the correct address? Indeed is a licence already in effect at the premises, preventing the Licensing Authority issuing a licence to the applicant?
- 5. The plans do not comply with the requirements of the Gambling Act 2005 (Premises Licences and Provisional Statements) Regulations 2007 (SI 2007/459).
 - a. it is not clear where the boundary of the actual premises lies, the plan does not show, as required, the extent of the boundary or perimeter of the premises;

- b. a description of the place from which entry is made or to which exit leads, for the exit/entry apparently down the side of the building. What road is this?
- c. It is not possible to identify the location and extent of the part of the premises in which gaming machines will be made available for use in reliance on the licence.

Please accept the above serious issues as representations in relation to the application.

I should be grateful if you would please confirm receipt of this email.

I write further to our recent emails with regard to the above matter and acknowledge receipt of the representations that you have received.

It may assist if I set out a bit more information about the application and I wonder if you could forward this email to those who have made representations as I should not contact them direct without their approval.

- 1. The applicant is an independent operator of Adult Gaming Centres and is based in London. The applicant currently operates seven other Adult Gaming Centres with licences granted for a further 6 premises.
- 2. The following conditions have been agreed with the MET police and would be implemented at the premises:

1.CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for <u>31 days</u> and shall be made available to police and licensing officers if requested.

- 2.A CCTV camera shall be installed to cover
- a) All entry and exit points to and from the premises enabling frontal identification of every person entering under any light conditions
- b) The areas of the premises to which the public have access (excluding toilets)
- c) Gaming machines and the counter area
- 3.An overt CCTV monitor to be installed, able to be seen by customers

- 4.CCTV shall be made available for the police viewing at any time with minimum delays when requested.
- 5. The following crime prevention measures shall be implemented:
 - A time delay safe with deposit slot and anti-fishing mechanisms must be used at the counter till area
 - Regular robbery awareness and cash handling training shall be given to all staff.
- 6. The Licensee shall maintain a bound and paginated 'Challenge 25 Refusals' register at the premises. The register shall be produced to the police or licensing authority forthwith on request.
- 7. Prominent signage and notices advertising the Challenge 25 will be displayed showing the operation of such policy.
- 8. Third party testing on age restricted sales systems purchasing shall take at least twice a year and the results shall be provided to the Licensing Authority upon request.
- 9.A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.
- 10.A magnetic locking device, commonly referred to as a Maglock will be installed and maintained on the main entrance/exit to the premises which will be operable from the ground floor cashier counter by staff.
- 11.All doors and windows shall remain closed during any licensable activity.
- 12. There shall be no pre-planned single staffing/lone working at any time.
- 13. There will be a minimum of **two** staff present at all times when the premises are open.
- 14. The licensee shall ensure that all seating within the premises are either secured to the floor or are weighted to prevent lifting.
- 15.A suitable intruder alarm complete with panic button shall be fitted and maintained.
- 16.A fire alarm and smoke detection system shall be installed.
- 17. The licensee will ensure that customer toilets are checked every hour for evidence of drug taking and alcohol consumption. Toilet checks are to be documents stating the time and member of staff who made the checks.
- 18. Toilet doors remain locked, fitted with a magnetic style-locking device and access given by staff only.
- 19.An incident log shall be maintained and made available on request to an authorised Local Authority officer or the Police, which will record the following:
- a) All crimes reported to the venue.
- b) Any complaints or incidents regarding crime and disorder.
- c) Refusals and banned customers.

- d) Any faults in the CCTV system.
- e) Any visit by a relevant authority or emergency service.
 - 3. The applicant has also agreed conditions with the licensing authority and these will also be implemented at the premises should the licence be granted:

CCTV

- 1.A comprehensive CCTV system shall be installed and maintained on the premises as required by the Metropolitan Police Licensing Team. CCTV shall cover the following:
- (a) All entry and exit points to and from the premises enabling frontal identification of every person entering under any light conditions
- (b) The areas of the premises to which the public have access (excluding toilets)
- (c) Gaming machines and the counter area
- 2. The CCTV shall continue to record activities 24 hour a day for 31 days.
- 3. CCTV shall be made available for the police viewing at any time with minimum delays when requested.
- 4. The premises shall display notices near the entrance of the venue stating that CCTV is in operation.
- 5. A monitor shall be placed inside the premises above the front door showing CCTV images of customers entering and exiting the premises.

Children and Young People

- 6. The licensee shall maintain a bound and paginated 'Challenge 25 Refusals' register at the premises. The register shall be produced to the police or licensing authority forthwith on request.
- 7. Prominent signage and notices advertising the Challenge 25 will be displayed showing the operation of such policy.
- 8. Third party testing on age restricted sales systems purchasing shall take at least twice a year and the results shall be provided to the licensing authority upon request.
- 9. A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification cards, such as a driving licence, passport or proof of age card with the PASS Hologram.

Staffing Levels

- 10. There shall be no pre-planned single staffing at any time.
- 11. There will be a minimum of 2 staff at all times when the premises is open.

Identification of Offenders or Problem Persons

- 12. The licensee shall implement a policy of banning any customers who engage in crime or disorder within or outside the premises.
- 13. The licensee will refuse entry to customers who appear to be under the influence of alcohol or drugs.

Seating

14. The licensee shall ensure that all seating with within the premises are either secured to the floor or are weighted to prevent lifting.

Alarms

- 15. The licensee shall install and maintain an intruder alarm on the premises.
- 16. The premises shall install and maintain a panic button behind the cashiers counter.

Toilets

17. The licensee will ensure that customer toilets are checked every hour for evidence of dug taking. Toilet checks are to be documents stating the time and member of staff who made the checks.

Signage, Promotional Material and Notices

18. Prominent GamCare documentation will be displayed at the premises.

Staff Training

- 19. The licensee shall provide training on the specific local risks to the licensing objectives that have been identified for those premises as part of the staff induction training programme. Periodically provide refresher training to all its staff working at these premises on the specific local risks to the licensing objectives.
- 20. The licensee shall train staff on specific issues related to the local area and shall conduct periodic refresher training. Participation in this training shall be formally recorded and the records produced to the police or licensing authority upon request.
- 21. New and seasonal staff must attend induction training and receive refresher training every six months. Participation in this training shall be formally recorded on each member of staffs training records which, if requested will be presented to the Licensing Authority as soon as practicable.

Homeless and Street Drinking

- 22. The Licensee shall take all reasonable steps to prevent street drinking of alcohol directly outside the premises and to ban from the premises those who do so.
- 23. The Licensee shall place a notice visible from the exterior of the premises stating that customers drinking alcohol outside the premises is not permitted and those who do so will be banned from the premises.

Recording of Incidents and Visits

- 24. An incident log shall be kept for the premises and made available on request to an authorised officer of the Council or the Police which will record the following:
- (a) All crimes reported to the venue;
- (b) Any complaints received regarding crime and disorder;
- (c) Any incidents of disorder;
- (d) Any faults in the CCTV system; and
- (e) Any visit by a relevant authority or emergency services.

- 4. I can also confirm that the following will be in place at the premises if the licence is granted:
- 1. Clear signage on the front door prohibiting under 18s from entering the premises and anyone carrying alcohol from entering the premises.
- 2. There will be staff training with regard to all licensing objectives, in particular protecting the vulnerable.
- 3. GamCare posters will be displayed in the premises and staff will liaise with customers who will be able to self-exclude both from these premises and any other Future Leisure premises. Staff will be trained on intervention and safeguarding.
- 4. Anyone who does not look 25 will be asked to provide passport or driving licence identification.
- 5. The fact that there will be 2 members of staff on the premises at all times will ensure that there is constant supervision of customers, more than adequate security and staff availability to assist any customer who requires any help.

I am happy to confirm that all of the above will be in place at the premises and would be grateful if you would notify those who made representations.
