If a Member is aware they have a Disclosable Pecuniary Interest\* in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent and must leave the room without participating in discussion of the item.

If a Member is aware they have a Personal Interest\*\* in an item of business, they must declare its existence and nature at the start of the meeting or when it becomes apparent.

If the Personal Interest is also significant enough to affect your judgement of a public interest and either it affects a financial position or relates to a regulatory matter then after disclosing the interest to the meeting the Member must leave the room without participating in discussion of the item, except that they may first make representations, answer questions or give evidence relating to the matter, provided that the public are allowed to attend the meeting for those purposes.

The supply of alcohol and to remain open from 9am to 7.30pm Monday to Saturday and 9am to 5pm Sunday.

#### 2. Background

The review of the Statement of Licensing Policy has introduced Cumulative Impact Zones for all new or variation applications for 'Off' licences in the borough.

This application falls within a Cumulative Impact Zone.

The presumption is that any new licence or variation to an existing licence that increases the scope for the sale of alcohol will not be granted unless the applicant can evidence that the licence will not negatively impact on the licensing objectives.

If situations arise where the licensing objectives may be undermined but cannot be dealt with by the use of appropriate conditions the Licensing Authority will consider whether it is appropriate for a licence to be granted or continue to operate.

- grant the licence;
- exclude from the scope of the licence any of the licensable activities to which the application relates;

#### a) General – all four licensing objectives (b, c, d, e) (please read guidance note 10)

THE SHOP DOES OPERATE TO A HIGH STANDARD, AND WILL CONTINUE TO DO SO SHOULD THIS LICENCE BE GRANTED IN TERMS OF THE SALE OF ALCOHOL. STAFF WILL BE FULLY TRAINED IN THEIR RESPONSIBILITIES WITH REGARD TO THE SALE OF ALCOHOL, AND WILL BE RETAINED EVERY SIX MONTHS, THIS WILL BE KEPT ON THE RECORDED TRAINING FOR INSPECTION. THE SHOP WILL BE CLOSED 30 MINUTES AFTER LICENSING ACTIVIES HAVE CEASED, TO ALLOW CUSTOMERS ENOUGH TIME TO FINISH THEIR DRINKS AND LEAVE THE PREMISES QUIETLY TO DO NOT DISTURB ANY NEIGHBOURHOOD.

IN ORDER FOR OFF LICENSING ALCOHOL WILL BE MAINTENED IN A PLASTIC BAG AND CUSTOMERS WILL BE ADVISED NOT TO OPEN AT THE PUBLIC STREETS AND NOT TO SELL FOR PEOPLE WHO ARE SHOWING DRUNKENNESS AND UNDERAGE PERSONS.

#### b) The prevention of crime and disorder

CCTV WILL BE USE AT THE SHOP, IT SHALL BE APPROPRIATE STANDARD AS AGREED WITH THE LICENSING AUTHORITY

IN CONSULTATION WITH THE POLICE.

CCTV EQUIPMENT WILL BE MAINTENED IN A GOOD WORKING ORDER AND CONTINUALLY RECORD WHEN LICENSABLE ACTIVITY TAKES PLACE AND FOR A PERIOD OF TWO HOURS AFTERWARDS.

PREMISES LICENCE HOLDER WILL ENSURE IMAGES FROM THE CCTV ARE RETAINED FOR A PERIOD OF 31 DAYS. THE IMAGE RETENTION PERIOD MAY BE REVIEWED AS APPROPRIATE BY THE LICENSING AUTHORITY, THE CORRECT TIME AND DATE WILL BE GENERATED ONTO BOTH THE RECORDING AND THE REAL TIME IMAGE SCREEN.

AN INCIDENT RECORD WILL BE KEPT IN A BOOK, AS WILL REFUSALS FOR THE SALE OF ALCOHOL. THESE BOOKS WILL BE MADE AVAILABLE TO THE POLICE OFFICER FROM THE COUNCIL ON REQUEST.

#### c) Public safety

STAFF WILL BE TRAINED TO BE ALERT TO ANY POTENTIAL DANGER TO CUSTOMERS AND REACT ACCORDINGLY. IF IN CASE THEY ARE UNABLE TO DEFUSE THE SITUATION WITHOUT RISK TO CUSTOMER OR STAFF, THEY ARE INSTRUCTED TO CALL THE POLICE. ALL RELEVANT FIRE PROCEDURES ARE IN PLACE FOR THE SHOP OF THIS SIZE. THERE WILL BE ON-SITE ACCIDENT BOOK IN OPERATION TO RECORD ANY ACCIDENT OR INJURY INCUREED ON THE PREMISES.

THIS DOCUMENT WILL BE RETAINED FOR INSPECTION BY THE BUSINESS FOR A PERIOD OF THREE YEARS.
THERE WILL ALSO BE APPROPRIATE FIRE SAFETY PROCEDURES IN PLACE THAT INCLUDES FIRE EXTINGUISHERS
(FOAM, H20 AND CO2), FIRE BLANKET, INTERNALLY FIRE EXIT SIGNS, SMOKE DETECTORS AND EMERGENCY LIGHTING.

#### d) The prevention of public nuisance

I AM AWARE THE SHOP IS UNDER A CUMULATIVE IMPACT ZONE (CIZ), HOWEVER AS THE OPENING HOURS FINISHES AT 1930 THERE'S LESS RISK TO POSE NOISE POLLUTION, BUT GUESTS WILL STILL BE REMINDED BY WAY OF NOTICE AT THE ENTRANCE/EXIT DOOR TO PLEASE LEAVE THE SHOP QUIETLY.
CLEAR AND ELIGIBLE NOTICES WILL BE PROMINENTLY DISPLAYED TO ALSO REMIND CUSTOMERS TO LEAVE QUIETLY AND HAVE REGARD TO OUR NEIGHBOURS.

#### e) The protection of children from harm

ONLY PHOTOGRAPHIC ID IS ACCEPTED (PASSPORT, DRIVING LICENCE, PROOF OF AGE CARD WITH PASS HOLOGRAM, OR MILITARY ID). ANYONE THAT APPEARS TO BE UNDER AGE OF 25 IS CHALLENGED TO PROVIDE WITH AN ID. IF THE CUSTOMER IS UNABLE TO PROVIDE WITH AN IDENTIFICATION THEN NO SALE IS MADE. NO ID NO SALE. CHALLENGE 25 POS WILL BE ON DISPLAY IN THE STORE. IF THERE'S ANY STAFF MEMBER WHO IS UNDER 18 MUST CALL A SENIOR STAFF MEMBER TO DEAL WITH THE SALE AND FINISH TRANSACTION. IF IT IS KNOWN THAT A CUSTOMER INTENDS TO PURCHASE ALCOHOL TO PROVIDE TO A MINORS THEN SALE WILL BE REFUSED. ALL REFUSED SALES WILL BE RECORDED IN A REFUSALS BOOK, WHICH WILL BE MADE AVAILABLE FOR INSPECTION BY POLICE OR LICENSING OFFICERS OF THE COUNCIL ON REQUEST.

ALL CHILDREN ON THE PREMISES WILL BE SUPERVISED/ ACCOMPANIED BY AN ADULT AT ALL TIMES.



Police certify that we have considered the application shown above and wish to make representations that the likely effect of the grant of the application is detrimental to the Council's Licensing Objectives for the reasons indicated below.

Officer: PC Philip BRISTOW Licensing Constable 3193NW

An officer of the Metropolitan Police, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the Licensing act 2003. The Police representations are concerned with all four of the licensing objectives, namely:

- The prevention of crime and disorder.
- Public safety.
- The prevention of public nuisance.
- The protection of children from harm.

#### **The Application**

The application is for a new Off License / Delicatessen in Cricklewood Broadway.

The applicant is asking for venue to be open from 09.00 hours to 19.30 hours Monday to Saturday and on Sunday 09.00 hours to 17.00 hours. The supply of alcohol is requested from open to close on each day.

The application quite rightly states that the venue is located within one of Brent's Cumulative Impact Zones (CIZ- Cricklewood Broadway Junction of Mora Road to Walm Lane).

#### **Cumulative Impact Zones**

Brent Council Licensing Policy introduced CIZ's on 7<sup>th</sup> January 2020 in order to combat a rise in crime, disorder, public nuisance, anti-social behaviour and street drinking all of which is fuelled by the sale and consumption of alcohol

There are many studies reflecting the relationship between alcohol consumption/abuse with increases in ASB and violent crimes, as highlighted by such organisations as the Institute of Alcohol Studies. There is also evidence that the most disadvantaged of socio-economic groups (as represented by some of the local populous) that they are disproportionately at risk of alcohol-related violence.

#### **Police Representations**

Conducting checks on or near Cricklewood Broadway NW2 where the venue is situated it shows the following figures:

- (a) Two Hundred and Thirteen (213) Recorded crimes. These are a wide variety of crimes including assaults, possession of drugs, racially aggravated public order offences, GBH, domestic assaults and numerous thefts.
- (b) Two Hundred and Fifty Eight (258) Calls to police.
- (c) Thirty seven (37) Stop and searches by police.
- (d) Forty six (46) Arrests.

These are a wide variety of crimes including racially aggravated public order offences, commercial burglary, antisocial behaviour, vehicle crime, violent and sexual offences and thefts from persons. Furthermore this would not include the crimes that have happened on the other side of this road as this would be on Camden Borough and none of the figures include the surrounding roads.

In addition to this area which is already suffering from very high crime figures, there are at present twenty three (23) other venues selling alcohol to the public on Cricklewood Broadway on Brent's side of the road, never mind Camden's side. This community does not require another venue selling alcohol which will only fuel the street crime, ASB and create price wars between rival venues.

I see no benefits in adding another venue that sells alcohol to Cricklewood Broadway with the existing crime rate.

Taking into account of Police concerns and guidance related to CIZ's given in the Brent Council guidance; the presumption is that the application will be refused unless the applicant can satisfactorily evidence that their application or variation will not negatively impact on the licensing objectives.

Due to all the points raised above, the Police licensing team oppose the granting of this premises licence.

I certify that I have considered the application shown above and I wish to make a representation that the likely effect of the grant of the application is detrimental to the Licensing Objectives for the reasons indicated below.

An officer of the Licensing Authority, in whose area the premises are situated, who is authorised for the purposes of exercising its statutory function as a 'Responsible Authority' under the Licensing Act 2003.

The application has been made for a new premises licence under section 17 of the Act.

The Licensing Authority representations are primarily concerned with the four licensing objectives;

- the prevention of crime and disorder;
- public safety:
- the prevention of public nuisance; and
- the protection of children from harm.

#### **Cumulative Impact Zone (CIZ)**

The Council has established twelve (12) Cumulative Impact Zones (CIZs) in Brent. The purpose of these CIZs is to address levels of crime and disorder, and anti-social behaviour, particular that associated with street drinking. Therefore, the CIZs will specifically relate to applications and variations for off-licences.


#### **Cricklewood Broadway**

Cricklewood Broadway is a busy High Street with a variety of shops on one side of the Broadway which is in Brent. The data shows that there is a high level of ASB.

This is a new CIZ for Brent.

Between 1 July 2021 and 30 June 2022 there were 238 reports to the police, including 149 relating to anti-social behaviour, 2 relating to public order breaches and 81 reports relating to violence.

The below map shows violence with injury crimes.



#### **The Premises**

The premises, namely, Xodo Brazil, 29 Cricklewood Broadway, NW2 3JX falls within one of Brent's CIZs.



#### **Public Space Protection Order (PSPO)**

The entire Borough of Brent is subject to a Public Space Protection Order for street drinking and it is an offence for if a person to fails to comply with a request to cease drinking alcohol by an authorised officer.

If a police officer reasonably believes that a person is, or has been, consuming intoxicating liquor within these areas, the officer may require the person concerned:

- a) not to consume in that place anything which is, or which the officer reasonably believes to be, intoxicating liquor
- b) to surrender anything in his/her possession which is, or which the officer reasonably believes to be, intoxicating liquor or a container for such liquor (other than a sealed container)
- c) An officer may dispose of anything surrendered to him/her as above.
- d) Issue fixed penalty notices on offenders
- e) Prosecute persistent offenders

However, in reality there are limited police officer resources, which in practice would prevent the above from being enforced. This therefore places a greater emphasis on the responsibility of those premises that are selling alcohol for consumption off the premises. It is clear that if off licences did not exist, the number of street drinkers would decline.

Therefore, simply selling alcohol to customers who once off the premises, are no longer the responsibility of the licence holder, the Designated Premises Supervisor (DPS) and/or members of staff is no longer a viable option.

#### **Operational Plan & Conditions**

History – Complaints

The Council received a complaint in December 2023, which triggered a licensing visit to the premises in response to allegations of noise disturbance in the form of loud music and the supply of alcohol. The applicant, Mr Goncalo was in charge of the premises at the time, when the investigation took place.

Mr Goncalo initially denied any licensable activities taking place but after further questioning by the Licensing Officer, he later admitted that he had gatherings with his friends and held parties with alcohol supplied at the premises. Mr Goncalo confirmed he was hosting a live concert for his daughter who is a gospel singer.

Following a warning letter issued by the Council, the Licensing Authority received a new application for the supply of alcohol and provision of regulated entertainment.

On 11 January 2024, a request for further information was sent to the applicant in respect of the new application. On 12 January 2024, the applicant responded to my questions and provided an amended plan eliminating the side external areas including the rear garden, see below details:

#### **Business Information**

- 1. Please confirm who is the business rate payer?
- The business rate payer is under Lina Lai.


- 2. Please confirm if you are the leaseholder and how long you hold the lease for?
- The leaseholder of the premises is under the name of Lina Lai and is for 15 years.

#### **Operating Schedule/Licensable Activities**

- 3. What sort of alcoholic beverages will you supply?
- Mainly Beers, but also Wine and Spirits.
- 4. Do you intend to supply single can/bottle of alcohol beverages?
- Yes
- 5. Do you intend to supply beers, ciders and lagers over 6%abv?
- Yes
- 6. Will the 8 seated customers be located inside the premises?
- Yes
- 7. With regards to live music, are you intending to host events in the future or invite other musicians to provide entertainment?
- No, the licence for live music is for the use of my daughter to record for her YouTube channel.

#### Plan

- 8. It would appear that you have proposed licensable activities areas outside the property, please can you provide a plan labelling the areas *for example front external seating area, rear garden* as indicated with an arrow below:
- The New plan will be attached on the e-mail.
- 9. It would appear that the customer toilets are located in a separate building at the rear, how would your customers gain entry to the toilets?
- Yes, the toilet is located on a separate building near the rear of the garden, however with restricted access. For the customers to gain entry to the toilets they must ask one of the staff to gain access.
- 10. Are there residents living above or behind the premises?
- Yes, there is resident living above the premises and gain access to their flats from the side of the shop which is a private and independent entrance.



On 12 January 2024, a Licensing Officer visited the premises and took pictures of various areas within the premises (Appendix 1).

The Licensing Authority would expect to see information on how the business plans to ensure that their particular premises will go above and beyond in promoting the licensing objectives in a crime hot spot and in this case the applicant has not provided such information to support this.

Furthermore, it would appear that the applicant is not familiar with a CIZ. There are existing off licences within close proximity.

In respect of the plan, there is concern with customer access to the rear toilet. All toilets in food business premises should be separated by a lobby from food eating or preparation areas. It

transpires that customers would need to enter the preparation area in order to access the toilet, which is unhygienic from a food safety point of view.

The size of the premises is of a compact nature and does not appear to be appropriate to run as an on licenced venue. Mr Goncalo holds the capacity of a manager, therefore it is questionable whether he is suitable to be a licence holder on the basis that he flouted the law.

#### **Summary**

The Statement of Licensing Policy states that any licence application in a CIZ area will need to demonstrate with evidence that its operation will not add to any cumulative impacts that the CIZ is seeking to address. Further, new applicants and those applying for variations would be required to demonstrate how their premises will not contribute to street drinking in those areas.

The effect of adopting a CIZ is to "create a rebuttable presumption" that applications for licences which are likely to add to the existing cumulative impact will normally be refused (or subject to certain limitations) unless the applicant can demonstrate that there will be no negative cumulative impact on the licensing objectives.

It is on this basis, that the Licensing Authority ask that the application for a new application of the premises licence is **refused** by the Licensing Sub-Committee.



I would like to confirm that I have considered the above proposal with regard to the prevention of public nuisance. On behalf of the Environmental Health I would like to,

Make representations on the following grounds:

The noise caused by regulated entertainment (loud amplified music and in particular live music and vocals) is likely to be detrimental to the residential amenity.

The nearest noise sensitive properties are the flats above the commercial units along Cricklewood Broadway, therefore increasing the likelihood of residents suffering from loss of amenity should inadequate measures be taken to reduce the level of noise.

The Nuisance Control Team are currently investigating allegations of statutory nuisance caused by loud amplified music and amplified speech emanating from the premise. A number of reports have been submitted to us via the Noise App depicting loud amplified music that also portray heavy bass (Appendix 2). Upon assessment of these recordings, I am of the opinion that the noise is likely to be causing a statutory nuisance to local residents.

I am also of the opinion that the premise is unsuitable for the playing of live music as the building is uninsulated against the transmission of sound into adjoining properties, particularly low frequency noise.

No formal action has been taken against the license holders of the premise as recent intervention from the Business License Team is likely to have resulted in a reduction of nuisance level noise. Should the premises licence be granted however, the Nuisance Control Team would have concerns that noise from loud amplified music during the events detailed in the application would give rise to noise complaints from local residents once again.

I would therefore recommend the following condition:

There shall be no regulated entertainment permitted.



It should be noted that Xodo, whether as Xodo Brasil Butcher or Xodo Café, has been providing alcohol consumption & live/recorded amplified music events in & around its premise unlicensed for some time. Therefore, the objections which I raise are based on tangible, practical experience documented & evidenced. Available on request. Xodo Brasil have denied the public engagement in the process. They have not advertised the requisite licences application prominently on the premises for the required time. Neighbouring residents are unaware. The residents at (the residential property consists of , are only aware of this application by chance. We are made up of & presently in the process of coordinating legal proceedings in relation to Xodo Brasil which led our counsel to stumble upon the application. Otherwise, no one would ever know. The excessive alcohol consumption of Xodo Brasil's staff & patrons has a detrimental effect on the health and wellbeing of the local populations. The quality of life for those who live and work in the vicinity of the premises is greatly compromised by drunken hostile congregations & the nuisance caused by both live & recorded amplified music. Moreover, the forecourts trading of street food via charcoal barbeque & rotisserie, the queues they serve, the outdoor seating, along with street signage cause an obstruction to pedestrians & nuisance to neighbouring residential occupiers. The limited internal floorspace for customers in the butcher shop itself means that noisy, drunken, hostile crowds congregate outside (front & back) & must be negotiated & navigated through in order to pass by. The forecourt prevents safe, easy and convenient access for all users of the building Residents are victims of abuse from drunken patrons & staff when entering exiting or even receiving deliveries. There are not efficient toilet spaces for a drinks licence. Patrons are directed to an outdoor staff toilet in the residential garden & are often witnessed urinating against the residential premise, its walls, its doors, its windows & even against property such as bikes, tools, furniture belonging to residents. Nuisance and safety issues associated with Xodo operating as a licensed premise, include, music noise, dispersal noise from patrons, intrusive odours and general safety. No sound control or mitigation measures have been considered. In fact, the opposite. Requests to reduce noise are ignored & followed by an increase in the frequency of music events & level of noise. Xodo Brasil's Tony Goncalo even exacerbates the noise harassment further by playing unplugged versions of Xodo gigs from their out building, directing the performance into our ground floor bedroom window. Under floor insulation installed for residents has been compromised with much of it removed during the installation of the fascia signage by the commercial premise. Consequentially both noise & odour permeate the resident's home. Particularly given the installation of an awning which now helps funnel street food odours & smoke into the residential building rendering the residence unliveable on an unreasonable number of occasions. This is on top of the fact that the commercial premise itself only has a suspended panel ceiling with basic fissured tiles as a barrier for noise & smell. It is not sufficient. The general safety of the building is massively compromised by drunken patrons in & around the property. CCTV was put in place to deter antisocial behaviours & criminality. The response of Mr Goncalo of Xodo Brasil was to personally destroy the CCTV with a combination of a heavy construction ladder (used as a projectile) & shutter pole, beginning with the rear camera in our residential garden before moving to the front camera. Mr Goncalo is fostering a crowd hostile to residents, from the patrons of his unlicensed events & his staff. Mr Goncalo has been witnessed & documented inviting friends, staff & patrons to become hostile to residents. Both in the front & back of the building, Xodo's patrons are invited to survey residents' windows, security cameras, & even the residents themselves. Residents have been followed by foot & car in a campaign of intimidation. All because they appose the commercial premise operating as if it were a licensed alcohol serving music venue. The residents have no option but to oppose this as the building has been rendered unliveable. I should note that, for the criminal aspects of what is outlined in this, Met Police are already involved. Met Police, as one of the responsible authorities, can be consulted with regard to our cases & also cases of neighbouring residents also. Neighbours who have been denied the opportunity to object because of Xodo's failure to adequately advertise the application. As we can evidence, staff themselves also partake in alcohol consumption on premise, during their work hours, in uniform, often during music events. It's a health & safety concern obviously, in terms of food preparation & service, but also a concern in terms of fire safety. Food staff who do shots in work all evening cannot be relied upon to follow proper safety protocols. It is a matter of when not if our property & its residents are irreparably harmed.




