This EA is in relation to the commissioning of a contract for the provision of OT for Children and Young People in Brent schools.

Section 26 of the Children and Families Act 2014 places a duty on local authorities to implement joint commissioning arrangements with Health Partners for the support required in children and young people with Speciale Educational Needs and/or Disabilities Education,

Health and Care Plans (EHCP).

The primary target group of this proposed service is Reception and Key Stage 1-4 pupils attending Brent mainstream schools.

The service adheres to all aspects of the SEND Code of Practice 2015 (updated October 2020). The service supports delivery of the priorities identified in the Brent SEND strategy 2021 – 2025:

- Education, employment and training
- To live a healthy lifestyle
- To be fully active citizens of Brent.
- To live independently
- My Brent The voice of young people to be heard in shaping the Brent of the future.

The Service ensures that the Council meets its statutory responsibility to provide the expert level of care which is specified in Section F of a child's EHC Plan with regard to OT and an equitable service across all Key Stages taking into account the needs of children and young people requiring the service.

The service is expected to achieve the following outcomes:



- An improvement in the educational attainment and ability to participate in the curriculum of children and young people with OT needs listed in Section F of their EHCP.
- Children and young people who are aware of and, where possible, able to independently use strategies to support their therapeutic difficulties in everyday situations.
- Children and families receiving a seamless service when transferring between primary, secondary and independent providers of OT, and are aware of the on-going support available.

The Service is also expected to contribute towards achieving the following outcomes:

- a) The rate of improvement in under achieving groups is accelerated.
- b) All children and young people with SEND are able to access the same wide educational opportunities and life chances as their peers.

The Service ensures the council meets its statutory responsibility to provide the level of care specified in Section F of a child's EHCP with regards to OT and an equitable service across all Key Stages taking into account the needs of children and young people requiring the service. The service is expected to achieve the following outcomes:

- a) An improvement in the educational attainment and ability to participate in the curriculum of children and young people with OT needs listed in Section F of their EHCP.
- b) Children and young people who are aware of and, where possible, able to independently use strategies to support their therapeutic difficulties in everyday situations.
- c) Children and families receiving a seamless service when transferring between primary, secondary and independent providers of occupational therapy, and are aware of the on-going support available.

The Service is also expected to contribute towards achieving the following outcomes:

- a) The rate of improvement in under achieving groups is accelerated.
- b) All children and young people with SEND are able to access the same wide educational opportunities and life chances as others.

The primary target group of this service is Reception and Key Stage 1-4 pupils attending Brent mainstream schools. The number of children and young people with an EHCP in Brent is continuing to rise. The total number of children and young people with an EHCP have risen from 2950 in 2022 to 3350 in 2023 (an increase of 400 children and young people).

The total number of Education Health Care Plans Needs Assessments (EHCNA) completed for the 2022-2023 financial year was 155. This is an increase of 27% from the number of EHCNA's completed in the previous financial year 2021-22. At the end of the reporting period covering 1 January 2023 to 31 March 2023:

- 223 children and young people with an EHCP which included OT targets, accessed OT provision through this arrangement.
- 37 EHCNAs were completed.
- 12 children were successfully discharged and moved off the EHCP caseload.

OT services aims to enable children and young people to improve their ability to perform everyday tasks and activities successfully and to access the national curriculum more effectively. The service is intended to provide support at the earliest opportunity. Services are therefore designed to reduce any adverse impact by identifying and working with children who would benefit from early intervention speech and language support. The additional support they receive increases pupils' and parents' understanding of their needs, and will equip them with the relevant tools and aids to allow them to realise their potential.

OT services are therefore designed to reduce any adverse impact on children and young people who have occupational therapy needs which are listed in Section F of their EHCP as well as identifying and working with children and young people who would benefit from an early intervention programme of support.
