I make this statement in relation to Mr Ajaz Ali of 19 Woodland Avenue, Luton, LU3 1RW. Mr Ali was granted a personal licence by Luton Borough Council. The licence was granted on 28 March 2008 and expires on 27 March 2018.

Under the Licensing Act 2003 the Authority responsible for granting the Personal Licence is unable to revoke the licence following convictions or breaches of legislation, the Courts must undertake this requirement at the time of conviction. The Police may object to the renewal of the licence if the applicant has received convictions during the period of his/her licence. The Licensing Authority may prosecute for breach of legislation.
