## STATEMENT OF JENNY VAN BEUKELEN

I am employed by Luton Borough Council as a Licensing Enforcement Officer in the Licensing Service and have been specifically authorised powers, by Colleen Welfare and Laura Church from 01 July 2011, the Head of Environment & Consumer Services to enforce licensing legislation, (or any amendment, or enactment of or any Regulations made under such legislation) where the local authority has an imposed statutory duty, and have been in post since April 2005.

I make this statement in relation to Mr Ajaz Ali of 19 Woodland Avenue, Luton, LU3 1RW. Mr Ali was granted a personal licence by Luton Borough Council. The licence was granted on 28 March 2008 and expires on 27 March 2018.

Mr Ali was interviewed on 26 April 2012 and had a further interview on 12 July 2012. During both interviews Mr Ali was confused as to whether he had actually received a conviction for selling alcohol to persons under the age of 18 or not at the store in Willesden Road, London. He does however admit that he received a fine and a conviction in relation to the sale of lighters.

Mr Ali repeatedly suggested during both interviews that the Police enquiry is personal, malicious and unwarranted in specifically in respect of Police Constable McDonald and a Police Sergeant colleague actions.

Under the Licensing Act 2003 the Authority responsible for granting the Personal Licence is unable to revoke the licence following convictions or breaches of legislation, the Courts must undertake this requirement at the time of conviction. The Police may object to the renewal of the licence if the applicant has received convictions during the period of his/her licence. The relevant Licensing Authority may prosecute for breach of legislation.
