

I am a Civilian Licensing Officer employed by the Metropolitan Police and have been in post sin that I was a police officer for 30 years. In charge of this room was a m name as Mohammed Ali. The room was cleared by the staff and subsequently photographed b upon examination it was found that the access was controlled by a steel door with Maglock and outside leading one to believe it was staff quarters. However it is actually capable of seating a customers in comfort with it's own toilets etc. There was no additional fire escape and the one access/egress did not have an illuminated fire exit sign, this was in a room containing several the etc. There is also a large smoke extractor fitted that vents to the rear of the building.
