In relation to Condition 5, I have spoken to the Licensing Authority and they do not appear to have plans for the premises. **Could your client provide plans of the premises including the current window display layout and the condition wording to refer to that reference of that plan.**

It is disappointing to read that your client will not agree condition 15. What Police request is reasonable considering the increase in operating hours when the late night economy must be a major consideration in the operation of the premises. The Safe Bet Alliance is a collaborative initiative whose members include Association of British Bookmakers and recommends a risk assessment for lone workers and evidence to show lone working at a particular time of day is safe. **Police have not been furnished with a risk assessment with this application.**

Please see the attached document that contains crimes recorded by Police (CRIS) intelligence information (Crimint), phone calls made to Police 999 system (CAD) and Custody records (arrests) to Betting Shops in High Road Wembley only, from 1800 hours daily for the previous two years. (This is the period of time since applications were granted for trading outside the 'ordinary' daily hours)
