Annexe 1 - Mandatory Conditions

- (a) No supply of alcohol may be made at a time when no designated premises supervisor has been specified in the licence or at a time when the designated premises supervisor does not hold a personal licence or his or her licence has been suspended.
- (b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- (c) All persons present on the premises who are required to carry out a security activity must be licensed by the Security Industry Authority.

Admission of children must be restricted according to film classification.

- (d) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (e) The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- (f) The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- (g) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (h) The responsible person shall ensure that-

- (i) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
- beer or cider: half pint;
- gin, rum, vodka or whisky: 25ml or 35ml; and
- still wine in a glass: 125ml; and
- (ii) customers are made aware of the availability of these measures.

Annexe 2 - Conditions Consistent With the Operating Schedule

- 1 CCTV shall be installed at locations agreed with the police and maintained in a working condition.
- 2 All CCTV recordings shall be kept for 31 days and shall be made available to police and licensing officers if requested.
- 3 If the CCTV becomes inoperative, or is not installed to the satisfaction of the Police and Licensing Authority, they shall be contacted at the earliest opportunity by email or telephone to enable agreement to be reached as to what licensable activities can take place.
- 4 Notices shall be displayed at the entrance and in prominent positions throughout the premises advising that CCTV is in operation.
- 5 Door supervisors of a sufficient number and gender mix, shall be employed on any day when a club function is held and they shall be in attendance one hour before the function commences and the start times shall be notified to the Police and Licensing Authority 14 days prior to the event date.
- 6 All persons entering, or re-entering, including staff and performers, shall be required to pass through a search arch and wand search on days when there is a public or private event.
- 7 A hand held and/or 'head cam' camera system should be operated at the premises in accordance with the Police Clubs and Vice Unit's 'Recommendations for the Use of Hand Held Cameras Within Licensed Premises' document.
- 8 A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.
- 9 Door supervisors as part of their duties shall ensure that customers when queuing for entry, or leaving, do so in a manner that does not cause a nuisance.
- 10 The licensee shall keep an incident book which shall be made available to the Police and Licensing Authority.
- 11 Customers shall not be permitted to take open glass containers outside the premises as LBB Premises Licence 210131 Page 8

- defined on the plan submitted to and approved by the Licensing Authority.
- 12 There shall be a minimum of 2 door supervisors on any day when the premises are open for the sale of alcohol past midnight to control the entrance to the premises and to control order within the premises.
- 13 There shall be at least one door supervisor for every 50 customers or part thereof.
- 14 A copy of the premises licence summary including the hours which licensable activities are permitted shall be clearly displayed and visible from on a notice board to be affixed to the ground floor left hand wall located immediately to the left of the entrance area.
- 15 The total number of people permitted on the premises including staff and performers shall not exceed 200.
- 16 Where Police or Licensing officers require admittance to the premises in an emergency or as part of an impromptu visit they shall not be impeded by requiring to be signed in or searched.
- 17 Substantial food and non-intoxicating beverages including a free supply of drinking water shall be made available to customers during the whole of the licensed hours in all parts of the premises where intoxicants are provided.
- 18 Toilets shall be checked at regular intervals for the use of drugs and other illegal activities.
- 19 There shall be a minimum of one hour between the termination of general activities and the commencement of a 'Club Dance' and this sterile period shall be used to ensure the premises searched.
- 20 Photographic proof of age shall be required from all persons appearing to be under the age of 21
- 21 When prior notice has been given the licensee shall allow free and unimpeded access to police officers with drug sampling equipment and/or 'sniffer' dogs, to test customers prior to entry, for drug use and possession.
- 22. The premises may be subject to surveys from the Metropolitan Police Clubs and Vice Unit re the suitability of club events, and matters arising from the surveys shall be incorporated into the operating schedule as agreed.
- 23 All doors and windows shall remain closed during any licensable activity and where a door is used for patrons to enter or leave the premises the door shall be fitted with a self-closing device.
- 24 All speakers shall be mounted on anti-vibration mountings to prevent transmission of sound energy to adjoining properties.
- 25 No noise or vibration shall be detectable at any neighbouring noise sensitive premises.
- 26 All entertainments shall use the in-house amplification system and a noise limiter set at a level agreed by Brent Council's Licensing Unit shall be used at all times.
- 27 Notices asking customers to leave quietly shall be conspicuously displayed at all exits.

- 28 The licensee or his/her deputy shall be a member of, and actively participate in the local Pubwatch scheme.
- 29 Arrangements shall be made with a local licensed taxi/minicab company to ensure sufficient transport is available to take patrons home after a late night event.
- 30 No person under the age of 18 shall be permitted on the premises after 22:00 hours unless it is for an event specially arranged for young persons and prior notice has been given to the Licensing Authority.
- 31 The locks and flush latches on the exit doors shall be unlocked and kept free from fastenings other than push bars and pads whilst the public are on the premises.
- 32 The socket outlets (or other power supplies used for DJ equipment, band equipment and other portable equipment) that are accessible to performers, staff or the public shall be suitably protected by a residual current device (RCD having a rated residual operating current not exceeding 30 milliamps).
