Also broken glass bottles which makes it a danger for people walking in the pavement this is a common factor every weekend.

I am a disabled person who suffers from various illnesses and insomnia is one of them where trying to sleep is a big issue.

Am also frightened to leave the flat at weekends and evening as there are crowds hanging around our main entrance drunk and acting in a bad manner.

I strongly request for this matter to be taken serious and some action to be taken.

Otherwise living in this flat will very difficult for me to live. I have also experienced damage to my car and peaches staff knocking at my door so therefore I would appreciate if you could not disclose any of my details I would appreciate it as I do not want any problems as I am scared for myself.

We are facing many problems in night time specially on Friday and Saturday. When we are sleeping around 2 o'clock people screaming and shouting Then we suddenly wake up when we look outside of the window we can see the drunk people fighting and shouting out side the peaches bar because of that me and my family can't sleep all night as my wife is 7 month pregnant this is affecting her health.

From the bedroom which is facing shisha lounge there is lots of loud music coming from the shisha lounge and lots of smoke and smell is coming into in my bedroom and it's not good for our health.

When there is any sports or match going on people are screaming, shouting and cheering in support of their team from the shisha lounge. Some time the condition is out of control we don't know what to do and we also get scared.

We try not to go out on Friday and Saturday night because of few bad experience like one day me and my wife came back home after dinner few drunk people from peaches blocked my door and did not allow us to get in and I felt scared then suddenly I seen my two friends come towards me then I felt better and told the drunk people to move out of my way.

I understand police asking for review of peaches bar so I would like to make representation to support police and to close down peaches bar by 11 or 12 o'clock.

We already have been complaining several times with regards to the smoke and noise from the Shisha Lounge which has been coming to my flat on a regular basis until 3 and 4 in the morning. Now the shisha lounge closes at 12 midnight but still it's irritating due to the smoke and noise which is still coming from shisha lounge.

The noise also includes loud shouting and screaming and noise of laughter from customers as they leave the bar. We would also request you to ensure that peaches is shut by 12 midnight especially on Fridays and Saturdays.

I have come to London for my further education which is being severally damaged due to the intolerable noise from Peaches and smoke from shisha lounge.

Also the type of music they play at high volume on weekends and the dj's constant announcement on the microphone are very disturbing. Due to the type of music and high bass it creates a vibration.

We also fear for our safety as there are constant fights at the Peaches premises. We are also scared of going out of the flat in the evenings on Fridays and Saturdays as the result of all the above.

Furthermore, as a result of all the above mentioned our sleep is being disturbed and this has had a negative effect on our health and even studies.

This problem has been faced by many people in our building and all of us have complained on several occasions but no action has yet been taken.

We would therefore request the Peaches to be shut by 12 midnight everyday.

We have even found that the bins which has been allocated to us for our residential use are constantly blocked by peaches cars. This is preventing us disposing of our waste on weekends especially.

Finally we sincerely hope that you will take notice of our complaints this time and ensure that the Shisha Bar is shut down and Peaches Restaurant is closed each day by 12 midnight.

For these reasons we support the police review of peaches premises licence and make a presentation in this respect and hope you will give this matter serious consideration.

We request you not to disclose our details as we live immediately above the peaches bar and we fear of being disturb by the owners of the peaches and their staff.

I am a tenant in [REDACTED] Kenton, HA3 0AW.

I have been constantly complaining to the landlord and their managing agent regarding the noise pollution from the Peaches Bar & Restaurant, which is based in front of our building (177-179 Kenton Road, Harrow). I have been asked by the managing agent to file a complaint to your department. We are facing constant nuisance from the goers of the Peaches Bar & Restaurant, in terms of noise and disturbance to us, and the immediate area.

There are constant fights, and on some occasions even police appearances, on Friday and Saturday nights, which cause a great deal of hassle to us. We have trouble sleeping due to drunkards who enter into our car park and cause noise. The customers of the Bar leave at roughly 3-4 am every Friday and Saturday which adds to our troubles, due to their cars constantly starting and revving. They show no care or respect for us residents. Following their activities from the Bar, the screaming and shouting adds to the commotion as they proceed to the scores of cabs which wait directly in front of the building. It takes us a very long time on the weekend to fall asleep due to this.

The constant noise is ear-ache to us, and we feel that immediate action must be taken to put a definite end to these troubles.

Due to the above complaints which we have made previously, and no action has been taken since, I would like to make a representation in support of the police review of Peaches' Premise licence.

RE: Peaches Bar and Shisha Lounge/ Police Review of Premises Licence

I write to express concern due to the disturbances caused by customers of Peaches Bar in our neighbourhood. This concern extends to concerns over safety.

Previously, I had noticed marked improvements in the area after the closure of the Shisha Lounge as the noise levels and disturbances into the early hours of the morning had reduced due to the action from the police, but things are back to normal now. I am writing to confirm my support for the Police Review of Peaches premises Licence.

My concerns about the following are now back:

- Noise in the early hours of the morning caused by general rowdiness of patron of Peaches Bar and Shisha Lounge. The car park shared by the Peaches Bar and Shisha Lounge with residents of Evergreen Court further contributes to the noise when patrons leave, playing loud music and driving aggressively;
- Patrons using car park often leave their rubbish behind and generally leave the car park in an untidy manner
- Cars are parked in front of the residential rubbish bins blocking accesses to these; and
- Patrons, often under the influence of alcohol, using the private gardens at Evergreen Court, often urinating and vomiting in the compound.

Apart from the disturbances that frustrate me and result in noise at night, we as residents feel a very real threat to the security of our lives and properties.

The above problems have started all over again as a consequence of the Shisha Lounge being allowed to open again and Peaches Bar continuing its late hours of operation on Friday's and Saturday's.

I therefore feel that the Shisha Lounge should be shut down and the opening hours of Peaches bar should be reduced. This can benefit this otherwise peaceful residential community even more positively. I am therefore proposing at the very least, a much earlier closing time for Peaches Bar which will ensure that the patrons causing this disturbance, will leave the area in a timely manner, hence reducing our noise and security concerns. Your urgent and serious attention to address the concerns affecting our neighbourhood will be highly appreciated.
