**Notice 3 review of Peaches license brought by Metropolitan Police to restrict their opening hours**

We have been suffering from noise and nuisance for many years and we feel that this cannot continue. Below are some of the issues we have with Peaches nightclub.

**Crime and Disorder**

Over the years we have seen a number of crimes in the street from breaking into a vehicle and letting the handbrake off allowing the car to run into Kenton Road, to having gang fighting in the street. Sometimes the fighting appears to be racially driven with white and Asian gangs of young men running up and down the road in the middle of the night; often with drunken girlfriends screaming in the background. At weekends we have been woken up with shouting and fighting with bottles being broken and used as weapons. Our daily lives have been affected with the levels of crime in our area most weekends (as well as Bank Holidays at Christmas, Easter and summertime.) Beside number 2 Draycott Ave is an alleyway and often young people are gathering there and have been seen to sell drugs. This disorder is having a detrimental effect on our health with lack of sleep affecting ailments such as epilepsy to those who have disabilities on this part of the street.
