## SURVEILLANCE REPORT

## Remarks & Relevant Information:

01 - 2300

Further to instructions, our operatives set up surveillance outside Peaches, 177-179 Kenton Road, Harrow.

At this time, there is a small queue of approximately 12 customers. Doormen admit the customers. Music can be heard from within Peaches though is drowned out by passing traffic. Doors are kept closed.

02 - 2310

Our operative enters Peaches and is asked to show Identification which is closely looked at and scanned and is then admitted.

Music is loud inside with hip-hop and R&B being played. The music has a heavy bass line. Our operative does not hear any speaking on the microphone tonight.

Our operative observes no direct sales of spirits in bottles however drinks are being sold in pint glasses, and spirits look to be poured into glasses for example vodka and coke will be served in a small glass. Beer is observed being sold in bottles.

Our operative is sold a pint of beer in a glass.

Note: The bar is extremely busy at this time. Our operative is being monitored by a manager and a doorman. He pays in cash - £3.60 - and despite requesting a receipt, the barmaid does not provide one and continues serving other customers.

Our operative was not asked for identification at the bar. However, this is done on entry to the bar. There appears to be a 'no identification, no entry' policy in place.

Several doorman are seen within Peaches.

Our operative exits into the beer garden he is allowed to exit with a pint glass containing beer.

Shisha tent is closed and there is no longer any Shisha being sold from the premises. The television which was once on outside is no longer there.

At approximately 2330hrs, our operative is informed by a member of staff, possibly a manager, that no drinks are permitted into the beer

garden and that he will have to return inside. The same person is observed briefing a doorman to make sure there are no more then 15 people at a time outside and strictly no drink past 2330hrs

On exiting peaches our operative is told that there is no re-admittance

Having been furnished with the keys to Flat 4, 177-179 Kenton Road, Harrow to ascertain if there is any nuisance caused to the tenants from Peaches Bar below, we report as follows:

Our operative gains entry to flat 4 which is situated directly above Peaches. The address looks out over the smoking area of the bar.

Music is heard inside the flat; the beat and the bassline of the music in particular is heard.

Voices of males and females from the smoking area are also clearly heard speaking loudly; on one occasion, someone is shouting.

A female customer is observed in the smoking area drinking what appears to be alcohol.

The general atmosphere in the smoking area appears friendly - no incidents are observed whilst our operative is in the flat.

At no point throughout the night does our operative observe more then 15 customers in the beer garden at any 1 time.

Our operative exits from flat 4 and takes up a last position from a vehicle in Carlton Avenue, opposite Peaches.

At this time a small group of approximately 10 male and female customers are standing directly outside Peaches. The doormen look to be refusing entry inside.

- 05 0121 Intoxicated males and females are observed loitering around outside the front of peaches and making moderate noise.
- 06 0125 Doorman are now outside wearing high visibility jackets controlling people in the area.
- 07 0130 Peaches is very rarely free of people loitering outside. Many of them are speaking loudly and some clearly intoxicated.

Customers are observed gradually leaving Peaches. Some of whom are heard shouting.

- 08 0200 More doormen are now observed standing in the street outside Peaches. They are wearing high visibility jackets to control customers exiting and asking customers to move on faster.
- Two doormen approach our operative having recognised him within Peaches. They tell our operative that his vehicle registration will be taken down and reported to the police and that they will be keeping a close eye on his future movements in case he is drug dealing or up to any other illegal activities.

Accordingly, our operative briefly exits the immediate area.

- Peaches appears to be closed. Customers are exiting into the street. At this time, lots of noise is heard with many customers hanging around outside. Doormen are observed outside in high visibility jackets, moving customers on.
- Doormen continue moving customers on from outside Peaches. They slowly walk customers along the street until they disperse. At this time, all customers have been moved on from the immediate vicinity of peaches.
- 12 0253 Some customers have now been moved on as far as Draycott Avenue.

  Doormen stay in the vicinity. However, the doormen are observed paying attention to our operative.

Final customers are dispersed and the doormen return into Peaches. Only two doormen are now outside.

13 - 0310 Note: Doormen are becoming increasingly suspicious as to our operative's attendance in the vicinity of Peaches.

Peaches now appears closed. Two doormen remain monitoring the front door though are paying particular attention to our operative. Other staff remain inside.

Our operative ends surveillance.
