Allow me to underline the representation.

I consider removal of the Condition will be detrimental to the licensing objective of promoting the prevention of public nuisance. It is the additional wider use of the external area by patrons at noise sensitive times which also includes regulated entertainment that gives rise to our concern. Furthermore the external area has been the subject of complaints alleging noise disturbance from shouting, screaming, fighting. This noise (and smoke) has allegedly prevented residents from opening the window of their accommodation.

I have taken receipt of this application.

You are already aware of my response for the Minor Variation which seeks to replace Condition 25.

This application is to remove Condition 24: "No shisha to be served after 00.00hrs. Mon-Sun".

I do acknowledge that shisha smoking is not a licensable activity. However, this Condition has at some time been placed on the Premises Licence either by application or by a Licensing Committee and the purpose of that would be to promote the licensing objective of promoting the prevention of public nuisance. As I have already pointed out, the proximity of residential accommodation is very close to this area. Because of this fact, in my recent discussions with the business proprietor about his operations I have explicitly stated that a time control on the shisha activity is the best form of noise control.

Consequently the Nuisance Control Team make representation against the application to remove the Condition.

I have not had any discussion with Mr Pritchett about this particular application and I understand he is out of the office until tomorrow. I should advise that I am in the office tomorrow day time and then I will be on leave until 24<sup>th</sup> Feb. I have copied Jennifer into this response.

In noting the other legislative provisions Mr Pritchett raises in his application I cannot help but wonder, as an aside, whether the shisha set up at this premises is compliant in respect of smoke free requirements in the Health Act 2006. I have not been able to speak to anyone in Consumer & Business Protection about this today.

Please let me know if I can be of any further assistance today, tomorrow or upon my return to work.
