
This patient was an A&E referral. I saw this 27 year old gentleman today in clinic who sustained an injury to his nose on the 29<sup>th</sup> March of this year. He was alleged assaulted by a group of people in a pub, he was seen in the A&E department and then referred to the ENT clinic. He complains of pain and difficulty in breathing and deformity of the nose.

On clinical examination there was obvious deformity of the nose and the nasal septum is deviated to the left side. Nasal airways are compromised. Since the injury is already 4 weeks old the realistic outcome of the procedure has been explained. I have placed him on the waiting list for MUA of nose fracture under general anaesthesia.





I am a Police Constable of 24 years experience, the last 18 years I have worked on the London Borough of Brent. Since 2005 I have been attached to the Licensing unit for the borough. I have been authorised via a delegated authority to represent the Borough Commander for the London Borough of Brent and for the Commissioner of the Metropolitan Police Service to act on licensing matters.

One of the roles I conduct as a responsible authority is supervising licensed premises, that they conduct their business in accordance with the four licensing objectives of the Licensing Act 2003. One of the premises I supervise is Masters Bar 217 Kenton Rd Harrow. An allegation of assault was made to Police occurring at that premise on 29th March 2014. I then began making enquiries in to the conduct of the premises. As the CCTV within the premises was not recording correctly on 29th March 2014, I had to source other means to assist my investigation. There are no local authority CCTV cameras located outside Masters. On 16th April 2014 I attended Peaches Bar 177-179 Kenton Road Harrow. I established from viewing CCTV footage at Peaches Bar that the victim of the assault entered Peaches at 0054 hours and left there at 0152 hours. I then followed a CCTV trail and the victim went to Kenton Kebab 130 Kenton Road. On 15th April 2014 I watched the CCTV footage from The California Chicken Shop 180 Kenton Road (opposite Masters). At 0224 hours something significant occurs in the street near Masters generating the attention of the customers. All the customers within the Chicken Shop run to the window and curiously looking outside, fingers begin pointing towards forward outside the shop towards the direction of Masters. I was unable to see the front of Masters through the window of the shop, however I could see a small amount of the pavement and the road outside, and I could make out several dark silhouettes of people. The customers in the Chicken shop continue to watch out of the main window for about 3 minutes and then return to eating and ordering food. The silhouettes disappear. There was nothing else of relevance on any of the CCTV footage I viewed.
