I have spoken to the victim and he said that he was with his friend at the rears of the pub having a drink and a cigarette along with his friend. Suddenly a male aproached in his mid 20's IC1, medium build and was wearing whit tshirt, was on his way to enter the pub from the rear entrance, where he brussed his shoulder against viw1 friend and approached the male and told him: 'thats not a way to threat a man'.
