The Green Man is failing to promote all four of the licensing objectives, namely the protection of children from harm, Prevention of crime and disorder, The prevention of public nuisance, and Public Safety. Police have no faith in the ability of the management to operate the premises responsibly and therefore wish to bring the matter before the sub-committee for consideration.

This venue is situated in the middle of a residential area, and backs on to a Primary School, (Kingsbury Green Primary School) it is positioned on the junction of Slough Lane, and Old Kenton Lane. The premises licence holder (PLH) is a Limited company by the name of Mary - Le - Bone Enterprise Limited, this company has held a licence for this premises since 15/02/2007, in that time they have had two designated premises supervisor (DPS) the first one being a Mr Nicolaas Francois Le Roux, and the Current (DPS) is Miss Stela Mantonyte, who took over in August 2013. Since Mary - Le - Bone Enterprise Limited took over there has been a series of incidents which have occurred within the premises and directly outside resulting in police attendance. The premises has no working CCTV, and they do not employ any Door Supervisors, due to the lay-out of the premises staff are unable to see what is happening in certain parts of the pub, and evidence of offences is being lost due to the lack of CCTV. The owners have not invested in any type of security, be it CCTV or Door Supervisors, and seem oblivious to the fact that serious violence is happening within the venue, and they appear to be unhelpful to any investigation that police attempt to instigate.

Most recently on the 21/06/2015 a large disturbance occurred inside the venue where approx ten Travellers started fighting and smashing up the pub after an argument broke out between them, one of the males smashed pint glasses and broke pool cues in half before threatening people with them. The estimated damage caused was £150.00 This incident then continued outside where one of the Traveller males forced his way into a passing vehicle and demanded to be driven away from the scene, when the driver refused he was assaulted by being punched in the face several times by the male who then fled the location before police arrived. Officers from Brent Licensing team visited the venue on the 25/06/2015 and spoke to the DPS Miss Mantonyte, she showed no interest in speaking to officers and stated that she was just waiting to find a new job so she could leave. Officers eventually spoke to Miss Samantha VALIUSKAITE who informed us that she was the girlfriend of the

owner a Mr Barry BURKE, however she was unsure if his first name was Barry or John, when asked what her role was within the pub she seemed unsure and very hesitant at first saying she was like a manager but had no formal role.

She was asked if the owner of the premises Mr BURKE was aware of the incident, again she was unsure and stated that she thinks he is aware but he hasn't been at the pub much recently.

I have tried calling Mr BURKE several times and have left messages for him to contact me, to date 08/07/2015 he has not returned my calls .

On the 14/11/2014 there was a large fight at the pub between a group of females, on police arrival they were informed by the staff that no incident had happened inside the venue and the fight had happened outside, the manager stated that there was no CCTV outside the venue but CCTV covering the inside of the pub.

When officers spoke to the victim at her home address, she stated that the fight had initially started inside the pub and the manager had taken her and another person into the rear of the premises, it's a short time later when they left the rear of the pub they were attacked again outside, numerous attempts were made to get the CCTV from the pub, which eventually turned out the pubs internal CCTV was not work.

On the 07/08/2014 police reported a crime at the venue where a regular customer to the pub, smashed numerous pint glasses and was threatening other drinkers, officer tried three times to conduct an investigation, but were unable to due to the lack of assistance from the pub staff..

On the 27/05/2013 police were called to the venue to two males fighting, on arrival police found an unconscious male who had allegedly been hit in the head and chest with a hammer.

On the 21st /09/2013 at around 00.00 hours police attended the Green Man in SLOUGH LANE were a customer stated he was going to kill a barmaid, staff called police and once he left they cancelled police, there were no security on the duty.

On the 27/03/2012 a male is seen standing inside the pubs smoking shelter smoking a cannabis joint, he is stopped and searched and issued with a cannabis warning.

On the 27/01/2012 officers observed a male sitting outside the pub in the smoking area conducting what they believe to be a drug deal, as the suspect was seen retrieving an item from behind a shrub next to the pub wall and then placing it inside the pubs window box, a search of the window box found a wrap of cannabis and behind the shrub they found eleven Wraps of cannabis. Whilst dealing with the male, they saw a message on his phone which indicated that he was dealing drugs, the manager was informed of what had happened and Stated that he would secure the area to prevent any further incidents.

On the 17/09/2010 police spoke to two females that had been drinking in the pub, they stated that after three drinks they became unwell and one became unconscious, they were taken to hospital when they noticed that the victims handbag had been stolen from the pub, again there was no CCTV covering the area of the theft.

25/09/2010 Police Licensing officers conducted a visit at the premises at 01.50 hours they found 10 people inside all consuming alcoholic drinks. Two males at the bar sleeping, with pints of lager in front of them on the bar, one of which had been recently poured, as it was still cold there was No DPS present, Barmaid STELA MARIJA MATONYTE was in charge. She states that the DPS NICHOLAS LAROUX had only just gone to bed at 1pm. Officers asked her why there were people still drinking, she replied that she had not served a drink since one o'clock but they were just finishing their drinks. I pointed out that there was no drinking up time any more and that there was no drinking up period incorporated in the licence. She stated that she had never heard that before and that it was common practice to allow them to drink up till 2am when they all left.

Licensing Officers visited the premises on the 11/9/10 at 0130hrs.they spoke to manager Stela Marija MATONYTE who was standing in the doorway apparently closing up although she was showing little effort to get rid of the approx 12 inebriated and loud drinkers in the smoking shelter and front garden, all in possession of a glass drinking vessel and most still plenty in them. They were laughing/talking loudly to each other and if left would quiet happily have stayed for some time. Stela was advised to collect the glasses and encourage them to go quietly.

On the 11/05/2009 in the beer garden at the front of THE GREEN MAN public house OLD KENTON LANE KINGSBURY a male was seen rolling cannabis into a cigarette whilst on a bench in the beer garden he stated he bought the cannabis from someone outside the pub shortly before.

Licensing Officers attended the pub on the 23/11/07 at 2335 hrs. There was approx fifteen people standing at the entrance of the pub. They were smoking and consuming alcohol from glasses that were either in their hands or on picnic style tables at the side of the entrance. The group was mainly males; they were very jovial and loud. There was vomit in the entrance. Officers went in to the premises. There was approx 20 customers and a male guitarist

providing entertainment? They spoke to a female member of bar staff who spoke limited English, asking to speak to the DPS. She then called for a male who gave his details as Nicholas Le Roux 30/12/1980 and resides in accommodation above the Pub. He was neither the DPS or a personal licence holder but the person who had been left in charge. He was advised about people drinking and smoking out the front of the premises.

On the 16/11/2007 police called to the location - Child neglect. - Female takes her 6yr old daughter to the pub after picking her up from school. At 2200hrs police attend with LAS after subject falls over because she is so drunk. Female arrested, daughter conveyed into custody of grandmother, child handed over to grandmother. Licensing officers met with the owner Mr John Burke on the 27/11/2010 and asked for an Explanation of the incident with the child in the premises on 16/11/07. John said his policy is no Children in the pub after 1800hrs, but somehow the female had sneaked the child inside. Officers explained that this was not acceptable and staff should be aware of all customers in The premises and their behaviour.

Below are complaints to Brent Council regarding Noise Nuisance to the Council.

18/03/2009 Premises Licence - Complaint 480934 Noise – Loud Music

03/03/2009 Premises Licence - Complaint 477823 Noise

10/10/2008 Premises Licence - Complaint 435827 Going beyond licensing hours for music and dance

19/07/2007 Premises Licence - Complaint 284008 Noise – Loud Music.

The above highlights a clear mismanagement of the premises, and the lack of responsibility taken by the DPS and owners to put in place a safe environment for patrons and staff.

The above evidence shows the lack of control over patrons and the disorder they cause, along with noise nuisance, and Anti-Social Behaviour caused to local residents, the DPS has failed to show any regard towards local residents.

These types of incidents as highlighted above draw police officers away from other calls, putting the public at risk of harm, and the ongoing nuisance that the arrival of several police vehicles, police sirens, then the subsequent dispersal of large groups cause to local residents.

It is my opinion that it would be detrimental to the licensing objectives if Miss MATONYTE is allowed to continue running this operation in such a way. Police request that the current DPS Miss MATONYTE be removed and a new DPS appointed in her place.

To further reduce the risk to the licensing objectives and to assist the new DPS in upholding these objectives, in particular crime, disorder and to prevent public nuisance within such a densely populated residential area, police request the following conditions be put on the licence.

1. A minimum of three door supervisors of a suitable gender mix, shall be employed from 19.00 hours on any day when the premises are open for the sale of alcohol past 23.30 hours
2. Door supervisors shall wear clothing that can be clearly and easily identified on CCTV.
3. A register/log containing the names, badge number, dates & times of duty of security staff and any incidents that occur shall be kept and made available to the Police and Licensing Authority.
4. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to Police and authorised Officers from Brent Council.
5. CCTV camera shall be installed to cover all entrances of the premises and further cameras Installed to cover the entire bar area and the outside seating areas of the Premises.
6. A "Challenge 25" policy shall be adopted and adhered to.
7. A refusal book detailing date and time of the refused sale and the name of the person refusing the sale shall be kept and maintained and made available for inspection.

8. Notices explaining the licensee's policy on admission and searching shall be placed at each entrance.
9. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:
 - (a) all crimes reported to the venue
 - (b) all ejections of patrons
 - (c) any complaints received
 - (d) any incidents of disorder
 - (e) all seizures of drugs or offensive weapons
 - (f) any faults in the CCTV system.
 - (g) any refusal of the sale of alcohol
 - (h) Any visit by a relevant authority or emergency service.
10. The outside drinking areas shall cease at 22.00 hours.
11. Patrons permitted to temporarily leave and then re-enter the premises, e.g. to smoke, shall be limited to 2 persons at any one time after 22.00 hours.
12. Notices requesting customers to leave quietly shall be displayed at each exit.
13. No children shall be permitted on the premises after 18.00 hours.
14. Notices clearly explaining the licensee's drugs policy shall be displayed at the entrance, in all toilets and at suitable places throughout the premises.

This list is not exhaustive.

Police feel these requests are in keeping with the license holder's human rights and promote the running of his business and livelihood. These conditions are wholly reasonable, proportionate and appropriate measures to be put in place to promote the licensing objectives.

Police reserve the right to give evidence on any further incidents which may take place at, or in the vicinity of the premises, between the service of this application and the hearing and/or during the time allowed for any appeal proceedings.

CAD10282 Duty Officer Handover – Wembley: 16/11/2007 -. Child neglect.

Subject ***** 35yrs takes her 6yr old daughter to the pub after picking her up from school. At 2200hrs police attend with LAS after subject falls over because she is so drunk. QD1 attends. Subject arrested, daughter conveyed into custody of grandmother. SCD5 aware. – This was at the Green Man, Slough Lane, NW9, child handed over to grandmother – CAIT informed

Visit PS 10QK & PC 157QK attended 2335 hrs 23/11/07. Two transparent plastic smoking shelters at both side of the premises but there was no one using them, instead there was approx fifteen persons standing at the entrance of the pub. They were smoking and consuming alcohol from glasses that were either in their hands or on picnic style tables at the side of the entrance. The group was mainly male; they were very jovial and loud. There was vomit in the entrance. Officers went in to the premises and in to the bar on the left. There were approx 20 customers and a male guitarist providing entertainment? I spoke to a female member of bar staff who spoke limited English, asking to speak to the DPS. She then called for a male who gave his details as Nicholas Le Roux 30/12/1980 and resides in accommodation above the Pub. He was neither the DPS nor a personal licence holder but the person who had been left in charge. He thought the DPS was either Sean Burke or Martin Deneen. It became apparent that in the bar to the right of the main entrance was a 30th birthday party, some of these customers were definitely worse for wear. Nicholas was told that the smokers should use the shelters and not take drinks outside with them. They should not be encouraged to remain outside for long periods of time and respect the local neighbours. He was advised to supervise the sale of alcohol more closely. Message left for DPS to contact QD.

A Mr John Burke left a message at QD today; I phoned him back and left a message with Nicholas asking John to confirm a meeting with himself at QD on 27/11/07

Meeting At 1400hrs on 27/11/07 Mr John Joseph Burke attended QD. I spoke to him about what I witnessed at the Green Man Slough Lane, NW9 on 23/11/07. It became apparent that he was not only the owner of the premises but also now the DPS. Advised to apply to vary. He showed me his personal licence issued by Westminster 05/05896/lipers. He decided the picnic tables at the side of the main entrance will be removed, and customers will only be allowed to leave the small side doors which lead towards the smoking shelters. He will make sure his staff are more authoritative and vigilant with the smokers and the vessels leaving the premises after 2300hrs. He said that his manager Nicholas has passed his personal licence exam and he is waiting for the application to be processed. John informed me that the ground floor restaurant area at the rear is going to be knocked down after Christmas, it is no longer financially viable to have it on the remainder of the building.

I asked for an explanation of the incident with the child in the premises on 16/11/07 (above). John said his policy is no children in the pub after 1800hrs, but somehow the female had sneaked the child inside. I explained that this was not acceptable and staff should be aware of all customers in the premises and their behaviour. I asked if staff received training and he said every Sunday morning they have a staff meeting. I asked him to make staff aware of our meeting and explain Police requirements. John left QD heading for Brent Hse to vary the DPS.

Crimint L00407159/2007 THE GREENMAN PUBLIC HOUSE in SLOUGH LANE KINGSBURY NW9 was the venue of a disturbance to which it was necessary for the landlord to call police. It was reported that the landlord had asked a customer to leave as he was drunk. The customer refused, and a struggle ensued. Another relative of the first male joined in and the landlord and two customers received injuries. Both suspects left but one was arrested later. Incident fully reported on cris.

Attended venue 2300hrs 20/7/07. There was a small green and white striped marquee on the grass outside the front of the building. Inside the marquee were picnic style bench tables with ashtrays and several people inside smoking. The marquee had a roof and four full sides with a small doorway opening. It was an inappropriate structure to be used as a smoking area, it was more than 50% enclosed. I spoke to the DPS and explained my concerns, he said an Eastern European male had put it up earlier in the day, his English was not very good and not only had he put the sides on (which he was not instructed to do) but he put it in the wrong place, it should be to the side of the premises. As I was standing talking to the manager several customers came out and stood to the side of the entrance doors to have a cigarette, they had brought their drinks out with them and a table had been put to the side of the door with an ashtray inviting customers to put their drinks there. The longer these customers remained outside the more the noise levels grew emanating towards the residential area. I advised the DPS not to allow this as it is going to cause problems with local residents. He said he has already received some complaints about noise. DPS agreed to remove the table and he is going to get a member of staff on the door late on an evening to prevent customers from taking their drinks outside. Council officers were with me and will be informing planning of the marquee.

Crimint : QKRT 368501. On 11/05/2009 in the beer garden at the front of THE GREEN MAN public house OLD KENTON LANE KINGSBURY Mr ***** was seen rolling cannabis into a cigarette whilst on a bench in the beer garden ***** stated he bought the cannabis from someone outside the pub shortly before but obviously would not provide a name. Strongly suspected someone in the pub is dealing cannabis as the bag seized was full and just been bought and there is evidence of cannabis misuse in the beer gardens outside the pub.

CRIS : 1911593/09 Poss Cannabis O/S, The Green Man Public House, OLD KENTON LANE, KINGSBURY SUSP1 seen by Police rolling items into a cigarette. On approach discovered the items were cannabis. SUSP1 admitted possession of cannabis for own personal use. Issued PND.

Visited 0130hrs 11/9/10. female manager Stela Marija MATONYTE standing in the doorway apparently closing up although she was showing little effort to get rid of the approx 12 inebriated and loud drinkers in the smoking shelter and front garden, all in possession of a glass drinking vessel and most still plenty in them. I can see how this would be a nuisance to local residents as they were laughing / talking loudly to each other and if left would quiet happily have stayed for some time. Advised Stela to collect the glasses and encourage them to go quietly. There appeared to be one other female member of staff with Stela, DPS on holiday. Message left for him to contact us upon his return apparently 12/9/10. No premises licence displayed.

Cris: 1924605/10 VIW was in the pub - states she only had 3 drinks but became unconscious. LAS were called - and her friend later realised that VIW1's handbag had gone. 17/09/2010

Visit 25/9/10 0150Hrs, Green Man, Slough Lane, Kingsbury, 10 people inside all consuming alcoholic drinks. Two males at the bar apparently sleeping, with pints of lager in front of them on the bar, one of which had been recently poured, it was still cold with a half inch head and CO2 bubbles, clear and copious. No DPS present, Barmaid STELA MARIJA MATONYTE in charge. She states that the DPS NICHOLAS LAROUX had only just gone to bed at 1pm. I asked her why there were people still drinking, she replied that she had not served a drink since one o'clock but they were just finishing their drinks. I pointed out that there was no drinking up time any more and that there was no drinking up period incorporated in the licence. She stated that she had never heard that before and that it was common practice to allow them to drink up till 2am when they all left. I doubt that she was going to close at 2am because they had full pints and the customer's reaction was quite abusive towards Esther Chan and myself when they were told to drink up and leave. It was apparent that they were used to staying till much later. One male had to be dragged away by his friends because he was being hostile towards us. Some of these people, certainly those sleeping, the hostile male and another male in a leather jacket nearest to us were clearly drunk. I explained to Ms MATONYTE the offences disclosed and asked her to get Mr Laroux to phone me first thing to arrange a meeting at Wembley Police station to discuss affairs at the premises asap

Crimint : QKRT410272. On Friday 27/01/2012 at 1440 PC 635QK Stanton was walking along OLD KENTON LANE, KINGSBURY towards SLOUGH LANE, KINGSBURY, when a IC1 male, a/a 20, in casual dress standing on SLOUGH LANE shouted towards the GREEN MAN PH "Safe" whereupon the subject ***** who was seated at the wooden table inside the Perspex shelter directly outside the GREEN MAN PH stood up and placed something behind a shrub located by the drainpipe on the pub wall. He then walked in front of the pub and placed an object from his pocket into the window box of the pub. He was stopped and returned where a wrap of cannabis was found in the window box where he had been seen to place an item. A bag of 11 wraps of cannabis were found behind the shrub where he had been seen to conceal an item when first seen by police. A black rucksack which he confirmed was his was placed on the wooden table. Beneath the bag was another partly open bag containing small amount of herbal cannabis. Inside the bag was found a Sony Erriccson mobile telephone which he stated was his and had been given him by a friend. Illuminated on the screen was a text which read "I just called a few mins ago let me know when u reload, I'm nearby so I'll come pick up a tenz". Local passing youths stated the Perspex shelter of the Green Man pub had been used by cannabis dealers for the past 2 weeks described as eastern European youths, all times of day.-1/2/12 Owner Shaun spoken to, he will attempt to secure this area out of hours so it cannot be used for dealing or anything else.

Cris:1908321/12 Poss Cannabis Suspect seen smoking cannabis joint, seized and cannabis warning issued 27/03/2012 1525 Suspect ***** was seen smoking a cannabis joint in the smoking shelter outside the Green Man P/H stopped and searched under Sec 23 Misuse of Drugs Act 1971, negative result. PC Stout found a cannabis joint in the suspects hand in possession of the suspect.

Cris: 1930539/12 Viw1 phone stolen by an unknown suspect by way of snatching it from the victim's left hand during an unrelated fight in a public house.25/11/2012

Cris: 1912086/13 Susp hit VIW with a hammer in the chest 27/05/2013 VIW1 had collapsed and was unconscious in the pub. On return there, VIW1 was breathing and conscious although unresponsive, lying on the floor by the bar. First Aid given on scene and a basic check of injuries, swelling and a bloody graze on VIW1 right hand side of his chest in the rib area. Checked VIW1 head as VIW2 & 3 said he had been hit in that area. No blood or swelling seen. LAS C121 arrived on scene and took over the treatment. VIW1 could not give an account what had happened other than he had been hit on the head and in the chest with a hammer. He stated that he did not know the male who had done this. VIW2&3 both stated to officers on arrival that VIW1 had been hit in the head with a hammer. However, upon further investigation, both said that they had not seen this happen.

Cris:1916114/13 VIW1 was assaulted by SUS1 ans SUS2 13/07/2013 2130 Possibly false allegation - 15/7/13

Cris:1919385/13 By suspect stealing bag from outside pub where victims was sitting 23/08/2013 2100 -27/8/13

E-Mail Hello Licensing On the 21st September 2013 at around 00.00 hours we attended the Green Man in SLOUGH LANE were a customer stated he was going to kill a bar maid they called police and once he left they cancelled police. QK1 wanted you to be aware of this as they had no security on the door.

Cris: 1919332/14 By suspect attending the venue where he causes a disturbance with customers breaks glasses and throws chairs around. 07/08/2014 1750 Skeleton report with little in it at the moment - 11/8/14

Cris: 1927582/14 Viw1 and 2 were assaulted by susps 1 and 2 14/11/2014 2030 Viw1 and 2 are partners. Susp1 and 2 are sisters. Dets read, this appears to have taken place outside.

Cris:1914378/15 Large pub fight occurred in the pub by a group of persons during which a number of pint glasses and equipment were broken in the process of the fight 21/06/2015 22:00:00

Cris:1914379/15 Susp1 has punched Viw1 in the face on at least 2 occasions, and poked him with a car key in the stomach 21/06/2015

Visit 25/06/2015 - DPS Miss Stela MANTONYTE working behind bar, she was not working when the recent incidents happened, she informed officers that she no longer wanted to be the DPS and was looking to leave. The manager /owner Mr Barry BURKE not present, but his partner Miss Samantha VALIUSKAITE was there and spoken too, she stated that the travellers started fighting and caused damage, but they did not want to pursue the matter she confirmed the pubs CCTV did not work and there were no plans to repair it, they do not employ door security but have been advised to consider having Security on over the weekend in case the offenders return, she went on to say that the travellers were all drunk, and when asked why they were still being served alcohol she changed her mind saying they wasn't drunk. Male customer in the pub standing at the bar chatting to a female. He was very drunk despite having a near full pint glass in front of him.

Visit 26/06/2015 - Visit at 2045 - Lots of drunks present inside, also six children under the age of five. They were with two females who were drinking alcohol with them. The PLH was again not present and no one appeared to know where he is! This is becoming a common theme with this premise. DPS was not present. Serving behind the bar was Mr. Brij Patel and Ms. Samantha Valiuskaite. Pub fairly busy. This premise is currently subject to a review application which is to be submitted by 368QK.
