QK STT officers arrive on scene following the first attending units transmitting that they are in a foot chase.

STT Officers see two QK units having already TOA'ed but chased and detained several males running from the Scene and reports over the radio a a knife possibly been used and discarded during the foot chase

On Arrival at the VENUE which is described as a very bust restaurant / bar. the venue is packed full of MOPS and Families dining and socialising.

As STT officers at the front of the venue there are approx 30 males out in the front car park. Numerous MOPS are telling the officers that part of the group that were fighting are inside by the bar and described as a black male and white female. SUS 1 and 2 for this report.

As officers enter the Venue they see SUS 1 and 2

standing by the bar. Both are in an agitated and excitable state. They are spoken to and both confirm they have been involved in an altercation with an Asian group who were also in the restaurant and that it all started over where SUS2 had parked his car in the front car park.

SUS2 was alleging that he was trying to pay for his food and a large Built Asian Male (SUS 3 on this CRIS) approached him and was rude to him about where he had abandoned his car because it was blocking in other vehicles. He states that a fight started. SUS1 was also talking and was complaining about a small eye injury she sustained in the fight. Officers could see a minor red graze under her left eye.

The restaurant was very busy and loud and both SUS 1 and 2 were shouting over each over so were asked to join officer out the rear of the restaurant so an account could be established.

Numerous other QK units began to arrive and speak to persons out the front. Whilst this was happening staff confirmed they could play back footage of the incident and led officers to the CCTV room behind the bar.

The CCTV is in colour and is described as good quality CCTV and has goo coverage of the inside and outside of the venue where this incident took place.

On viewing the Available footage as shown to officers by Staff at the location officers view the footage from 21.31 to 21.36 which is when the first QK unit arrives on scene.

SUS1 and 2 are standing by the Bar, they are approached by SUS3 who stands 3/4 feet from them. SUS3 appears to be remonstrating and after what appears to be a verbal altercation between SUS1/2/3 SUS 2

launches himself at SUS3 and a fight starts by the bar area. SUS1 is seen to be trying to fight SUS3 when others are holding SUS2 back. Eventually the security guard arrives and separates the group with the assistance of other MOP's at the venue. This doesn't last long and the incident then spills outside onto the front car park.

The footage from outside the venue shows SUS2 again trying to attack SUS3 and SUS1 also assisting him. The incident is lost to the right of the camera briefly and then a group of other males arrive and appear to be fighting against SUS3 and his crowd. Its unknown at this time how or why this 2nd fraction arrive at the scene and who if anyone called them. SUS2 did not have a mobile phone on him.

When this 2nd group of 5/6 males arrive who appear to be siding with SUS 1 and 2 a large fight breaks out in the front car park. This is where SUS4 is seen to become involved and go to the boot of a parked Dark coloured Astra? And remove a weapon where he is seen on CCTV to thrash out at other males. SUS 4 is also seen placing these items back into the boot after the fight and Police ID Sus from the footage and also recover 2 metal wheel cranks from the boot of the VEH and these are seized and exhibited. Exhibits to follow.

When QK officer first arrive on scene the 2nd group of 5/6 males are seen to sprint off up Honey pot lane. This is where police give chase and see one of this group discard something into a bush. Dog unit arrives and a knife is recovered and seized and exhibited.

The two males stopped after the foot chase are SUS's 5 and 6 on this report where the knife is
