To confirm, below are the agreed hours and conditions:

Hours for Supply of Alcohol

Monday to Saturday: 8:00hrs – 23:00hrs Sunday: 8:00hrs – 22:30hrs

The Licensing Authority require the following points to be included in the operating schedule or added as conditions on the premises licence:

1. CCTV shall be installed to Home Office Guidance standards and maintained in a good working condition and recordings shall be kept for 31 days and shall be made available to police and authorised Officers from Brent Council.

2. The CCTV system shall be capable of obtaining clear facial recognition images and a clear head and shoulder image of every person entering or leaving the premises.

3. A "Challenge 25" policy shall be adopted and adhered to at all times

4. A sign stating "No proof of age – No sale" shall be displayed at the point of sale.

5. An incident log shall be kept at the premises, and made available for inspection on request to an authorised officer of Brent Council or the Police, which will record the following:(a) any complaints received

- (b) any incidents
- (c) any faults in the CCTV system
- (d) any refusal of the sale of alcohol

(e) any visit by a relevant authority or emergency service.

6. A copy of the premises licence summary including the hours which licensable activities are permitted shall be visible from the outside of each entrance to the premises.

7. Any staff directly involved in selling alcohol for retail to consumers, staff who provide training including managers shall undergo regular training of the Licensing Act 2003 legislation. The training shall be documented and signed off by the DPS and the member of staff receiving the training. This training log shall be kept on the premises and made available for inspection by police and relevant authorities upon request.

8. No high strength beers, lagers, and ciders above 6.0% ABV shall be stocked.

9. No single cans or bottles of beer, lager or cider shall be sold.

10. All alcohol stocked and sold shall be labelled

11. A clear and unobstructed view into the premises shall be maintained at all times.

12. All deliveries shall take place during the normal working day (i.e. 09:00 to 18:00 daily).

13. A suitable intruder alarm complete with panic button shall be fitted and maintained.

14. The following crime prevention measures shall be implemented:

• A time delay safe with deposit slot and anti fishing mechanisms must be used at the counter till area

• Regular robbery awareness and cash minimisation training shall be given to all staff.

15. Outside of the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grills, locked screens or locked cabinet doors so as to prevent access to the alcohol by customers or staff.

16. No alcohol shall be purchased from door to door sellers.

17. Goods shall be purchased only from established traders.

18. Seller's name and address, VAT and vehicle registration shall be recorded.

19. Copies of invoices and receipts shall be kept for a minimum of 18 months and made available to authorised officers.
