Thank you for your email.

We do not have engineers to obtain the CCTV recordings, it is the responsibility of the premise licence holder to supply this to us. Whilst the installation of CCTV and provision of CCTV recordings is not a condition on your premise licence, we would strongly suggest that you have CCTV in a good working condition and recordings are kept for 31 days in order to uphold the licensing objections. Please find attached guidance on CCTV from the home office, which I hope you find useful.

As discussed during my visit on Tuesday 27th September 2016, as the licensee and DPS, you are expected to know all the conditions on the premises licence and to have made provisions with staff to ensure that none of the licensing conditions are breached.
