## PROTECTIVE MARKING

I am giving this certificate because I am of the opinion that other procedures under the Licensing Act 2003 are inappropriate in this case because:

Brent Police Licensing have been in consulation with the premises licence holder and designated premises supervisor for several months in connection with all of the licensed premises in the building. Recently on 15<sup>th</sup> March 2017 when discusions were had about the use of appropriately secuirity industry authorised door supervisors. On 2nd April 2017 at approximately 0515 hours Police were alerted by Brent Council CCTV operator to a fighting and disturbance outside the front of Ruby Lounge. Police also received three 999 calls at 0512 hours from males stating there was fighting, his friend was being punched by security staff. Police Officers that attended the scene described the customers has heavily intoxicated. Footage from the Police Officers Body Worn Video recorders clearly shows how drunk the males had been allowed to get inside the venue and visible facial injuries.

There was two door supervisors employed at the venue and several other members of staff including the designated premises supervisor.

From subsequently viewing the council CCTV footage it clearly shows the premises emptying of a substantaile amount of drunk customers. The management and door supervisors can be clearly seen outside the front of the premises attempting to deal with the remonstarting drunk customers. Serious disorder then breaks out whereby the door supervisors and management are clearly seen punching several customers to the floor/in the road and kicking them in the head, one male appears to be momentarily unconscious

From subsequently viewing the CCTV footage from within the premises just prior to the disorder the intoxicated levels of the customers is clear to see.

Crime alleagtions have been recorded and are under current investigation by Detectives.

It is not felt suitable for a standard review as the risk from subleasing the venue to management that permit intoxiation to levels that lead to serious disorder and assualt, the current opeartion and management to the safety of the public. As a result of these incidents, police have lost faith in the management. Police believe that the immediate suspension of the premises licence is necessary to prevent any further crime and disorder in partcular an immediate review of the opeartion and door supervision team.

This is deemed an appropriate and proportiante measure in view of the above evidence and to reduce any further threat to the piblic safety and the prevention of crime and disorder licensing objectives.
