#### Other achievements throughout the period:

I have followed up my Chairing of the ACF by the creation of a bespoke Councillor Blog (www.jamesdenselow.com/ councillor-blog) which reports on highlights from the event and linked issues. I have also developed an excellent working relationship with the Brent Consultation team and look forward to continuing to work with them in the coming year.

Over the course of the next year I hope to increase the participation numbers in the ACF by better linking it to the variety of community hubs in the wards it represents. Working with local councillors, residents associations and other groups to feedback into what exactly they want from the meetings. I have also been working with the Ward Working team on trialling a 'Dragons Den' style consultation with local residents – held prior to an ACF – to debate the allocation and priorities of the ward's annual fund. Hopefully this will encourage higher participation rates in the ACF and give residents greater ownership over local decision making. I've held meetings with the officers on the Ward Working team and have also held discussion with Cllr. Lesley Jones on the issue, with all feedback being very positive.

I believe that the ACFs represent a fantastic opportunity to show the residents of Brent that the administration is on their side in these difficult times of government cuts. More often than not constituents' complaints I receive are linked to communication issues and I think that the administration has to be far more proactive in addressing residents concerns.
