I submit the following review as activities I have participated in as a councillor over the Municipal Year 2010/2011.

Local ward work:

I have maintained regular contact with my constituents and stakeholders in Tokyngton since my being elected to the Office in May 2010.

In this respect, I set out below few examples of the local work that I have supported and where I have committed some of the Council's *Ward Working* capital:

- Oakington Manor School Woodland Development Project to create an outdoor environment in the wooded area in the School
- Route 18 Project to provide support to all members of the local community in the need of shelter during the winter months at the St Michael's Church
- White Horse Bridge Public Art Hoarding to provide an attractive screen endorsed with public piece of art to prevent rubbish and fly-tipping etc at this prime location in the heart of Wembley Hill
- Islamic Cultural Centre Luncheon Club to bring together isolated elderly residents of all faiths together in Monks Park Parade for a wide range of activities
- Tree planting along Harrow Road to enhance visual appearance to one of the main roads of Tokyngton

Further, I have worked closely with the Council's Officers to ensure that potholes and other general damages to Tokyngton's public highways and footpaths are repaired in timely fashion; rubbish and unwanted household items left on pavements and elsewhere are quickly removed; and trees and grass verges are routinely maintained to improve visual appearance and to foster civic pride in the area.

Surgeries held:

During the past year, I have held regular surgeries at Tokyngton Library and St Joseph's Social Club Centre.

Additionally, I have held regular ad hoc surgeries at St. Michael's Church Hall, St Joseph's Pastoral Central and on various routine walkabouts throughout the Ward.

Council meetings attended:

I have attended all the Full Council meetings and several Executive meetings in the past municipal year.

However, as a lawyer, it has been immensely satisfying to be able to serve on the two quasi-judicial committees of the Council during this period, namely as a Chair of Staff Appeals Committee and as Vice-Chair of the Planning Committee. These roles have provided me with the unique opportunity to utilise my legal knowledge and skills for the continued good governance and prosperity of the Borough as a whole.
