I have reviewed the evidence in this case and have discussed this matter with the OIC. I have made a decision as above and have recorded below the key factors that have been considered in reaching this decision:

1. Both suspects have been the victim of an assault or otherwise involved in an altercation in which they received injuries.

 Suspect have waited outside venue for a considerable period of time, a minimum of 20 minutes whereby there are no other people present. No other parties are involved in this matter and there is no altercation.

3. Suspects both leave the venue and travel into a public car park where they arm themselves with long lengths of tile which they proceed to walk back

towards the venue they were originally at.

4. Suspects call the police to claim they have been the victims of assault.

5. NAME REDACTED specifically states he armed himself as he was going to hit one of those who assaulted him if they came outside. NAME REDACTED has stated he armed himself in self defence while he waited for the police.

6. There is no instance arming here. There is no immediate threat, the suspects move themselves from the scene and have a long period of time
