Description of Incident:

A car was parked across the road which had Asian customers from another club sitting in the vehicle (2 Male, 4 Female) where they had been ejected for drunken behaviour, the group in the car had been troubling random people were twice I had to call the security from the other club to come and tell their customers to leave from the residential area, but they had refused to move on and said they was waiting for a cab, for over an hour or so, when the cab office was one door down from Savanna Lounge.

The two Asian Males and one female where sitting outside the Flats opposite Savanna Lounge, when the two black males came out of Savanna Lounge for Fresh air where they had been provoked by a few words been said by the Asian Girls and one of the Males, when the two Black Males had gone across the road to see what they was saying to them, where the tall male in a grey jumper had stood up and came to the face of the Black male in a Red Jumper and had asked what his problem was and the Black male ha said there was no problem, where the second Asian male (in a black jacket) had stood up and told his friend to calm down but would not listen and had shoved the Black Male and the male for self-defence had pushed him away and the tall Asian male had gone into his vehicle and bought out a tow bar and lunged and punched the black male (red jumper) and the black male had retaliated back by trying to hit him in self-defence where then the second black male had taken his belt of to protect his friend and then they both had gone inside savanna lounge and his friends cousins family had seen blood on him and had all came rushing out and started to find out who had hit his friend cousin family and that is when the Asian male realised he had no chance to fight and tried to get away but a black male had taken away his car keys and they had beaten him 20 minutes or so later the police arrived and everyone scattered away.
