# Application to renew designation of Sudbury Town Neighbourhood Forum

# 1.0 Summary

1.1 This report includes details relating to the request from the Sudbury Town Residents' Association (STRA) to renew their Neighbourhood Forum status. The application was subject to consultation for a 6 week period ending 28 November 2017. Ninety eight responses were received. There were no objections to the application. This report recommends that the Lead Member approve the designation applied for.

### 2.0 Recommendations

2.1 That the designation of Sudbury Neighbourhood Forum, as set out in the submitted application, be agreed.

# 3.0 Background

- 3.1 Neighbourhood planning was introduced through the Localism Act 2011. The Act enables communities to develop planning policies that will become part of the planning framework for their area. It also allows them to grant planning permission for certain types of new development.
- 3.2 Neighbourhood planning is delivered by 'Neighbourhood Forums' for their 'Neighbourhood Area'. Neighbourhood Forums and Areas need to be agreed by local planning authorities, following local publicity.
- 3.3 Sudbury Town Residents' Association has been designated as the Neighbourhood Forum for the Sudbury Neighbourhood Area since December 2012. Neighbourhood Forum designations expire after five years and this application seeks to renew the Forum's status for a further five years. Renewal of the Forum's designation means no other organisation or body may be designated for that Neighbourhood Area until the designation expires or is withdrawn.

# The Application

3.4 In October 2017, the Sudbury Town Residents' Association applied to renew its status as a Neighbourhood Forum, maintaining the boundary of the current Neighbourhood Area as

adopted in 2012. The application, including a map showing the extent of the Neighbourhood Area, is included in Appendix A of this report.

- 3.5 The council assessed the application and is satisfied that it complies with the statutory requirements as set out in the Neighbourhood Planning (General) Regulations 2012. A summary of the assessment is included as Appendix B.
- In line with the Regulations, the council published the application for a six week consultation period ending on 28 November 2017. During the consultation period application documents were made available to view online at a dedicated website <a href="www.brent.gov.uk/stnp">www.brent.gov.uk/stnp</a>. The consultation was publicised via site notices at 6 locations in the Sudbury Neighbourhood Area, and via Facebook and Twitter. The following groups were also invited to comment via email:
  - All Brent Councillors via the Members' Bulletin
  - Members of the Sudbury Neighbourhood Forum
  - Relevant organisations and groups from the Local Plan consultation database, including neighbouring boroughs and community groups

### Consultation Responses

- 3.8 Ninety eight responses were received to the consultation. There were no objections.
- 3.9 Sudbury Ward Councillors Aden, Hoda-Benn and Daly submitted a joint response in support of the renewal of the Forum, outlining the work the Forum has done and future plans which will continue to benefit the neighbourhood.
- 3.10 Various organisations responded in support of or without objection to the Forum renewal including:
  - Highways England
  - Natural England
  - Historic England
  - The Canal and River Trust
  - Brent Indian Association
  - North Brent Parks and Residents Association Forum
- 3.11 In addition to this there were 91 responses from members of the public, all in favour of the renewal of the Forum. A summary of these responses is included in Appendix C.

# 4.0 Financial Implications

4.1 As the council has previously applied for and received funding towards the designation of STRA as the Neighbourhood Forum for Sudbury Neighbourhood Area, no funding is available for this subsequent designation. If the Forum reviews its Neighbourhood Plan the council can apply for £20,000 on successful completion of an examination into the Plan. This funding will go towards the cost of examination and a referendum.

# 5.0 Legal Implications

5.1 Once designated as the Neighbourhood Forum, no other organisation or body may be designated for that Neighbourhood Area until that designation expires or is withdrawn.

# 6.0 Diversity Implications

- 6.1 The Equality Act 2010 introduced a new public sector equality duty under section 149. It covers the following nine protected characteristics: age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation. The council must, in exercising its functions, have "due regard" to the need to:
  - 1. Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited by the Act.
  - 2. Advance equality of opportunity between people who share a protected characteristic and those who do not.
  - 3. Foster good relations between people who share a protected characteristic and those who do not.
- 6.2 The application has been subject to an Equality Analysis Assessment which is attached as Appendix D. The assessment identifies no potential negative impacts in relation to different equality groups.
- 6.3 The Neighbourhood Planning (General) Regulations 2012 requires the council to ensure that those applying for Neighbourhood Forum status are representative of the area to be covered. Sudbury Town Residents' Association satisfies this requirement.

# 7.0 Staffing/Accommodation Implications

7.1 No additional staff resources will be necessary to support neighbourhood planning, depending upon the number of Plans that are taken forward, or staff resources will be diverted from other plan making projects to provide support and advice.

# 8.0 Environmental Implications

8.1 A Neighbourhood Plan will allow local communities to focus better on local planning issues relevant to their particular area and there is potential for measures to be proposed and implemented that would lead to improvements to the local area's environment.

STRA was awarded the status of Sudbury Neighbourhood Forum (SNF) when STRA was one of the front runners for a Naighbourhood Plan. After extensive consultation with the residents and businesses of Sudbury, a referendum. relating to the adoption of the Neighbourhood Plan was held on Thursday 10th September 2015. An amazing result was achieved: 93% YES VOTE for the Neighbourhood Plan.

STRA's Neighbourhood Forum status has given an additional momentum to its

residents and businesses. Through its forum status, STRA is empowered to maintain its much-needed "CLEANER, GREENER, SAFER SUDBURY TOWN, WITH A HIGH STREET AT THE HEART OF THE COMMUNITY THAT WE CAN ALL BE PROUD OF'.


STRA has a Business Wing that meets on the first Wednesday of every month.
