Hi Nicola,

Good to meet last week, just following on from our initial conversation the main precautions we were seeking to address were the following -

1) Exit time being the same as Paradise.

We're happy to finish serving drinks at 2am, and have the venue vacated by 230am, to avoid large congregations of ours and Paradises guest crowding the streets.

2) outdoor smoking area - noise complaints from local residents

We will implement a restriction on smokers in the back garden from 11pm, and will only allow 5-10 out front at any given time, with printed signs requesting guests respect local residents.

3) effective queuing system / security

Due to the running times of the event 3pm-2am, we anticipate a staggered arrival of our guests which should mean large queues never really ever build up. If at our anticipated peak times (7-9pm), queues happen to build up, one of us organisers will be on hand to assist the security in managing the queue, and can help to speed up the process by scanning tickets of people in the queue.

We will utilise barriers to make the queuing system as organised as possible, and these can later be used to form a mini enclosure where a few smokers can be.

We will also add a stipulation to the tickets that "Entry is only guaranteed before 11pm*" to minimise late / drunk arrivals.

We are still in the process of confirming a security firm and will send over further details on this within the coming week or so, however our chosen firm will have metal detector wands and will be equipped with radios to ensure effective communication.

1 member of the security team will be stationed in the garden at all times.

We'll aim to be back in touch with you before the end of the week with details of our chosen security company, and a draft our letter to local residents, which we'll deliver 2 weeks in advance of the party.

Please could you send us an up-to-date risk assessment form we can fill out?

Let us know if there's anything else you require from us before the end of the week.

Dear Nicola

I refer to your recent relevant representations in respect of Jesse Dunford-Wood's application for a TEN at his premises, Parlour, in Kensal Rise. I attach the representations again for your convenience.

By way of introduction we are the team of organisers who are wanting to hold the event at Parlour. Between us we have organised 6 Carnival after-parties (i.e. post 7pm events) on the Sunday and we hope that we can demonstrate to you that we are a safe set of hands who can deliver a safe, effective and trouble-free event that would promote all of the licensing objectives.

Jesse said that you would be keen to meet with us and we would like to make that happen. Could you let us know when we can come and speak with you and explain our event plan in more detail to you. Or headline point is that we do not want this to be just another loud and loose Carnival event - we want to reclaim Carnival and show that it is possible to organise a safe and controlled event for those who live locally and who may otherwise be tempted to leave the area and not to engage with Carnival.

Please note I am copying in Linda and Yogini from the Licensing Authority as a matter of courtesy and we would similarly wish to extend our offer to Brent to meet and discuss the plan for the event in more detail. We look forward to working with you on this.
