Community Infrastructure Levy & s106 Planning Obligations

2. Briefly describe the aim of the service/policy etc? What needs or duties is it designed to meet? How does it differ from any existing services/ policies etc in this area

The aim is to adopt a Community Infrastructure Levy (CIL) charging schedule, in accordance with the Planning Act 2008 and CIL Regulations 2010, to be applied on new developments across the Borough. The charging schedule will require qualifying developments to make financial contributions on the basis of £ per m², where m² are the net additional gross internal area created by the development. These CIL contributions will be collected by the Council and then used to fund identified infrastructure projects across the Borough. This will replace the existing system of collecting infrastructure contributions from developers through the use of s106 agreements as this will no longer be possible after April 2014 due to changes in planning legislation. The aim is also to adopt a new SPD on s106 Obligations which will continue to be used to secure non-financial planning obligations from development.

3. Are the aims consistent with the council's Comprehensive Equality Policy?

The Council's Equality and Diversity Policy statement makes reference to the importance of ensuring that the services that we provide meet the needs of the community. The policy seeks to ensure that everyone has equal access to services, regardless of their race, heritage, gender, religious or non religious belief, nationality, family background, age, disability or sexuality. Services must be relevant, responsive and sensitive, and the council must be perceived as equitable in its provision of services by its service users, partners and the wider community.

The Community Infrastructure Levy will assist the Council in funding a wide range of infrastructure projects across the Borough which will not only support growth, but at the same time also help meet the needs of local people. The Localism Bill will require the Council to consult with communities regarding the CIL collected within their area and which infrastructure projects that CIL will be spent on, including local projects. This will require the allocation of CIL be both transparent and accountable, thereby helping to ensure an equitable distribution of CIL across the borough and that communities are given a level of infrastructure funding that is appropriate to the impact of new development within their area.

In terms of the revised s106 SPD, most S106 agreements are directly linked to planning policy requirements that have been the subject of public consultation and examination as well as an equalities impact assessment. The planning strategy for Brent (London Plan and the LDF) reflects the needs of the borough's diverse community.

4. Is there any evidence to suggest that this could affect some groups of people? Is there an adverse impact around race/gender/disability/faith/sexual orientation/health etc? What are the reasons for this adverse impact?

There is no evidence that the adoption of CIL charging and a revised s106 SPD would adversely impact on certain groups of people, and on the contrary would provide a number of benefits to new and existing residents through the provision of new infrastructure. The type of infrastructure to be provided would include roads and other transport facilities, flood defences, schools and other educational facilities, medical facilities, sporting and recreational facilities and open spaces. There are general requirements for these types of infrastructure projects to be designed to be accessible to all members of the community.
